Results of examination:

FIREARMS - TOOLMARKS EXAMINATIONS

The serial number on the black rifle box, Q1, was determined to be 4744Z5. This box originally contained a .243 Winchester caliber Browning rifle.

The Q3 cartridge case was identified as having been fired in the Q2 rifle. The only marks found on Q3, other than marks made during manufacturing procedures, were one extractor mark which was identified as having been made by the extractor of the Q2 rifle and the marks left on Q3 by the Q2 rifle when Q3 was fired.

The bullet, Q64, from the victim, is a .30 caliber metal-jacketed "soft-point" sporting type bullet of Remington-Peters manufacture which was fired from a barrel rifled with six lands and grooves, right twist. Based on the physical characteristics of the general rifling impressions, the Q64 bullet could have been fired from the Remington rifle, Q2. The Q64 bullet has been distorted due to mutilation and insufficient marks of value for identification remain on this bullet. Therefore, it was not possible to determine whether or not Q64 was fired from the Q2 rifle.

The Q64 bullet is identical in all remaining observable physical characteristics to the 150 grain bullets in the five loaded .30-06 Springfield caliber Remington-Peters cartridges, Q4 through Q8.

Based on physical characteristics, specimen Q64 and the cartridge case, Q3, could originally have been portions of the same cartridge, which would be the same as the Q4 through Q8 cartridges. No marks are present on Q64 of the type which would permit determining positively whether or not the Q64 bullet was originally a portion of the cartridge represented by Q3.

The five cartridges, Q4 through Q8, conform in description to the type of cartridges packaged by the manufacturer in the Peters cartridge box in which they were submitted. Because of the manner in which cartridges are boxed at the factory, it is not possible to determine whether or not the cartridge represented by Q3 or any of the

Q4 through Q8 cartridges were packaged in the same box by the manufacturer.

The Peters cartridge box in which Q4 through Q8 were submitted also contained four U. S. Military cartridges, containing full-metal jacketed 150 grain bullets, different from Q64. The manufacturer's headstamp on these cartridges is "R A 55." The "R A" indicates that these cartridges were manufactured by Remington Arms Company, Incorporated, Bridgeport, Connecticut. Cartridges bearing "55" are those normally manufactured in 1955.

Examination of the four cartridges, Q9 through Q12, revealed no marks indicating these cartridges had ever been loaded into a weapon. The only marks on these cartridges appear to be marks produced by the manufacturer's machines and marks of the type produced by metal-link ammunition belts of the type used with machine guns. The link belt marks on Q9 through Q12 are suitable for comparison with the metal links from which the cartridges were withdrawn. In metal-link belts, each cartridge serves to hold adjacent links together. As each cartridge is withdrawn, a link (which is expendable) separates from the rest of the belt.

No aluminum, screen-type scratches, paint, wood or other foreign material was found on the muzzle or side of the barrel of the Q2 rifle.

No record was located in the National Stolen Property Index or the National Crime Information Center for a Browning rifle, Serial Number 4744Z5, as originally contained in Q1; for the Q2 rifle; for a Redfield 2X-7X variable telescope sight, Serial Number A17350 (which is mounted on Q2), or for the Bushnell binocular, Q14, Serial Number DQ408664.

No serial number which would facilitate tracing was found on the Weaver telescope sight mount and base on Q2. The screws used to secure the sight tube to the mount were "finger" tight. No tool was required to loosen them and no toolmarks of value for comparison are present.

The magnification setting of the telescope sight tube was "6½x" when the Q2 rifle was received. Therefore, objects viewed would be enlarged to approximately 6½ times normal size.

HAIR EXAMINATION

Numerous brown head hairs of Caucasian origin were found on or in specimens Q13, Q15, Q26, Q29, Q30 and Q38. Numerous dark brown to black beard fragments of Caucasian origin were removed from the Q24 and Q46 razors. All of these hairs and beard fragments have been mounted on glass slides for comparisons with any suspects you may develop.

No Negroid hairs were found on or in any of the above-listed evidence.

FIBER EXAMINATION

Brown cotton fibers, green cotton fibers and lustrous green viscose fibers like those composing the Q13 bedspread were found on the Q2 rifle and in the debris removed from the Q1 box. These fibers could have originated from Q13.

MISCELLANEOUS EXAMINATIONS

Specimen Q1 is a black cardboard box measuring 6 3/4" x 2½" x 44½". Printing on the box indicates it contained a Browning Mauser rifle, "SAFARI" grade. The number "130712" is printed on the end of the box and "4744Z5" has been hand printed on the same end.

Specimen Q13 is a large green and brown bedspread. It is composed of approximately 50% brown cotton, 25% green cotton and 25% lustrous green viscose fibers. It measures 106½" x 85½" and has a herringbone design. The ribs of the herringbone have a 40° angle and each rib is 3/4" in width. No visible, invisible or manufacturer's markings were found on Q13. It exhibits above-average wear and is of the type sometimes found in hotels or motels.

The Bushnell Q14 binocular was manufactured in Japan. Bushnell binoculars are distributed by Bushnell and Company, Incorporated, 639 Bushnell Building, Pasadena, California. Specimen Q14 bears number "DQ408664." A paper

label on the center post indicates Q14 was passed by the "Japan Telescopes Inspection Institute."

The Q15 zipper bag measures 15" x 20" x 5 $\frac{1}{4}$ " and is an inexpensive bag of Japanese manufacture. The bag is a "Tel-Star" model that retails for about six to seven dollars. This model bag comes in six different sizes, 16", 18", 20", 22", 24" and 26". The importer or jobber for "Tel-Star" luggage is the United Products Corporation, 2500 Genessee, Kansas City, Missouri 64141.

The Q16 duck-bill pliers are 7 $\frac{3}{4}$ " in length and the jaws are 1 $\frac{3}{8}$ " long. A price tag on one handle bears "ROMPAGE HARDWARE \$1.98." Just above the word "Rompage" are three characters printed in blue. Two characters on the left appear to be "10." The single character on the right appears to be "0." No other data was noted on the label.

Also in Q16 is a small tack hammer with a metal head 4 $\frac{1}{8}$ " long. Imprinted on the wooden handle is "MAGNETIC" The handle is painted white with a blue band around the end of the handle. The U. S. Patent Office has no record of the trademark on this hammer.

The Q17 metal "BAND-AID" box contains twenty-one regular adhesive bandages and ten "JUNIOR" adhesive bandages. The number of bandages in the box agrees with the count printed on the box. A small round price tag on top of Q17 has the numerals ".57."

Nothing of significance was noted concerning the partial role of toilet paper, Q21.

Specimen Q22 is a black binocular case for a Bushnell binocular. Inside Q22 was found an instruction booklet, lens cloth and guarantee card.

Specimen Q23 is a cardboard box for a Bushnell binocular. A price tag on Q23 has the numerals "11-67" and "\$39.95" printed on it. Also on this box was hand printed:

Specimen Q24 is a travel kit manufactured by Gillette. It is clear plastic and contains the following:

- 1 - Safety razor with double-edge blade
- 2 - Package of "Gillette" stainless steel double-edge blades
- 3 - 1.3 ounce can of "foamy" shaving cream
- 4 - 1 ounce can "RIGHT GUARD" deodorant
- 5 - $\frac{1}{2}$ ounce bottle "Sun Up" after shave lotion
- 6 - $\frac{3}{8}$ ounce tube "HEADS UP" hair dressing

A price tag on the top of Q24 has the following printed on it: "OLIVER REXALL," "WHITEHAVEN PHONE 397-2301," "\$1.89," "E" and "00."

The Q25 gray paper bag has the name and address of the "YORK ARMS CO." of Memphis printed on it. Inside this bag was found a cash register receipt dated "APR 4" in the amount of "\$041.55 CBH." The numerals "083" also appear on the receipt.

The Q26 white and yellow checkered towel is 26" x 15". No labels or visible or invisible markings were found on Q26.

Specimen Q27 is an inexpensive common man's handkerchief measuring $14\frac{1}{2}$ " x 15". No labels or markings were found on Q27.

Specimen Q28 is a partial tube of "Colgate" toothpaste, 3.25 ounce size.

The Q29 and Q30 socks are a pair of black knee length synthetic stretch socks. No markings or labels were found on these socks.

The Q31 can of "RIGHT GUARD" deodorant is a 7 ounce size. "M313" is printed in black on the bottom of the can.

Specimen Q32 is a Channel Master radio receiver. A label affixed to the inside of the rear cover indicates that the receiver is Model 6502, 6 transistor, super heterodyne, with a frequency range of 535-1605 Kc/s and operates

on a 9-volt battery supply. The words "CHANNEL MASTER CORP." are imprinted on the bottom of the label. The words "HONG KONG" are molded on the outside of the light-colored plastic cover, however, some components are marked "JAPAN." A 9-volt Eveready battery, #216, was connected inside the case. The front of the case is made of polished or plated metal and is stamped "6 TRANSISTOR CHANNEL MASTER." The remainder of the case, about one-third down each side, is maroon-colored plastic. The case measures approximately 4" x 2 3/8" x 1 1/4".

Radio products bearing the Channel Master name are very common.

When received, the dial indicated approximately "10" and was turned to approximately 1020 Kc/s. The tuning range of the receiver is approximately 530 Kc/s to 1660 Kc/s, which covers the regular broadcast band. The receiver was operational when received.

The Q32 radio bears scratches on one end interpreted to read "00416."

The Q33 plastic "BUFFERIN" bottle is a 60-tablet size and contained 10 whole tablets and 2 partial tablets, all bearing the letter "B."

Specimen Q34 is a man's elastic belt bearing Greek or Roman heads on the buckle. The belt is 3/4" wide and 31" long, unstretched. The waist measurement of the wearer could not be determined in view of the type of belt.

Specimen Q35 is a partial tube of "BRYLCREEM" hair dressing, 3 ounce size.

Specimen Q36 is a bottle of "ONE A DAY" vitamins, 25-tablet size. There were 21 tablets in the bottle.

Specimen Q37 is a small hotel-size bar of "Cashmere Bouquet" soap.

Specimen Q38 is a clear plastic hairbrush with white synthetic bristles. "U.S.A." has been molded to the underside of the handle.

The Q39 bar of "dial" soap is a 4 7/8 ounce size and has the price "2/45¢" stamped on one end in blue ink.

The Q40 tube of "Head & Shoulders" shampoo is a 2.7 ounce size. It bears a price label with "LIGGETT-REXALL 1678 1.10" on the side.

The Q41 can of "KIWI" brown boot polish is a 1 1/8 ounce size. Some of the polish has been used.

A price tag on the Q42 can of "PALMOLIVE RAPID-SHAVE" menthol shaving cream bears "LIGGETT-REXALL 3478 .79."

Nothing of significance was noted about the Q43, Q44 or Q63 buttons; however, they are suitable for comparison with other buttons present on suspect garments.

Specimen Q45 is a used red-handled "Pepsodent" brand toothbrush. "U.S.A. M K5" is present on the underside of Q45.

The Q46 razor is a "Gillette" make and has no blade in it.

A price tag is on the Q47 3.75 ounce bottle of "MENNEN afta" after shave and skin conditioner lotion bearing "\$1.00 PLS TAX." "202x" is printed in blue ink on the bottom of Q47.

Specimen Q48 is a small bar of "Cameo" soap manufactured by the Brunswick Soap Company, Brooklyn, New York.

Specimen Q49 is a small bar of "Cashmere Bouquet" soap, a product of Colgate-Palmolive Company, New York. A shield with "Member Friendship Inns" has been printed on the wrapper.

The Q50 and Q51 bobby pins are light brown colored, common pins.

Specimens Q52 and Q53 are full cans of Schlitz beer. "MISSISSIPPI TAX PAID 4 CENTS" has been printed in black on the bottom of each can. "03" has been stamped into the

metal in the bottom of each can. Both cans are alike. These cans were found attached to the Q54 carrying device in the Q55 paper bag.

Nothing of apparent significance was noted about the 4" x 6" brown paper Q56 bag.

The Q57 key fits the lock on the Q15 zipper bag and probably belongs to this bag.

Specimen Q58 is a common, round, used toothpick.

The metal split ring, Q59, has overlapping ends. It appears to be the type of ring that new keys are attached to.

Nothing of significance was noted about the Q60 and Q61 coat hangers.

Specimen Q62 is a two-link portion of an "ADJUST-O" silver-colored watchband. The links may be compared with the watchband should same be recovered.

SOIL EXAMINATION

Fine smears and deposits of brown silty soil having the appearance of being deposited while wet were found on Q13. The soil in these smears and deposits is suitable for comparison purposes. The specific origin of the soil cannot be determined by a Laboratory examination.

DOCUMENT EXAMINATION

Specimens Q18, Q19, Q20, Q23, Q25, Q55 and Q56 were examined for writings and pertinent indented impressions, but nothing of significance was noted.

The Q55 bag is imprinted "HOMESTEAD" "STUBBY." Information available in the Laboratory shows that the "HOMESTEAD" brand name is registered to the Graham Paper Company, 1014 Spruce Street, St. Louis, Missouri 63102, while "STUBBY" refers to the type of bag.

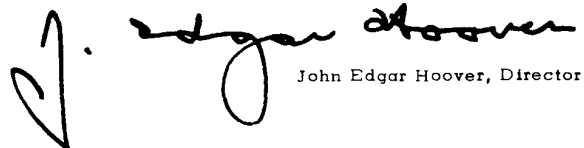

Result of examination:

The hand printing appearing on the slip of paper comprising a portion of Q124 was searched in the Anonymous Letter File without effecting an identification. Appropriate photographs have been added to this file for future reference.

The cellophane tape comprising a portion of Q124 is of common $\frac{1}{2}$ inch-wide variety, the ends of which appear to have been torn or cut unevenly.

Due to the limited nature of the questioned hand printing on Q124 and because of unexplained variations, a definite conclusion could not be reached whether the hand printing on Q124 is identical to the hand printing appearing on documents attributable to Eric S. Galt, submitted in this case. A number of significant differences were noted indicating

this questioned hand printing may not have been prepared by the writer of the hand printing on documents attributable to Galt.

Result of examination:

The "Eric S. Galt" signatures on Q128, Q130, Q131, Q132 and Q135 were prepared by the writer of the signatures in this name appearing on items previously submitted in this case.

The typewritten impressions appearing on Q127, Q128, Q130, Q131, Q132 and Q135 were found to be the same style of type but the lack of identifying defects precluded a determination as to whether the same typewriter prepared all of these items; however, no significant differences were noted between the impressions appearing on these items. The style of type appearing on these specimens conforms to a standard for Royal pica style of type spaced ten letters to the inch. This style of type also appears on a typewriter sold under the Singer name.

It was determined that the hand printing appearing the Q133 order blank and the Q134 enrollment form was prepared by the same individual. No questioned hand printing appears on the other items received.

Indented impressions were noted on the reverse side of the Q128 letter. The names "Ray," "Galt" and "Rily" and numerals "ET3623" were some of the notations interpreted on this item. A photograph of the indented writing is enclosed for the information of Los Angeles.

The submitted evidence has been retained.

INVESTIGATIVE DEVELOPMENTS

This case concerns the murder of Martin Luther King, Jr.

When Eric S. Galt enrolled in a locksmithing course, 7/31/67, he gave his address as 2589 Rue Notre Dame Est, Montreal, Canada, and it appears that he received mail directed to his address by the locksmithing school. Canadian sources have advised that this address consists of 40 or 50 apartments, that Galt is unknown there, and the rental office has no record of his tenancy. In reviewing rental records, however, a notation was found on the back of a page listing the name and address "Eric S. Galt, 507 Chestnut Street, Kansas City." The employee who made the notation is no longer there and is presently located in Windsor, Ontario, Canada. Present employees believe the notation indicates that Galt contacted the office on 3/1/67 to inquire about reserving a room. Canadian sources are locating the former employee in Ontario for interview and are also checking various public and government records throughout Canada for any record of Galt.

At Kansas City it has been determined that the building at 507 Chestnut Street was torn down several years ago for a freeway. Intensive investigation which is proceeding at Kansas City has not yet located any record of Galt.

A confidential racial source has advised the Los Angeles Office that on 4/16/68 a representative of Drew Pearson and reporters for "Newsweek" contacted Dr. Theodore Evans and his wife Dodie (with whom Martin Luther King, Jr., had a relationship) on a "fishing expedition" to determine the nature of their relationship with King. Dr. Evans told reporters his wife had been friendly with King. According to the source

Evans and his wife are extremely upset over the interviews by the press. Pearson's man and "Newsweek" are allegedly still "nosing around in Los Angeles."

Galt was registered at Hotel Rio, Puerto Vallarta, Jalisco, Mexico, 10/19/67 to 11/6/67. It has now been determined he registered at the Tropicana Hotel, Puerto Vallarta, 11/7/67 and checked out 11/13/67. Luis Garcia, bartender at Hotel Ocena, Puerto Vallarta, states he was acquainted with Galt for a few days in Puerto Vallarta. Galt told Garcia he had been in the Army for nine years serving as a driver or chauffeur but had not previously been out of the United States. Garcia said he terminated his brief association with Galt when Galt indicated an interest in obtaining marijuana.

An office of the Piedmont Laundry is just around the corner from the Atlanta rooming house used by Galt. Laundry records show Eric Galt, no address given, brought in nine laundry items and three dry cleaning items between 9 a. m. and 10 a. m. on 4/1/68. All items were picked up by the customer on 4/5/68 shortly after 9 a. m. The dry cleaning items included a black check sport coat, gray trousers and a black tie with tan and brown stripes. The laundry was marked EGC 83 with an indelible pencil. The dry cleaning was marked with a removable tag showing a figure 8 over the number 755. It is noted Galt also had a necktie dry cleaned while in Los Angeles.

Richard Gonzalez, fellow bartending student from 1/19/68 to 3/2/68, says Galt told him he had been in Mexico for about three years, exact time not stated. He said he liked Mexico and planned to return. Gonzalez stated he understood from Galt that he planned to go to Birmingham after graduating from bartending school to visit a brother for two weeks. Galt indicated to Gonzalez he had been a chef in the Merchant Marines on a seagoing vessel. He never mentioned any other type of employment or members of his family. Gonzalez said Galt was right-handed when mixing drinks.

Thomas Lau, director of the bartending school, said that Galt can speak only a few words of Spanish. He now recalls Galt mentioned he had lived in Puerto Vallarta, Mexico, for about three years.

Sharon Rhoads, part time dancing instructor at the dancing school at Long Beach, California, which has previously been mentioned,

recalled giving instructions to Galt between December, 1967, and the middle of February, 1968. She describes him as an introvert, very shy with crowds and with women, and said he would not talk about his past or background. She believed Galt had visited a brother in Louisiana in January, 1968, and he said he had formerly owned a bar in Mexico but sold it shortly before coming to Los Angeles. She states that Galt signed his name left-handed and had "pretty" blue eyes.

When enrolling in bartending school at Los Angeles, 1/19/68, Galt showed employment as "Mr. Willard," 751 South Figueroa Street, Los Angeles. No record of either Willard or Galt can be located at this address.

All phases of this investigation are continuing to receive top priority attention.

PROPOSED PROSECUTIVE ACTION

This case concerns the murder of Martin Luther King, Jr.

On 4/16/68 the Attorney General authorized the filing of a complaint charging Galt with violation of Title 18, Section 241, U. S. Code, for conspiring to interfere with the constitutional rights of Martin Luther King, Jr. It was understood that no publicity would be given to the complaint unless some change in the situation indicated the complaint should be made public. A proposed complaint is set out below:

On or about March 29, 1968, at Birmingham, Alabama, in the Northern District of Alabama, Eric Starvo Galt and an individual whom he alleged to be his brother, entered into a conspiracy, which continued until on or about April 5, 1968, to injure, oppress, threaten, or intimidate Martin Luther King, Jr., a citizen of the United States, residing in Atlanta, Georgia, in the free exercise or enjoyment of a right secured to him by the Constitution or laws of the United States; namely, the right to freely travel from state to state. In furtherance of this conspiracy, Eric Starvo Galt did, on or about March 30, 1968, purchase a rifle at Birmingham, Alabama, all in violation of Section 241, Title 18, U. S. Code.

The above proposed complaint is considered to disclose the absolute minimum information that would be acceptable to a U. S. Commissioner or Federal Judge. To satisfy the judicial officer, it may be necessary to add some additional details such as the description of the gun and the fact it was abandoned at the crime scene. If necessary, such detail will be added but only to the extent necessary to obtain a warrant.

Under the statute being used the complaint can be filed in any District in which the conspiracy took place or an overt act occurred. On the basis of facts presently available, we are limited to filing the complaint at Memphis or Birmingham.

We understand that we cannot rely on the U. S. Attorney at Memphis. If we tried to file there, we would immediately lose control of the situation and the complaint would become public knowledge.

We have checked with Birmingham and we have no assurance we could keep a complaint filed there a secret. We would have to go through the U. S. Attorney's Office and Mincey Weaver, the U. S. Attorney, is presently in Houston. The U. S. Commissioner is a woman who does not have too firm a grasp on her operations.

Investigation at the Canadian address given by Galt, 7/31/67, has not been productive and a Kansas City address as of 3/1/67, that we obtained in Canada is nonexistent. Galt is last known to have been in Atlanta, 4/5/68, and his present whereabouts are unknown. We are faced with the danger that he may leave the country before he is located.

In view of the above circumstances, it now appears charges should be immediately filed and Galt's fugitive status should be given the widest possible publicity.

ACTION:

- 1. We should openly file the proposed complaint at Birmingham.**
- 2. We should issue a wanted flyer and a fugitive press release.**
- 3. We should issue an Identification Order even though no fingerprints are available.**
- 4. At the appropriate time, the Attorney General should be advised that circumstances have required the action being taken.**

LATENT PRINT EXAMINATION

A box, together with a shipping bill, a slip of paper with notation "Dr. Rev. Martin L. King will be dead by 4-4-68," and other items used to ship stationery supplies from A. L. Garber Company, Ashland, Ohio, to Pittsburgh Plate Glass Company, Miami, Florida, was submitted by Miami Office for examination.

Two latent fingerprints and five latent palm prints were developed on these items. One latent fingerprint has been identified as a fingerprint of a Miami agent.

An envelope and a two-page letter received by the Attorney General naming a possible suspect have also been examined and three latent fingerprints were developed on the letter.

Lifts of latent prints and other items from rooms 107 14th Street, Atlanta, Georgia, have been examined and two latent fingerprints and eleven latent palm prints of value located.

These latent prints have all been compared with latent prints previously reported in this case, but no identification effected.

Two garments were recovered from a blue bag abandoned at the scene of the murder and believed to be the property of the assassin. These two garments, a pair of shorts and a T-shirt, contain laundry markings consisting of a Thermo-Seal stick-on type tape bearing the printed numbers "02B-6." Numerous of our field offices have been submitting strips of Thermo-Seal tape produced by laundry marking machines similar to the machine that would have been used to mark the questioned laundry marking. We have eliminated many of these and by our airtel of 4/11/68 advised Los Angeles that laundry markings Los Angeles submitted from Home Service Laundry and Dry Cleaning, 5280 Hollywood Boulevard, Hollywood, California, were similar to the questioned markings and no significant differences exist suggesting the questioned markings could have originated from the Home Service Laundry and Dry Cleaning Company.

Los Angeles has now verified from the records of Home Service Laundry and Dry Cleaning that a particular cleaning service was performed for "E. Galt" and this service is referred to in the records by the number "02B-6," thus obviating the need for pursuing this line of inquiry any further.

ACTION: Unless advised to the contrary, the samples of laundry tape submitted but not yet compared with questioned material will not be subjected to further examination since the source of the questioned material has now been established.

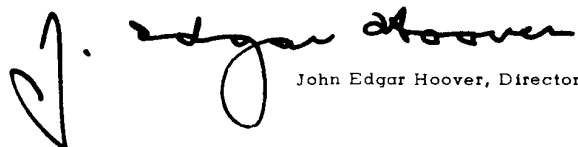

It was concluded that ANITA LOUISE KATZWINKEL, K26, did not prepare the questioned handwriting "Ginger & Anita Katzwinkel" appearing on Q118, the portion of a tissue box, previously submitted. Because of unexplained variations and insufficient comparable material, a definite conclusion could not be reached whether KATZWINKEL prepared any of the remaining questioned handwriting on Q118. Some significant handwriting differences were noted in this remaining questioned handwriting excluding the words "Day" and "at pool." These words are too limited and contain insufficient handwriting characteristics to determine if they were or were not prepared by KATZWINKEL.

Due to the lack of a sufficient number of significant comparable letters, it was not possible to determine if the words "broulh" and "Olkahombe" on Q118 were prepared by the person or persons responsible for the remaining questioned handwriting appearing on this specimen.

It was concluded that the FLIKEID signatures appearing on the bottom of K27, were prepared by THOMAS M. FLIKEID, FBI#534039D.

Because of insufficient significant comparable handwriting and unexplained variations, a definite conclusion could not be reached whether the questioned Lowmyer signature on the gun invoice previously submitted or the writings attributable to Eric S. Galt, previously submitted, were prepared by the writer of K27. Some handwriting differences were noted in the handwriting attributable to Galt when compared with K27; however, these characteristics are not sufficiently strong to definitely eliminate FLIKEID as a possible writer of the Galt material.

The K28 and K29 maps are not identical with two maps, Q18 and Q20, previously submitted and recovered from the blue bag in Memphis.

Q139, Q140, K27 through K29 are temporarily retained. Appropriate photographs of the writing appearing on K27 have been made.

One 8 inch head hair of Caucasian origin was found inside the Q139 left shoe. This has been dyed black. No similar hairs were found in or on items previously submitted in this case. No other hairs or debris was found in Q139 or Q140.

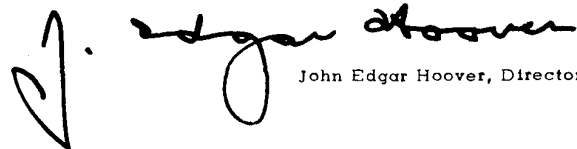

Result of examination:

The hand printing appearing on the slip of paper comprising a portion of Q124 was searched in the Anonymous Letter File without effecting an identification. Appropriate photographs have been added to this file for future reference.

The cellophane tape comprising a portion of Q124 is of common 1/2 inch-wide variety, the ends of which appear to have been torn or cut unevenly. It is doubtful that the source of this tape can be ascertained in view of the common nature of the tape used and the fact that the torn edges could only be matched with corresponding adjacent pieces of tape.

Due to the limited nature of the questioned hand printing on Q124 and because of unexplained variations, a definite conclusion could not be reached whether the hand printing on Q124 is identical to the hand printing appearing on documents attributable to Eric S. Galt, submitted in this case. A number of significant differences were noted indicating

this questioned hand printing may not have been prepared by the writer of the hand printing on documents attributable to Galt.

Q124 through Q126 are temporarily retained.
Appropriate photographs of Q124 and Q125 only have been made.

This case concerns the murder of Martin Luther King, Jr.

It has previously been reported that Galt met Charles Stein, Stein's sister, Rita Stein, and Marie Martin in a Los Angeles bar 12/14/67, and drove Stein to New Orleans, 12/15/67, to get Rita Stein's children and return them to Los Angeles.

Marie Martin says she first met Galt in the middle of December, 1967, in the Sultan Room at the St. Francis Hotel, Los Angeles, where she works as a cocktail waitress. She asked Galt if he would take her home and when he agreed she told him she lived in New Orleans. She explained that Rita Stein had to pick up her children in New Orleans and Galt was given the impression that either Marie or Rita was going to New Orleans with him. When he learned that Charles Stein was going to New Orleans with him instead of one of the women, Galt told her, "If it's a set up, I'll kill him. I have a gun."

After Galt returned to Los Angeles from New Orleans, 12/21/67, Marie Martin says she saw him about 30 times in the Sultan Room. He usually drank straight vodka but sometimes drank beer. He never smoked. His hands were clean and were not calloused. His eyes were blue but sometimes appeared hazel. He was always solemn, showed no emotion and was pale as if he were indoors a great deal. Galt said he had just finished a six-week bartender course but could only make a screwdriver.

Marie Martin said Galt told her on one occasion he was driving through a Negro community and tomatoes were thrown at his car because it had Alabama license plates.
