SA Paul Burns, U. S. Secret Service, Truman Library Detail, and Major Hall, 113 INTC, Group, MI, telephonically contacted this office and requested that their individual agencies be notified of any incidents reported to this agency with regard to instant assassination.

They were both advised that they will receive the requested information.

Major Hall, in addition, informed that his office is on nationwide alert due to this incident.

Both advised they have had no indication of any incidents in the KC area due to the above assassination but that the FBI will be kept advised.
