INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAMA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. HIS WHITE MUSTANG TO NEW ORLEANS, WHERE HE CLAIMED HE CONTACTED
EITHER AN ENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON
DECEMBER 19TH AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT

At 10:15 a.m. this date, ROBERT AKER, age 18, a student at Parkhill High School, residence 8410 High Ridge, Parkville, Missouri, telephone SH 1-8865; and DOUGLAS HUFFAKER, age 18, student Parkhill High School, residence 6610 Valley View Drive, Parkville, Missouri, telephone SH 1-4808, appeared at the Kansas City Office and informed that they were sitting at the counter at the Fedderman Drug Store, 11th and Grand, Kansas City, Missouri at 9:30 a.m. this date when a man sat down beside them and struck up a conversation. The man stated, "Heard you had alot of trouble with the riots here in Kansas Soon we will have to eliminate all of the Negroes." He advised he had come to Kansas City from Memphis and he was eating supper in Memphis when he heard the shot that killed MARTIN LUTHER KING. He stated you could tell from the sound the shot came from a high-powered rifle. He advised KING was a fool for being in the South. He was "just asking for it".

This individual then advised that the front page of the Memphis newspapers last week stated in the headlines, "Negroes destroy own neighborhood in Kansas City." This individual told the complainants that the killing of KING was a part of a conspiracy and it was not an individual acting on his own like LEE HARVEY OSWALD. He further stated the Ku Klux Klan and the Minutemen were not involved. He stated the FBI would never catch the killer and that KING was a Communist. He stated "even Director HOOVER said KING had at one time attended a Communist training camp."

He continued to voice his hate against Negroes and also against Jews and Catholics. He said it was Pope PAUL who made KING a martyr.

He had a cup of coffee which he drank hurriedly, then entered into this conversation with the boys. The boys stated there was a Negro waitress with little or no hair who waited

Reference memorandum of SA RAYMOND B. HOWE dated 4/17/68.

At 10:45 A.M., SA ROBERT B. BOTHWELL observed a man fitting the description furnished by two teenage boys from Parkhill High School near the Continental Trailways Bus Station. SA BOTHWELL picked up SA THOMAS in front of the office, and the unknown male was continued to be observed by SA JAMES E. RUSSELL. SA RUSSELL observed the unknown male to enter a Rambler automobile and proceed east from Oak on Tenth Street. Upon arriving, SA RUSSELL was advised by radio to request the unknown male in the Nash Rambler to stop. At this time, SA BOTHWELL and SA THOMAS arrived on the scene.

The Agents immediately identified themselves and asked the unknown male if he was willing to talk to us, that he is unknown to us, and that we know of no trouble that he is involved with, and advised him of his rights. He immediately commented that he knows his rights and that he has talked to FBI Agents before and was pleased to talk with the FBI Agents.

He at this time furnished a State of Ohio driver's license number reflecting his name to be JOHN KENNETH MADDEN, 3440 Brookline Avenue, Cincinnati, Ohio This driver's license reflected his date of birth as Knoxville, Tennessee, white male, 152 pounds, 5' 6 1/2", hair brown, eyes blue. He also exhibited a motor vehicle registration card for 1968, which reflected the name of JOHN KENNETH MADDEN, 170 South Raymond Street, Alhambra, California. The war was described as a 1960 four-door white Rambler, VIN 4DSDDXAR, AO892343, California Certificate Number TA3715435. The license plates on the car were BML384, California, 1968.

He related that this is his brother and that he calls him often, and he would receive any mail through this address. He advised that all his family thinks that he is working for CBS News.

He, at this time, showed a pin-type badge which had the name of JOHN K. MADDEN. Under the name was CBS News and TV. He advised that this tag has been able to get him into any news media conference and that he has used this exclusively. He also showed a card with the name of Keisco Photography, 3990 Park Avenue, Memphis, Tennessee, owned by RAY and JUDY KEISLING, and stated that he has worked with these people, but they may not know him by the name of MADDEN.

He stated that he thinks KING was on many lists to be killed.

He stated that when he was in Chicago he called the FBI Office sometime on the afternoon of April 4, 1968, after he had learned that KING was shot and told them that he was on his way back to Memphis. He stated that he drove from about 8:00 P.M. on April 4, 1968, and arrived in Memphis, Tennessee, about 5:30 p.m. on Friday, April 5. He did not furnish a reason for his returning to Memphis.

During the conversation, he mentooned a man by the name of GALT, stating that this means "Red Star"; therefore, he believes that the man who killed KING belongs to some organization. He advised that he does not know for sure if GALT actually killed KING, but he believes GALT would know who killed KING. He stated that he is of the opinion that the person who killed KING belongs to some political organization not influenced by anyone in this country but perhaps by some foreign country for propaganda purposes. He stated that he does not believe that the rifle found was actually the rifle used to shoot KING. He also advised that the reported suitcase found could be a planned tactic.

He advised that he recalls of being in the Peabody Sheridan Hotel where he observed a militant group of colored people wearing black berets same as those he recalls in Columbus, Ohio, several years previously with the letters on them "SDS".

He advised that he has been in Kansas City only two hours, and he believes that the trouble in Kansas City is only beginning as the people here are thinking too fast and too stupid.

He advised, getting back again to the Peabody Hotel, that he saw two well dressed colored men, and they remained in the lobby of the hotel most all day taking notes. He stated one had broom hair, about 6' 2", and weighed approximately 250 pounds. The other colored fellow with him wore a beret hat and was very neatly dressed. He advised that the Memphis paper on Monday after the shooting reported that revolutionary action movements were in Memphis, which story he believes to be true. He also advised that from his knowledge he believed that KING was in violation of a court order in going to Memphis. He advised that he believes the Revolutionary Action Movement (RAM) was responsible for shooting of KING, and the person who actially fired the shot could have been colored, that this group upon arriving in Memphis was heavily armed and possibly have more weapons than the Minutemen. He also stated that he knows from overhearing conversation that the RAM does not like ABERNATHY, but they would not kill ABERNATHY; however, they would hire someone to do their killing. again advised that he can only believe that some political foreign country has an interest in this complete matter and possibly from some communist country.

He advised that on his second visit to Memphis he went to the funeral procession in Atlanta, Georgia, and from there he went to Washington, D. C. He advised that while he was in Washington, D. C., he learned that a lot of the looting was being performed by colored government employees. He stated that perhaps the federal government is well aware of this but that he observed some of the looting and found that they had parking stickers on their automobiles from government lots in the Washington, D. C., area. He

advised that he left Washington, D. C., and visited in Ohio, and on to Kansas City, and had been here only about two hours at the time he was stopped by FBI Agents.

He stated that he would like to add that CARMICHAEL was reportedly in Washington, D. C., two or three days before the serious trouble broke out and told some of the constituants that he wanted Washington, D. C. burned. He further advised that he has the utmost respect for the FBI and that he believes the next trouble will be in Oakland, California, and also additional trouble will develop in the Los Angeles area; but at the present time from information obtained he believes that the next riots will occur in Oakland, California. He advised that CARMICHAEL is the one that wants to create animosity and trouble in Oakland and Los Angeles, California.

He advised that he previously owned a newspaper in Columbus, Ohio, and that he has a reason for gathering information relating to all the rioting in this country.

He also advised that he had served time on a federal charge for cashing bad checks, and part of this time was spent in the federal penitentiary at Terre Haute, Indiana.

MADDEN commented that there was another thing that may be of importance that he has failed to previously advise the FBI Office of:

He commented that one day in the Peabody Sheridan Hotel in Memphis that he talked to a psychology teacher who stated that he was from Canada. He advised that he is sure that this man was staying at the Peabody Sheridan Hotel and claimed that he was teaching at a university in western Canada and that he was in Memphis because of the problems existing and that he was very interested in this situation inasmuch as he had adopted a Negro child. He described this man as being Jewish, silver hair, age about 50 to 55 years old, 5' 7" tall, and weighed approximately 160 pounds. He commented that the only thing peculiar, in addition to his comments, was the fact that he had

abruptly had to leave immediately and stated after giving him his name, which he lost, that he must leave immediately.

While agents conducted the above interview, the NCIC checked MADDEN's name, birth date, auto license plate, and VIN with negative results. Also the Kansas City Office telephonically contacted Chicago and Memphis Offices who confirmed MADDEN's story. These offices also advised MADDEN was neurotic, emotionally disturbed, and violently anti-communist.
