On 4/19/68 JERRY LAMB, Secret Service, 811 Grand, advised he could locate no record concerning the subject and ~~no~~ akas in their files.

On 4/19/68 JAMES P. TIERNEY, Attorney, 1200 Commerce Towers, 9th & Main, KCMO, advised he had no record indicating that he may have represented the subject in a trial in 1955, and he was probably a court-appointed attorney for the subject as court records indicate. After about one year, records concerning persons of which he was a court appointed attorney, and of which there has been no further contact by the person with him, are destroyed. He has a vague recollection that he represented RAY, but he can recall no further contact with RAY since ~~1955~~ 1955. He advised that permanent files are maintained concerning clients that pay their own fees, and a review of his records indicated no record of the subject.

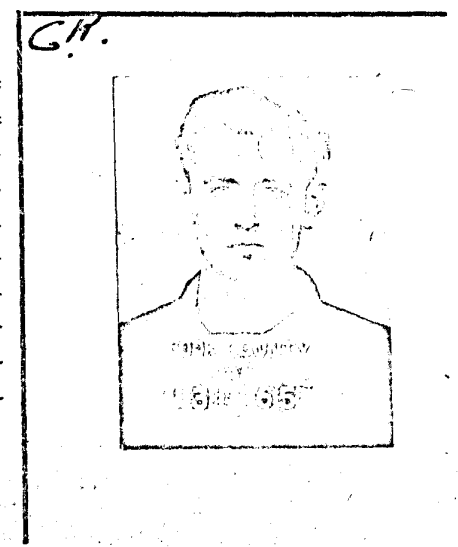

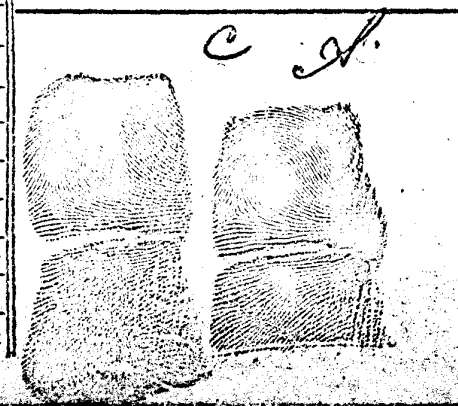

On 4/20/68 Mr. DANIEL S. KELLY, 2533 North Wall Avenue, Milwaukee, Wisconsin, telephonically furnished the following information to the FBI, Milwaukee. Mr. KELLY stated that he and his wife were recently in Florida, having arrived there 3/28/68 from the West Coast. They checked into the Sun Castle Club, 1380 South Ocean Blvd., Pompano, Florida which Mr. KELLY stated was operated by an ex-FBI Agent, ERNEST CASTLE. He said that upon his arrival he was roomed by a bellboy of the Club and subsequently requested this bellboy to furnish him with three or four copies of various newspapers. He stated that two or three days later he attempted to locate the bellboy to reimburse him for the papers and found out that he had left the employ of the Club. He stated that inquiry revealed that this bellboy, whom he knew only by the first name of EARL, had told others at the Club that he was leaving to accept an offer to work as an electrician someplace in Tennessee for \$500 a week. Mr. KELLY stated that this salary sounded absurd and that upon subsequently checking photographs of JAMES EARL RAY he and his wife felt that this individual closely resembled RAY, both in looks and general description. Above being furnished for whatever action deemed necessary by Miami.

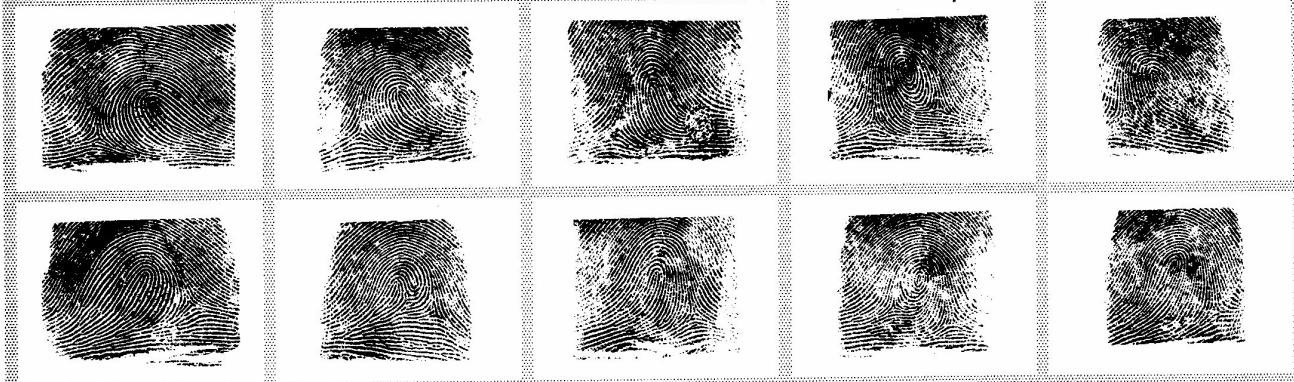
