A review of the report of SA ROWEN B. AYERS, dated 8/29/67, at Kansas City, reveals that on 7/10/67, Mr. BERARD C. POIREY, Custodial Assistant Warden, Missouri State Penitentiary Jefferson City, Missouri, advised he had conducted an investigation into the escape of the subject and had determined that an associate of the subject's, who worked with him in the prison bakery, had let the subject get into one of the large boxes consigned to the church firm near Jefferson City, Missouri and then had covered him up, thereby helping him to effect his escape. On 7/19/67, Warden HAROLD SWENSON, Missouri State Penitentiary, said he had contacted several inmates who knew the subject and they indicated to him that the subject had indicated he wanted to escape from the penitentiary and leave the state of Missouri.

A review of a pre-sentence report on the subject prepared by the U.S. Probation Office, Kansas City, Missouri, on 4/26/55, reveals that the subject on 4/1/55 had entered a plea of guilty due to information charging him with forging U.S. Post Office money orders. His companion in forging a large number of these money orders in numerous states was WALTER PERRY RIFE, who also entered a plea of guilty to a similar account and records of the Post Office Inspector's Office, Kansas City, Missouri, indicate: both Subject RAY and WALTER PERRY RIFE were sentenced to the Federal Penitentiary at Leavenworth, Kansas on 7/1/55 in Kansas City, Missouri and were apparently released from that institution on 4/5/58. Inasmuch as Subject RAY and WALTER PERRY RIFE, FBI # 4558766 were very close friends for a period of time and it has been difficult to identify other friends and relatives of the subject, it is felt that an effort should be made to locate and interview RIFE.

The following investigation was conducted by SA ROWEN B. AYERS:

AT JEFFERSON CITY, MISSOURI:

On February 1, 1968, Warden HAROLD SWENSON, Missouri State Penitentiary, advised he has received no further information which might aid in locating JAMES EARL RAY. He said he had disposed of all of his notes regarding the original investigation of this escape. He said, for this reason, he could not furnish the names of any person or persons, who had furnished him with details regarding either the escape of RAY, or his possible whereabouts. He said the investigation had been handled by Captain DENTON STEELE and Major BERNARD POIRY.

On February 1, 1968, Captain STEELE said the only information he could recall about the escape of RAY was that his clerk, WILLIAM SOCKLE, told him it was a waste of time to look for RAY in the walls because he had escaped. He said he heard this same thing "on the prison grapevine" from others, but he did not know the source of this information and believed SOCKLE might know. He said SOCKLE is working at the University of Missouri Medical Center.

On February 1, 1968, Major BERNARD POIRY stated that a GEORGE OWENS covered RAY up in a box in a bread truck so RAY could get out of the walls. He said there was another inmate involved, but he could not recall his name.

On February 14, 1968, Major POIRY further advised he could not recall the name of the other inmate referred to by him. He said the investigation, as far as he was concerned, left no doubt that RAY got into a bread box for Church Farm and was covered by another inmate and gained access to an "out truck". After he cleared Jefferson City, RAY apparently got out of the truck and departed. Major POIRY said he has not developed any information as to the whereabouts of RAY.

On February 15, 1968, WILLIAM SOCKLE, Sunset Trailer Court, formerly an inmate of the Missouri State Penitentiary, said he worked with RAY in the kitchen for a time. He said he also knew him well later because he took his meals in the kitchen, as a clerk, and RAY was there most of the time at meals. He said RAY talked all the time about escaping and "getting out of the area". He did not have any associates and did not divulge his plans to others. SOCKLE could not recall that RAY ever said where he would go if he escaped. SOCKLE said all he knew about the background of RAY was that he "fell" from St. Louis. He said RAY is quite intellectual and would be hard to find. He said he tried to escape on previous occasions, but was not deterred. He did not recall telling Captain STEELE that RAY had left the walls, but said this was possible as all the inmates who knew RAY, knew that he had left, in spite of the fact that he had previously "hidden out" within the walls.

SOCKLE said he could not suggest the name of any inmate or nothers who might furnish information regarding the whereabouts of subject.

AT KANSAS CITY. MISSOURI:

On January 18, 1968, Miss FRANCES M. ZIMMERMAN, U. S. Parole and Probation Office, 419 U. S. Post Office and Court House, made available a presentence report regarding subject JAMES EARL RAY, which had been prepared by that office on April 26, 1955. This report reveals that the subject on April 1, 1955, had entered a plea of guilty to an Information charging him with forging United States Post Office Money Orders. His companion in forging a large number of these money orders in numerous states was WALTER TERRY RIFE, who also entered a plea of guilty to a similar charge after which both he and the subject were sentenced on July 1, 1955, in Kansas City, Missouri, to the Federal Penitentiary at Leavenworth, Kansas. Both were apparently released from that institution on April 5, 1958.

A further review of the files of the U. S. Parole Office indicates that after the subject's release from the U. S. Penitentiary at Leavenworth, Kansas, he reportedly returned to the Kansas City, Missouri, area briefly to reside at the Blackstone Hotel and to contact the Missouri State Employment Service regarding employment possibilities. Accordingly, the following individuals were contacted on the indicated dates in a negative effort to develop information regarding the current location of the subject:

He viewed subject's photographs and stated he did mot recall seeing an individual resembling subject in the hotel. 

Upon viewing a photograph of subject, she denied being related to this individual and stated she had never seen him. When questioned concerning her husband's employment, she advised he worked for some hardware store and stated she was unable to furnish the name or address of this business place.

In view of Mrs. PEPPER's uncooperative attitude the interview was terminated.

On 3/20/68, Mr. and Mrs. ERNEST M. COOK, 712 Shenandoah, were interviewed. They advised after viewing subject's photograph they had never observed an individual resmbling him visiting the PEPPERS who had resided upstairs over their apartment for a period of several months up until two or three months ago. When questioned concerning other relatives or close associates of the PEPPER family, they advised that JAY and ROSEMARY SHIRLEY and their three children, SHERILL, JAY and ANNETTE, had been frequent visitors at the PEPPER home. They were of the opinion that Mrs. SHIRLEY was the sister of ALBERT PEPPER. This family had resided at the 712 A Shenandoah adress prior to the time the PEPPER family moved in. The COOKS were of the opinion that the SHIRLEY family had recently bought a home somewhere in the St. Louis area. They can furnish no other information concerning the identity or the location of the SHIRLEY family.

Reference is made to a telephone call to the Kansas City office on the early morning of 4/30/68, by BURTON W. ARNOLD, 915 Wall Street, Joplin, Missouri, telephone number MI 3-3478.

The following investigation was conducted by SA ROBERT E. HICKAM at Joplin, Missouri:

At 10:30 a.m., 4/30/68, Attorney BURTON W. ARNOLD was contacted by telephone at his residence, 915 Wall Street. He stated he called the Kansas City Office of the FBI at approximately 2:00 a.m. on 4/30/68, but declined to be personally contacted for interview stating he was an attorney and was too busy on that date to be interviewed. He sounded as if he had just awakened and his speech was very difficult to understand.

When Mr. ARNOLD declined to be interviewed, he was asked if he could repeat the information he had furnished the Kansas City FBI Office and he then furnished the following information.

On 4/29/68, he was in contact with an individual, whom he refused to identify, stating it was a "privileged communication" and under no circumstances would he divulge the identity of the person. This person stated that approximately two or three days ago, he had observed an individual in the Lone Elm Road vicinity which resembled fugitive JAMES EARL RAY. This individual in no way indicated what part of Lone Elm Road, nor did he indicate whether the individual was hitchhiking, in a vehicle, or if he had

observed the individual in a particular establishment in the Lone Elm Road vicinity. He noted that the Lone Elm Road vicinity had a lot of "shacks" and he got the general impression from talking to the source that the area he had seen this individual in would have been at a location north of Joplin, and in an area which was accessible by Lone Elm Road. He was pressed for specifics in this regard but could furnish no information whatever other than "Lone Elm Road vicinity", nor could he furnish under what circumstances source had seen this individual allegedly resembling RAY. He stated his source had served one prison term in the past but he did not know where he had served his time and did not know if his source was acquainted with RAY.

Mr. ARNOLD was asked if he would recontact his source for more specific information and he advised he would attempt to do so. He was further requested for a time which he could be interviewed and he again declined stating he was too busy and that if he developed any additional information he would contact the FBI Office at Joplin, Missouri.

Mr. ARNOLD stated that from news accounts, he got the impression RAY was moving around and not living at any one particular location. He then stated that from contact with his source, he had no information indicating RAY was actually living in any of the residences in the Lone Elm vicinity and could not elaborate on the circumstances surrounding his source having seen an individual who allegedly resembled RAY.

ARNOLD advised he could furnish no additional information.

On 4/30/68, Identification Officer EARL FORTNER, Joplin, Missouri, Police Department, advised SA JOSEPH W. JACKSON that BURTON ARNOLD was a confirmed alcoholic and had been known as a heavy drinker for years.

BRITTI stated the original leth lafantry was beadquartered in Austria with Battalions spread all over Europe. BRITTI and 13 others were sent from Austria to Frankfurt, Germany to reorganize the 16th. The reorganized group was formed from other units being deactivated or from excess personnel which other units no longer needed.

Sergeant BRITTI said that the Regiment moved from Frankfurt to Grafenwohr, Germany and was actually there, in 7/7/48, when the roster was made up. He said after the roster was made up the group was known as the 7892 Infantry Regiment, although it remained the 16th.

The Segrant said when RAY was discharged in 12/48, his Battalion was stationed in Furth, Germany at the Montieth Barracks. He said they were sent there from Grapenwohr in the fall of 1948.
