Mr. WAYNE W. WADMAN, Customer Service Manager, Browning Arms Company, 1706 Washington Street, St. Louis, Missouri, advised the printed number "130712" appearing in the upper left corner of the label on the Browning High Power Rifle box found in this case, is a code designation which means the weapon it contained was a Safari grade, .243 Winchester caliber, Browning Rifle, with light weight barrel and sights.

The handwritten number appearing in the lower left corner of the label is the serial number of the weapon.

Browning high power rifle serial numbers consist of four arabic numerals, which are the actual serial number of the weapon, followed by a letter of the alphabet, known as the "Alpha designation", which is indicative of the caliber and grade of the weapon. This is followed by a single arabic numeral which is indicative of the last digit of the year in which the rifle was manufactured, in this case 1965.

Browning files fail to disclose any record of receipt or shipment of any .243 Winchester caliber, Safari grade rifles bearing serial numbers 4444Z5 or 4449Z5.

Serial number 4Y44Z5 is not a proper Browning serial number, as the first four digits are not arabic numerals, but was considered significant by Mr. WADMAN as being indicative of some question as to the second digit.

Mr. WADMAN explained that the serial numbers are handwritten in French script arabic numerals, which are sufficiently different in form in some instances to cause Americans considerable difficulty in correctly reading or interpreting them. In his experience, what may appear to be a "Y" is actually either a "1" or a "7".

Browning records for serial number 4744Z5 disclosed a .243 Winchester caliber, Safari grade, Browning rifle, bearing this serial number was part of a shipment destined to All American Sporting Goods, 1025 Chapala Street, Santa Barbara, California, on April 4, 1966, pursuant to Browning invoice number 017794 dated March 30, 1966, customer order number 0016265 and number 0016248.

This weapon was subsequently returned to Browning by the dealer, for credit. There is no way of knowing whether or not it was returned in the original box.

This rifle was later part of a shipment to Aeromarine Supply Company, 5701 Airport Highway, Birmingham, Alabama, on October 21, 1966, pursuant to Browning invoice number 079679, dated October 17, 1966, customer order number 0001420 and number D001232. This is the last record Browning has of this weapon.

Mr. WADMAN stated that he felt almost sure that this rifle, serial number 4744Z5, was the one referred to by the box label in this case, but that it would be necessary for him, or some other experienced Browning employee, to view either the original label or a clear photograph thereof in order to effect a positive identification.

Mr. WADMAN is in lawful custody of pertinent Browning records, and is the proper person to whom a subpoena duces tecum should be directed for their production in court.

He was honorably discharged on May 5, 1943, as a Technician Fifth Grade at Fort Sill, Oklahoma, to accept appointment as Second Lieutenant.

GARNER accepted the appointment and served in the U. S. Army May 6. 1943, to December 19, 1944, under Service Numbers

He was discharged under conditions other than honorable as a Second Lieutenant at Fort McPherson, Georgia, upon approved findings and recommendations of a Reclassification Board proceedings held at Camp Campbell, Kentucky, June 29, 1944. The Board found GARNER demonstrated habits and traits of character during a probationary period which were undesirable in an officer. It was noted he was released from active duty August 7, 1944. He was assigned to Camp Campbell, Kentucky, in July 1943, and transferred to Fort McPherson, Georgia, for a discharge in August 1944.

The following disciplinary actions were taken:

At the time suspect ERIC STARVO GALT rented a safety deposit box at the Birmingham Trust National Bank he listed as his nearest relative on the application KARL GALT, 2515 Lafayette Street, St. Louis, Missouri.

There is no such address as 2515 Lafayette Street, the numbers jumping from 1907 to 2323 Lafayette (the north side of Lafayette Street at this point being Lafayette Park). Thereafter, the numbers on Lafayette Street jump from 2355 to 2605 Lafayette.

Therefore, logical variations 2151 and 2155 are nonexistent.

Logical variations 1251 and 1215 Lafayette were also checked. Lafayette runs from the 1100 series to 1515 Lafayette, there being nothing between these numbers. 1515 Lafayette is the address of City Hospital #1.

Logical variations 5125, 5215, 5512 and 5521 are also nonexistent. The highest number on Lafayette is 4431. Thereafter, at Vandeventer, Lafayette becomes McRee Street.

The following investigation was conducted in the area of 2300 Lafayette:

2313 is a private house containing the office of Dr. GEORGE SEIB.

2327 and 2329 Lafayette is a roominghouse managed by R. W. LIESER. He stated to SA BROWN he has been here 10 years, that nobody named GALT now lives at either of these

addresses nor has since he has been here, and he has had no roomer who works on barges on the Mississippi.

2345 Lafayette is the German House, formerly the St. Louis House. KARL B. MUELLER, Assistant Manager for five years, and JOHN MEIGEL, Manager for 10 years, advised SA JOHNSON they have no knowledge of anybody at that address named GALT.

2351 Lafayette is a rooming house. MARGARET ASPHIN, Manager, has been there two years and advised SA JOHNSON she has had no tenant named GALT.

HAROLD VOGT, Manager, Kroger Store, 1700 South Jefferson, and DELORES LOEBIG, Cashier, advised SA JOHNSON they know nobody in the neighborhood named GALT.

SA BROWN contacted a barmaid who refused her name at the Ten Pen Bar, corner of Lafayette and South Jefferson. She said she knows nobody named GALT, and the only man named CARL she knows lives at the northeast corner of Whittemore and South Jefferson.

The house at that address is 2355 Whittemore, and is abandoned.

JOSEPHINE HYSOP, 2351 Whittemore, advised nobody named GALT is at that address. The house at 2355 Whittemore was occupied until the fall of 1967 when the family moved to a South Jefferson address. 2355 is owned by LEONARD BEELMAN, who has a bar on the northwest corner of Lafayette and South Jefferson. Contact was made with BEELMAN by SA BROWN, and he advised the former occupant at 2355 is JIM KIMBROUGH.

BEELMAN stated the only man he knows in the area who works on the Mississippi is JOHN CREWS, a barge captain, who lives on Lafayette about 3400 west.

The telephone directory lists a KENNETH CREWS at 3239 Lafavette. Inquiry was made there by SA BROWN, but no response could be obtained. It was noted there was a letter addressed to JOHN C. CREWS in the mailbox.

SA JOHNSON made the following additional contacts: BILLIE DROWN, Manager, Carl's Grill, 1659 South Jefferson; TED RAVENOTEEN, JR., Manager, jewelry store and pawnshop, 1653 South Jefferson - both with negative results.
