PAUL BRIDGEMAN, FORMER INMATE, MSP, JEFFERSON CITY, MISSOURI, ADVISED HE MET RAY IN PRISON IN NINETEEN SIXTY-FOUR. LAST SAW RAY FIRST TO MIDDLE OF FEBRUARY, LAST, IN KANSAS CITY, MISSOURI, AT OLD FORTRESS BAR. BRIDGEMAN CLAIMS HE WAS APPROACHED BY GIRL WHO ASKED HIM IF HE WAS PAUL AND WHEN HE ANSWERED YES, SHE TOLD HIM HER NAME BEVERLY HILL AND THAT JIMMY WANTED TO SEE HIM. HE ADVISED HE FOLLOWED HER OUTSIDE AND MET RAY. RAY DRIVING NINETEEN SIXTY-THREE T-BIRD, LIGHT BLUE WITH PLATES WHICH WERE WHITE WITH RED LETTERS. RAY TOLD BRIDGEMAN HE NEEDED SOME MONEY. THIS WEEKEND", AND LEFT. BRIDGEMAN CLAIMS THIS WAS LAST AND ONLY TIME HE SAW RAY SINCE RAY'S ESCAPE MSP.

HE DESCRIBED BEVERLY HILL AS FEMALE, WHITE, TWENTY-THREE, FIVE FEET TWO TO THREE INCHES, ONE ONE ZERO POUNDS, BLOND, ATTRACTIVE, WHO APPEARED FAMILIAR TO HIM AND POSSIBLY IS PROSTITUTE.

WHILE AT MSP, BRIDGEMAN TOLD RAY HE HUNG OUT AT OLD FORTRESS AND HIGH HAT BARS IN KANSAS CITY AND THAT IS WHY RAY KNEW HOW TO FIND HIM. BRIDGEMAN RECALLS DISCUSSING WITH RAY WHILE AT MSP A JOYCE MARTIN, AKA JOYCE WILLIHAM, ONE THREE THREE FIVE SOUTH MINNIE STREET, SANTA ANA, CALIFORNIA, WHO WAS DESCRIBED BY BRIDGEMAN AS "GOOD PEOPLE" FOR A CON ON THE RUN. SHE WORKED AT KINGS INN IN COSTA MESA, CALIFORNIA.

RAY ALSO MENTIONED A DI RANGO'S OR RANGO'S IN LOS ANGELES CHINA TOWN AS A DOPE HUSTLING PLACE. RAY TALKED LOT ABOUT MOHANNAN (PH) WHO OWNED PLACE CALLED PUSSY CAT A GO-GO ON GAS LIGHT SQUARE IN ST. LOUIS. BRIDGEMAN FELT RAY WELL KNOWN AT THIS NIGHT CLUB AND GOOD INFO. CONCERNING RAY CAN BE OBTAINED THER.

RAY ALSO MENTIONED A "JOINT" ON SOUTH BELDEN OR BELVAR IN

GEORGE GILL, SANTA ANA, CALIFORNIA; JIMMY POE, SEVEN ONE EIGHT TWENTY-SEVENTH PLACE, NORTH GRANITE CITY, ILLINOIS; BILL RUSSELL, TWO FIVE TWO THREE WARREN, ST. LOUIS.

BRIDGEMAN DENIED EVER BEING OUT OF U.S. AND DENIED KNOWING ANYTHING CONCERNING RAY'S WHEREABOUTS. BRIDGEMAN DESCRIBED RAY AS BEING A PRETTY COOL CON WHO MANAGED TO OBTAIN INGREDIENTS, I.E., RAISINS, SUGAR, YEAST, WHICH HE USED TO MAKE INTOXICANTS WHILE AT MSP, MAJORITY OF WHICH HE SOLD TO OTHER INMATES. BRIDGEMAN EXPRESSED OPINION RAY WOULD BE CAPABLE OF MURDER BUT ONLY IF THERE WAS MONEY INVOLVED. RAY HAD STRONG DISLIKE FOR NEGROES AND REFUSED TO ATTEND VARIOUS SPORTING EVENTS WHILE AT PRISON DUE TO FACT MAJORITY OF TEAM CONSISTED OF NEGROES.

BRIDGEMAN ADVISED RAY AT ONE TIME MENTIONED WANTING TO GO TO BRAZIL AND ALSO EXPRESSED INTEREST IN CASTRO GOVERNMENT OF CUBA. HE ALSO MENTIONED WANTING TO GO TO AUSTRALIA BECAUSE HE FELT THERE WERE NO NEGROES IN AUSTRALIA.

WAYNE ROTHBERG ADVISED AT ABOUT ONE THIRTY AM JUNE SEVEN HE HAD JUST RECEIVED TELEPHONE CALL FROM BRIDGEMAN IN MINNEAPOLIS. BRIDGEMAN GAVE HIS ADDRESS AS APARTMENT THREE ZERO THREE, TWO EIGHT ONE FOUR PORTLAND DRIVE, MINNEAPOLIS. BRIDGEMAN TOLD ROTHBERG HE KNEW FBI WAS LOOKING FOR HIM. HE SAID HE KNEW JAMES EARL RAY BETTER THAN HE HAD ADMITTED TO ROTHBERG. HE CLAIMED HE HAD SEEN RAY SOMEWHERE IN OKLAHOMA SOMETIME BEFORE THE SHOOTING OF KING AND AT THAT TIME RAY HAD PLENTY OF MONEY. ROTHBERG STRONGLY URGED BRIDGEMAN TO IMMEDIATELY CONTACT THE FBI AND BRIDGEMAN PROMISED TO DO SO.

AT ABOUT TWO THIRTY AM JUNE SEVEN ROTHBERG REPORTED HE HAD RECEIVED ANOTHER CALL FROM BRIDGEMAN. BRIDGEMAN SAID HE HAD CONTACTED THE FBI IN MINNEAPOLIS AND WAS GOING TO MET WITH AGENTS ON THE MORNING OF JUNE SEVEN.
