He commented that the woman he was living with was a Registered Nurse. He advised that he had been to Dallas on one trip previous to this one and lived with a girl he declined to name who worked at the Carousel Club in Dallas, Texas. He stated that she was a widow and that she had murdered her husband. This woman was about 25 years of age and had one child, a girl, 7 years old.

BILLINGS stated that he is very faint on dates and places but he believes that after he left Dallas he traveled to Las Vegas, Nevada where he stayed at the Horseshoe Club under the name of ROBERT JAMES, Dallas, Texas. He stated that while here he sent a telegram to his wife in Pennsylvania and she and their son came out to visit him. They bought a 1964 Buick and with his family traveled to Artesia, New Mexico. They arrived in New Mexico about July, 1965 at which time he opened a fruit stand in the 4900 block of Main Street which he called Roberts Produce. They lived right behind the fruit stand. In August, 1965, he sent his wife home because she was always trying to get him to surrender which he did not want to do. He stated that he drove them as far as Wmlmington, Delaware and then called his brother to come after them.

He sold his Buick in Las Vegas and obtained a Plymouth Valiant. He sold this Plymouth to a Ford dealer in Artesia, New Mexico and obtained a new Ford truck and a 1962 Chevrolet. After he took his wife to Wilmington, Delaware he traveled to Hartford, Connecticut whereme got a job with Williams Ford where he was in charge of a used car lot. He obtained this job in the name of JAMES ROBERTS and as such he had charge of carrying the night deposits to the bank. He worked at this place two weeks and on one evening instead of taking the night deposit to the bank he took it to the motel room, took out the money, left the checks in the bag and absconded.

He then traveled to Batavia, New York for the purpose of gambling at the race track in this town. He said this was the last part of 1965. While traveling to the races at Batavia he actually lived in Buffalo, New York at a hotel under the rame of Laurent Riquier. This was some stolen identification which he had found. He stayed in this area for two weeks during which time

he bought a new Corvette and left the Chevrolet on a parking lot and called the owner of the Chevrolet in Artesia, New Mexico and told him where it was located. He then returned to New Orleans where he continued his gambling activities in Slidell and Covington, Louisiana. He sold the Corvette in Baton Rouge, Louisiana to the Love Motor Sales for \$900.00. He stayed in a motel in New Orleans that he believes was called Monte Leon under the name LAURENT RIQUIER. He stated that still BLACKWELL was staying at the Canal Bank Inn. He wished to emphasize that he did not stay at the Canal Bank Inn continuously from May to December, 1965 as CARMERDELLE indicated.

AT SAN QUENTIN, CALIFORNIA

RE: KENNETH LEE WADE

The following investigation was conducted by SAS® DALE F. NORTON and MICHAEL T. GEARY, on May 17, 1968.

KENNETH LEE WADE stated he had no reason to lie to the FBI. He advised "I don't even know why I am talking to you guys. After I talked to you the last time, I got plenty of heat in the yard. Some of the men told me that I shouldn't have spoken to you. The grapevine will know that the FBI was back again today and I expect to get more heat."

WADE advised that prison time is getting pretty heavy and he stated that he does not know whether he will be able to make this sentence. WADE stated that he needs help to get a reduction of sentence or transfer to another less strict institution in the State of California, and that he desired to be cooperative hoping that his cooperation could be of value both to the FBI and to himself.

WADE stated that he had escaped in 1959 from the Missouri State Penitentiary (MSP). WADE stated that he was working on the prison farm at the time he walked away. He stated that he had \$1500 in cash in his pocket at the time he escaped. He stated it was his opinion that any man escaping from prison would have or would try to have on his person as much cash as possible as this money would enable him to move away from the scene of the escape and to purchase items of clothing, et cetera, that would make him less conspicuous. He stated he imagined that RAY also had money in his pocket at the time he escaped from the penitentiary.

WADE stated that RAY impressed him as being the type of person that did not and would not trust anyone. He stated this was another factor which led him to believe that RAY would have taken whatever money he had with him at the time of his escape. He stated that in the event RAY had any money with anyone, that it would be with an individual that RAY had absolute trust in.

WADE stated RAY earned \$1.50 per month from his bakery work. WADE reported it was his recollection that \$15 or \$20 per month could be furnished an inmate by his friends and/or family outside the prison for the prisoners' personal use in the purchase of commissary items.

WADE stated that any money that RAY had over and above his salary and the money received from the outside would be money that RAY would not want the prison authorities to know about. He stated that RAY would keep this money in some safe hiding place.

WADE reported RAY was extremely conservative in the handling of his money. WADE advised that he, WADE, gambled a great deal and when he was completely broke, would ask RAY for a loan and that RAY always had the money to loan him.

WADE reported RAY from time to time would play in a prison card game but that even his card playing indicated his conservative bent in the handling of his personal funds.

WADE reported that the money their clique earned from the sale of pep pills and stimulants could be either in currency or services such as commissary chits or leather goods or other prison items.

WADE stated money could be sent out of the MSP by using guards who had been bribed by prisoners to act as couriers involving items leaving or entering the prison.

WADE stated he did not desire to identify any guard as that guard might still be available and usable by present MSP inmates.

WADE advised it was his recollection that an MSP guard earned about \$260 per month at the time he was confined. He stated it was not difficult to bribe a guard as they were usually in need of money due to the low pay scale.

WADE reported that the clique engaged in the sale of

"Bennies" and antephamine hydrochloride.

He advised that they paid a prison guard \$100 to bring in a 1,000 pill bottle of "Bennies". He stated each pill was then sold for \$1 which resulted in a profit of \$900 per bottle.

He advised that the antephamine hydrochloride was also brought into the prison by a guard who had been bribed. He advised that the usual package of antephamine hydrochloride weighed 2 ounces, and that the guard was paid \$100 for bringing it in.

He advised that when the antephamine was received in the prison, it was immediately cut with 1 ounce of powdered sugar thus making the shipment total 3 ounces. He advised that it was sold by the spoonful and that 16 level spoonsful were obtained from each ounce. He advised, therefore, a total of 48 spoonsful were available for sale at \$100 per spoon, making a \$4800 gross income possible.

He advised that they usually got one jar of "Bennies" and one package of antephamine a month. He stated, therefore, their total income would run approximately \$5800 per month less \$200 for the cost of bribing the guard to bring it in plus whatever the pills and antephamine cost on the outside.

He advised that requently inmates who had been paroled or discharged would send the stuff back through guards whom they knew to be reliable couriers.

WADE stated he has no knowledge of RAY's whereabouts. He stated he has no knowledge of how RAY obtained his money except to believe that he undoubtedly received some of it from his participation in the group that was selling stimulants. He advised that he has no definite knowledge as to how RAY got his money out of MSP except he feels certain that RAY carried some of it if not all of it out at the time of his escape. He said if RAY did not take it all with him, he was very sure that he would get it from the person he had left it with.

WADE stated RAY always had money. RAY was conservative in the use of his money and "We wondered what he did with his money". WADE stated RAY spent very little money while he was in prison.

WADE reported that RAY would not place any "prison earnings" in his account and claimed he did not know how RAY handled his prison earnings. He reported that how RAY handled his money was RAY's personal matter and no one would inquire as to how the other person handled his money.

WADE stated it was speculation on his part, but he believed that RAY could have had as much as \$5,000 available to him at the time he escaped. He reported this money could be on RAY's person, or part of it on his person and the rest with some safe individual. WADE reported this was guess work on his part, but he feels certain that RAY would not have gone out of MSP without having some money available to him.

WADE stated a Lieutenant DICKSON or DIXON (phonetic) was discharged by the MSP about 1965 and that this man had been used by WADE and his associates to bring in and take out items of value.

WADE stated RAY was a close friend of a WILLIE SHOW or SCHOAF (phonetic), a parolee in 1964 or 1965 from MSP, who originally came from the Chicago, Illinois area. He advised that after WILLIE SHOW had been paroled, that he sent "some stuff" back in to us.

He advised it was his recollection that SHOW was GLEN SHURNICK's (phonetic) fall partner.

WADE stated that he had no reason to lie. He said that frankly his main interest was in trying to help himself. He advised that the information he had furnished was the fruth. He stated that he has not seen RAY since he was discharged from the MSP. He advised he has absolutely no knowledge of RAY's present whereabouts, his connections on the outside and no knowledge of his financial position.

On June 3, 1968, HARRY LAUF, Records Office, Missouri State Penitentiary, advised that PAUL OSBORN BRIDGEMAN, MSP #10134, also known as PAUL JAMES BRIDGEMAN, was received from Jackson County, Missouri on April 23, 1965 to serve five years. He was discharged by commutation on January 16, 1968; not paroled.

On June 3, 1968, Mr. HERBERT BUNKER, Classification Office, Missouri State Penitentiary, furnished the institution file for BRIDGEMAN from which the following was noted:

He was transferred to Moberly on March 7, 1966; reassigned to the Missouri State Penitentiary on May 22, 1967 and Renz Farm May 22, 1967 as of May 16, 1967. On June 7, 1967, he received \$10.00 from WAYNE ROTHBERG who was put on his visiting list. The file indicated his parents were deceased and that WAYNE ROTHBERG was the guardian of his child. He resided at 8228 Holmes, Kansas City, Missouri. However, as of March 13, 1967, there was a letter from Mr. ROTHBERG, indicating his address as 8603 Beuregard, Dallas, Texas and he was employed by the RoCo Auto Supply Company.

Also, there was a letter in the file indicating that GREEN and GREEN of West Plains, Missouri (Attorneys) were representing IRENE BRIDGEMAN; mother of inmate. BRIDGEMAN was born at Winchester, Indiana on He was married when 18 years of age to a CAROLYN BROOKER who apparently took one child and deserted him and he had no contact with her after November of 1963. He had no visitors. Communications were reflected only with ROTHBERG. He attended Salem, Arkansas high school to 10th Grade, and has served time in Illinois.

Warden HAROLD SWENSON, on June 3, 1968, said that

ROTHBERG was a real problem to him in connection with BRIDGEMAN. He said there was an apparent homosexual relationship existing between the two and he caught ROGHBERG smuggling currency to BRIDGEMAN through another inmate.

A Classification Sheet and photograph of BRIDGEMAN were obtained.

LEE CHAPMAN, Clerk, Records Bureau, Kansas City, Missouri, Police Department, made available the arrest record concerning PAUL JAMES BRIDGEMAN, Kansas City, Missouri, Police Department #104182. This record indicates the following arrests:

On March 13, 1964, BRIDGEMAN was arrested for investigation for larceny but was released by the #1 Detective Unit. On November 6, 1964, a pick-up order was issued for investigation concerning robbery. On December 8, 1964, BRIDGEMAN was arrested for robbery and sentenced to five years, Missouri Department of Corrections, on February 8, 1965.

The record indicates BRIDGEMAN was received at the Missouri State Penitentiary April 23, 1965, from Jackson County, Missouri, and was discharged from the Penitentiary on January 16, 1968. On February 8, 1968, BRIDGEMAN was arrested for disturbing the peace, which charges were dismissed at the request of the complaining witness on February 12, 1968.

A review was made of the file maintained by the Kansas City, Missouri, Police Department concerning PAUL JAMES BRIDGEMAN, which indicates the arrest on March 13, 1964, was for investigation in connection with the larceny of a cash register at the Oak Hotel, 414 East 8th Street, Kansas City, Missouri. On this date BRIDGEMAN listed his employment as the Princeton Hotel, 3241 Paseo, Kansas City, Missouri, as clerk. A sister by the name of JANET CAWVEY was listed as nearest relative but no address shown. An associate was shown as CLARENCE ROUNDS, white male, age 40, 414 East 8th Street, Kansas City, Missouri.

On December 8, 1964, BRIDGEMAN was arrested for investigation of robbery at Clark Service Station, 4241 Blue Parkway on November 6, 1964, and the Clark Service Station at 7441 Troost also on November 6, 1964. At the time BRIDGEMAN was arrested, he was driving a 1960 Dodge two-door hardtop, Missouri license SW5-897, and was accompanied by

NICHOLAS E. EDWARDS, white male, born residing 1201 East 8th Terrace, Kansas City, Missouri. EDWARDS was released by the Kansas City, Missouri, Police Department. An associate in addition to EDWARDS was shown as WAYNE ROTHBERG, 5000 Oak, Kansas City, Missouri.

On February 8, 1968, BRIDGEMAN was arrested at 85th and Troost for disturbing the peace by fighting in the Old Fortress Tayern at that address. The complainants were ROBERT G. NELSON, 524 Benton, and JERRY D. HENDRICKSON, 12811 13th Street, Grandview, Missouri. BRIDGEMAN listed his employment as K. W. Dart Company, 3541 Gardner, North Kansas City, Missouri, and his address as 3653 Skyline Drive, Mission, Kansas. He listed nearest relative as KATHY BRIDGEMAN of 3653 Skyline Drive, Mission, Kansas.

The Missouri Department of Corrections report concerning BRIDGEMAN maintained in the Kansas City, Missouri, Police Department files shows BRIDGEMAN's parents moved to Warrensburg, Illinois, when he was six months old and seven years later moved to Salem, Arkansas, where they resided five years. BRIDGEMAN's parents were divorced when he was fifteen years old but were later reunited. BRIDGEMAN's parents, JAMES and IRENE BRIDGEMAN, were involved in a murder - suicide in 1962.

The records show BRIDGEMAN married CAROLYN BROOKER in 1961 and two children were born to this union. The wife, CAROLYN BROOKER, allegedly took one of the children and deserted the home; and BRIDGEMAN's son is reported to be residing with friends in Kansas City, Missouri.

IDAMAE HARBOLT, Manager, Twin Oak Apartments, 5000 Oak Street, Kansas City, Missouri, advised WAYNE M. ROTHBERG resided at this address for approximately six months and moved in August, 1964. She stated she believes an aunt of ROTHBERG's by the name of FANNY WALKER also resided at the Twin Oak Apartments in 1964. She stated, however, WALKER has also moved from this address and she has no forwarding address for WALKER. She advised ROTHBERG listed employment with the Inland Underground Storage, Kansas City, Kansas.

KAYE HAMMOND, barmaid, Old Fortress Tavern, 85th and Troost, Kansas City, Missouri, advised she recognizes the photograph of PAUL BRIDGEMAN but she does not believe he has been in the tavern for approximately two months. HAMMOND viewed photographs of JAMES EARL RAY and advised she does not know this individual.

JAMES DUARDIC owner, Old Fortress Tavern, 85th and Troost, Kansas Chity, Missouri, advised that PAUL BRIDGEMAN frequented this tavern up until about two months ago and apparently left town. He stated he does not know for sure that BRIDGEMAN has left town but he has not seen BRIDGEMAN for about two months and since BRIDGEMAN came to the tavern frequently, he assumes BRIDGEMAN left town. DAUGHERTY advised also that MIKE HEAD frequents this tavern and BRIDGEMAN and HEAD frequently played pool at the tavern. He stated he does not believe HEAD is closely associated with BRIDGEMAN and HEAD still frequents the Old Fortress Tavern.

FAYE ANTHONY, 305 West 109th Terrace, Overland Park, Kansas, advised she is a friend of JACKIE KLINE and she talked by telephone with KLINE last Sunday morning, June 2, 1968. She stated KLINE did not mention leaving town and she has no idea concerning KLINE's present whereabouts. She stated JACKIE KLINE was dating PAUL BRIDGEMAN and she believes BRIDGEMAN's family is in Bloomington, Illinois. She stated she could furnish no information concerning the whereabouts of BRIDGEMAN but she believes BRIDGEMAN left town one month or six weeks ago.

Mrs. ROSE LONDON, 2511 West 75th Place, Prairie Village, Kansas, advised JACKIE KLINE has worked as a nurse for a number of years and has been placed in several employments by Mrs. LONDON, who operates a nurses' registry from her home.

Mrs. LONDON advised KLINE knew an individual who was serving time at the Missouri State Penitentiary and KLINE at one time was keeping the son of this individual. She stated at one time KLINE considered adopting the son of the individual who was serving time at the Missouri Penitentiary but for some reason never did so. Mrs. LONDON stated KLINE told her sometime in the winter of 1968, that the individual was being released from the Missouri State Penitentiary and that KLINE was going to meet him when he was released. She stated KLINE later told her that she had met this individual when he was released from the Penitentiary, and she got the impression that KLINE's relationship with this individual became rather close after he was released from prison.

LONDON stated a few weeks ago KDINE told her she was in trouble because this individual had stolen checks from her car, which checks were drawn on KLINE's bank account. LONDON said KLINE advised her that she was in trouble because of these checks and was being charged by Johnson County authorities for cashing bad checks. She said KLINE advised that this individual had used KLINE's name on the checks. stated about four days ago KLINE called and asked if LONDON could find a replacement for her because she was leaving town. She stated also KLINE called last Sunday, June 2, 1968, and indicated she was leaving town late that evening. and mentioned Omaha, Nebruska, and Iowa but did not indicate specifically where she was going. Mrs. LONDON stated she asked KLINE whether she was going to meet this individual and KLINE stated she was not going to meet the individual because of all the trouble he had caused her.

Mrs. LONDON stated KLINE also asked whether or not she would recommend her for another position and Mrs. LONDON indicated she would inasmuch as she had had no complaints from employers concerning KLINE. Mrs. LONDON advised it she gets any inquiry concerning KLINE, she will advise the Kansas City FBI Office.

SANDRA LAUGEN was interviewed at her mother's residence, 3131 Quincy Drive, Kansas City, Missouri. She advised she presently resides at 116 East 43rd Street, Kansas City, Missouri, telephone WE 1-8149, and is employed for the National Central Life Insurance Company, 38th and Summit, Kansas City, Missouri.

LAUGEN advised she resided with JACKIE KLINE at the Roe Village Apartments. During this time KLINE was dating PAUL BRIDGEMAN. She stated Bridgeman stole some blank checks from KLINE's automobile and some of these checks were cashed by BRIDGEMAN. The checks were drawn on the Roeland Park State Bank, Roeland Park, Kansas. She stated, however, KLINE was identified as cashing one of these checks and as a result, was placed on one year probation by the Johnson County, Kansas, authorities. She stated about the time KLINE was charged for the bad check in Johnson County, Kansas, BRIDGEMAN left town. She does not know BRIDGEMAN's whereabouts. She stated, however, JACKIE KLINE kept in touch with BRIDGEMAN by long distance telephone calls. She stated these calls were made on a telephone at the Roe Village Apartments #CO 2-5355. LAUGEN stated this telephone was obtained by KLINE, using the name KAYE ROSENBERG. She stated also BRIDGEMAN traveled while he resided in Kansas City, Missouri, and mentioned Bloomington, Illinois, and Dallas, Texas. She stated she believes an individual in Dallas, Texas, cares for BRIDGEMAN's son and BRIDGEMAN made a number of trips to Oklahoma City. Oklahoma, to meet this individual.

LAUGEN advised she knew PAUL BRIDGEMAN had served time at the Missouri State Penitentiary and JACKIE KLINE had mentioned that possibly she and LAUGEN would be questioned inasmuch as BRIDGEMAN served time at the penitentiary while JAMES EARL RAYWAS there. LAUGEN stated she does not recall RAY's name being mentioned by BRIDGEMAN and she does not know whether BRIDGEMAN was ever closely associated with RAY.

LAUGEN advised BRIDGEMAN was arrested March 19, 1968, while driving JACKIE KLINE's car, a 1968 white two-door

Malibu 307. She stated KLINE purchased this car from Pappas Chevrolet, and it was financed through the Commerce Trust Company, Kansas City, Missouri. She stated BRIDGEMAN posted bond when he was arrested March 19, 1968, and KLINE had to furnish money to recover the car since it was impounded by the Kansas City, Missouri, Police Department. She stated BRIDGEMAN was charged with drunk driving and having no driver's license.

LAUGEN advised the only friends BRIDGEMAN had in Kansas City, Missouri, were JACKIE KLINE, JIM DAUGHERTY, Old Fortress Tavern, and MIKE HEAD, an individual who frequented the Old Fortress Tavern.

LAUGEN stated she talked to KLINE on Sunday and KLINE advised she was leaving town and did not want anyone to know where she was going. LAUGEN stated she assumes KLINE drove the 1968 Chevrolet, and she does not know whether KLINE was going to meet BRIDGEMAN.

Mrs. KATHERINE TAVERNARO, 6314 Baltimore, Kansas City, Missouri, advised JACQUELINE KLINE was employed for her as a nurse for eleven months at the salary of \$102 per week. She stated KLINE last worked on Sunday, June 2, 1968, at which time she had her car packed and stated she was leaving town. TAVERNARO stated KLINE did not indicate where she was going but indicated possibly Omaha, Mebraska, or Des Moines, Iowa. She advised KLINE told her that she had gotten into trouble because of a bad check and was going to a new town to start over. She stated KLINE advised her that PAUL BRIDGEMAN had stolen some of her checks from the glove compartment of her car and had cashed these checks, and for that reason she was in trouble with the police.

TAYERMARO advised KLINE was not questioned concerning her association with PAUL BRIDGEMAN but she got the idea that BRIDGEMAN had left town four to six weeks ago but KLINE was still in touch with BRIDGEMAN. She stated KLINE had remarked some time ago that it was thirty degrees where BRIDGEMAN was now located and TAYERMARO got the idea that possibly BRIDGEMAN was in Minnesota. TAYERMARO stated BRIDGEMAN did not work while he was in Kansas City, Missouri, and KLINE supported BRIDGEMAN.

TAVERNARO advised KLINE left her house about 7:30 p.m., June 2, 1968, and she has had so information from her since that time. She advised KLINE is registered with a nurses' registry operated by ROSE LONDON, 2511 West 75th Place, Prairie Village, Kansas.



HEEREN is an international salesman for the Gordon and Johnson International Company and has been since June 1958. She advised that his territories include Mexico and South America as well as territory overseas. He does no selling in the United States.

Mr. MARVIN W. HEEREN, 10606 Westbrooke Drive, Shawnee Mission, Kansas, advised he is salesman for Gordon Johnson International Company, made numerous trips out of the country, many of which were in Mexico. He stated that during the week April 1 through 7, 1968, he was in Kansas City at work during the work days and at home on the weekend and that on April 8, he flew to Jacksonville, Florida, where he met a customer in the poultry processing business by the name of MIKE PENYADO from Jamaica, who had come to this country to study some poultry processing plants in Gainesville, Georgia. He stated that he and PENYADO flew from Jacksonvelle to Atlanta on April 9 and arrived at approximately 5:00 pm and he placed PENYADO on a Greyhound Bus for Gainesville, Georgia, and then he himself checked into the Downtown Motel in Atlanta, where he stayed April 9 and 10 and checked out on the morning of April 11. He stated that Wednesday night, the tenth. PENYADO stayed in the motel with him. He stated that he was unable to conduct any business on the minth, due to the fact all business establishments were closed because of the funeral of MARTIN LUTHER KING, JR. Mrs. HONTZ stated she does not recall receiving a telephone call from Beaumont, Texas, in December, 1967, or at any time since she has had this number. She stated she has no relatives in Texas and can recall no one calling at her residence from the Texas area in December, 1967. She said her children were not on a trip away from home at that time and no one called them to her knowledge or recollection.

Mrs. HONTZ viewed photographs of JAMES EARL RAY, and stated she did not recall ever meeting anyone who resembled him and said she knew no one who used any of the known aliases of RAY.

The following investigation was conducted at Kansas City, Missouri by IC WILLIAM F. ROHR on May 15, 1968:

A review of Kansas City, Missouri Police Department file #94249 disclosed JAMES WILSON BROWN, described white, male, born Alabama. 5'62", 176 lbs., FBI # 504 977 3, was arrested by the Kansas City, Missouri Police Department on November 23, 1959 for investigation - hold for homicide. arrest disclosed BROWN shot and killed a man in Kansas City in what was termed a "lover's quarrel." The victim had been dating BROWN's girlfriend and thereafter BROWN shot and killed victim. BROWN gave a signed statement admitting this murder and on March 6, 1960, this charge. was reduced to murder second at which time BROWN entered a plea of guilty and was sentenced to a period of 20 years to be served at the Missouri State Penitentiary, Jefferson City, Missouri. It was noted that from the date of arrest, November 23, 1959, until date of sentencing, March 6, 1960, BROWN was incarcerated in the Jackson County Sheriff's Office, Kansas City, Missouri,

Upon arrest BROWN furnished the following list of relatives;

No other arrests for BROWN in the Kansas City area.

A review of Kansas City, Missouri Police Department file 92747, disclosed JOHNNY VELANTI, also known as RAYMOND DUTTON JACKSON, MELODY RENO LA VALLE, ROY DOUGLAS TAYLOR, CARL DUTCHIN VON DEMERON, MILES SWIFTWATER, "RENO". VELANTI described white male, born Virginia, 5'8", 175 lbs., FBI # 416 361 2.

VELANTI was arrested by the Kansas City, Missouri Police Department on February 10, 1959 for investigation - recent activities. It was determined that VELANTI held up a hotel clerk in Kansas City and he furnished a signed statement admitting same. VELANTI was tried by a jury for this holdup and tried under the habitual criminal statute and was found guilty by the jury, sentenced to 20 years to the Missouri State Pentientiary, Jefferson City, Missouri, date not given. This file disclosed that after the jury returned the guilty verdict and the Judge sentenced him to 20 years, he walked in front of the jury box and cried out "Twenty years is a hell of a long time" and slashed his wrists with a razor blade.

File also contained a newspaper article which disclosed VELANTI, while incarcerated in the Jackson County Jail, Kansas City, Missouri awaiting trial, had fashioned a gun from a bar of soap and covered it with black shoe polish which made this gun look real. The gun was located during a routine search of VELANTI's cell.

At the time of arrest by the Kansas City, Missouri Police Department, VELANTI advised the arresting officers that he had no father and that he did not know his mother's name.

A copy of the FBI identification record of BROWN and VELANTI were obtained as were photographs of these two individuals.

The following investigation was conducted by SA RAYMOND B. HOWE:

AT INDEPENDENCE, MISSOURI

On May 21, 1968, Attorney PHILLIP LEE BAKER, 214 South Springfield Street, Independence, Missouri, advised that in January, 1963, he was appointed by Judge GIBSON, U. S. District Court, to represent JAMES EARL RAY at the Missouri State Penitentiary in his application for Writ of Habeas Corpus. He stated that previous to this, RAY had filed application for appointment of counsel as an indigent pauper. This Writ of Habeas Corpus was to bring the warden into court to show why he was being detained. The hearing was unsuccessful.

BAKER advised that prior to the hearing and sometime during 1963, he talked to RAY at the Penitentiary and he believes this is the only time he spoke with him at the Penitentiary and the only other time he saw him was at the hearing which was held in Jefferson City, Missouri. After the hearing, RAY indicated to him he was going to appeal. BAKER stated he did not wish to represent RAY any further and his records show that on September 23, 1963, he wrote RAY at the Penitentiary to confirm his understanding to appeal and advising him that he should handle it himself.

BAKER stated he remembers nothing unusual in his conversations with RAY. They mainly talked of the hearing. He has not been in contact with RAY since September, 1963, and could furnish no information as to his whereabouts. He did advise that in about August, 1963, RAY sent him a \$50.00 fee for representing him in this matter. Also, he received a letter dated July 24, 1963, from another inmate, Missouri State Penitentiary, JOHN W. MYERS, Registry #03848J, Hall F, Cell 90. This inmate advised that BAKER had been recommended to him by RAY and he requested BAKER to handle his case in the same manner he handled RAY:s case.

BAKER said he sent MYERS a letter in August, 1963, advising him he would be unable to handle his case. BAKER also produced a letter dated July 10, 1963, that he received from JERRY RAY, 1713 Lafayette, St. Louis, Missouri. This letter states as follows:

"I visited my brother James Ray this past Sunday and he said you represent him. Also, he said he was going to mail you \$49.75 plus later on send you some money and you are supposed to send it to me.

"He will let you know when he sends it. He will also let me know.

"/s/ Jerry Ray"

BAKER advised that this was the extent of his contact with RAY and can furnish no further information regarding him. However, if such conformation comes to his attention, he will immediately contact the FBI.

After interview with attorney PHILLIP LEE BAKER at Independence, Missouri, SA RAYMOND B. HOWE returned to the office and checked subject's file to determine if there was a recording of subject's sending \$50 to attorney PHILLIP LEE BAKER. Prison records failed to substantiate this. In fact, they show that on June 19, 1963, PHILLIP LEE BAKER, 516 Guitar Building, Columbia, Missouri, sent a money order of \$50 to JAMES EARL RAY. Because of this, SA HOWE recontacted attorney PHILLIP LEE BAKER the same date.

BAKER advised that his file reveals that he received a letter from JAMES EARL RAY dated May 19, 1963, from the Missouri State Penitentiary stating he was going to sign over \$50 to BAKER and the money would be sent to him when money orders can be sent out. He advised that he got a letter dated June 11, 1963, postmarked June 11, 1963, from JAMES EARL RAY indicating that a relative was sending him \$100. He stated he received another letter dated June 7, 1963, postmarked June 12, 1963, from the Missouri State Penitentiary enclosing a check or money order (BAKER could not tell from this letter) for legal fees. This letter was unsigned, however, the return address listed NATHAN J. MURPHY, Missouri State Penitentiary #04725, Hall K, Cell 91. BAKER advised that his records revealed that on June 17, 1963, he sent RAY a check for \$50 which was the excess over his legal fees.

BAKER stated he could not remember any further details of these transactions, however, he would continue to review his files and check records and see if he could furnish any information which would be more helpful in this matter. BAKER supposed that maybe he was supposed to send the \$50 to JERRY RAY instead of back to the subject in view of the letter he received from JERRY RAY on July 10, 1963, however, he could not elaborate on this.

AT SPRINGFIELD, MISSOURI

On May 16, 1968, JOHN T. THOMASON, Greene County Parole Officer, Greene County Court House, advised that on September 26, 1967, IVAN DALE UNDERWOOD, appeared before Judge BARBOUR, Springfbeld, Missouri in connection with insufficient fund check and was released. THOMASON advised the record shows a money order was received from UNDERWOOD making restitution on the insufficient funds check on February 28, 1968 and a return address is 5105 Minnesota Avenue, Apartment B, St. Louis, Missonii and this is the most recent information in the file.

The following investigation was consucted by Special Agent ROWEN B. AYERS:

AT JEFFERSON CITY, MISSOURI:

On May 22, 1968, Mr. DAVID BRYDON, Attorney, to whom a phone call was made by J. D. DAILEY from St. Louis, Missouri, on November 30, 1967, said this call related to his attempting to obtain a parole for THOMAS BEECHER CREWS, MSP #71845, doing life for murder and robbery. He said DAILEY said he was motivated by humanitarian reasons, but he also believed CREWS had stacked some money from a robbery and DAILEY may have hoped to share in that. He said CREWS is still in the penitentiary and is suffering from tuberculosis.

The following investigation was conducted by SA THOMAS H. WEAVER:

AT COLUMBIA, MISSOURI:

On May 3, 1968, Chief of Police PAUL CHEAVENS (NA), Columbia Police Department, was telephonically advised by SA WEAVER of the statement from a witness in St. Louis, Missouri, that one individual driving a 1964 Chevrolet bearing a license issued to RICHARD L. BREY, 1505 West Worley, Columbia, resembled the subject. Chief CHEAVENS said that he would cause investigation to be conducted to determine if the person driving the above-described car could be identical with subject.

On May 3, 1968, Chief CHEAVENS advised SA ROWEN B. AYERS that RICHARD L. BREY, 1505 West Worley, Apartment 2, taught school at Hickman High School in Columbia until about March 1968. He said that he thought BREY was fired, and indications were that he had gone to Mexico, Missouri. He stated it was thought that BREY was single and had come from around Springfield, Missouri, and apparently not much was known about him among teachers at the high school, but there was no indication of any remote possibility that he would be identical with JAMES EARL RAY.

Mr. DONALD BUNKER, Director, Classification and Assignments, Missouri State Penitentiary, who maintains personnel files on inmates of the Missouri State Penitentiary, advised that a visitor's card is issued to a person desiring to visit inmates by the Warden. This contains the signature of the visitor. When this person makes a visit, the card of the inmate is "pulled" by the matron in the visiting room, who checks the card upon presentation. The person visiting signs the register of visitors. This is a sheet of paper in columns. This is checked on the inmate's file, according to date, and when such entries are made on the inmate's card for all visitors each day, the sheet signed by the visitor is destroyed.

Mr. BUNKER said, therefore, the only signature of a visitor is that contained on the inmate's official visitor's card. He said, if it did not agree, in the opinion of the checking matron, no visit would be allowed, and trouble might result both to the inmate and the visitor.
