William Bradford Huie has written a third article for "Look" magazine. The article appears in the issue dated April 15, 1968, but this issue was circulated on April 1, 1968. A review of the article reveals that James Earl Ray allegedly registered at the Travelodge Motel, Five Points, Birmingham, Alabama, on March 28, 1968; at a motel near Florence, Alabama, on April 1, 1968; and at a motel near Corinth, Mississippi, on April 2, 1968. It is to be noted that Ray, using the name Harvey Lowmyer, negotiated the purchase of a rifle at the Aeromarine Supply Company, Birmingham, Alabama, on March 28 and 30, 1968. On April 3, 1968, he was registered at the Rebel Motel in Memphis, Tennessee.

In an effort to establish whether or not Ray was in contact with any individuals immediately prior to the assassination, appropriate investigation should be conducted by the Birmingham and Jackson Offices. It should be understood that there is to be no indication made whatsoever that the following investigation has any connection whatsoever with the case involving James Earl Ray.

Birmingham and Jackson Offices should make inquiries of the motels in or near the cities indicated above to determine the identities of individuals registered during the period March 28 to April 3, 1968. Efforts should be made to identify all individuals listed, as well as

obtaining descriptions and registrations for the automobiles of such persons. A review of such records might indicate whether any one individual might have accompanied Ray or been in contact with him during this period. Pertinent or questionable registration records should be obtained if possible for examination by the FBI Laboratory.

Memphis should insure that the Bureau is kept currently advised of pertinent developments in this case, particularly all aspects of court action since the death of Judge Rattle on March 31, 1969.

In view of the fact that more than a year has passed since these persons stayed over night at Corinth, and since similar investigation of this type in this case has previously been unproductive, and since RUIE has admitted that RAY frequently is untruthful in statements to him, and further since it is not believed that it is of any particular importance to establish whether or not JAMES EARL RAY stayed over night at Corinth on 4/2/68, all offices will disregard the leads set out in Jackson airtel dated 5/7/69 unless specifically advised by the Bureau to cover same.

Re Savannah airtel to the Bureau, 5/7/69, which advised that according to SV 524-R, Attorney J. B. STONER and the subject's brother, JERRY RAY, might be located somewhere in Tennessee.

Savannah is requested to maintain contact with SV 524-R, and when more definite information is obtained as to JERRY RAY's location, Savannah is requested to get out leads to have JERRY RAY interviewed regarding statements made by him that he believes JAMES EARL RAY was part of a conspiracy to murder Dr. MARTIN LUTHER KING, JR. For Savannah's information, JERRY RAY has been quoted in various news media as having stated that his brother conspired with other individuals to murder KING. He has not furnished any specific details regarding this conspiracy, and it is desired that he be interviewed to determine if he has any knowledge of a conspiracy. The interview with JERRY RAY should be recorded in an LHM suitable for dissemination.

In the event Knoxville has any indication that STONER and JERRY RAY are located within that division, appropriate action should be taken to interview JERRY RAY, as set out above.
