Writer received call from Mr. H. N. HIGGINS, 152 West College Way, La Verne, California, telephone #593-4236, who advised as follows:

Up until about three years ago, was well acquainted with an individual known to him as ERIC A. ALLSTROM. Neither he nor his wife has seen ALLSTROM for about three years and have no idea as to his present whereabouts, however, during the period of time he and wife were acquainted with ALLSTROM, they obtained quite a bit of info about his background and activities. Stated that they have wondered whether ALLSTROM might be identical with man who killed KING ever since they heard name ERIC STARVO GAULT and description of man believed to have shot KING, which HIGGINS believes is almost identical with that of ALLSTROM.

Stated that ALLSTROM used to hang around his dress shop in Pomona and they became well acquainted with him through this means. Stated that ALLSTROM was always a little "kooky" and after reading the book "Atlas Shrugged" by AYN RAND, started to use an alias of JOHN GAULT. ALLSTROM stated that he believed that he was destined to save the world. ALLSTROM also used to read alot of metaphysical publications, and after reading one particular edition, told HIGGINS he beilved he was the Christ and was going to save the world.

Stated that from what ALLSTROM related, ALLSTROM was born in Mexico to parents that were evangelists. ALLSTROM could in fact read, speak and write fluently in Spanish and indicated a large knowledge of areas in Mexico.

ALLSTROM also related that he had served in the shipping industry as a boy in capacity of merchant seaman and had an older brother, last name also ALLSTROM but first name not recalled, who is retired from Navy and residing either in San Francisco or San Diego. Believes brother

was an officer in Navy. Related that mother and father both dead and had lived most of his life in Mexico until their deaths there. Indicated that he had no other living relatives.

HIGGINS stated that ALLSTROM has been married many times, most occurring in the Pomona area and names of wives not recalled.

HIGGINS stated ALLSTROM always had a liking for white cars and believes owned a Mustang, color white, the last time saw him. ALLSTROM also has been arrested by local police departments on charges of bad checks, impersonating officer and non support. HIGGINS states believes ALLSTROM was arrested by Ontario PD around 1964 for bad checks.

HIGGINS stated he could identify ALLSTROM from a photo.
