ROSS was extremely anxious to find out how we got his name, and what was the relationship between him and GALT. He was not told how we determined his contact with GALT.

ROSS claimed to have known one JOHN GAULT, an actor, who was active in the theatrical business in Los Angeles. He claimed not to know ERIC STARVO GALT. He stated if he knew how we associated him with GALT he would probably recall. He stated he may have waited on someone by the name of GALT and fitted him with a hair piece. He would have no objection whatever to cause a check of the records of his establishment for anyone in the name of GALT.

ROSS, who is English, and who speaks with an accent, seemed to be most cooperative...He stated he would be available for intermiew after 12 Noon 4/15/68

## RECOMMENDATION:

Contact ALLAN ROSS, 6725 Sunset Blvd, Los ?Angeles after twelve noon, 4/15/68. Show him the composite photo of GALT and review the records for anyone in his files who may be identical with GALT by description or alias. Do not reveal how ROSS's name came to be know to the FBI.
