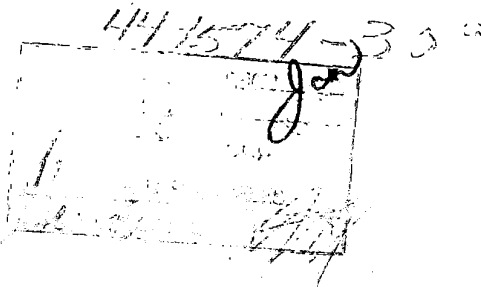

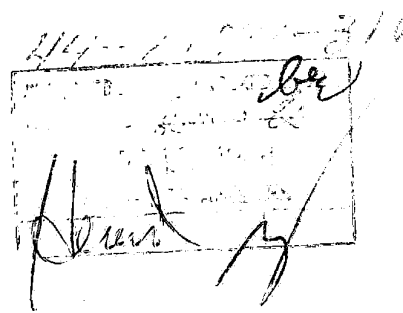

The possibility exists that the Kleenex box top which was found in the abandoned Mustang with DAY's and KATZWINKEL's name and address on Serrano Street, was dropped in the car by STEIN during the trip to New Orleans; or by RITA STEIN and/or MARIE BERINO during the time they ran around with GALT.

Also, due to the fact GALT subscribed to "girlie" magazines, purchased a film or slide projector, and appeared to associate with prostitutes, it is possible he either makes, buys, or sells obscene movies, or photographs. Maybe TOM FLIKEID should be re-interviewed to determine if he was in the business, or if SUE HARRIS, was in the business of making obscene movies.

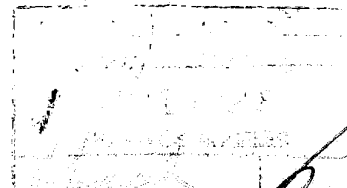

During the call Breen asked the caller if he was a member of Hells Angels and the caller replied that he once was a member. This call had reference to the killing of Martin Luther King. The caller pleaded with Breen for permission to talk to Breen's producer.

C advised that the producer is the person who handles the calls and the audience does not hear the conversations between the callers and the producer. C said she does not know the caller might have said to the producer.

While the caller was on the air, he did not say what the nature of his inside information was.

Action Recommended Consider contacting Breen show.

On 4/17/68 at 1:05 P.M. Miss BOILEAU, business telephone 274-8706, home telephone 780-0032, an employee of Martindale's Book Store on Santa Monica Boulevard between Rodeo and Beverly Drive, Beverly Hills, advised as follows:

On 4/11/68 she noted a man in the bookstore who was neither purchasing nor browsing but definitely killing time. His suit was rumpled as if he had slept in it. She said that he exactly fitted the profile version of the composite photo of Dr. KING's murderer.

Miss BOILEAU is sure of the date, because the same day she was at Morley's Drug Co. at Beverly Drive and Santa Monica and sat next to a "bigot" who was reading Life about Dr. KING's March in Memphis which resulted in violence, and this individual told her he had been in Memphis and had seen Dr. KING run out when the violence started. She advised that she had discussed this individual with a waitress in the store, who advised that his name is (FNU) SEEBURG or SEEBERG, and that he was a regular patron. Miss BOILEAU also mentioned to the waitress about the man she had seen in Martindale's and described him, and the waitress was sure he had also been in the drugstore.

Miss BOILEAU offered the suggestion that these two may have had a meeting.
