Writer called on above date of one SERMON BUNCH, 11740 Lugo Park Ave., Lynwood, Calif., tel# 774-1281, who advised that during KABC radio program a few days ago, "The RAY BRIEN Show", which is a "talk to the public show", the Ass't Chief of Police at Memphis was interviewed on the air. During the conversation, the language used by the chief became so vulgar and statements so crude, that the conversation had tobe to the true trom theair before it was finished.

During the conversation, the chief made statements reflecting his apparent hatred for MARTIN LUTHER KING, and other statements, that, according to BUNCH, might provide a clue to the FBI as to how the KING killer was allee to escape Memphis undetected. When asked to expand on this, BUNCH stated that just from the statements made and context in which they were made, it appeared that the Chief possibly knew an attempt would be made to kill KING in Maxaphia Memphis and that the chief didn't give a hoot.

BUNCH continued that he has called KABC in attempt to determine where the tape of the interview is and he was advised it had been destroyed.
