WATTS could not be specific other than to say they were from the East Coast and did not want to return there because the "District Attorney was looking for them."

WATTS stated that he had seen a picture of GAULT on television and one of the men looked "a little like GAULT." He advised that these men had told him that they would be returning to the Playroom Bar, Norton and Long Beach Boulevard, Lynwood, California, at 4:00 p.m. today.

When WATTS was questioned regarding the physical description of either of the subjects, he was not specific and when questioned further, he stated the two men indicated they would return to the Playroom Bar between 3:00 and 5:00 p.m. today. He further advised, upon additional inquiry, that he had lost money to these two individuals shooting pool this morning at the Playroom Bar. He stated that he was presently at the Playroom Bar and the two men had not returned.

WATTS indicated that these men were speaking to a female at the bar but he did not know if they were known to the regular patrons.

Due to the non-specific description and the circumstances prompting the call, it is suggested that photographs of the subject be displayed to the bartenders and/or owners of the Playroom Bar to see if they can identify GAULT as a patron of the bar.

TOMMY PIKE, KNOWN MEMPHIS BURGLAR, AND GORDON FORBES WHOSE FATHER IS IN CHARTER BOAT BUSINESS IN FLORIDA. ERIC INTRODUCED HIMSELF TO INFORMANT AND WHEN INFORMANT OVERHEARD ANOTHER PERSON IN GROUP CALL ERIC BY NAME OF STEVIE SHE QUESTIONED HIM ABOUT HIS NAME AND HE SAID STEVEN OR STEFAN WAS HIS MIDDLE NAME. ERIC MENTIONED THAT A GROUP OF THEM HAD BEEN BOATING ON THAT DAY AND THAT SHE HEARD LATER ON IN THE EVENING FORBES ASK ERIC "IF HE WAS GOING BACK ON THE BOAT." ERIC REPLIED "I DON'T KNOW, IF THINGS PAN OUT AS I PLAN I MAY NEVER GO BACK ON THE BOAT." INFORMANT DOES NOT KNOW SIGNIFICANCE OF THIS REMARK.

SECOND TIME INFORMANT MET ERIC WAS AT MANHATTAN CLUB AT APPROXIMATELY THREE A.M., A COUPLE OF DAYS BEFORE THE BIG SNOW THAT OCCURRED IN MEMPHIS ON MARCH TWENTY TWO, LAST. LAST TIME SHE SAW ERIC WAS BETWEEN THREE THIRTY AND FIVE A.M., ON MARCH TWENTY EIGHT, LAST, AT CHENNAULT'S RESTAURANT. ERIC LEFT RESTAURANT APPROXIMATELY FIVE A.M., STATING HE HAD TO GO SEE "DUKE" AND INDICATED HE MAY RETURN TO RESTAURANT AFTER SEEING "DUKE." "DUKE" IS UNKNOWN TO INFORMANT.

ERIC NEVER MENTIONED ANY TYPE OF TRAVEL TO HER HOWEVER DID VOLUNTEER THAT HE RESIDED IN SAN FRANCISCO, CALIFORNIA, FOR A BRIEF PERIOD OF TIME AND HAD FRIENDS WHO LIVED IN A COMMUNITY THAT BEARS LAST NAME "BEACH" NEAR LOS ANGELES, CALIFORNIA.

THE INFORMATION SHE FURNISHED POLICE DEPARTMENT CONCERNING A POSSIBLE CONNECTION BETWEEN ERIC, KNOWN BURGLARS, A FARM HIDEOUT FOR BURGLARS IN ALABAMA, AND TRIPS TO MEXICO WAS MERELY SPECULATION ON HER PART. INFORMANT CLAIMS THAT ON ALL OCCASIONS WHERE SHE HAS OBSERVED ERIC HE ALWAYS APPEARS TO BE WITH A LARGE NUMBER OF PEOPLE HOWEVER OTHER THAN FORBES, PIKE, AND A PROSTITUTE DRUG ADDICT BY THE NAME OF WANDA WILKES SHE HAS BEEN UNABLE TO IDENTIFY ANY OTHER PERSONS IN GROUP.

IT IS NOTED THAT EFFORTS TO LOCATE WILKES HAVE BEEN NEGATIVE AND THAT BOTH FORBES AND PIKE HAVE BEEN NEGATIVE AND THAT BOTH FORBES AND PIKE HAVE DENIED KNOWLEDGE OF EXISTENCE

WHITE FEMALE INFORMANT OF MEMPHIS POLICE DEPARTMENT REINTERVIEWED BY BUREAU AGENTS THIS DATE. UPON VIEWING A PHOTOGRAPH OF ERIC STARVO GALT SHE ADVISED THERE ARE DEFINITE DISSIMILARITIES IN THAT THE MAN SHE KNEW AS ERIC STEFAN GALDEN (PHONETIC) HAS EARS WHICH LIE CLOSE TO HIS HEAD, WHILE GALT'S EARS PROTRUDE AND THIS IS A PHYSICAL FEATURE OF MEN WHICH SHE ALWAYS NOTICES. INFORMANT STATES THAT THE HAIRLINE OF GALT RECEDES FAR MORE THAN THE HAIRLINE OF PERSON KNOWN TO HER AS GAULDEN. SHE ALSO STATED THAT GAULDEN DID SMOKE CIGARETTES PREFERRING NON FILTER TYPE BECAUSE ONE NIGHT HIS CIGARETTES, BRAND NAME UNKNOWN, WERE ACCIDENTALLY RUINED BY A SPILLED DRING AND HE TOOK ONE OF HER CIGARETTES AND TORE OFF THE MENTHOL FILTER.

ADDITIONAL CONTACT WITH KNOWN ASSOCIATES OF GORDON FORBES AND INFORMANT WHO FREQUENT CLUBS MENTIONED IN PRIOR TELETYPES HAVE FILED TO DEVELOP ANY INFORMATION TO INDICATE THAT THE PERSON DESCRIBED BY INFORMANT AS BEING ERIC EVEN EXISTS. ONE SOURCE WHO KNOWS GORDON FORBES WELL STATED THAT HE KNOWS EVERY ASSOCIATE AND ACQUAINTANCE OF GORDON FORBES AND THAT NONE OF THESE PERSONS RESEMBLE THE MAN DESCRIBED BY INFORMANT. THIS SAME SOURCE ON A REGULAR BASIS FREQUENTS THE SAME CLUBS AND LOUNGES IN MEMPHIS AND HAS NEVER OBSERVED AN INDIVIDUAL FITTING THE DESCRIPTION OF GAULDEN.

ACCORDING TO THE INFORMANT WANDA WILKES HAS BEEN PRESENT WITH THE GROUP ON ALL OCCASIONS AND SHE HAS OBSERVED GAULDEN, AND SHE SHOULD BE ABLE TO IDENTIFY ERIC GAULDEN.
