On 4/18/68, ~~Joseph Waring~~, manager, Tony's Liquor Store, 22523 West Pacific Coast Highway, Malibu, California telephonically advised he had just waited on a customer who he thought resembled the man the FBI was looking in connection with the King case. He described the man as a white male, 6' 0", 170-180 lbs., late thirties, receding dark brown hair, and medium complexion. He advised the man bought a package of tea and a bag of Fritos and left the store and drove north on the highway in a late model, Mustang, white color, bearing Oklahoma license plates XD 1338.

The above described vehicle and license plate were run through NCIC with negative results for a stolen. On 4/18/68, D. K. Lloyd, Malibu Division, IASO, was alerted re the above person and vehicle.

On 4/18/68, D. K. Lloyd, Malibu Division, IASO, advised the vehicle had been located parked at the Casa Malibu Motel, 22752 West Pacific Coast Highway.

On 4/18/68, Russell Young, Manager, Casa Malibu Motel, advised a man and a woman driving a white Mustang with Oklahoma license plates XD 1338 had checked into the motel on 4/16/68 and were staying in Unit #6. He produced a register card which indicated the room was rented to a Jim K. Davis, 1312 Georgia Avenue, Perry, Georgia, driving a Ford with Oklahoma license plates XD 1338. He said he did not think this person resembled the photograph of the man known as ERIC STARVO GALT.

On 4/18/68, SA's Steven E. Ducker and John T. Martin interviewed Jimmy K. Davis, #6, Casa Malibu Motel, and he advised he was a Senior Master Sergeant in the Air Force, AF 14299147, stationed at Robins Air Force Base near Macon, Georgia. He advised he maintained a permanent address of 1312 Georgia Avenue, Perry, Georgia.

Davis advised he was in possession of a 1967 Mustang, white color, VIN 7F01C193137, bearing Oklahoma license plates XD 1338. He stated the vehicle belonged to his sister-in-law, Shirley Burleson and her husband, Frank S. Burleson. He produced Oklahoma title # K773391 showing owner as Beryles Bumper Service, 1106 S. Robinson, Oklahoma City, Oklahoma. He advised this firm is owned by the Burlesons.

Davis was accompanied by his wife and Shirley Burleson. He advised he was a career serviceman, having entered the service at the age of 16.

While Davis could not be positively eliminated as being ERIC STARVO GALT based on the available information concerning GALT, it should be noted that a discrepancy exists in the birth dates of Davis and GALT and the fact that Davis has a prominent mole high on the cheek bone approximately 1 $\frac{1}{2}$ " below the outside corner of the left eye.

On 4/20/68, an canvass of all boarding houses, flop houses, rescue missions, and rental units, in the harbor area of San Pedro, California, was conducted in an attempt to locate JAMES EARL RAY. (BOOKMAN information). Six square blocks of such residences were checked from Harbor Boulevard to Pacific Boulevard and between First and Sixth Streets on a door to door basis. The surrounding area to the west, and south of the area consists of residential homes. The area to the north and east is made up of harbor facilities and non-residential area.

No pertinent information was developed on the canvass, during hours of 5:30 am to 9:12 am, on 4/20/68. Managers and employees of the established were alerted and advised they would immediately contact this office if person answering RAY'S description.
