



At 11:00pm the writer contacted Mrs. Jo Ann Watkins at the Ye Olde Inn at which time she advised that after viewing a newspaper photo of Ray she reviewed the membership records and determined that she has two members who have names similiar to aliases of Ray namely James H. On May 6, 1968, the Wanted Notice regarding RAY was exhibited to the employees of Thrifty's, a drugstore, 6639 Laurel Canyon Boulevard, Los Angeles, as named below. These employees were also provided with pertinent information regarding the visit of the man seeking treatment at the Vineland Convalescent Hospital including descriptive information and information that he might have been at the restaurant in this drug store. All these employees said to their knowledge that they could not identify the picture of RAY nor could they recall anyone on the basis of the information provided regarding the man visiting the hospital. These contacted in this regard were:

JACK YATES, manager of this drug store.

MIKE SWENDDAL, First Assistant Manager of this store.

JEFF KAPLAN, Second Assistant Manager of this store.

FRED TENOSO. Manager of the restaurant at this drugstore.

Immediately north of the Vineland Convalescent Hospital is the Carl Vess Nursery School. Mrs. TOMAC advised on May 6, 1968, that she works during the day at this nursery located at 6128 Vineland Avenue, She said that the owner of these premises, Mrs. CONTE, lives in San Francisco, California, but her daughter and the latter's husband live at this address and there have been no tenants or roomers there for at least four years. She said that they were not then there. She said that she could not

recall anyone resembling RAY when she was shown the Wanted Notice. She also said that she could not identify the person who had reportedly visited the Vineland Convalescent Hospital.

Immediately south offethe Vineland Convalescent Hospital are apartment buildings/managed by Mrs. GLORIA NELSON and her husband, NELS NELSON, 6114 Vineland Avenue, North Hollywood. They were shown photographs of RAY as well as the Wanted Notice, but they said they could not recall having seen him. Both persons were furnished information regarding the man reportedly visiting the hospital, but both advised that they did not know that individual. They advised that they currently have a tenant in Room 5 at 6110 Vineland Avenue, North Hollywood, who came in on March 18, 1968. This tenant is named JERRY FARISH, but had also given another name. At first, he claimed to be a photographer, but later to be a writer for a studio. He said he had written part of "Mission Impossible" a television show. He said that his wife had died about March 1, 1968, and that he had taken their child to her family in Arizona. He later met a girl and after he started living at this address, was away for about two weeks going to Tennessee to marry this girl. Her family lived in Tennessee. He first gave a name which looked like "RAULS (first name unknown) and indicated that he was doing phtographic work for Columbia Studios. Mrs. NELSON called that studio but could not verify his employment on the basis of the name she had for him at that time. On one occasion, he showed a check for \$3,500 which he claimed he got for a script, but later he said that check was no good. Mrs. NELSON said his stories are so different. They described this man as follows:
