Inquiry for LEROY A. PAGE at the Pacific Coast Club on 4/27/68, met with negative results.

On 4/29/68, LEROY A. PAGE, Stock Broker, Goodbody Stock Brokerage, 213 East Broadway Street, advised he was the owner of the 1968 Ford Mustang convertible bearing Arizona license NAA 305. PAGE stated this car was presently in his possession, that he is the sole driver of the car, and he does not loan the car to anyone.

PAGE said that on or about 4/25/68, he was driving this vehicle in Los Angeles.

It was determined through personal observation and interview that PAGE was not identical with subject RAY.

PAGE is a White male, 34 years of age, 6'4", 210 pounds, light brown hair, and blue eyes.

On 4/29/68 VICTOR MALER, Hollywood Wilcox Hotel, 6500 Selma Avenue, Hollywood, California (469-1161) advised that WARREN (Billy WILSON, who resides at this hotel, is well known to the hotel guests as a "nut" who takes pride in writing letters to everyone who will answer him. Recently he wrote a ten page letter to GREGORY PECK telling him what was wrong with the recent Academy Awards on T.V. He also carries a large briefcase which includes letters from anyone who will take the time to answer him. Recently he received a form letter from President Johnson.

WARREN WILSON is described as follows:

Height--5'8"	slight paunch.

Hair--grey	

MALER stated that WILSON reads the papers or watches TV and then starts writing letters. He is believed to have been a public relations man for the Dobritsch Circus at one time, but now spends most of his time just walking around the Hollywood area.

ACTION--In view of the content of the letter sent to the FBI, coupled with the information from MR. MALER, no further investigation regarding this phase of the MURKIN case is being undertaken.

Mrs. FRANCES STOKER JAMISON, 453 Paseo, Kansas City, Missouri, advised she has been legally separated from her husband, WILLIAM HOWARD JAMISON, for about three years. She stated he has been extremely religious since getting out of prison, and in her opinion is "sick", but would not harm anyone. She said JAMISON was in Kansas City, Kansas, at the time of KING's murder residing at 906 Ohio, Kansas City, Kansas, but left about a week later for California.

Mrs. JAMISON said she had a letter from her husband on 4/29/68 in which he indicated he was an Evangelist for Gospel Wings, 1948 Clinton, Los Angeles, California. She does not know of any threatening statements made by JAMISON regarding MARTIN LUTHER KING, but stated he might have made such statements while he was a member of the John Birch Society. She stated he has not been associated with this organization since getting out of prison.

BARRERA stated that in December 1967 he was traveling from Romar, Texas, to Moorpark, California, when he became involved in a severe snowstorm at Marfa, Texas. He telephonically contacted his brother-in-law, MANUEL HUGO GARCIA, at approximately 6:00 P.M. in December 1967, exact date not recalled, advising him of the fact that he would be delayed in returning to Moorpark, California, because of the snowstorm. Mrs. MC CALLUM recalled that on Saturday morning, 12/16/68, the MC CALLUMS received a telephone call from her in-laws, Mr. and Mrs. JOHN MC CALLUM, who were at Marathon, Texas. The in-laws reside in Roscommon, Michigan, and were driving to South Pasadena, California, to spend the Christmas holidays with the MC CALLUMS. The purpose of the call was for the in-laws to advise the MC CALLUMS that they had encountered difficulties with their car at Marathon, Texas.

Mrs. MC CALLUM stated that she does not know JAMES EARL RAY.

WOODS, U. L. BAKER, PETER CHERPES, WILLIAM DAVID PAISLEY, JR.,
and HERBERT KELLY on 4/26/68. DE SHAZO stated he thought the
photo was a good likeness of subject and HANNERS said it
looked "something like" subject, especially the hairline.
The remaining witnesses each stated they did not believe
this was the subject, and could not identify him from this
photo.

These same witnesses were shown the 1966 Missouri
prison photo of the subject, and all agreed this was a poor
photo of the subject as they each did not remember him being
that thin in the face.

Each witness to date has stated the best likeness
of the subject is the 1960 Missouri prison profile photo, if
hair was added.

She stated this individual is employed as the manager of the car wash located on Highland Avenue, San Bernardino, California.

On 4/23/68, JERRY LA BRIER, born [redacted], 5'9½", 140 pounds, was contacted at the Highland Avenue Car Wash, where he advised he is the manager. He exhibited company records, which reflected that he worked from 8:00 a.m. until 7:00 p.m. on 3/29/68. Physical observation of this individual indicates that he is not identical to JAMES EARL RAY, in addition, to the fact that he was employed on the day that MARTIN LUTHER KING was murdered.
