Source advised on 6/12/68, that he is now employed at Alladen's Liquor Store, Hoover Street and Florence Avenue, Los Angeles, telephone 759-3911. He also stated that he owns a Ford 350 wrecker truck, bearing 1968 California license No. X-90404.

Source continued that the talk in the Negro community of Los Angeles, indicates that the people are for more concerned about JAMES EARL RAY being returned safely to the United States and tried for the murder of MARTIN LUTHER KING than they are about the assassination of ROBERT F. KENNEDY. He continued that the general feeling is pessimistic that RAY will ever stand trial and that the Negros will then be deprived of the satisfaction of having the assassin of their former leader convicted.

Source stated that he believes that the Negro community is simply awaiting the outcome of the RAY case before taking more violent action to make their frustration apparent.

On 6/24/68, source advised that he has received no further information concerning the KING or KENNEDY assassination. He stated that he believes there is a Black Panther Society located near his place of work and he is attempting to obtain more detailed information about it.

She is aware the Glendale PD and the LAPD have arrest warrants out on Fisher aka Blaa.

Simpkins phoned 7-18-68 and said Blaa in town staying at the Cecil Hotel on Main St near 6th ST.She is to meet him about 9:00 am at the Early Bird Cafe next door to the Cecil Hotel. He was with Richard Francis Howard (91-2368) on the pm of 7-18-68 when they had a number of small radios, TV's, some watches, rings which they were attempting to sell around bors in the 5th St. and Los Angeles St. area of L. A. She did not know where they got them. "Rocky claimed to have sold a small TV to a bar tender, "Johnnie" at 5th and Maple, L. A., 7-18-68, for \$50.00. Rocky was wearing gray work shirt and pants. Simpkins will meet Rocky as above and set him up for the police.

Lt. Boothe, LAPD, fugitive detail was advised by hone 7-19-68. He said LAPD want is a misdemeanor. He talked to Det. Kenneth Hessee, Glendale PD who will attempt to arrest Blaa. Agent called Hesse and furnished details. He and partner D.R. Hunt came by the FBI office at 8:30 am and a snap shot photo of Rockey he had sent to Simpkins was furnished to Junt.

Simpkins choned at 9:20 am,7-19-68 said Rocky staying on the 12th floor of the Cecil Hotel under the name of <u>David Fisher</u>. She thinks she has spotted the Glendale DD and will make contact with them.

He stated" They can't hang any thing on me I only had some drinks with Ray and drove he and his brother to Tenn. Rocky claimed he left them and drove 48 miles to visit his mother in Colton, Tenn. It was not clear just where he left them in Tenn. and what date he claimed to have driven Ray and his brother there. Holloway thinks Rocky was referring to Ray meaning James Earl Ray who lived at the St. Francis Hotel where Rocky as Donald Martin Blaa had worked in Dec., 1967.

Rocky claimed to have "picked up" a new '68 Dodge from a parking lot near the Greyhound Bus Sta., L. A. before he left for Chicago shortly before Agents interview ed Holloway 4-29-68. He said he change the plates on it drove it to Tenn., then to Chicago where he sold it for \$800. Rocky had a Bank of America credit card which had another name on it which started with the letters "Shae---". He said he had found it in the car he lifted from the parking lot

Clifford Wolf who works at the "est Coast Cycle Co., 221 S. San Pedro St., L. A. and who rooms at the apartment where Holloway lives, was present when Rocky was making the claims about Ray and the car on Thursday pm 7-18-68.

Action: Det.Hunt advised about possible car theft.He will seek evidence in Fisher's property.

Florence Holloway was interviewed personally 7-25-68at 1232 W.5th St. L. A. Re data in memo in serial 1284 furnished by Holloway, aka Florence Holloway Simpkins, about Rocky associating with one Paul and one Earl and the Earl was a close look a like to James Earl Ray, she stated the following. Rocky, who she had met in 1959 first showed up at her apt.in late summer of 1967 following a trip to Cleveland Ohio, (see ser. 739) with Paul and Earl. She saw Paul and Earl, reportedly brothers, Rocky had met in Kansas City in July, and broght to Calif. again with Rocky at her apt. around Thankgiving, 1967. The last time in Pasadena in a bar around Xmas 1967.

When Rocky was in Holloway's apt. 7-18-68 pm following his return from Chicago, he commented. He had learned from Dick Howard (see ser. 1294 p3) the FBI was looking for him in the MURKIN case. "I don't know what the FBI wants me for, I only had some drinks with Ray and his brother at the the hotel and drove to Tennessee with them bet I don't know whether they are the ones who did the shooting. "Holloway was of the opinion Rocky was referring to the brothers Earl and Paul and assumed one of them may have been James Earl Ray on basis of the FBI inquiry. Rocky did not say when he went to Tenn. Holloway thinks they made two trips. Rocky has a mother who remarried to John Fisher who resides in Colton Tenn. (ph) He claimed when they went to Tenn. "they "had a new car and "they" let him out as "they "were going in a different direction. He told them how to get there. He was foot then and there was a curfew on in this city (not named) and he was stopped by the police who detained him in jail till the next am. He did not say he was charged with anything. He then took a bus for 40 miles then a cab to Colton (ph) where his mother lived, a distance of 8 miles.

When Rocky, Earl and Paul were at Holloway's apt. in Nov. 1967 they were in what in her opinion was a late model white Mustang. She did not note what type of licence plates on the car,

Rocky who was arrested by the Glendale Police 7-19-68 has been moved to the LACo Jail and as 7-25-68 was still there in leiu of \$2200. bail.

Glendale PD. still have a warrant for <u>Delores Fisher</u> who was involed with Rocky and living with him as man and wife at apt. # 102 at 410 S. Glendale Av., Glendale Cal., phone 244-0692 as of May 1967. Delores whose truentastnname not known to Glendale P.D or Holloway was d scribed by Holloway as FW,37-38 to 40 yrs 5'8", med build, long brown hair with a copper colored cast. She has worked as a baby sitter, domestic and a sales girl. Rocky said,7-18-68 he had seen Delores on his way to Ghicago about 4-68. he was in Cleveland Ohio with her mother who lives in the vicinity of 98th St. and Lorraine in that city. Delores had credit with Kay's Jewelry Store in Glendale on Brand Bl. about 5/47. She bought wedding rings for herself and Rocky who were posing as man and wife.

Rockyts father, Martin Blaa has remarried and is living in Chicago.

Carl Siemon an atty.in the Trustee Div. of Financial Federation Inc. 615 Wilshire Bl. L. A. # 624-10901, Res. HU-76609 has assisted Rocky financially in the past. He is currently investigating Rocky's arrest and told Holloway 7-24-68 he thought Rocky might go to the pen. and might not make bail due to outstanding warrants for arrest with LAPD and one being processed in St Louis, Mo. Carl is married but not living with his wife who has a home in the Glendale area. Carl likes to drink and hit the night spots. Holloway thinks Carl may have a homosexual interest in Rocky. In April 1968 Rocky told Holloway he was going to run off with Carl's car, go to Chicago and sell it anf Carl would never press charges. Holloway told Carl who took security action. Rocky then told Holloway he was goint to steal a car and had his eye on some in a parking lot near the Greyhound bus stagtion in L. A. He was looking for a late model Dodge, Chev. or Ply.

On 7-18-68 Rocky berated Holloway for telling Carl his auto was going to be taken and he had got a good one off a lot near the New Grayhound bus station, had stolen some plates from a car on another lot near 5th and L. A., switched plates till he got out of Calif. He then went to Chicago where he sold it for \$800. He claimed he knew where to sell it and no questions would be asked.

Rocky asked Carl to have Holloway to pick up his personal belongings at the Cecil Hotel where his room rent expired 7-24-68 and keep them till he got out of jail. Holloway declined as she felt Rocky had some hot radios, TV's and jewelry (see memo SA L. Warren 7-19-63) and she might get her probation revolked. She said her probation of ficer knew she was cooperating with the FBI as he had originally referred her to the FBI in the Murkin case.

Rockey told Holloway to open some letters he was expecting from his girl friend in Chicago and let him know if there was any thing important in them. Holloway received a letter from Rocky post marked St. Louis 7-12-69 and one addressed to John Fisher, 1232 W. 5th st. L. A. post marked Chicago Ill 7-22-68, with a return address of Mrs Joan Fisher, 5611 N. Lincoln Av., Chicago, Ill. 60645. Both letters were furnished to the TBI and they need not be returned according to Holloway. She opened the one from Joan and was of the opinion Joan had knowledge of some of Rocky's illegal activities in Chicago ant St Louis on basis of the text of the letter (see la)

Rocky in the past has operated a badger type game with bar girls. He and a girl named Barbara operated out of the Pleasant or Peasant bar near 6th or 7th and Wall St., L. A. They posed as broth er and sister, picked out drunks, took the drunks to their rooms where Barbara turned tricks with the victim while Rocky searched the room and the clothes of the victim for money and pawnable items.

Action Taken:Det. D.R. Hunt and Det. Kenneth Hese, Glendale PD. on 7-24&25-68 were furnished with above details pertaining to their case.# 253318.(John David Fisher)They have advised LAPD of the arrest as LAPD has a warrant for Fisher on basis of a theft from the St. Francis Hotel, Hollywood 12-5-67 of \$95.00. Agent also advised Lapd of Fisher being in town, 7-19-68(see memo 7-19-68)

Det. E.J MacLyman, Traffic Warrant Div., Long Beach PD. was of Fisher being in the County Jail, 7-25-68. They hold a traffic warrant issued 6-10-68 for a parking violation 4-4-68 at 1634 E. 4th St., Long Beach Cal. In name of John D. Fisher Holloway, 1219 W. 4th St. L. A. (former residence of Holloway) for a 1959 Ford Lic. # SBF-294. (see serial 1283 attachment for registration.) (Holloway claimed 7-25-63 Rocky sold this 1959 Ford just before he went to Chicago about the last week in April 1968.)

Det. C.J. Blaney, Burglary Div., LAPD, 7-25-63 was furnished data re possible theft of auto by Rocky in lat April, 1968 from a lot in vicinity of the Gray Hound Bus Depot. He ran the data through the Auto theft statistics section and said he could not come up with any thing as yet but would check further.

Enclosed is the full account of the experience I have been calling you about.

Although I am sending you a carbon, I have not shown this to anybody else. I am most hesitant about implicating any poor, unsuspecting, innocent people and I keep telling myself that this whole thing is just a series of coincidences which I have pieced tegether in such a way as to look significant. The "two men" were probably Finance men trying to repessess an automobile or some such thing.

As I teld yeu, I called the E.B.I. yesterday and teld them about these two pictures, but I really think that I should have tried to find other pictures in other poses before I said anything. It is possible that another picture of the same person would look entirely different. I am well aware of that, - but I suppose the F.B.I. is well aware of that, also. It was not my intention to "stir up" anything, nor to seek any publicity - you know that. I gave it a let of serious thought and I kept coming up with the opinion that it was extremely unlikely that two men looking so much like those pictures would come to Long Beach looking for a man named Ray on that night, and that it would be pure coincidence. (But that is probably just what it was!) I'll probably hear nothing more about it, - in fact, I HOPE I hear nothing more about it. I still thing it entirely plausible that, if it was actually them, and they think I might recognize their pictures, it would occur to them that I should be silenced. (Believe me, any men coming to my door in the future are going to get short shrift from me!)

I would be most interested in hearing from you as to your opinion of my story and whether you agree that I should have reacted as I did.

When you didn't call me back, I figured that you were not interested, so that is another reason why I called the F.B.I. myself rather than contacting you again.

On the night of April 1st, I was sitting alone in my den watching television. I heard heavy footsteps walking back and forth between the building in which I live and the building next door. This is not unusual, but for some reason, the sound attracted my attention. Shortly after that, my front doorbell rang. It was exactly 11:45 P.M. I went to the front window and, peeking between the closed drapes, I saw a man standing at the door, facing the window, holding, what at first glance appeared to be, a camera. He was holding it very high and close to his face, as if he was looking at me through the view-finder. I immediately jumped back and called out, "Who is it?" His reply was, "The Police." Having seen that he was not wearing a uniform, I said, "Come on, you're not a policeman. What is the camera for?" He replied, "That is not a camera. I was holding up my badge." Telling him to wait a minute, I went to put on a robe. When I returned to the window and pulled open the drapes, he was still holding the badge very high and close to his head. He was smiling very broadly. The badge looked "odd" to me, but I cannot explain exactly why. It was large and seemed to have a coppery cast. It was attached to a wallet or folder. In his other hand, he held a small, chrome flashlight. I noticed a small red insignia on the end of it. It was then that I saw the second man standing below on the steps. When I asked what they wanted, the man with the badge said that they were looking for a man who, according to reliable information, was "holed up", (or some similar slang expression), with one of the tenants next door. He hold out a picture. I remember thinking that, since we were yelling through the closed window, if the man they wought was next door, he would surely hear them. Since I could not see the picture clearly, I opened the door. (I am positive that the man said that they were "police", because as I opened the door, I remarked that I was hardly in any condition to talk with anybody, much less the pelice.) The first man, who did almost all of the talking, apologized for the lateness of the call and said that, since mine was the only light on inothe vicinity, they had decided to "take a chance and ring the bell". He asked if there was a "caretaker" in the building next door. When I replied that there was not, he again held out the picture, asking if I had seen the person around there recently. I still could not see clearly, so I opened the screen door and told them to come in. (I den't knew why, but I distinctly remember that he sert of chuckled and said, "Oh, all right.") They both entered. The first man was dark with black, hair and brown eyes, and looked to be of Italian derivation. He was about 5'10", of medium build, were an almost constant smile and smelled strongly of shaving letion. He had a decided dimple in his chin. He was wearing a dark suit, white shirt, dark tie, and a black raincoat or trench-coat. I seem to remember that he was wearing one glove and was carrying a hat, which he placed on a nearby chair. The second man had light brown hair, flecked with gray, cut in a "butch" style. His face was more wrinkled and his blue eyes had rather large circles or "bags" under them. I think that he had a round scar on the lower left side of his face and he wore a very serious, almost apprehensive expression. He was slightly taller and wore a gray suit under a black raincoat or trench-coat. He had no hat, but I think he, too. was wearing gloves. I have the impression that they were both wearing scarves, one was dark red; the other was brown, blue and gray plaim. The first man was between 38 to 45 yrs. of age; the second looked older.

I took the picture across the room to look at it under the light from a table-lamp. The two men remained standing just inside the door. The picture was a combination of full face and profile views of a young man, probably in his early thirties. It was a rather ordinary face which would not make a striking, lasting impression. I have the impression that he, too, had a "butch" haircut. At least, it seemed shorter on the sides than the top. He had a dimple in his chin, and I remember noticing his ears particularly. I think that the photo was in a cellophane case, the multiple kind which holds credit cards, etc., but it was folded in such a way that the one picture was all I saw.

...

I teld the men that I could not be sure that I had, or had not, seen such a person. The first man said, "He is a little older now than he was when that was taken. " - As I passed the picture back to him, the second man spoke for the ... first time. He said, "His name is Ray." The first man, who had been facing me, turned his head quickly and threw him a sharp look, as much as to say, - What did you say that for?" This was the definite impression I got, because I had been on the verge of asking what this person was wanted for, but upon seeing that look. I decided to ask no questions. (I am positive that the name was "Ray". because my brother's first name is Ray and I made that connection in my mind.) The first man turned back to me, resumed his smile, and said, "He is a really bad boy. We're very anxious to get him. Do you know any of the tenants next door? Do you have any idea what "flat" he might be in?" I replied that I had known only one of the tenants, but he had moved away just the previous day. I said that, as far as I knew, all the tenants were young men, with the exception of two girls who shared one of the second floor apartments. The second man then spoke for the second time. "They're who we should be talking to!" The first man readily agreed, indicating that if there were girls over there, Ray would have certainly made himself known to them. He asked me if I had seen a white car parked in front of the building recently. I described an off-white car, with red uphelstery, I had seen there recently, but they did not seem to think that it was the one to which they had reference. Apologizing again, and going all through the same explanation of why they had "bothered" me, they left.

I walked out to the kitchen window and saw them cross Ocean Elvd. and get into a dark-colored, late model car. They left the inside car light on and sat there for several minutes looking at a large map. I knew that it must be a map because of its size. I remember wendering why, if they were local police, as they had given me to understand, they would need a map. Then they turned out the light, but did not start the car right away. Just at that time, my husband came in from work. I told him to go back outside to see if a black car, with two men in it, was parked across the street. He returned to say that there was now car at all in the area I had indicated. It was exactly 12:20 A.M.

This whole episode "bugged" me. There was something "wrong" with it. I considered calling the Long Beach Detective Bureau immediately to check on it, but decided against it. I wendered, "Why the raincoats? It was not raining, nor was it chilly. (Such coats are seldom, if ever, seen in this area) Why were they so noisy, if they were actually trying to "catch" somebody? Who let them in next door? If nobody let them in, what were they doing up there so long? I had seen no lights in the building, but I was certain I had heard a door close. Why did they need a map? Why did I have the definite impression that the first man had not wanted the suspect's name divulged? etc. etc.



It was at this point that I started to remember and piece things together, and my story now enters into the realm of conjecture, interpretation and, probably, my own imagination.

Almost every night, from the time we first moved here last October, I had heard the fellow who lives in the second floor apartment of the building next door, on the side facing me, get out, a car at about 3:30 or 1:00 A.M., walk between the two buildings past my window, climb those same stairs and stop. Then T would hear his keys as he unlocked his door. The door would close noisily, his kitchen light would go on, shining down into my window, and I would hear him moving around in his kitchon. This occurrence was so regular and so much the same each night, that it became a sort of habit with me to listen for it before I went to sleep. Shortly after the visit from the two mon, I suddenly realized that this fellow's 'pattern' had changed some time recently. The same wan was still deming home at the same time. I recognized the footsteps going up the stairs and stopping, but he did not unlock the door. It seemed to me that the door was being opened from the inside. Then I remembered that I had heard him speak, one night, saying, "It's me. Let me in." I had idly wondered about it at the time, but had attached no significance to it. It struck me that the lights in that apartment had been turned on during the evening for perhaps the last couple of weeks, where, previously, the windows had been dark. I mentioned this "change in pattern" to my husband, saying, "I'll bet the guy those men were looking for was up there." He laughed at me, telling me I was imagining things.

The fellow who lived in the first floor apartment in the building next door was in the process of moving out on the day President Johnson made his announcement of not running for office again. His first have was "Dick" and, although I did not know him well, I had had several conversations with him. His front door was so close to my kitchen door that I could hear everything that transpired over there almost as well as if I was in the same room. On that afternoon, I heard two fellows come down the stairs and stop at Dick's open door. One of them introduced the other to Dick, telling him that this person had been staying with him for several days. Dick expressed surprise that he had not been aware of the person having been there. I seem to remember that the man was planning to end his visit that evening or the following marning. Although I was not consciously listening to their conversation, I remember some discussion of a trip to Mexico and gathered that tho "visitor" had been there recently. Dick was taking his time about getting his belongings packed into a U-Rent truck, so they stayed over there all afternoon, talking and drinking beer. There was a long conversation about renting a beat. (The may not have been on that same afternoon that I heard it, but I think it was.) Dick's was the only familiar voice to me, so I remember best what he said. He was very much impressed with the size of the boat, the sleeping quarters, etc. He asked about the cost of ronting such a beat, etc. I know that nothing was said about fishing. I gathered that it was ronted for the purpose of taking a rather long veyage or cruise. The two girls, previously mentioned, were also in and out of that apartment all afternoon, talking to the fellows. I distinctly remember that one of the girls said something about one of the men having taken dancing lossens. She seemed to think it was most unusual and rather humorous. From what was said, I realized that she was referring to ballroom dancing. That same evening, after Dick left, there were two or three couples dancing in the livingroom of the aforemontioned eccond floor apartment. (I noticed it particularly, because it had never happened before, since I had lived here, - and it has never happened since.) When I took my dog out that evening, I glanced up at the windows and saw a tallish, slender, dark-haired fellow dancing with one of the girls. I did not recognize As I remember it in retrospect, it was just about that period of time that both my husband and I noticed a late model white automobile parked in a space behind that building. Neither of us is certain about the "make", but it was a compact car. It was there only a few days and has not been seen there since.

any of this with the assassed lon of Varian Luther King until the name "James Earl Ray" was mentioned in the news. Then it really started to bother me as I compared the things I had seen and heard with what I read in the papers. I tried to clearly remember the photograph which had been shown to me that night. If that was a picture of the same "Ray", it was not the same picture as any of those I have seen published, with the proception we are which had been taken of him several years ego. However, because of the coincidences, the subject continued to bother me to such a degree that I finally telephoned the Long Beach Detective Bureau on the afternoon of Yay 2nd or 3rd. I get no satisfaction from the woman I talked with at that time, so I phened back that night. The officerwho enswered told mo that no men from his office had been looking for any man named Ray provious to the death of King. He advised me to call the F.B.T., which I did. The gentleman who answered the telephone in the Los Angeles Office of the F.B.T. that night quite obviously did not believe a world I said. He did assure me most definitely, however, that had any two men come to my door as I claimed, had they been F.R.I. Agents, they MOST CERTAINLY would have identified thomselves QUITE CLEARLY as being from the FFDERAL BUREAU OF INVESTIGATION and 🕾 there would be no subsequent doubt in my mind. I asked him, "If they were not Long Beach Detectives, and they were not F.B.I. Agents, who were they?" He did. not seem to care. I tried to convince him that I was not a nut and was telling the truth, but he ended the conversation by telling me I had better forget the whole thing.

In the June 17th issue of The National Observer, there were four photo-prographs printed on the front page. One of them was the usual one of James Earl Ray wearing the dark-rimmed glasses, but two of the others struck me immediately as looking vaguely familiar. I read underneath to see who they were. I studied the faces, even using a magnifying glass to see them more clearly. In order to help myself, I drew black coat collars on them. That didn't seem to make them look exactly right, so I made their hairlines receded bit. That was better, but it seemed that one of them should have a "butch" haircut, so I gave him one. The more I fooled around with the pictures, the more vertain I became that they were the two men who had come to my door that night looking for a man named "Ray". The two pictures were of the two men whose names James Earl Ray had been using, Rausen George Sneyd and Erio St. V. Calt.

On 7/28/68, at 7:15 p.m., WILLIE JAMES ACGUIRE, who gave his residence as 2747 Central Parkway, Los Angeles, California, telephonically contacted Birmingham Office and claimed he had been standing on balcony of Lorraine Motel close of victim MARTIN LUTHER KING at time "shots" fired, and claimed the "shots" were not fired from rooming house on Main Street, as claimed, but from another building located "behind Goldstein Clothing Store." McGUIRE said he was calling the FBI after being convinced by some friends that he should make his information known to the FBI. These friends had directed him to Mr. KRNEST POOLE, operator of a Negro funeral home in Birmingham who, on behalf of McGUIRE, put McGUIRE in telephonic contact with Birmingham Office. McGUIRE said he was a lease truck driver for Transcon Co., Los Angeles, and was leaving Birmingham at 9:00 p.m.

McGUIRE was contacted at Poole Funeral Home, 7/28/68, by Buagent, and furnished the following:

McGUIRE said he lived at 627 Alameda St., Los Angeles, telephone 827-3581, with his wife and children. He is employed as lease truck driver by Transcon Co., and presently en route to Los Angeles. On "the day KING got shot in Memphis" (exact date unrecalled by McGUIRE), McGUIRE arrived in Memphis with a load about 2:30 p.m. in his

tractor-trailer, en route to Los Angeles. He was accompanied by a helper, JAMES THOMPSON, 1237 Abilene St., Sioux Falls, South Dakota. He parked the tractor-trailer near "3rd and Vance," near the Goodyear Tire Company and also near the "Queen Anne" Motel. He had to wait in Memphis to pick up some freight bills. Between 2:30 p.m. and about 5:45 p.m. he and THOMPSON, in the trailer, drank at least a pint of Seagram V.O. Whiskey, with at least three or four beers. (McGUIRE also advised that prior to contacting the FBI on 7/28/68, he had drunk a "couple of pints of whiskey. I drink a couple of pints every day.") At 5:45 p.m., McGUIRE checked into Room 337 or 347, "on the second floor" of the Lorraine Motel, where he was supposed to meet his "ex-wife," EVELYN JOHNSON, who lives in the 400 block of South Arlene St., JOHNSON never kept the date. Hemphis.

About 6:00 p.m., McGUIRE observed MARTIN LUTHER KING arrive at the metel in a black Cadillac driven by a chauffeur and accompanied by a couple of other associates. KING walked up the stairs from the parking lot to the second floor balcony, where McGUIRE said "Hello." At the time McGUIRE was standing on the balcony looking out towards the parking lot, "just standing, looking, like Negroes do." KING said "Hello" to McGUIRE, as he recognized McGUIRE. McGUIRE said, "I seen him all over the world - he knew me." KING entered the room next door to the room occupied by McGUIRE and stayed in there for at least an hour, perhaps 90 minutes. At that time, KING came out of this room and McGUIRE was just leaving his room to go eat dinner. The chauffeur called up to KING to get a topcoat, as it was getting cool. KING walked back into his room and came out carrying a "brown beige topcoat over his left arm. never forget that topcoat." McGUIRE was looking towards KING when he heard "two shots" come from his left. McGUIRE immediately looked to his left and saw the "flash" come from the second floor of a building located next to the Goodyear store building, a distance of not more than 75 feet. McGUIRE did not see who fired the shots. He then looked back and saw KING lying on the floor. About then, a white man came up and put a sheet over KING.

McGUIRE then immediately left the motel and walked over to Main Street, near the "Goldstein store," where he

observed a pistol on the street. About them, a white policeman picked up the pistol and put it in his squad car.

From there, McGUIRE went to the Queen Anne and drank until 3:00 a.m., when he went to his tractor-trailer parked nearby and went to sleep. At 8:00 a.m. the next day, he and THOMPSON left and drove back to Los Angeles. He stated he never returned to the Lorraine Motel, and had not taken any personal effects with him when he went there originally to meet his "ex-wife." McGUIRE said he was told several times after this by friends (whom he would not identify) that he would be in danger if he told what he knew, and that he had not told anyone what he knew and what he saw until his interview 7/28/68 by the FBI. After telling some Birmingham friends, they told him to contact Mr. ERNEST POOLE, who could give him the proper advice and put him in contact with the proper authorities.

DAVID (JOAN) HEINZ, 415 Calle Granada, Santa Barbara. advised that she and her husband flew from Los Angeles via Mexicana Airlines to Puerto Vallarte, Mexico on Thursday, 10/26/67, arriving at 6:05 PM. They were booked by their travel service at the Hotel Rio, where they had a room on the second floor at an outside street corner of the hotel. They stayed there only one night and because of the noise of truck traffic ousside their window they moved on Friday, 10/27/68 to another hotel, the name of which she recalled as the "Inn of the Jungle", a quarter of a mile away. They stayed there two nights and on Sunday morning, 10/29/68 they flew on to Guadala jara.

She recalled that they had observed no one coming in or out of any rooms at the Hotel Rio and she observed no one who resembled any of the photographs of subject RAY. She recalled no suspicious persons in Puerto Vallerte during the period they spent there and stated that although they observed several North Americans in various bars and dining places and struck up a conversation with one or two, they did not know the names of any other North Americans in town.

She stated that her husband is presently employed by Autonetics, a division of North American Aviation at Anaheim, and that she has sold their Santa Barbara home and will join him in a few weeks.

Interview of Dr. and Mrs. E. G. SCHNEIDER, JR.

Dr. E. G. SCHNEIDER, Dentist, 315 South McClelland Street, Santa Maria, California, who resides at 2189 Lake Marie Drive, Santa Maria, advised on 5/6/68, that he and his wife took a vacation trip to Mexico at the end of October, 1967, and returned to Santa Maria during the first week of November, 1967. He stated they had not planned to stop at Puerto Vallarta but that their commercial airplane stop ed there on account of bad weather, and they had to spend the night. He informed that they spent one night at the Hotel Rio, arriving in the evening and leaving the following morning. He stated that he could not recall the exact date they arrived at the hotel but that it was either one of the last days of October or the first days of November. Further that their room was on the second floor of the hotel but that he cannot recall the room number. He informed that they did not become acquainted with any of the other guests at the hotel, and did not talk with any of the other guests. on 5/6/68 Mr. GELMER C. BOGGS, 10761 Landale St., North Hollywood, furnished the additional information to SA SHAW.

After thinking about the matter, Mr. BOGGS recalled that upon returning to the Hotel Rio In Puerto Vallarte on 10/18/68 he now recalls that starting on Thursday 10/19 for the next three days he saw a white Mustang bearing a Florida license plate and very muddy and dirty parked across from their bedroom window, on the very busy street located in front of the hotel. He saw no one around the car and on the fourth day, the car was gone. He thought it very unusual at the time because it would have been very difficult to drive there because of the bad weather and also it was unusual for a car to set on the street for so long without being moved.

In addition, he and his wife left the hotel on the morning of 10/21/67. While preparing to leave the hotel to go to the airport they observed an American woman, embrace an American man. All they could recall of the man in the hotel lobby is that he was a white, American, slightly taller than the woman, light colored haff, wearing a blue shirt and tan trousers. The girl then rode to the airport with them. She indicated that she was from San Francisco and was then catching a plane to Mexico City. She was described as a white, female in her late 20's, attractive, well built. medium build, appr. 5'6-7", brunet, well mannered and poised. Mr. BOGGS said that he thought it strange that the American man and woman parted at the hotel and he assummed they were both residents at the hotel. He did not recall having seen the man before.

Mr. and Mrs. GELMER C. BOGGS (not Selmer C. Goben, as set forth in ser#969), 10761 Landale St. were contacted on 5/3/68. Mr. BOGGS is and has been a Federal employee the past 21 years with Federal National Mortgage Co. and Mrs. BOGGS is a housewife. They advised that they vacationed in Mexico as follows; they left Los Angeles, 10/11/67 and stayed at Hotel Rio, Puerto Vallarta, Jalisco from 10/12 in room 208 as they recall until approximately 10/15. They then visited in Guadalara, Jalisco returning to the Hotel Rio about 10/20 and returned to Los Angeles about 10/25/67.

They advised that they have visited in Mexico several times and this was but one of several trips to Mexico. They stated that while at the Hotel Rio they did not associate with other Americans as they enjoyed talking and visiting with the "natives". They even ate their meals at the hotel in the bar, rather than the dining room, so as to avoid the American touists and have more time to talk with Mexicans. While at the hotel, they spoke very briefly with two or three other couples, one man being a Mormon professor from Salt Lake City and the other a retired banker. Both were shown available photo's of the subject with his full description however both stated that he was a complete stranger to them and neither recalled having seen or met anyone in Mexico even closely resembling the subject.

Mr. MITCHELL stated that they stayed in the Hotel Rio until 11/2/67. While at the hotel they stayed in adjoining rooms on the second floor; however, Mr. MITCHELL could not furnish the exact room number.

On that date Mr. FULLER stated he is a route man for the "Los Angeles Times" and is co-owner of a Cessna 210 airplane with RAYMOND MITCHELL. Mr. FULLER advised he recalls flying to Puerto Vallarta with his wife and the MITCHELLs around the last of October, 1967. On 5/8/68, at approximately 12:45 p.m. writer and SA CHARLES W. BADGLEY were driving out Wilshire Boulevard. A male white individual was seen running north across Wilshire Boulevard, approximately at the intersection of Sycamore Street and Wilshire Boulevard. This individual had what appeared to be blood running down his face. At the same time another individual was observed running in the opposite direction. The Columbia Bank is located in the immediate vicinity and it was decided to pursue the individual seen running north across Wilshire to determine what the circumstances were. As the vehicle was in the inside lane of traffic, it was impossible for us to turn on Sycamore and pursue the individual, and it became necessary to go one block west to La Brea and turn north. Subsequently, an unknown driver of a tow truck apparently recognized was as police officers and asked if we were looking for the individual involved in a hit and run accident at Melrose and La Brea. After turning up an alley and asking an unknown individual if he had seen theindividual with the blood on his face, he replied that he had jumped over a fence into a residential area. The individual was located by the agents in a yard near an alley behind 640 La Brea. The agents identified themselves as police officers and asked the individual what had happened, and the individual replied, "I hit a car." Then he stated, "I want to talk to a lawyer." At this time a police car drove up and a uniformed officer of the Los Angeles Police Department got out and identified himself as Officer IRWIN, Badge Number 2200. He placed the individual under arrest and subsequently determined that a hit and run accident had in fact occurred near the La Brea - Melrose intersection. IRWIN then transported the individual to

that location and agents also went to that location. At that location officers conducted a search of the individual in order to determine his identity. SHIPP advised that it was determined that there were numerous addresses, obscene pictures, and other materials located in the car at time of recovery.

He examined all available photographs of the subject and states that he has no recollection of having seen him.

The following investigation was conducted by SA Frank T. Callahan at Van Nuys, Calif. 5/3/68

Mr.& Mrs. Gene S. Mantle, 7120 Texhoma, telephone 343-5837 advised that on 11/2/67 they had statted a vacation trip to Mexico for 12 days. They stated that they had spent from the afternoon of 11/2 -7/67 at the Hotel Rio, Puerta Vallarta, Jalisco, Mexico, and had then proceeded on to Mexico City, Mexico where they had stayed until 11/12/67, and returned to their residence.

The Mantles advised that they had met several individuals names unrecalled on the above trip, and that the majority of people were on vacation trips in connection with the fishing derby being conducted during this time in Mexico.

Photographs of subject were exhibited to the Mantles with negative results, and they both advised that they could recall no one at the Hotel Rio or anywhere in Puerta Vallarta who resembled subject in any way.

FTC 44-1574

On May, 1968, JAMES D. WALLACE, SP #75682, born in 1933, said he is the clerk of C Hall. He said he "fell" from St. Louis in 1959 for Armed Robbery and other charges. He was paroled in 1965 and was returned for violation by reason of drunk driving on March 11, 1968.

He said he was raised with JAMES L. OWENS, the "fall partner" of JAMES EARL RAY. He said he knew OWENS in the Penitentiary and saw him on three or four occasions in St. Louis, Missouri, while he was out. He said he recalled that he was C Hall tender when RAY tried to go over the walls and his ladder or rope of something broke about 1966. He said he was not a good friend of RAY's in the Penitentiary and knew him only to speak with him. He said he saw RAY in St. Louis sometime during the summer of 1967. He said it was probably the early part of the summer. He said RAY was with OWENS. He was just coming out of the Jefferson-Gravois Bank, located at the same address. and OWENS were just entering the bank. He stopped and said to them that he was glad he got his money out before they got in. He said RAY laughed and said that "they were putting in". He said his wife was waiting in a car at the curb and he did not stop to talk and he went on out and drove off.

He said he had no way to fix the date. He said he reflected, at the time, that RAY must have escaped because he knew he had attempted to escape and had been "set back" on parole and he had too much time to have been released.

He said he saw OWENS on other occasions. He recalled that in 1966 he went to take a Missouri State Driver's license examination. OWENS was there and they got to talking about the Penitentiary and the examiner made OWENS leave because he apparently thought he was getting answers to the questions. He said the people at the examining station mentioned that OWENS had been there before and caused them some trouble.

WALLACE said that RAY had the reputation of being the type of person who served his time without comment and did not "mess" in the affairs of other people. He said he did not think that RAY would kill anyone as he is just not the type. He also said he has never heard of any organization in the Penitentiary and has never heard the name of COOLEY used in connection with any type of business or "racket" inside the walls and he did not know filed anyone by that name.

He said that inmates have over the years used—LOS ANGELES cigarettes as medium of exchange in lieu of money and they make "parlay" bets on baseball games, horse races and other types of contests similar to bets made with money outside. He said he knew of no "lottery" as such involving cigarettes, but he said this might exist. He said there are "cliques" of prisoners who connive together for various reasons, and who become close associates, but there is no wide-spread organization and never has been to his knowledge. He said he certainly would be in position to know about it if there was and would have no hesitation in saying so if such existed.
