JAMES EARL RAY

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., is one of the FBI's "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his prompt location. Ray has been the subject of a massive search since the gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom FBI wanted notices have been posted determined that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray, who escaped on April 23, 1967, from the Missouri State Penitentiary, is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery.

Possessing an arrest record dating back to 1949, Ray has been convicted of burglary, armed robbery and forging United States Postal Money Orders.

A 40-year-old white male, reportedly born in Illinois on March 10, 1928, Ray is approximately 5'10" tall, weighs from 163 to 174 pounds, has blue eyes and short brown hair. He has a nervous habit of tugging at an ear lobe and his left ear protrudes noticeably.

Described as a "loner and "drifter," with a "rural" quality in his speech, Ray has worked as a baker, laborer and color matcher. He has taken dancing lessons and completed a course at a school of bartending.

THE CRIMES: Ray escaped from the Missouri State Penitentiary, Jefferson City, Missouri, on April 23, 1967, while serving a 20-year sentence for armed robbery and operating a motor vehicle without the owner's permission. He subsequently allegedly conspired, under the alias Eric Starvo Galt, to violate the civil rights of Dr. Martin Luther King, Jr., shot to death on the balcony of a Memphis, Tennessee, motel on April 4, 1968.

THE CRIMINAL: A 40-year-old white native of Illinois, who is known as a "loner" and "drifter" and has taken elaborate steps to establish a false identity, Ray has an extensive criminal record, including convictions for burglary, robbery and forging U.S. Postal Money Orders. Outstanding characteristics include a straight narrow nose, straight and even teeth, a noticeably protruding left ear and a nervous habit of tugging at an ear lobe. He has taken dancing lessons, attended bartending school, enrolled in a correspondence course in locksmithing and traveled widely in a 1966 Mustang recovered in Atlanta, Georgia, a week after Dr. King's murder. Ray likes western and country music, drinks vodka and beer and has worked as a baker, laborer and color matcher.

PROCESS: A Federal warrant issued at Jefferson City, Missouri, on July 20, 1967, charges Ray with unlawful interstate flight to avoid confinement for robbery. Another Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, as Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a citizen.





"TEN MOST WANTED FUGITIVES" PROGRAM

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., has been added to the FBI's list of "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his earliest possible location.

Ray has been the subject of a massive and intensive search since the brutal gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel. One rifle bullet, believed fired from the window of a nearby rooming house, felled the victim.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom wanted notices have been posted in the FBI's Identification Division, succeeded in determining that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray, who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year-old white male, reportedly born in Illinois on March 10, 1928. He is approximately 5'10" inches tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. He has a small scar on the center of his forehead and a scar on the palm of his right hand. He has been described as having a straight, narrow nose and straight and even teeth and to have a nervous habit of occasionally tugging at an ear lobe. His left ear protrudes noticeably.

Acquaintances describe him as a "loner" and "drifter" whose language and diction reflect a "rural" quality and indicate he has had limited education.

He is reportedly a fan of western and country music, drinks vodka and beer, dresses neatly and claims past employment as a merchant seaman and cook on Mississippi River vessels. He is known to have worked as a baker, laborer and color matcher.

He is known as an avid dancer who has taken dancing lessons. He also completed a course at a school of bartending in the Los Angeles area early in 1968.

Ray should be considered armed and extremely dangerous.







On 4/11/68 Dr. IRVING HALL, 712 39th Street W., Bradenton, Fla., telephonically advised the Sarasota RA that between the hours of approximately 8:00 and 10:00 p.m. 4/7/68 he and his wife viewed a television program over channel 3, educational television station WEDU-TV, Tampa, Florida. HALL stated the program was a panel-type discussion concerning the study of the march on Washington that was to be lead by Rev. MARTIN LUTHER KING in the Spring of 1968. HALL stated a white male who was a member of the panel who was sitting on the floor near a Negro who was standing and who was the moderator nade several comments that dealt with KING leading the march. The white male, according to HALL, reportedly made a comment to the effect, "If KING leads the march on Washington the march will be a Negro march and the poor white people will be getting screwed."

HALL stated that upon viewing the artist's conception of the assassin of KING and comparing the description that had been set forth in local newspapers regarding the assassin, he believes the white male on the above television program who made remarks critical of KING's leadership appeared a similar description to the artist's conception of the assassin.



It is noted that one individual, which according to the tape was located in the area of, or next to, the Negro moderator, who was HOSEA WILLIAMS, seemed to be pulling at his left car lobe as depicted in the enclosed excerpt from the film.

CREG SHUKER, Producer, PBL, stated he was in the room during the filming of this sequence of events and identified the location as Paschal's Hotel, located on Hunter Street, Atlanta, Georgia. He stated he personally recalls most of the participants in the discussion other than the man with his hand up to his ear. He stated that the Southern Christian Leadership Conference Headquarters (SCLC) in Atlanta is believed to have a list of all persons attending this discussion. He stated that the events took place on 3/14/68 and that BILL RUTHERFORD, Executive Director, and TOM OFFENDERG, Public Relations, SCLC, Office # (404)-522-1420, possibly could furnish names of all persons in the room. RUTHERFORD's home number was given as 523-3381 and that of OFFENDERG, who is Director of the March as 522-1425.

SHUKER stated that other groups and races of people were meeting at the time in the same motel in connection with the upcoming march, but indicated that the group in question was basically white and that HOSEA WILLIAMS came in late only to answer their questions and to convince them that KEM would lead and speak for all the poor people, regardless of race, in the March on Washington.

SHUKER is in the process of preparing a copy of the entire tape for the FDI which is to be made available to the MYO possibly today, 4/22/68.



SLAYER OF DR. KING STILL ELUDES FBI OFFICERS

It is disappointing that the man who murdered Dr. Martin Luther King on April 4 has not been apprehended. There is every indication that the Federal Bureau of Investigation has been making a diligent effort to solve the mystery but the man with the trigger finger continues to elude law officers.

It seemed that progress was being made when it was announced that a fugitive warrant had been issued for the arrest of a man named "Eric Starvo Galt." Two days later the FBI identified "Galt" as James Earl Ray, who escaped from a Missouri prison April 23, 1967.

The thoroughness of the FBI in its search for the wanted man is indicated by the fact that 53,000 sets of finger prints in FBI files were examined before prints were found that are identical with those of the man named Galt.

The prestige of the FBI is at stake and will nost likely be sustained eventually. It will be fortunate if the murderer may be taken alive and his guilt clearly established. This would prevent speculation as to identity of the guilty person and avert such uncertainty as surrounded the assassination of President Kennedy.
