APRIL FOUR INSTANT. CLAIMED PREVIOUS FEDERAL SENTENCE FOR CHECKS AND THAT HE ASSISTED FBI AND SECRET SERVICE, CLEVELAND AND COLUMBUS, OHIO, IN FEBRUARY SIXTY-SIX RE SUPPOSED PLOT TO ASSASSINATE VICE-PRESIDENT HUMPHREY. CLAIMS TO BE PART-TIME WRITER, WHO TRAVELS A LOT AND DESIRIOUS OF HELPING HIS COUNTRY. CHICAGO HAS HAD NO PREVIOUS CONTACT, RELIABILITY UNKNOWN.

CLAIMS HE ARRIVED MEMPHIS MARCH TWENTY-SIX LAST, PENDING MARCH BY MARTIN LUTHER KING. HE TALKED FREELY TO NEGROES REPRESENTING HIMSELF AS CBS REPORTER, AND WITNESSED MARCH FROM SECOND FLOOR WINDOW ON BEALE STREET. MADDEN ATTENDED FUNERAL OF NEGRO YOUTH SHOT DURING RIOTING. THEREAFTER, HEARD CHARLES STEPHENS NEGRO MALE, SIXTEEN YEARS AND PAUL JOE ADKINS, ALSO KNOWN AS LITTLE JOE, NEGRO MALE, SEVENTEEN YEARS.

ADDRESSES UNKNOWN, ON SEPARATE OCCASIONS, SAY THAT YOUTHS DID NOT INTEND TO FOLLOW KING AGAIN, BUT INTENDED TO BECOME MORE MILITANT. THEY WERE RESENTFUL OF WHITE POWER STRUCTURE, LACK OF PUBLIC SERVICES AND POLICE BRUTALITY. MADDEN COULD FURNISH NO SPECIFIC PLANS OR IDENTIFY FURTHER INDIVIDUALS, HOWEVER, IS OF OPINION THAT IF GOVERNMENT STOPS KING FROM MARCHING YOUTHS WILL BECOME VIOLENT EVEN THOUGH THEY WILL PROBABLY NOT FOLLOW HIM.

MADDEN ADVISED THAT HE INTENDS TO RETURN TO MEMPHIS TO BE THERE FOR SECOND REPORTED MARCH BY KING. NO REQUESTS WERE MADE OF HIM, BUT HE ADVISED HE WOULD CONTACT MEMPHIS OFFICE RE ANY INFORMATION OBTAINED BY HIM.

MADDEN FURNISHED UNDEVELOPED FILM AND TAPE RECORDING REFLECTING OBSERVATIONS OF CONDITIONS IN MEMPHIS. CHICAGO WILL FORWARD TO MEMPHIS BY SEPARATE COMMUNICATION.

MADDEN IS FIVE FOOT SIX INCHES, ONE FIFTY POUNDS, LIGHT BROWN THINNING HAIR, DRIVING NINETEEN SIXTY WHITE RAMBLER WITH CALIFORNIA LICENSE. DURING PREVIOUS VISIT TO MEMPHIS HE ASSOCIATED GOOD DEAL WITH RAY KEISLING, KEISCO PHOTOGRAPH, THREE NINE NINE ZERO PARK AVENUE, MEMPHIS, AND AGAIN END PAGE TWO

MADDEN CONTACTED CI OFFICE AND ADVISED HAD PREVIOUSLY OPERATED SMALL ANTI-COMMUNIST NEWSPAPER IN COLUMBUS, OHIO, WHICH HE HAD CLOSED DUE TO FAMILY PRESSURE AS A RESULT OF THREATS FROM UNSUBS CLAIMING MEMBERSHIP IN COMMUNIST PARTY.

MADDEN STATED HE HAD TRAVELLED TO CLEVELAND IN FALL OF SIXTYSIX WHERE HE HAD DEVELOPED INFORMATION REGARDING ASSASSINATION THREAT TO VICE PRESIDENT HUBERT HUMPHREY. CLAIMED TO HAVE PROVIDED THIS INFORMATION TO USSS. CLEVELAND.

MADDEN STATED AFTER LEAVING CLEVELAND, WENT TO CALIFORNIA

TO ESCAPE PRESSURE FROM COMMUNIST AGENTS, AND SUBSEQUENTLY RETURNED

MADDEN, AT TIME OF EXTORTION COMPLAINT, STATED EMPLOYED AS ATTENDANT, LONGVIEW STATE MENTAL HOSPITAL, CINCINNATI. CLAIMED SUPERINTENDENT, LONGVIEW HOSPITAL HAD RECEIVED LETTER FROM UNSUB USING NAME ANDREW O. BERNHARDI, SECURITY AGENT FOR SPARTICUS PARTY. LETTER TOLD LONGVIEW OFFICIALS TO FIRE MADDEN AS MADDEN WAS A "CAPITALIST DOG WHO DEGRADED HEROIC PEOPLE OF NORTH VIET NAM AND CHINA."

ORIGINAL OF THIS LETTER OBTAINED FROM LONGVIEW HOSPITAL AND SUBMITTED TO FBI LABORATORY, WHO HAD ADVISED LATENT FINGER-PRINTS OO MADDEN FOUND ON ORIGINAL LETTER. OFFICIALS AT LONGVIEW HOSPITAL STATED MADDEN NEVER HAD ACCESS TO ORIGINAL LETTER.

ATTEMPTS THEN MADE BY CI TO REINTERVIEW AND OBTAIN HANDWRITING SAMPLES FROM MADDEN. HE REFUSED AND LEFT CINCINNATI FOR UNKNOWN DESTINATION IN CALIFORNIA.

MADDEN'S MOTHER INTERVIEWED, ADVISED HER SON "HAS NERVOUS PROBLEM AND IS SICK". MADDEN PREVIOUSLY CONVICTED OF ITSPP IN KNOXVILLE AND CONFINED IN FEDERAL REFORMATORIES AT CHILLICOTHE, OHIO AND TERRE HAUTE, INDIANA. MOTHER CLAIMS MADDEN FALSELY CONVICTED OF ITSP CHARGE AND BASES THIS STATEMENT ON HIS WORD TO HER.

AT APPROXIMATELY SIX ZERO THREE PM, KING WAS ON SECOND FLOOR BALCONY OF LORRAINE HOTEL AND MOTEL, FOUR ZERO SIX MULBERRY, MEMPHIS, PREPARING TO GO TO DINNER. A SHOT WAS HEARD BY KING'S ASSOCIATES, WHO WERE AT STREET LEVEL. KING WAS OBSERVED TO FALL IMMEDIATELY AFTER SHOT. KING WAS TAKEN TO ST. JOSEPH HOSPITAL IMMEDIATELY. DRS. J. N. BARRASSO AND FREDERICK GIOIA, ST. JOSEPH HOSPITAL, INFORMED THAT KING WAS PRONOUNCED OFFICIALLY DEAD AT SEVEN ZERO FIVE PM. APRIL FOUR LAST. THEY STATE DEATH CAUSED BY BULLET TEARING MAJOR NECK VESSELS AND SEVERING SPINAL CORD AT THE ROOT OF THE NECK.

ASSOCIATES OF DR. KING STATE BEFORE SHOOTING. POLICE OFFICERS WERE IN AREA PATROLING AND THAT SHORTLY AFTER ONE CAR OF OFFICERS HAD PASSED, DR. KING WAS SHOT. MOMENTARILY AFTER
