

INDICATING THAT THE SHOT HAD PROBABLY BEEN FIRED FROM THE REAR OF ONE OF THE BUILDINGS OF THE FOUR HUNDRED BLOCK OF MAIN STREET, THE OFFICERS ON THE SCENE BEGAN TO POINT AND SHOUT IN THE GENERAL LOCATION OF THE ROOMING HOUSE AT FOUR TWO TWO AND ONE-HALF SOUTH MAIN STREET. THEREAFTER, SOME OF THESE OFFICERS WHO HAD STARTED TOWARD THE SCENE TO THE LORRAINE MOTEL TURNED AROUND, RAN WEST TO MAIN STREET, THEN NORTH ON MAIN TO VICINITY OF CANIPE AMUSEMENT COMPANY AND THE ROOMING HOUSE.

OFFICERS STATED THAT THE TIME OF THE SHOOTING WAS APPROXIMATELY FIVE MINUTES AFTER SIX P.M.
