Dear Sirs:

I am a teacher and a graduate student in psychology who has an acquaintance, a woman who has shown a remarkable gift of what I consider extra-sensory-perception. She has been called in on two police problems which had very few leads and was able to be of considerable help.

She now has strong feelings about and has had visions pertaining to the ones responsible for the slaying of Dr. King in Memphis. She sees the one who ordered the killing as a fairly important member of the Klu Klux Klan. He has a round heavy face, rather florid, with eyes that are usually blood-shot from drinking, a long sharp nose and a feature that is rather striking, a hair lip or at least a lip that resembles a hair lip.

The one who did the killing is slender with sandy hair, a pale face(possibly only at the time of the killing) and is mentally unbalanced. He is accompanied by a girl with long blond hair who wears sun glasses most of the time. The killer also had dealings with the KKK before or was a previous member. He no longer is a member.

Accompanying this letter are three short notes which my friend has written and analysed to help confirm what has come to her through visions and thoughts. Note the circled letter in the bottom note. Could it be a symbol for a 44-1987-5 position in the KKK?
