LAWRENCE BUNDY, SUPERVISOR, TEEN CENTER, DECATUR, ILLINOIS; FIRST PRESBYTERIAN CHURCH, STATED HE INTRODUCED HIMSELF TO THE INDIVIDUAL WHO APPEARED AT THE CHURCH ON THE NIGHT OF FIVE TWENTYEIGHT LAST WHEN THE TEEN CENTER GROUP WAS LEAVING AND HE NOTICED THE PERSON APPEARED DRUNK AND WAS UNABLE TO TALK DISTINCTLY. THIS PERSON WAS SEARCHING FOR WORDS AND HIS MIND APPEARED TO GO ADRIPT. BUNDY NOTED HE GAVE HIS NAME AS STEVE REYNOLDS AND HE FIRST STATED "I AM NOT IMPORTANT" AND KEPT COMMENTING THAT THE GROUP WAS DOING A FINE JOB. THIS PERSON MENTIONED THAT HE WAS FROM PEORIA. BUNDY STATED THIS INDIVIDUAL KEPT BATTING HIS EYES. BUNDY MENTIONED THAT IT WAS DARK AND HAD BEEN RAINING. HE STATED THAT HE DID NOT SEE THE PERSON COME OR LEAVE AND AFTER VIEWING NUMEROUS

JAMES SMITH, SUPERVISOR, TEEN CENTER, STATED HE DID NOT SEE THE PERSON PARK HIS CAR, HOWEVER, HE NOTICED THE CAR WHICH APPEARED TO BE A FOUR DOOR FORD OR PLYMOUTH, WHITE OR LIGHT TAN IN COLOR WHICH WAS NOT A COMPACT OR A BIG MODEL CAR. HE MENTIONED THAT THIS PERSON WAS APPARENTLY PASSING AND SAW ALL THE YOUTHS AROUND THE CHURCH AND DECIDED TO STOP AND SEE WHAT WAS GOING ON FOR HE LEFT THE CAR MOTOR RUNNING WITH THE HEADLIGHTS ON. THE CAR WAS PARKED ACROSS THE STREET FROM THE CHURCH. SMITH STATED THE PERSON INTRODUCED HIMSELF TO SMITH WHICH ^ANAME HE DOES NOT RECALL. HOWEVER, IT DID NOT APPEAR TO SOUND THE SAME AS THE NAME HE PREVIOUSLY GAVE WHICH NAME HE DOES NOT RECALL. HE STATED THE PERSON APPEARED DRUNK OR WAS ON DOPE AND HE DID NOT TALK DISTINCTLY. THIS PERSON COMMENTED THAT HE THOUGHT THIS GROUP WAS DOING A FINE JOB. THEN AT ONE TIME IN THE CONVERSATION HE MENTIONED HE WAS FROM PEORIA. SMITH MAINTAINS HE COULD NOT TELL THE FEATURES OF THE PERSON FOR IT WAS DARK WHERE THEY WERE ALL STANDING AND IT HAD BEEN RAINING. THIS PERSON STOOD AROUND FOR APPROXIMATELY

FIVE OR TEN MINUTES, THEN WENT BACK TO HIS CAR AND LEFT AT A MODERATE SPEED. SMITH ADVISED AFTER VIEWING NUMEROUS PHOTOGRAPHS OF RAY THAT HE COULD ^{IN NO WAY} ~~NOT POSITIVELY~~ IDENTIFY THIS PERSON AS RAY.

JOE J. SLAW, SUPERVISOR, DID NOT SEE THE PERSON UNTIL HE NOTED HIM STANDING WITH A GROUP OF SUPERVISORS. HOWEVER HE SAW THE CAR PARKED ACROSS THE STREET AND NOTED THE MOTOR WAS RUNNING AND THE LIGHTS WERE ON. THIS CAR APPEARED TO BE A LIGHT BLUE TWO DOOR FORD, PLYMOUTH OR DODGE. SLAW STATED HE THOUGHT THE PERSON WAS DRUNK HOWEVER HE COULD NOT SMELL LIQUOR. THE OTHER SUPERVISORS KIDDED THIS PERSON AND SUPERVISOR SMITH MENTIONED THE GUY WAS ON DOPE FOR HE APPEARED TO FEEL NO PAIN. SLAW MENTIONED THAT HE THOUGHT HE HEARD THIS PERSON GIVE HIS NAME AS STEVERINO AND ALSO HEARD HIM SAY THIS IS A NICE GROUP. SLAW STATED THAT HE FELT THE PERSON WAS DRUNK AND SAW THE GATHERING SO STOPPED BY TO SEE WHAT WAS GOING ON AND HE (SLAW) PAID NO PARTICULAR ATTENTION TO HIM. HE STATED THE PERSON DID NOT LOOK LIKE THE PHOTOGRAPHS OF RAY.

JOSEPH G. BLACK, SUPERVISOR, STATED HE WAS NEVER CLOSER TO THE PERSON THAN FIFTEEN FEET AND IT WAS DARK SO HE COULD NOT TELL WHAT THE PERSON LOOKED LIKE. HE HEARD THE PERSON SAY "WELL I GOT TO GO", AND TOOK OFF ACROSS THE STREET. BLACK STATED THIS IS THE FIRST TIME HE NOTED THE CAR ACROSS THE STREET WITH THE MOTOR RUNNING AND LIGHTS ON. THIS CAR APPEARED TO BE LIGHT BLUE IN COLOR, MAKE AND MODEL UNKNOWN. BLACK STATED THAT BECAUSE OF THE TYPE OF TEEN CENTER THE CHURCH IS OPERATING NUMEROUS PEOPLE STOP BY TO OBSERVE AND THE GROUP HAS ALSO HAD SEVERAL INCIDENTS OCCUR WHEN THE GROUP WAS BREAKING UP AND BECAUSE OF THIS THE SUPERVISORS ARE ALWAYS ON EDGE. BLACK VIEWED PHOTOGRAPHS OF REY BUT STATED HE COULD MAKE NO IDENTIFICATION FOR HE WAS TOO FAR AWAY.

REV. M. HARRIS OF DECATUR AREA COUNSEL OF CHURCHES AND SUPERVISOR STATED HE COULD NOT FURNISH ANY ADDITIONAL IDENTIFICATION IN THIS MATTER FOR HE WAS TOO FAR AWAY. THE CAR DRIVEN BY THE INDIVIDUAL WAS DESCRIBED AS A LATE MODEL CHRYSLER PRODUCT, RAMBLER, PLYMOUTH, DODGE OR FORD, TWO DOOR
