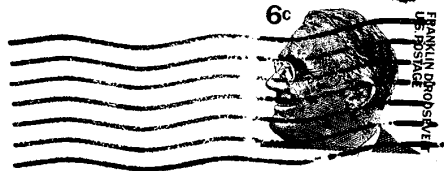

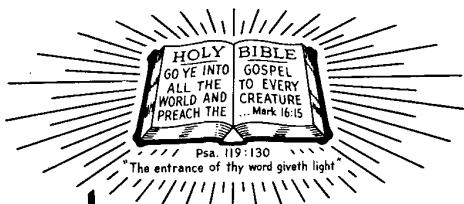

GOD'S SIMPLE PLAN OF SALVATION

PRAY—You talk to God. **READ YOUR BIBLE**—God talks to you. **WITNESS**—You talk for God.

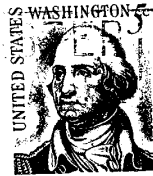

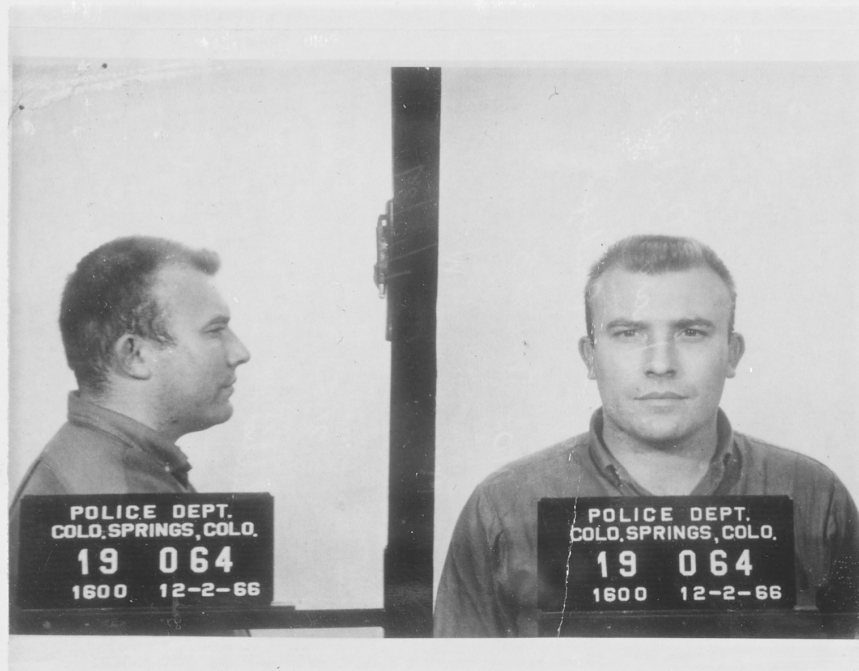

to control our schools," "We want our children educated," and "Closed by PTA."

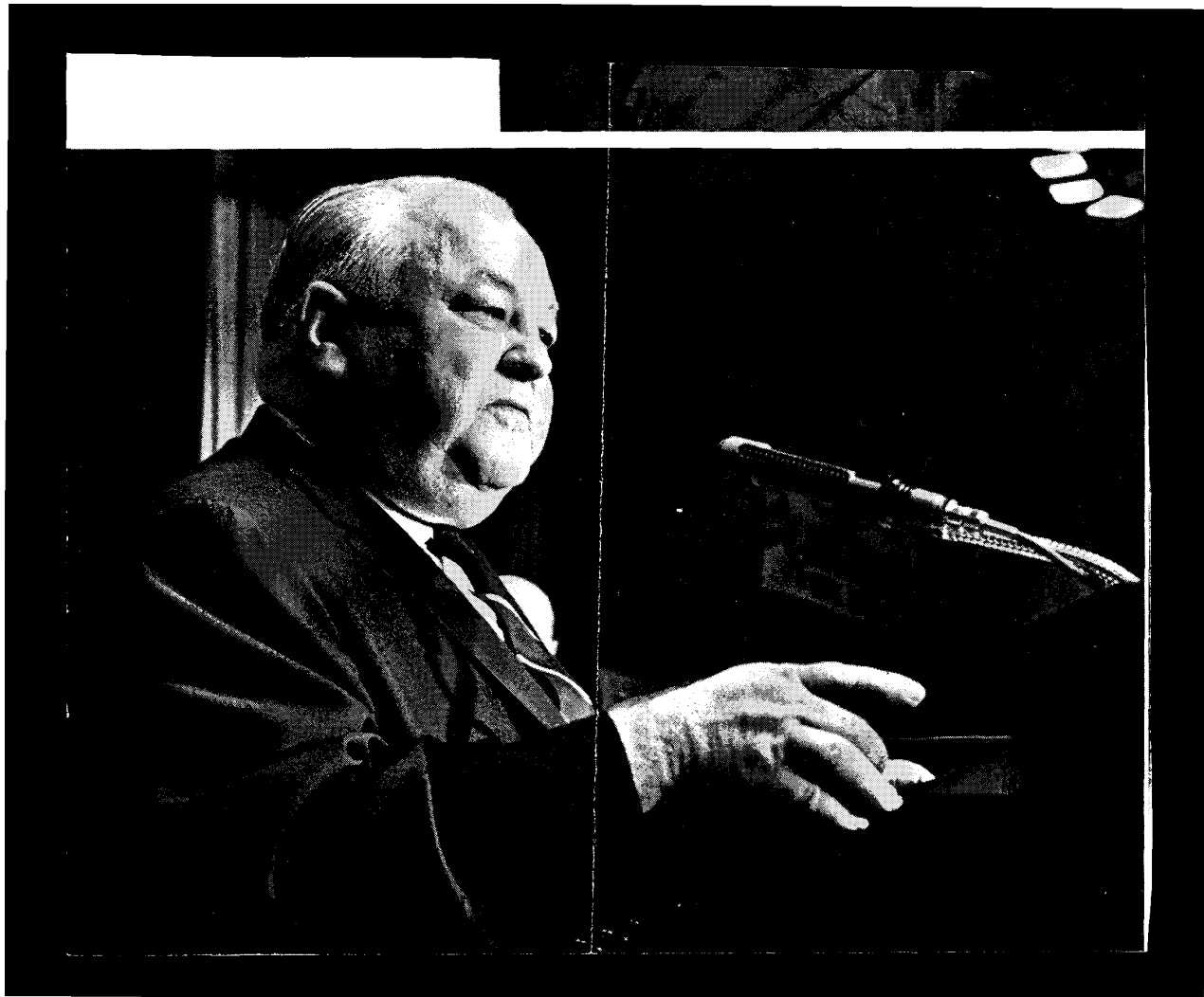
At Intermediate School 55, a few blocks away at 2021 Bergen Street, 26 of the school's 1,440 pupils showed up in the morning. But within an hour, 14 were taken home by their parents. The remaining pupils were shown films in the school auditorium while most of their teachers sat in empty classrooms.

Outside the largely windowless four-story building, which was opened on Feb. 1, a few children played in the streets. One youngster poked through the rubble of a building that had been razed by fire during Tuesday night's disorders until an adult chased him away.

For the most part, however, the littered streets were empty of schoolchildren. A mother explained that most of the parents were keeping their chil-

If you decide to answer questions now without a lawyer present, you will still have the right to stop answering at any time. You also have the right to stop answering at any time until you talk to a lawyer.

WAIVER OF RIGHTS

I have read this statement of my rights and I understand what my rights are. I am willing to make a statement and answer questions. I do not want a lawyer at this time. I understand and know what I am doing. No promises or threats have been made to me and no pressure or coercion of any kind has been used against me.

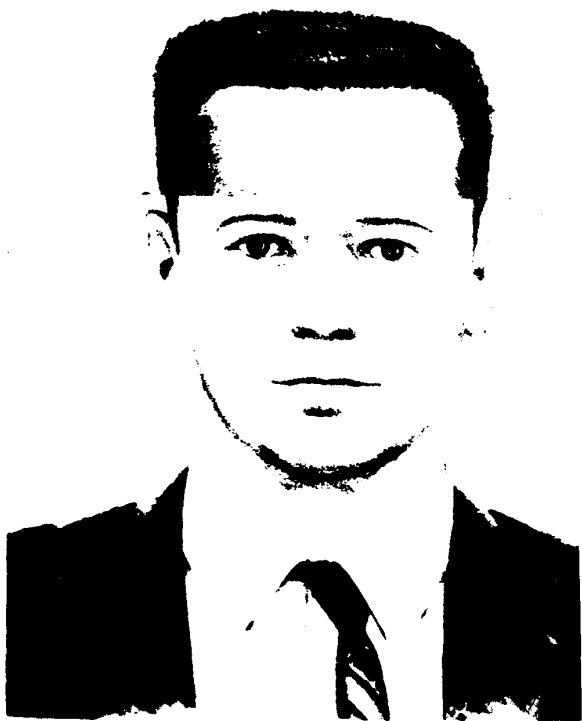
