RICHARD TOMETHSON, 97 Union Avenue, Saratoga Springs, New York, President of the Delaware Corporation, a small vending machine company, advised SA DANIEL V. HOGAN that he has an acquaintance named NELSON SCHAUB of Saranac Lake, N.Y. SCHAUB, according to TOMKINSON, is a coin dealer, recently convicted of smuggling gold into the United States, who is always looking for a chance to make big money. SCHAUB told TOMKINSON that he had an idea which might make a lot of money for both of them. SCHAUB said that the United States Government was offering a reward of \$100,000.00 for JAMES EARL RAY, killer of MARTIN LUTHER KING. SCHAUB was aware that there was a far right group in Lake Placid, W.Y., which included many prominent local people. This group included doctors and lawyers. It had recently sponsored a speech at the Lake Placid Arena by a former member of the "Green Berets", the Army Special Services Force. That speech and the talks of those who introduced and thanked the speaker, was very critical of United States policy in Vietnam.

SCHAUB had heard some people in Lake Placid discuss the death of MARTIN LUTHER KING and he felt they were not unhappy at KING's death and said they felt he had probably had his appearance changed and was out of the country.

He told TOMKINSON that if the United States Government would investigate this group which he believed to be a John Birch Society group, the Government might obtain information regarding the KING killing and SCHAUB and TOMKINSON could share in the reward money.

Local and New York State Police in the Saranac Lake and Flattsburgh areas characterise SCHAUB as a "con-man", of absolute unreliability.

SCHAUB was located and interviewed by SA EDWARD A. MC SHANE, Jr. on 6/7/58, at which time he stated that he had absolutely no reason to suspect anyone or any group in the Lake Placid, W.Y. - Saranac Lake, W.Y. area of involvement in the King Killing, but feels that such a group might be responsible for KING's death.

In view of SCHAUB's poor character, and history of unreliability, no further action is being taken.

RE: Witnesses In Unsolved Bank Robberies

During the period from April 23 1967 - April 4, 1968 Denver experienced three bank robberies which are presently unsolved in which witnesses are available.

It is noted that there are no unsolved bank burglaries in which eyewitnesses are available.

Photographs of JAMES EARL RAY were shown to the witnesses, who advised that RAY is not identical with the bank robbers.

RE: Unidentified Deceased Persons

On May 16, 1968, Mrs. VERA WOODS, Colorado State Department of Public Helath, Bureau of Vital Statistics, Denver, Colorado, advised Investigative Clerk ROLLO.J. TRUMBULL, JR. that her files for 1968 contain no record of an unknown deceased male who would be identifiable with JAMES EARL RAY.

On May 17, 1968, Mrs HELEN WILLMSCHEN, Bureau of Vital Statistics, State of Wyoming Health Department, advised Special Agent ROBERT C. GUSTAFSON that her office maintains death certificates on unidentified persons, however, there have been no such deaths since April 5, 1968. She stated that in each death in the state, each county coroner is required to submit a death certificate to her office within ten days. In the event a person dies and his identity is unknown, it is the responsibility of the county coroner and the sheriff to establish his identity. She stated that if any death certificates are received for unidentified bodies she will notify the Denver Office.

By communication dated May 20, 1968, the San Antonio Office of the FBI advised that a long-distance call was placed from a public telephone bearing telephone number 379-9059, which was located on Highway 90 or Interstate Highway 10 in Texas. The call was placed to telephone number 641-1586, Gunnison, Colorado on December 17, 1967.

On May 23, 1968, Mr. and Mrs. FRED GLASS, who live west of Gunnison, Colorado, advised Special Agent RAY M. HICKMAN that they have telephone number 641-1586 and that they have many relatives in the San Antonio, Texas area from whom they usually receive telephone calls rather than letters Mrs GLASS stated that she has a niece who had been having marital troubles during December. 1967 and that the niece had called her on several occasions from San Antonio. She could not recall the specific dates, but was sure that the calls were around the 17th of December.

Mr. GLASS stated that he is a contractor and that he receives many calls from all over the country. He stated that most of the time, calls are made to his office but occasionally a call will come to his home. He keeps no record of such calls and it is his belief that the call in question came from some relative of his wife.

Both Mr. and Mrs. GRAY stated that they do not know JAMES EARL RAY and that they had never heard of him prior to the publicity concerning the assassination of Dr. MARTIN LUTHER KING. They stated that they had never seen anyone identical with the person pictured on the Identification Order of the FBI.

RE: Check of Salvation Army and Other Charitable-type Missions

The Citizen's Mission, 1617 Larimer Street; the Baptist Mission, 1616 Larimer Street and the Denver Rescue Mission, 1818 Larimer Street, all Denver. Colorado, were previously contacted regarding the whereabouts of JAMES EARL RAY.

On May 22, 1968, the Salvation Army, Harbor Lights Center, 1736 Larimer Street; the Salvation Army Installation at 1200 Larimer Street and the Mile High Club, 2206 Larimer Street, Denver, were contacted for this same purpose by Special Agent G. HOWARD CARTER. None of the persons contacted were able to identify RAY with anyone they had seen and each expressed his willingness to be on the lookout for the subject.

RE: EDGAR EUGENE BRADLEY

On May 23 1968, REX H. BASINGER, 1416 Downing, Apartment 2, Denver, Colorado, advised Special Agent BOYD D. ADSIT that he received a collect call from EDGAR EUGENE BRADLEY in Tulsa, Oklahoma about 1:00 PM, May 17, 1968. BASINGER stated that he grew up with BRADLEY in Rudy, Arkansas and attended school with him in Alma, Arkansas. He stated that BRADLEY left high school to join the Navy in 1933 and that he has seen him once since, which was in December, 1963 or January, 1964, in Dallas, Texas. He stated that he accidentally met him in a tavern in Dallas.

BASINGER described BRADLEY as 5'11" tall, stocky build, blond hair, freckles, unknown tattoos, 180 pounds and 51 years of age. He stated that BRADLEY has a mother in Rudy, Arkansas, whose name may be Mrs. JOE "JAKE" FINE.

BASINGER claimed that during the call on May 17, 1968, BRADLEY appeared to be drunk and to be calling from a tavern. He thought that perhaps BRADLEY had relations in Tulsa, Oklahoma. He stated that BRADLEY indicated he might be passing through Denver sometime in the near future.

During the conversation, BRADLEY asked BASINGER if E.SINGER had seen him on CBS TV and indicated that he was one of those indicted by District Attorney GARRISON of New Orleans, who GARRISON claims to be involved in the JOHN F. KENNEDY assassination conspiracy. BRADLEY commented that "we famous people run together" and stated that he had been living in Tulsa with ERIC GALT for about a week. BASINGER stated he asked BRADLEY who GALT was and BRADLEY replied by asking BASINGER if he had heard of JAMES RAY. When BASINGER stated he had not heard of RAY, BRADLEY reportedly said that he was the one who "knocked over KING, JR.".

BASINGER stated he tried to determine where remains BRADLEY was staying, but was unsuccessful. He believed that BRADLEY was once on the West Coast possibly in San Jose, California, where he preached as a non-denominational preacher. During the conversation, BRADLEY indicated that he might be returning to the West Coast.

On May 23, 1968, BASINGER advised that he had received another telephone call from BRADLEY at 7:10 AM that morning. He stated that the telephone call was cut off for an unknown reason, but was not a collect call. BASINGER believes that the call was charged to someone in Fort Smith, Arkansas, from where it originated. During the conversation, BASINGER said that BRADLEY indicated he had been eating at the Old South Restaurant, 714 Towson Avenue, Fort Smith, Arkansas, which restaurant is run by a cousin of BASINGER, Mrs ELBA BASINGER THOMPSON. BASINGER was of the opinion that the call had been placed from that restaurant. BASINGER said that BRADLEY indicated he had traveled to Fort Smith to see the results of a recent tornado in that area and that he planned to head west after leaving Fort Smith.

RE: WILLIAM MOLLETT

On June 2, 1968, Mrs ETHEL T. GEORGE, 1922 Grant, Denver Colorado, the address of the Grant Hotel, telephone number 623-4461, advised Special Agent FREDERICK M. VOLZ that she is assistant manager of the Grant Hotel and resides in Room 2. She stated that she has a private telephone, which has the telephone number 623-4461. She stated the only other telephone is listed to the Grant Hotel.

She stated that WILLIAM MOLLETT stayed in Room 24 by himself for two months and moved out approximately six weeks ago to herd sheep, possibly in Montana. She did not know his employment while in Denver.

She advised that MOLLETT used her telephone to call his brother or sister in Kentucky and she exhibited a telephone bill showing that a call was made to Melvin, Kentucky, telephone number 606-938-2468 on April 5, 1968. The bill was \$1.35, which Mrs. GEORGE said MOLLETT paid to her in cash. She recalls that the conversation was about relatives and that some relative had died. She stated that this was the only time that MOLLETT used her telephone.

She described MOLLETT as 5'5" tall, slim build, approximately 55 years old, with grey hair. She was shown a photograph of JAMES EARL RAY and she advised that MOLLETT is definitely not RAY.

RE: Robert Edward Byrne V

On May 24, 1968, during the interview of Mrs. HOMER LANE BIGELOW, 4331 East Mexico Street, Denver, Colorado, Mrs. BIGELOW made available 102 colored photographs which she stated were pictures taken during their trip to Acapulco. Among the photographs was a full view of the yacht ULTIMA II, and a close-up view of a portion of the yacht with a reddish-mahogany speedboat tied to it. No crewmen were visible in either picture.

On May 24, 1968, the following Police Department record, number 53936, FBI number 909511A, was obtained from the Denver Police Department, Denver, Colorado, by SA THOMAS H. WISEMAN. This record relates to ROBERT EDWARD BYRNE, and shows that on October 1, 1954; August 3, 1956; August 24, 1957; and October 16, 1964, BYRNE was arrested for drunkenness and was fined \$10.00 in each instance, the first three fines being suspended. On June 1, 1966, he was arrested for investigation of Driving under the Influence, which charge was changed to violation of Colorado State Code 6107. This charge was dismissed on April 5, 1967, and was reduced to a charge of reckless driving, for which BYRNE paid a \$75.00 fine. The record further reflects that on January 27, 1968, he again was arrested but the charge and disposition is not recorded.

The Police Department record indicated that BYRNE is a white male, 6'5" tall, 198 pounds, born on in New York City, New York. The record contained a letter from Detective Sergeant C. M. MYERS, New Jersey State Police, mailed on August 15, 1956, which indicated that on October 23, 1951, BYRNE was charged with Atrocious Assault and Battery, but the charge was dismissed in court in Egg Harbor Township, Bargain Town, New Jersey.

The record also contained a letter form Mr. FRANK E. SULLIVAN, Atlantic City, New Jersey, Police Department, post-marked August 15, 1956, which indicated that on April 23, 1949, BYRNE was charged with investigation of Assault and Battery, which charge was dismissed April 25, 1949, in Municipal Court.

On May 24, 1968, the Master File Section, Motor Vehicle Division, Department of Revenue, Denver, Colorado, was checked by SA THOMAS H. WISEMAN, and the driving history for ROBERT EDWARD BYRNE, under driver's license number Y924, indicated traffic violations on October 29, 1964; December 18, 1964; April 4, 1965; and June 1, 1966. Fines were paid in each instance, running form \$9.00 to \$75.00.

Records of the Retail Credit Men's Association, Denver, Colorado, were checked on May 23, 1968, by SA THOMAS H. WISEMAN, concerning ROBERT E. BYRNE. The records showed that BYRNE was a graduate of Cornell University, and was in the U. S. Marine Corps for five years. He was listed as self-employed in the oil business since college and claimed earnings of \$23,000.00 per year as of December 17, 1956. The file indicated that an Internal Revenue Service lien was filed against him in January, 1963. The file contained several bad credit reports and indication of suits having been filed against BYRNE.

On May 29, 1968, Mrs. ELDORAH HOLM, Records Department, Jefferson County Sheriff's Office, advised SA BOYD D. ADSIT that there was no arrest record on file concerning ROBERT EDWARD BYRNE or JAMES WILLIS HEYER.

On May 23, 1968, Mr. BUEL O'LOUGHLIN, Identification Division, Denver Police Department, advised SA THOMAS H. WISEMAN that JAMES WILLIS HEYER has Denver Police Department number 148418. HEYER was arrested March 7, 1968, for disturbance, interference with police officer, and using filthy language. The case is presently pending. Mr. O'LOUGHLIN advised that no record was on file concerning HAL HALE, BERNICE PAULSEN, RAY RYAN, or Mr. or Mrs. HOMER LANE BIGELOW.

Files of the Denver Office indicate that JAMES WILLIS HEYER, born at Denver, Colorado, was Assistant U. S. Attorney in Denver, Colorado in the mid-1950's, and was later a Municipal Judge, Denver, Colorado.

On May 24, 1968, the Master Files Section of the Motor Vehicle Division, Department of Revenue, Denver, was checked by SA THOMAS H. WISEMAN concerning JAMES WILLIS HEYER. The driver history record under driver's license S332493 indicates that HEYER was cited for various traffic violations on seven occasions between October 26, 1964, and February 2, 1968. Fines were paid in each instance, ranging from \$5.00 to \$25.00.

Files of the Retail Credit Men's Association, Denver, as checked on May 23, 1968, by SA THOMAS H. WISEMAN concerning Mrs. HOMER LANE BIGELOW, indicated that Mrs. BIGELOW has an unsatisfactory credit standing in the community and has numerous department stores indicating that her accounts are being handled very slowly.

Mr. FRANK F. BACHELLER, Bacheller Real Estate, 666
Sherman Street, Denver, Colorado, advised that he has known
ROBERT EDWARD BYRNE for approximately fifteen years, and
that he has no reason to believe that BYRNE is involved in any
criminal activity, syndicate or otherwise. He stated he has
never indicated to him or in his presence that he has ever
killed anyone or is a professional killer. He commented that
BYRNE does drink a lot and does make rather wild statements
while drunk. On one such occasion, he recalled that BYRNE made
some mention of a plane crash while he was a Marine pilot.
Mr. BACHELLER said he has no reason to think that any of
BYRNE's associates in the oil business, such as HAL HALE or
BUD SIMMONS, are in any way connected with criminal activities.
He advised that BYRNE has never mentioned the assassination of
MARTIN LUTHER KING, as far as he knows.

He stated in his opinion, anyone attempting to connect BYRNE with KING's death is spreading the most far-fetched story he has ever heard of.

Mr. BACHELLER stated he is not really well acquainted with Mrs. HOMER LANE BIGELOW, and that any judgment he would make of her would be superficial, but if she was the source of this information, he would have considerable reason to question her emotional stability. He stated that since learning of BYRNE's intention to marry GENEVIEVE BYRNE, she has indicated a vindictive attitude and has become emotional at times. He stated this was very evident when he found her at BYRNE's apartment recently at the time he stopped by to take BOB BYRNE to lunch. He stated she alleged that she knew something about BOB and would fix the marriage. He said there was no mention made by her of killing BOB and herself while he was present, but he later learned from someone, whose identity he cannot now recall, that she had made the statement.

During her conversation, she claimed that BYRNE had been with a syndicate for twenty years and was a hired killer. He stated she made no mention of his being connected with MARTIN LUTHER KING's assassination. He told her at the time that she had to be out of her mind. He said she is not in the same social group with him and he has purposely avoided her ever since.

BACHELLER said he recalled the trip to Acapulco, Mexico, and he is of the belief that it was a vacation trip which they took with Mr. and Mrs. HAL HALE. He also recalled seeing pictures of the trip after their return, but cannot recall specific pictures.

Mr. HAROLD B. MOTT, 684 Ogden Street, Denver, Colorado, advised that he has known ROBERT EDWARD BYRNE since at least high school days in New York. He stated that he has absolutely no reason to think that BYRNE is connected with any criminal activity, syndicate or otherwise. He stated that it was common knowledge among the group that knew BYRNE that he was in Lubbock, Texas, at the time of the death of MARTIN LUTHER KING for the purpose of settling the estates of his recently deceased mother and brother.

He advised that he knows that Mrs. BIGELOW is upset because BYRNE has started running around with another woman. He believes that Mrs. BIGELOW is rational but upset, and "ought to have her skull examined." He stated that undoubtedly the allegations concerning BYRNE came from her and he considers them fudicrous.

MOTT stated that BYRNE is inclined to kid a lot if he has been drinking and if he made any statements at all, he is sure that it was because of his drinking. He knows that BYRNE is not motivated by any racial feelings.

He stated BYRNE has never made any statements to him which could in any way be interpreted as connecting him with any criminal syndicate, any gun-running activity, or with MARTIN LUTHER KING's death.

BOB BYRNE again at the THOMPSON's apartment and a romance between them started at that time "hot and heavy". She said it progressed to the point where they frequently slept together. During their association, she met a close acquaintance of BYRNE by the name of HAL HALE. She stated that HALE is in the oil business and has several oil holdings. He is married and lives in California, but has an office in a house located in the 500 block of Gilpin Street in Denver, Colorado, which office is maintained by a bookkeeper. She stated that HALE is originally from Ashdown, Arkansas. She advised that she first met HALE in September or October, 1967 and that he is not a member of the partying group to which BYRNE belongs.

Mrs. BIGELOW described BOB BYRNE as 43 years of age, $6'4\frac{1}{2}$ - 5" tall, dark hair, scars on his legs, which he claims he obtained from wounds received while in the Marine Corps as a pilot during World War II. She stated that he is a graduate of Cornell University and has a degree in Hotel Management. She said that BYRNE was married once after he came to Denver about 15 years ago, but is now divorced. His ex-wife is now Mrs. JAMES S. (LYNN) ROBB and lives at 12534 West Virginia Avenue, Lakewood, Colorado. She recalled that BYRNES' ex-wife presently has BYRNE in court either for non-support or in connection with attempts on the part of her and her new husband to adopt the three children of the first marriage.

Mrs. BIGELOW stated that BYRNE does not appear to have money, but that he has refused to accepteash from her in the past. She believes, however, that he has accepted money from another girl friend, BERNICE PAULSEN, who resides at 1010 Clarkson, Denver and who is a secretary for a law firm.

She stated that BYRNE had a twin brother, JOSEPH BYRNE, who was killed March 13, 1968 while on a flight over Laos. JOSEPH BYRNE was a Lieutenant Colonel in the Air Force, whose wife's name is GENEVIVE and whose family consisted of six children, all residing with their mother at 4704 29th Street, Lubbock, Texas, telephone Swift 2-1182. She stated that he has two other brothers, WILLIAM BYRNE, in

insurance at 119 Underhill Road, Ossining, New York and DONALD BYRNE in the oil business in Kansas City, Missouri.

She stated that BYRNE is a "heavy, two fisted drinker" who does most of his talking when he has been drinking. She said that he is probably not an alcoholic as he never seems to forget anything he says, but that he is capable of drinking one to two bottles of liquor a day for four or five days and then will go without drinking for a like period.

Mrs. BIGELOW claimed that BYRNE started intimating that he was in some type of organized crime syndicate about a month after their romance started; but that he never became specific as to members of the syndicate or its activities. She said he also told war stories about his life in the Marine Corps during combat and he claimed he had killed many men. She was never sure whether the killings were while he was in the Marines or were in connection with the syndicate; but later she learned from other sources that he was never in combat.

She claimed that he once told her that he was a professional killer and also that after World War II. he was engaged in a gun running business in which he flew guns to Cuba in a light airplane prior to take over by CASTRO. She said that she gained the impression that he was in the employ of one RAY RYAN, while gun running and he described RYAN as "Mr. BIG", who spent part of his time in Kenya, Africa, where RYAN is a member of the Mt. Kenya Safari Club. She said according to BYRNE, RYAN supposedly cannot return to the United States as there is a Contract" out on him and he would killed the minute he set foot on American soil. She also said that BYRNE mentioned another name which she cannot recall of a man who was big in the underworld and who lives on an island between Miami and Miami Beach. man is supposed to have been connected with RAY RYAN and a financier of the gun running operation. BYRNE also reportedly referred to HAL HALE as "Mr. BIG" and inferred that HALE was involved in the criminal activity.

BIGELOW stated that in late November, 1967 BYRNE

told her he had been invited to Acapulco, Mexico by HALE and his wife DEE and that she was invited as well. BYRNE told her that it was a business trip, but not connected with oil. She said that she paid for the trip for the two of them and that they left Denver on December 28, 1967 and returned to Denver, January 12, 1968. She said that they met the HALES at a house named Casa Josette in the Las Brisas area of Acapulco. The HALES were accompanied by BILLIE and LOUIS FAWCETT of Ashdown, Arkansas. The HALES and the FAWCETTS left Acapulco two or three days before BYRNE did.

Mrs. BIGELOW stated that she gained the impression the three men attended meetings during the mornings although no one specifically so stated, and that the meetings related to criminal plans. She did not know who else might have been present at the meetings, although HALE once commented that he had seen RAY RYAN on the Street in Acapulco. said that BYRNE returned to the house one day upset. dinner he and she went to a club and started drinking, however, BYRNE was sober when she tried to draw him out. She asked him what it was all about and she claimed that she knew that he was supposed to meet RAY RYAN. BYRNE reportedly said "they want me to do a job., I don't want to do it. As you know, I have been trying to get out of this for three years, but they need a technician." She said that BYRNE claimed that "they" had threatened to harm Mrs. BIGELOW's children and that "this is the only way they could get to me". stated that BYRNE claimed to be frightened, said he was not going to do "it", and for her not to worry. He was not going to let "them" harm her or her children.

Mrs. BIGELOW stated that shortly after the group's arrival in Acapulco a yacht, the Ultima II, anchored in the harbor. They learned that it belonged to CHARLES REVSON, head of Revlon Cosmetic Company. She said she gained the impression that REVSON was not aboard. After lunch one day BYRNE wanted to take a small sailboat out on the harbor so she accompanied him and the operator of the boat. She stated that they circled the yacht and took pictures of it while some of the crewmen were at the yacht's rail. They waved and the crewmen waved back. She said that she had heard that RAY RYAN was aboard and thinks that it was HALE who mentioned it. She felt that BYRNE wanted to circle the yacht because of that. She said that BYRNE

later told her he rented the sailboat because he was supposed to identify the crewman and the crewman was to identify him. She stated that the next day or so, all the party took a speedboat trip and on the trip they again circled the yacht. More pictures were taken of the yacht and its crew.

On the trip to Acapulco Mrs. BIGELOW stated that she took seven rolls of pictures with 20 pictures to the roll. When they returned to Denver, she had them developed at a nearby drug store and BYRNE picked them up paying about \$35.00. She stated that she saw them at that time, but BYRNE stated he was going to keep them since he had paid for them and would have mints made for her. She recalls that they later showed them to JAMES HEYER. the attorney friend of BYRNE'. In March, while at BYRNES apartment, BYRNE passed out from over drinking according to Mrs. BIGELOW. She said that she took the pictures and the negatives and left his apartment. She thinks that she must have lost the negatives and some airline tickets out of her purse when she stepped out of her car at her apartment, discovered the loss the next morning and later noticed that all the pictures of the crewmen of the yacht were missing.

She stated that after returning to Denver she tried to discuss BYRNE's comments in Acapulco. He reportedly told her "for God sake don't bring that up". They eventually had words and did not see each other from January, 26, 1968 to February 9, 1968. Due to the need to talk to someone she went to her attorney, TOD BAKER, Denver, Colorado, shortly after their return to Denver and discussed the matter briefly with him. She said he laughed and said that it was impossible, but if she was worried, he would make one telephone call and would find out what it was all about.

She claimed that BYRNE knew she had seen her attorney the very next day and told her that she was in deep trouble. That was the day that they picked up the pictures from the drug store and took them over to JAMES HEYER. She said that they all drank a lot, but no one was drunk. After HEYER's wife went to bed, both BYRNE and HEYER started questioning her as to why she went to her attorney and telling her that she was going to get herself, her kids and

BYRNE killed.

She said HEYER told her that her house was "bugged" and that they knew of all her conversations. He said that he and BYRNE had to make a call to Dallas in order to get BYRNE out of trouble as a result of her talking. She said they asked her to go to the car and wait while they made the telephone call. She did and when she returned, they both continued to lecture her and obtained her promise not to talk further. Afterwards, HEYER again called Dallas, according to Mrs. BIGELOW and BYRNE handled the call out of earshot of Mrs. BIGELOW.

Mrs. BIGELOW stated after their fight on January 26, 1968, she next saw BYRNE on February 9, 1968 at another party given by KATHY RAHEL. She and BYRNE made up and no mention was made of past events until after BYRNE returned from Lubbock, Texas in early March where he had gone to be with his mother, who was having an operation. She claimed that BYRNE was tense when he returned and told her that he had his problems and did not know what to do about them. He said, cryptically that he had to do it and he did not want to. She said that he would not say what it was he had to do, but in response to her probing did say that "it" was going to happen soon, would make national headlines and would be just about as big as KENNEDY's death.

Mrs. BIGELOW said that on March 10, 1968 BYRNES mother died and as he was getting ready to go to New York, where the funeral was to be held, he received a call from his sister-in-law GENEVIVE on March 13, 1968, telling him that his twin brother, her husband, had been killed overseas. She said that he immediately went to Lubbock, Texas, where she called him frequently asking when he would be returning to Denver From these calls, she learned that he and GENEVIVE had gone off somewhere for a week. The night of the day on which MARTIN LUTHER KING was assassinated while others were at her house, she again called him. She said that he was at his sister-in-laws and was "absolutely, out of his mind, drunk". She said he yelled at her for having a "nasty mind" regarding GENEVIVE. In subsequent calls, he was reportedly calmer and indicated that he had a lot

to do in connection with the two estates

She stated that BYRNE returned to Denver on May 14, 1968 and was at her apartment that night "fairly drunk" by Before they retired she told him she was scared and asked him if he had had a hand in KING's death. She said he replied "what do you think, of course". She asked him if JAMES EARL RAY did the shooting and he replied asking her what made her think RAY did it. She said she indicated RAY was probably dead and that BYRNE said he was not. said she asked him if "that had been a picture of RAY on the yacht she had taken", and he replied that it was. she asked BYRNE where the pictures were and he replied "you don't think I would leave them around do you?" He ended the conversation by saying he would never let "them" harm The next night, according to Mrs. BIGELOW, while they were out with KATHY RAHEL and her friend MOTT, BYRNE told her that he was going to marry GENEVIVE in that he thought he ought to be a father to her six children. BIGELOW said that she walked out on the group and walked home, but that she has seen BYRNE a few times since.

She stated that on May 22, 1968 she received a telephone call from JAMES HEYER who wanted to contact BYRNE. He asked her to try to locate BYRNE as it was an emergency. She was to give BYRNE the message "emergency teacup" and BYRNE would know what it meant. She said BYRNE did call later and she gave him the message. She stated that he had her repeat it three times, swore and commented "I wonder if mine will be as big as the other". She fet the message frightened BYRNE and she has not seen nor heard from him since.

Mrs BIGELOW stated that she started making notes concerning this situation about April 18, 1968. She stated that she has thought about it many times and finally decided that if BYRNE was going down to Lubbock, Texas to marry GENEVIVE perhaps he ought to be stopped. She stated that she probably would not have called the FBI except for the fact that BYRNE plans to marry GENEVIVE. She stated that she realizes she has no proof of her allegations and she figures she will harm BYRNE by furnishing the information.

She advised that up to the time of MARTIN LUTHER KING's death there was no mention of KING in any of her conversations with BYRNE.

Mr. ROBERT EDWARD BYRNE, 1234 Clarkson Street, Apartment #7, Denver, Colorado, advised at the outset of the interview that he felt interviewing Agents were contacting him because of comments made by Mrs. HOMER LANE BIGELOW, known to him as "KIRK," with whom he had been going for the past several months and who was attempting to make trouble for him ever since he had informed her that he was going to marry GENEVIEVE BYRNE, the wife of his deceased twin brother. He stated that in his opinion, KIRK BIGELOW is a "very sick" woman emotionally, and, as the "woman scorned," is determined to do all she can to upset his marriage to GENEVIEVE. stated that she is too late as far as his marriage is concerned because over the past weekend, he married GENEVIEVE in Colorado Springs, Colorado, and they were presently honey-mooning at the Broadmoor Hotel there. He stated that he had returned to Denver, Colorado, with GENEVIEVE for the purpose of appearing in court in Jefferson County with his attorney, JAMES HFYER, for two reasons: 1) for the purpose of contesting the attempts of his ex-wife, who is now Mrs. JAMES S. ROBB, who with her new husband is attempting to secure the adoption of their three children; and 2) for the purpose of packing his furniture and belongings for the trip to Lubbock, Texas, where he intends to take up residence. He stated that he and GENEVIEVE were leaving for Lubbock, Texas, via the Broadmoor Hotel in Colorado Springs in the next few minutes.

Mr. BYRNE categorically denied that he was in any way involved in or had knowledge of MARTIN LUTHER KING's assassination. He stated he had been in the Marine Corps for five years as a pilot and while he saw no combat duty, he was at one time stationed in Cuba. He stated that he was in no way involved in any gun-running operation to Cuba at any time.

Concerning RAY RYAN, he stated that RYAN is a very wealthy individual who is one of the charter members of the Mount Kenya Safari Club in Africa, and who has financial interests in several oil ventures. He sabassas far have

knows, RAY RYAN is in no way connected with any criminal activity. He recalled that some years ago, RYAN was the victim of a proposed kidnapping plot on the West Coast and because of that, he could have mentioned that his life and safety was still in danger. He stated that he worked in affiliation with RYAN and with another wealthy oil promoter, HAL HALE, when RYAN and HALE were partners in the New Drilling Company, Denver, Colorado, a few years ago.

BYRNE advised that he knows HAL HALE quite well and has frequent business dealings with HALE in the field of oil. He stated he does not believe that HALE is in any way involved in any criminal activity.

He stated there is another wealthy individual who lives on an island between Miami and Miami Beach whose name is JIMMY BREUILS (he was not sure of the spelling of BREUILS' name), and BREUILS is also in the oil business, and is known to RAY RYAN and HAL HALE. He said as far as he knows, BREUILS is not involved in any criminal activity.

BYRNE continued by stating that last fall and winter, he and HALE were responsible for drilling several oil wells in Kansas and during this period of time, HALE invited him and Mrs. BIGELOW, BYRNE's girl friend, to accompany the HALEs on a vacation to Acapulco, Mexico. He said that in late December, they did make the trip, meeting the HALEs and Mr. and Mrs. FAWCETT of Ashdown, Arkansas, at a vacation house in Acapulco which HALE had rented. He emphasized that the trip was a vacation trip but, of course, he and HALE, who were associated in oil dealings, did discuss some business on the trip. He denied that any meetings were held where criminal activities were planned. He recalled that during one business discussion with HALE, a slight argument developed about an oil deal wherein HALE wanted him to handle it in a way that he did not desire. He stated that he did mention to Mrs. BIGELOW that he had a problem, but he did not go into detail as to what the

problem was because he made it a practice to avoid talking business with her since she fancied herself as an investor and a business woman, which she is not, and he did not want her becoming involved in any of his business dealings.

He also recalled that she brought up the subject of marriage which she had discussed on previous occasions and in the conversation, indicated that if he did not marry her, her daughter JENNIFER would be hurt. He said he told her he did not want to hurt JENNIFER, but he was not going to marry her.

BYRNE stated that the yacht ULTIMA II arrived during the early part of their stay in Acapulco, and it came up in conversation among the vacationing group on more than one occasion. He understood from HAL HALE that RAY RYAN was supposed to have arrived in Acapulco aboard the yacht and that HALE had seen RYAN on the street in Acapulco on one occasion. He said he had no specific knowledge that RYAN was present inasmuch as he never did see him. He stated that he and Mrs. BIGELOW did take out a sailboat and did circle the yacht, taking a few pictures. He said to the best of his recollection, only two pictures of the yacht were taken -- one of a full view of the yacht and the other a close-up of a section of the yacht, showing a red speedboat tied to it. He stated that upon his return to Denver, the pictures were developed and when he picked them up, he observed that only these two pictures of the yacht were in the group.

Concerning the pictures, BYRNE stated that he once had possession of all the pictures and negatives, but on some occasion, Mrs. BIGELOW took both the pictures and the negatives. He stated that he kept none of them.

Later, after Mrs. BIGELOW was informed by him that he was going to marry GENEVIEVE, she came to his apartment and left three of the pictures and each of these pictures were of Mrs. BIGELOW, BYRNE, and a sailfish that he had caught. On this

occasion, Mrs. BIGELOW was greatly distressed at his intention to marry GENEVIEVE, and according to BIGELOW, she stated that "in no way was he going to get to marry GENEVIEVE; that she was going to kill him and then herself." He stated that during the time she was in his apartment, a friend of his, FRANK F. BACHELLER, arrived at the apartment to take BYRNE to lunch and would know of Mrs. BIGELOW's upset condition.

BYRNE recalled the visit to the residence of his attorney, JAMES HEYER, on which he and Mrs. BIGELOW took the pictures of the Acapulco trip to show HEYER. He also recalled that he and HEYER were at that time working on a mining deal which involved individuals in Dallas, Texas, and during the evening, they contacted their business associates in Dallas. He stated because he did not want Mrs. BIGELOW becoming involved in the deal, he asked her to leave the room so they could hold their conversations on the telephone in privacy. He commented that the business proposition "never jelled."

He stated that all of his activities in Texas were in connection with his mother's illness and death, and in connection with his brother's death. He stated that several meetings were held with Air Force officials at Reese Air Force Base, near Lubbock, and he and GENEVIEVE found it necessary to travel to the headquarters of the Air Force at Randolph Air Force Base, near San Antonio. He said on that trip, they stayed with Colonel SAM KYLE, in San Marcus, Texas, a friend of GENEVIEVE's deceased husband, and who did them the courtesy of checking into the details of JOE BYRNE's death. He recalled that while he was in Texas, Mrs. BIGELOW frequently called and wrote to him. He stated it was obvious from her state of mind during the calls that she was mentally disturbed. In both the telephone calls and letters she accused him of immoral activities with GENEVIEVE. He stated he destroyed the letters immediately upon reading them.

BYRNE stated he has known Mrs. BIGELOW since approximately last summer and met her through KATHY RAEL and HAROLD

MOTT. He stated he has known MOTT since the fifth grade. He stated that he is extremely sorry he ever made her acquaintance because of her emotional instability. He said she tells people that she is worth millions when, in fact, she is not. He learned that prior to taking up with him, she dated and occasionally lived with one GUS NYBURG, a dishonest individual with whom BYRNE had had dealings in the past, and who took money from Mrs. BIGELOW, according to her.

BYRNE stated that at least most of the events that were brought up by interviewing Agents did take place, such as the trip to Acapulco, Mexico, his trip to Lubbock, Texas, and the visit to JAMES HEYER's residence, but that incorrect information had been added to what took place during the events. He stated that he is willing to assist the FBI in any way to clear the matter up, and that in the future, he can be reached at 4801 - 29th Street, Lubbock, Texas.

JERRY RAY said if he makes the described trips he might try to earn some money by selling interviews of himself to the various forms of mass media located along the route of his travels. FETTERS received the impression JERRY RAY is enjoying the attention and publicity he is receiving as a result of instant matter.

ALL MEMBERS OF THE DAML PANILY WHO WERE INTER-VIEWED REQUESTED THAT THEIR IDENTIFIES REMAIN CONFIDENTIAL.

Seattle Indices are negative concerning the DAHL family members and the GRACE family members.

On June 14, 1968, DAML was interviewed at work; and he advised his daughter, DEBBIE DAHL, is a friend of DEBBIE GRACE, who is the daughter of GEACE above. The summation of Mr. DAHL's information was that DEBBIE DAHL learned from DEBBIE GRACE that three days prior to the KING assassination, GRACE had remarked that KING would be shot. Further, GRACE has attended many John Birch meetings "sind others", types unknown. GRACE reportedly has a violent temper.

On June 14, 1968, DEBBIE DAHL, who is 17, was interviewed at her home in the presence of her mother. DEBBIE DANL related the substance of the information outlined above and added that GRACE is "violently", Communist.

On June 25, 1968, GRACE was interviewed at work by SA GIESE who prefaced the interview by stating merely that it had been reported to the Seattle FBI Office that GRACE proportedly had advanced information that KING would be shot.

GRACE stated that it was his feeling that since KING had been so much in the public eye and since some people were opposed to what he had been doing, he would not have been surprised if KING were shot. GRACE stated that he may have passed this remark to someone but he could not recall to whom or when. He said that he most certainly did not have any foreknowledge that KING would be shot although he was not surprised that it did happen for the reason stated above; but he deplored the shooting. GRACE said he most certainly did not have anything to do with the shooting itself, and he remarked that he has heard other persons remark that they would not be surprised if KING were shot in the connotation noted above.

The Scattle Division is forwarding this for the information of the Bureau and the Memphis Division but does not contemplate any further action in this specific instance.
