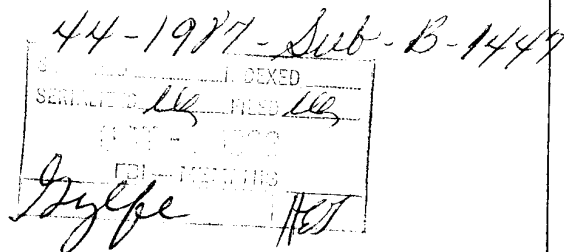

Date August 2, 1968

On July 24, 1968, DAVE ALEXANDER, City Editor, of the "Greensboro Record" newspaper, Greensboro, North Carolina, advised that his newspaper operates a column called "The Hot Line" which is in the form of a question and answer column appearing in each edition of the paper. He said that messages called in to this column are recorded on tape.

Mr. ALEXANDER advised that sometime on the morning of July 23, 1968 a man who did not identify himself called "The Hot Line" and the following message was recorded on tape:

"I'd rather not give my name under the circumstances because I know JAMES EARL RAY is innocent because at the time, he was in Greensboro with me but I knew he was a fugitive. I cannot get involved. If the hot line would like to carry on further, put it in the paper and I will call you back again and if you will keep my name confidential from the police, so I cannot get involved, I can prove EARL RAY did not kill or assassinate (three second pause on tape) you know who."

Mr. ALEXANDER said he did not intend to publish any item concerning this matter in his newspaper inasmuch as he felt that such an article might upset the public. He advised that the tapes on which the messages are recorded are normally erased after one or two days; however, he would keep the tape with this message on it intact for one week.

Mr. DAVE ALEXANDER, City Editor of the "Greensboro Record," Greensboro, North Carolina newspaper, on July 30, 1968 made available a plastic container bearing the name "Code-A-Phone" in which he advised was the tape on which the voice of the unknown caller who contacted "The Hot Line" Column of that paper on July 23, 1968 regarding JAMES EARL RAY.

Mr. ALEXANDER advised that subsequent to the time he advised the FBI of the existence of this recording on July 24, 1968 on the same date he telephonically contacted ARTHUR HANES, attorney for JAMES EARL RAY in Memphis, Tennessee, and quoted to him the message on the tape. He said that HANES indicated an interest in this matter and added he would be in contact with Mr. ALEXANDER, but as of July 30, 1968 HANES had not contacted him regarding the message.
