The following investigation concerning BOBBY DEAN MEDLIN was conducted at Charleston, South Carolina, on April 9, 1968, by Special Agents WARDLAW E. SKINNER, THOMAS J. NORTON, JR., and EDWARD E. FLECK:

J. ROBERT BROWN, Identification Bureau, Police Department, Charleston, S. C., made available a record on April 9, 1968, for BOBBY DEAN MEDLIN, PD #63-743, FBI #206-263-C, which reflected MEDLIN was born [redacted], at Milledgeville, Georgia. He is described as follows:

Record shows MEDLIN has several arrests for drunk and disorderly; disorderly conduct; reckless driving; and statutory rape, for which he served one year in prison.

JACK HOLST, Owner, James Island Garage, Ft. Johnson Road, James Island, South Carolina, advised April 9, 1968, that MEDLIN worked for him for about one week prior to March 27, 1968. Prior to working for him, MEDLIN was employed at Gage's Gulf Station, Folly Road, James Island, S. C.

He last saw MEDLIN on Saturday, April 6, 1968, when MEDLIN came to his garage to work on a friend's car. At that time MEDLIN did not indicate he had been out of town. He does not know where MEDLIN has worked since leaving his garage.

BOBBY DEAN MEDLIN, 1126 Pauline Avenue, Charleston, S. C., was interviewed on April 9, 1968, at his residence and he advised that he has not been outside the state of South Carolina, since January, 1968, when he went to Macon, Georgia, and Milledgeville, Ga., to visit relatives. He added that he is separated from his wife, and family and resides alone at 1126 Pauline Avenue. During the week of April 1, 1968, through April 5, 1968, he worked at his mother's home at 1482 Batallion Drive, James Island, South Carolina, every day painting the house and working in the yard, except for Monday, April 1, 1968, when he went to Charleston, South Carolina, with Mr. MC DADE, who resides at 1136 Pauline Avenue, and applied for work at Southern Railway Company, Anne and King Streets, Charleston, S. C. On the same date, he also went to the South Carolina Employment Security Commission to apply for unemployment benefits.

He added he owns a 1966 Pontiac GTO, color black, two door hardtop, bearing South Carolina License, which is parked at his residence. However, he is unable to drive the car as his drivers license has been suspended for driving under the influence.

On Tuesday, Wednesday, Thursday and Friday, April 2, 1968, through April 5, 1968, his mother, EUNICE L. ROGERS picked him up daily at his residence and took him to her home where he worked at her house. He is certain that the neighbors at his mother's home saw him there daily. He spent every night at his own home during this period.

He added that on Thursday night, March 28, 1968, he went into Charleston, S. C., and visited a bar with a neighbor, DANIEL THOMAS YOUNT, 1135 Pauline Avenue. Also, on Friday night, March 29, 1968, he recalls that YOUNT was at his residence. On Saturday night, March 30, 1968, he went to the Old Heidelberg Restaurant, Highway 17 south, Charleston, S. C., with YOUNT.

He added that he feels certain YOUNT can verify that he was at home every night during the last two weeks.

He made available for inspection a rifle which he described as a 7.65 Russian Carbine, bolt action type rifle with conventional type sights, no scope type sight. He added that he had never shot the rifle as he has no ammunition for the gun. He has owned this rifle for about one year as he obtained the rifle from BOA WEATHERFORD of James Island, S. C.

He added that he has never been a member of any klan groups or organizations of any type.

DANIEL THOMAS YOUNT, 1135 Pauline Avenue, James Island, S. C., Salesman, National Biscuit Company, Charleston, S. C., and a neighbor of BOBBY DEAN MEDLIN, was interviewed and he furnished the following:

He has seen MEDLIN at his residence, 1126 Pauline Avenue, every night for at least the past two weeks. He knows that MEDLIN has not been outside Charleston, S. C., area since January, 1968, when he went to Georgia to visit relatives.

On the evening of April 4, 1968, he was visiting at MEDLIN's home when they both heard that KING had been shot at Memphis, Tennessee.

He added that on Thursday night, March 28, 1968, he and MEDLIN went to Charleston, S. C., together and visited a bar in Charleston, S. C. On Friday night, March 29, 1968, he saw MEDLIN at his residence and on Saturday night, March 30, 1968, he and MEDLIN went to the Old Heidelberg Restaurant, Charleston, S. C., after briefly visiting at Folly Beach, S. C.

He knows that during the week KING was killed, MEDLIN was working at his mother's home on James Island, S. C., and MEDLIN's mother picked him up daily at his residence and took MEDLIN to her home to work.

He is certain that MEDLIN has not been out of the Charleston area since January, 1968.

Mr. JAMES HYBART, Owner, Appliance Parts and Service Company, 805 Church Street, advised as follows:

He is acquainted with Mr. M. J. (JACK) ENGLAND, a representative of the Westward Company, who was in Mobile, Alabama, on Thursday and Friday, April 4 and 5, 1968. He said he had lunch with ENGLAND at Wentzel's Oyster House on Dauphin Street, Mobile, Alabama, shortly past noon on Thursday, April 4, 1968.

Mr. HYBART said that ENGLAND was staying at the Travel Lodge Motel on Government Street in Mobile, and he had been in touch there with ENGLAND later on that same evening and also the following day, Friday, April 5, 1968. He believed ENGLAND had arrived in Mobile from possibly Jackson, Mississippi, earlier on April 4, 1968, and left Mobile for Birmingham, Alabama, possibly on Friday, April 5, 1968, or the next day.

Mrs. LUCILLE WILLIAMS, Desk Clerk, Travel Lodge Motel, 559 Government Street, advised that Registration Card 131-6458 dated April 4, 1968, on file at her company contained the following:

Mr. JACK ENGLAND, 2616 Ryan Avenue, Fort Worth, Texas, checked in to the motel on April 4, 1968, and was assigned Room 319. He indicated he was a representative of the Westward Company, not further identified, and that he was driving a 1968 Buick, Texas License DWW235. This card indicates he held Room 319 for two nights.

Mrs. WILLIAMS noted that the card shows that she handled this registration and although she has a recollection of registering ENGLAND and his being there for two days, she is unable to recall his exact time of arrival or departure. She said there is no time machine to stamp arrivals or departures and as her work hours for the days in question were from 7:00 a.m. to 3:00 p.m., it would have been between these hours from Thursday, April 4, 1968, to Saturday, April 6, 1968.

Mrs. WILLIAMS recalled ENGLAND as a tall dark-haired man in his middle or late thirties, who received several business calls and callers. She said he had apparently advertized the fact he would be at the motel a day earlier and they were bothered by phone calls for him prior to his arrival.

By communication dated April 8, 1968, the Dallas Office advised as follows:

T. G. GRIMES, Construction Business, Dallas, Texas, considers CHARLES NELSON GRIMES, age about thirty-seven, who was employed by him approximately four months ago, as a suspect. GRIMES is believed to be a Korean Conflict veteran and of unstable mind. He is obsessed with the subject of communism. GRIMES gave GIBSON's address as Rural Free Delivery 3, Box 310, Red Springs, North Carolina, but his present whereabouts is unknown to GRIMES.

The following investigation was conducted by SA RICHARD A. CARR:

AT RED SPRINGS, NORTH CAROLINA

On April 8, 1968, LUTHER HAGGIN, Chief of Police, Red Springs, advised that CHARLES NELSON GIBSON was committed to a mental institution in Columbia, South Carolina, about two years ago and he has not seen GIBSON in the area since that time. He advised that GIBSON's mother is Mrs. MAUDE GIBSON, Route 3, Box 310, Red Springs, North Carolina.

Investigation on Route 3, Red Springs, revealed that Mrs. MAUDE GIBSON is presently in the hospital at Laurinburg, North Carolina.

The following investigation was conducted by SA ROBERT M. STEVENSON:

AT LAURINBURG, NORTH CAROLINA

On April 9, 1968, Mrs. MAUDE GIBSON, a patient at the Scotland County Hospital, Laurinburg, North Carolina, advised her son, CHARLES NELSON GIBSON, who was born [redacted], in Robeson County, North Carolina, quit high school and enlisted in the United States Air Force in 1947 or 1948. He served in the United States Air Force during the Korean Conflict and was discharged about [redacted] that

time, he has never settled down and has traveled from place to place all over the United States. He is not married and to her knowledge, has never been married. He maintains infrequent contact with her; however, from time to time, she receives collect telephone calls from him from various places and she also receives, from various employers, his W-2 forms.

Mrs. GIBSON described her son as an alcoholic and a person who has mental problems. She stated he was confined in the Veteran's Administration Hospital in Tomah, Wisconsin for about nine months approximately four years ago. He visited her after his released and she has not seen him since that time.

She stated that approximately six weeks ago, a collect telephone call was made to her from her son who was reportedly in Dallas, Texas, at the time; however, she would not accept the call. She understands that CHARLES also made a collect call to his brother, HAROLD GLENN GIBSON, in Charlotte at the same time but HAROLD would not accept the call.

She stated CHARLES works at various construction jobs but does not stay on any one job very long. He has been arrested on many occasions during the past fifteen years, usually for public drunk and assault. In addition to her son in Charlotte, she has another son, EARL JONES GIBSON, age 40, who resides in Jacksonville, Florida, address unknown, who is employed at a printing company, name not known. She also has another son, THOMAS ALLEN GIBSON, a confirmed alcoholic, who is confined in the State Mental Hospital, Columbia, South Carolina.

AT CHARLOTTE, NORTH CAROLINA

On April 10, 1968, Mrs. HAROLD GLENN GIBSON, 634 Lansdowne Road, Charlotte, North Carolina, advised she and her husband last heard from CHARLES NELSON GIBSON about one month ago when he placed a long distance collect telephone call to their residence. They refused to accept the charges and the call was not completed. She stated she believes he was in Dallas, Texas, at the time of the call, address unknown. Mrs. GIBSON advised she has no information as to his present whereabouts or how he can be located.
