On 4/5/68, at 4:50 p.m., Mr. RAY MOORE, United Airlines Reservation Manager, Philadelphia, Pa., telephonically furnished the following information to Supervisor JOHN L. ADAMS:

Mrs. YVONNE BERNADING, Reservations Clerk, was telephonically making an airplane reservation for a Mr. C. WERKHEISER, telephone number 797-4683. While preparing the reservation, she overheard the following comments from WERKHEISER:

"My buddy shot that b----d, the police are still looking for him, but they will never find him because they hate the niggers as much as we do. All of them are going to get killed. I heard they are going to get Carmichael next - ya! He's going to get it and then Brown. My father said schools are closed and nothings opened. Should shoot all the niggers."

Mr. RAY MOORE said that Mrs. BERNADINO called her supervisor to monitor the call, but when the supervisor did so the conversation switched to flight reservation matters.

WERKHEISER had previously held reservations which he said he was cancelling because he was awaiting money from his father in Memphis to make the trip there.
WERKHEISER remade reservations for Flight 639 at 3:05 p.m., on 4/6/68, and from Allentown to Chicago O'Hare, with connection to Delta Flight 830 to Memphis.

At 7:00 p.m., RAY MOORE again contacted the Philadelphia Office and advised that WERKHEISER had changed reservations and was taking Flight 645 out of Allentown, Pa., on 7:22 p.m., on 4/5/68, arriving Pittsburgh 8:29 p.m. Then he would take Flight 821 out of Pittsburgh at 9:05 p.m., arriving 9:45 p.m., Memphis time.

MOORE stated that the telephone number which WERKHEISER left as a contact point was listed to a Mr. RAYMOND M. REISS, East Rock Road, Allentown, Pa., and that WERKHEISER's correct name was BRUCE WERKHEISER.

MOORE stated that WERKHEISER was described by the people at the Will-Call Ticket Desk as follows:

Name BRUCE WERKHEISER White Race Sex Male 19-21 Age 51911 Height Weight 165 Hair Dishwater brown - sandy - worn short Clothing Wearing light blue slacks, with dark blue sport jacket, no collar or lapel, turtle neck sweater Characteristics Wears dark horn-rimmed glasses.

MOORE stated that WERKHEISER was accompanied to the airport by two adults and a young lady.

Attempts were made by Philadelphia to contact RAYMOND M. REISS during the pertinent flight period on 4/5/68, with negative results.

On 4/6/68, Mrs. RAYMOND M. REISS, East Rock Road, Allentown, Pa., was interviewed by SA THOMAS F. HANNIGAN and C. HEBER SMITH.

She advised that she was the aunt of BRUCE JOSEPH WERKHEISER, who was born on _____, at Allentown, Pa., and who currently resides at 4375 Hillbrook Road, Memphis, Tenn., telephone number 398-0800. His parents are RAYMOND E. and LOUISE WERKHEISER. He currently attends the 11th grade at White Haven, Tenn., High School.

Mrs. REISS stated that BRUCE WERKHEISER had been in a motorcycle accident two years ago and had suffered severe head injuries. He was now ostensibly normal, although he does have periods of dizzy spells. He was hospitalized in Memphis, Tenn., at the time of his accident. He currently desires to study for the ministry.

He left home in Memphis on 4/2/68, when his father refused to purchase a 1965 automobile for him. He traveled to Allentown in a 1956 Pontiac automobile, color white over yellow, which is now currently at the REISS residence.

WERKHETSER arrived in Allentown at the REISS residence at 8:30 p.m., EST, on 4/4/68. Upon his arrival he had told the REISSes that he had heard over the car radio about KING's death.

During his stay in Allentown he made no phone calls to or from Memphis, other than to his parents.

Mrs. RAYMOND REISS stated that she had been present when BRUCE WERKHEISER had called United Airlines on 4/5/68, for airplane reservations. There had been some delay in making the reservations over the phone and while waiting BRUCE WERKHEISER made the comments attributed to him by Mrs. YVONNE BERNADINO to his cousin DOUGLAS. Mrs. REISS stated that she felt that the remarks were made in jest and that BRUCE WERKHEISER gives no indication of hatred for Negroes.

Mr. REISS was also present at that time, and admonished BRUCE WERKHEISER for his remarks in view of the current circumstances.

Mrs. REISS stated that BRUCE's father had paid for his planefare and that they had put him on the flight to Memphis on 4/5/68. PH 157-2574

Kramer was reportedly born ______, at Portland, Oregon, to Richard and Henrietta (nee Binemen) Kramer, both native-born V. S. citizens. He is described as 6' 1" tall, 170 pounds, brown hair and brown eyes. He reportedly attended University of Oregon, received BS degree in June, 1958; MS degree in June, 1963 and MD degree in June, 1963. Last known address is listed at 1472 C University Avenue, Berkeley, California.

Records of the Berkeley, California, Police Department reveal he was charged on 4/7/66 for gashing a fictitious check, no disposition shown. On 1/20/66, he was charged with possession of marijuans and sentenced to 90 days in jail with three years' probation. As of May, 1967, that charge was under appeal.

Kramer has frequently corresponded with CIA sub E-68 and has been interviewed at which time he reportedly engaged in a lengthy, rambling, disjointed discourse which ranged in scope from the future economic position of the world to the fact that a thermo nuclear conflict is eminent.

AT DALLAS, TEXAS

Accheck of the voters registration list for each of the 293 precincts in Dallas County failed to locate any entry under the last names LOWMEYER or LOWMYER. These lists were made available by E. C. MC CORMACK, Supervisor of Voters Registration Section, Dallas County.

A check of the Dallas County Clerk's Office determined 1967 Texas license LKF 414 is listed to a 1964 Chevrolet registered to DOUG ROY, 1548 Mapleton, Dallas, Texas.

Mrs. JOHN WORLEY, 13503 Shahan, advised that CLAUDE ROUX, who resides next door, moved to that address, which was observed to be 13509 Shahan, from Alabama prior to the time school started in September, 1967. ROUX has three cars, one of which is a company car just recently acquired by him. These cars have had Alabama licenses on them. All of them are full sized cars and she has never observed ROUX to have a Mustang. It was observed that there is no 13505 Shahan.

Later on April 10, 1968, during a telephone call from ROUX, he stated Alabama license 47-7514 was on a 1967 Ford four-door, that this car is a company car and that it was picked up by one of his employees in Memphis, Tennessee, on the day MARTIN LUTHER KING was shot.

HUBERT A. FERRELL, 4406 Holland Avenue, telephone 523-0716, after being advised of the identities of interviewing Agents and that information was received indicating he had information of possible interest relating to the murder of MARTIN LUTHER KING, advised as follows:

FERREIL is employed as a District Manager by United Savings Life Insurance Company and works out of his home. FERREIL has lived most of his life in Memphis, Tennessee, but moved to Dallas about 14 years ago.

Recently during a "bull session" with a large group of men, someone made a statement to the effect that during the first march in Nemphis, which march was led by KING, the riot was probably started by the militant Negroes as a diversion to give them an opportunity to shoot KING, but that KING had been gotten away before they had an opportunity. This individual, identity not recalled, further remarked that if this were true they would probably try again. He stated he has repeated these remarks to many people.

refrence that wife has been very upset and emotional about the situation in Memphis as her only close relative, a sister, resides in Memphis. She is very concerned over her sister's safety.

FERRELL has three brothers and a sister who reside in or near Memphis, as well as friends. He stated he knows no one in Memphis who he would suspect of killing KING. He stated that none of his relatives or friends appear to have any unusual animosity toward members of the Negro race.

WAYNE SMITH, 2420 Wicker, telephone CH 7-3037, after being advised of the interviewing Agent's identity, furnished the following information:

SMITH is a close friend of HERBERT A. (BUCK) FERRELL, 4406 Holland, Dallas, LA 8-0716, who formerly resided in Memphis, Tennessee. FERRELL has advised SMITH that if MARTIN LUTHER KING went to Memphis "they" would kill him. FERRELL did not further identify "they."

SMITH was watching television on the date that RING was shot and when the news appeared on television he telephoned FEHRELL's home to advise FERRELL, but he was not at home. FERRELL's wife, MARY ELIZABETH, answered the telephone and she was crying, appeared to be terribly upset and said, "Oh my God, I hope it isn't someone we know. You'll have to call back later if you want to talk to BUCK. I'm too torn up now."

SMITH telephoned FERRELL at home about an lour later and FERRELL stated he had been told by an "informant" (not otherwise identified by FERRELL) that "they" had tried to get KING two weeks ago and would try again.

FERRELL and his wife have been in Memphis frequently lately as her mother died in January, 1968, and they have been back and forth settling her estate.

FERRELL has a son JIMMIE, age 16 or 17, at home, and a son BILLY in the U.S. Marines. He has another son LAWRENCE A. FERRELL (wife BOBBIE), age 23 to 26, 7135 Fenton, Dallas, telephone DI 8-7916. LAWRENCE has a red Mustang with black top and a Volkswagen and is a motorcycle enthusiast. LAWRENCE

has been unemployed for a period of time and about two or three weeks ago when asked by SMITH what he was going to do, he stated that he was going to work for Blue Cross in their Dallas office. LAWRENCE was in the U. S. Air Force and after discharge he spent a year bumming around in Mexico. He rides with motorcycle clubs and would apparently like to be a "hippie."

MARY ELIZABETH FERRELL, wife of HERBERT A. FERRELL, has reportedly done a lot of work for GARRISON of New Orleans, and she has had GARRISON's people in her home, going to Love Field Airport at times to get them. This work done by her has apparently all been in Dallas. She has had Mrs. OSWAID, ex-wife of LEE HARVEY OSWAID, in her home.

FERRELL's daughter CAROL ANN is married, has two children and resides in the 4000 or 4100 Block of Holland, Dallas.

FERRELL has a 1964 or 1965 Lincoln financed through the Ford Motor Company, Dallas; recently purchased a 1968 Dodge Monaco from Dodge City, Dallas, financed at a local bank; and has a 1967 Bodge Dart for CAROL ANN financed at the First National Bank, Dallas.

FERRELL's home is financed at Oak Cliff Bank and Trust Company, Dallas, and he has gas credit cards with Mobil, Gulf and Shell Oil Company.
FERRELL has bank accounts at the Texas Bank and Republic Bank and Mrs. FERRELL has her own bank account and her own credit (Femme Sole). FERRELL is employed by United Savings Life Insurance Company, Dallas, as a Division Manager. He is gone most of the time during the week in connection with his employment and during the past year he has stayed in the Holiday Inn Motel, Mt. Pleasant; at motels in Dangerfield and at hotels in Tyler, returning home on the weekends.

JAMES FERRELL, brother of HERBERT A. FERRELL, is a conductor on a railroad out of Memphis and has a violent dislike for Negroes and has his family thinking the same way. He has rifles and ammunition and has taught his three or four sons to use these.

Last fall or early this year, FERRELL, went to Arkansas and purchased some land for himself and also some land for JAMES FERRELL deep in the hills and has advised SMITH that this land was purchased so they would have some place to go in the event the Negro problem got too bad in Memphis. FERRELL has stated that he made the down payment on this land and some of the payments for JAMES FERRELL.

On Saturday evening, April 6, 1968, SMITH telephoned FERRELL's home and asked JIMMIE, FERRELL'S 16 or 17 year old son, where FERRELL was and JIMMIE stated that his father had gone to Arkansas immediately following a business meeting which usually ends at about 5:00 PM on Saturdays.

MARY ELIZABETH FERRELL at one time worked for the Greenhill school and while there the FERRELL family became very close to a boyhnamed SCOTTY BARGNSON (Phonetic) from Mexico, whose father controls all the adhesive surfaced paper products in the Mexico City area and has property in Mexico, Europe and Dallas and has ships. SCOTTY went to School in Plano, but quit, married a local girl and now is employed by her father who owns a dry cleaning business in Dallas.

In addition to JAMES, FERRELL has a younger brother HERBIE who is in a management position in an insurance company in Memphis and another brother who is an officer in the U. S. Air Force, but his name and location is not known.

SMITH stated that the FERRELL brothers are very close, but that their wifes do not get along too well.

He described HERBERT A. FERRELL as a white male, 50 years of age, and he stated that all of the FERRELL men he has seen have dark sandy hair, fair complexions, weigh from about 160 to 200 pounds and are from 5'8" to 5'11" in height.
