The exact time of his departure is unknown inasmuch as his girlfriend MARJORIE KENNEDY drove him to Greensville, Mississippi, to catch a bus to Quincy, Illinois, where he was to board a riverboat. Mrs. FRITH has not heard from her son since he left lake Providence on April 4, 1968.

FRITH stated that her son recently purchased a 1967 Mustang two-door, blue in color, from TRAVIS SHEFFIELD. She stated the 1967 Mustang is presently in the possession of MARJORIE KENNEDY who resides at 501 Davis Street, Lake Providence, Louisiana.

FRITH further advised that to the best of her knowledge her son BILLY RAY KING has never been associated with the Ku Klux Klan or any militant-type group. She stated KING works on a tow boat on the Mississippi River and is, therefore, not home much of the time.

MARJORIE KENNEDY, 501 Davis Street, advised that she drove her boyfriend, BILLY RAY KING, to Greenville, Mississippi, April 4, 1968, where he boarded a Trailways bus for Quincy, Illisois. They used KING's 1967 Hustang, To the best of her knowledge KING left Greenville, Mississippi, by Trailways bus at approximately 7:00 PM. April 4, 1968. KENNEDY stated that she returned to Lake Providence in the 1967 Mustang which she is keeping until KING returns in May. At about 10:00 PM, April 4, 1968, she received a call. from KING who stated that he was in Clarksdale, Mississippi. at the Downtowner Motel. He stated that the bus could not go any further than Clarksdale and requested her to pick kin up at the Downtowner Motel. She then drove to Clarkedale, Mississippi, where she picked up KING at about 1:00 AM. April 5, 1968, and they returned to lake Providence. In the late marring hours on April 5, 1968, she drave KING to the KGW Towing Office, Greenville, Hististippi, where he was to obtain transportation to his tow best. KENNEDY advised that she did not know how KING left Greenville. Mississippi. inassuch as see returned to lake Providence immediately after she dropped him off at the KGW Office.

KENNEDY advised that to the best of her knowledge KING is not associated with the Ku Klux Klan or any militant groups. She also stated that to the best of her knowledge KING only had a duffle bag containing his clothes when he left Lake Providence, and she Thes not know of any weapons in his possesion.

KENNEDY pointed out the 1967 Mustans two-door. blue in color, parked in front of her residence as the one recently purchased by KING. The registration for this vehicle reflected that it has vehicle identification number 770171*772*13, bearing 1968-69 Louisiana License 86F948. The registration further reflected the owner as TRAVIS Sheff imad.

BILLY RAY KING was interviewed at the Rock Island, Illinois, Police Department, by ROBERT A: WICKWIRE and CHARLES E. SMITH who identified themselves as Special Agents of the FBI: KING was warned of his rights and he waived them as shown on an executed warning and waiver form.

BILLY RAY KING advised he has resided for ten years at 102 Arlington Street, Lake Providence, Louisiana. He has been employed as a deck hand on different boats in the Mississippi River since he was 18 years of age. He stated for the last three months he has been employed as a deck hand on a towboat for the K.G.W. Towing Company out of Greenville, Mississippi.

He added that he had been injured on his boat approximately twenty days ago and had been treated at the Greenville, Mississippi, General Hospital, but had been recuperating at his home in Lake Providence, Louisiana. He had recovered and arranged to catch his boat, which is the George Weathers, at Quincy, Illinois. His Personnel Director, JERRY WILSON, with the K. G. W. Towing Company in Greenville, Mississippi, had given him an airplane ticket from Greenville, Mississippi, to St. Louis, Missouri, to Quincy, Illinois, for April 5, 1968; however, he determined that all planes were full and was instructed to take a bus to Memphis, Tennessee, to catch a plane to St. Louis. He left his home by Trailway Bus around noon on April 4, 1968 and proceeded to Memphis, Tennessee, which is about 175 miles. He arrived in Memphis sometime in the afternoon probably around 4:00 p.m. While at the Trailway Bus Depot, the riots broke out due to the shooting of MARTIN LUTHER KING. He advised that the bus depot was closed. There was no busses allowed to leave or enter and the reople in the bus depot were forced to remain in the depot all night long. He advised that the depot was only two or three blocks from the Lorrzine Motel in Memphis, Tennessee, where KING was shot. He advised that he knows where this motel is located as he had stayed there on previous occasions. He added that it was general knowledge in all the papers that Dr. MARTIN LUTHER KING was in Memphis and staying at the Lorraine Motel

KING stated that he did not shoot MARTIN LUTHER KING but hastily added even if he had done so, he would not tell. He also stated that MARTIN LUTHER KING got just what he deserved and that the people in the North are getting just what they deserved on this racial problem as they caused the whole thing. When asked if he was a member of the KKK, KING stated that he was not a member but also added even if he was, he would not tell.

KING then stated during the early hours before daybreak, the busses started to move and he was able to take a taxi to the airport. He recalled that the fare was somewhere around \$4.65. When he arrived at the airport, he determined that there was only one plane that he could catch to Quincy, Illinois; however, this plane was full and he was placed on stand by. When the plane left and he could not get on, he then made a long distance telephone call to his boss JERRY WILSON who then told him to catch a bus to St. Louis and a bus to Quincy where he could catch the boat. He advised that he took a cab back to the bus depot where he boarded a Trailway Bus for St. Louis. Missouri. He advised this was early in the morning and arrived in St. Louis sometime around noon. He then caught a bus from St. Louis to Quincy; however, this bus made many different stops and he arrived too late in Quincy to catch the boat. He then took another bus to Rock Island, Illinois, where he now awaiting for the boat which is due to arrive at 12:00 midnight.

KING stated that he owns a 1967 bright blue Mustang which is at his home at Lake providence, Louisiana. He explained that the papers for this car are in the name of his friend TRAVIS SHEFFIELD, who lives approximately three blocks away on Foster Street. He stated he bought this car from SHEFFIELD and is making the payments but he has not had the papers changed over to his name. The car is at his home. KING also admitted that he owned a .38 pistol and a shotgun which are both at his home.

Enclosed for Memphis are 9 copies of an FD-302 reflecting interview of suspect BILLY RAY KING at Rock Island, Illinois.

On 4-7-68, Detective Sergeants JOHN COLEMAN and ROY WEST, Rock Island Police Department, advised an anonymous telephone call was received at the Police Department that a white male wearing gold colored clothing was at the Ft. Armstrong Hotel in Rock Island, Illinois, either had a gun or guns or made statements that he had killed someone or that he had been in Memphis, Tennessee, when MARTIN LUTHER KING was killed. The voice was very muffled and the exact comments could not be distinguished.

Both proceeded to the Hotel where they immediately located BILLY RAY KING whom they checked for a gun. In subsequent conversation, they determined that KING came from Louisiana and spoke very bitterly of MARTIN LUTHER KING. He stated he got what he deserved and when asked if he had killed him, this person responded that even if he had he wouldn't tell them. They decided to take him to the Police Department for further investigation.

Photographs were obtained and major case prints were obtained. The major case prints were mailed directly to the Latent Fingerprint Section and photographs directly to the Memphis Division.
