BILL QUINN, 1870 Whitney is capable of the murder in this matter. Quinn resembles the artists conception sketch. He is white, male, 44 years old, 5'9", 170 lbs, brown hair, nose like in the sketch. He is a plumber by occupation. He is not crazy but is different from most people, and he is capable of becoming emotionally disturbed about events. Quinn is married and lives with his wife and 4 or 5 children at the above address.

It is noted that Bill Quinn is a frequent caller to the Memphis Office. He complains about everything in Memphis, that he has called to the President of the United States, and that the Secret Service told him if he bothers the President anymore he will "be sent to Bolivar." Quinn has been drunk on a number of occasions, and on one such occasion stated he had two revolvers.

Mustang lead

On the above date Mr. Paul Matlock, 6096 Cedar Brush Brive, Southaven, 393-2547, furnished the following information;

He is employed at the Heyman Building, Madison Avenue and left the office a few minutes before 6:00 PM. He drove onto Riverside Drive heading home. A white Mustang pulled in behind and made several attempts to pass him but could not because of cars in the other lane. The Mustang was able to pass about where the exit goes under the tracks.

This Mustang was a white Fastback, with 4 tailites on each side, had a factory equipped trailer bracket with a chrome trailer hitch on the rear. The rear window appeared to be tinted. The Mustang passed him before he got to the stoplight before the Holiday Inn. When he made the turn and went over the hill the Mustang was out of sight. It was about 6:15 PM when he saw the Mustang.

It was his recollection that driving the Mustang was a thin faced white man wearing a light tan blazer. He was of a thin build, possibly a little above average in height, was wearing no hat, his hair was sandy or dark sandy and was combed back, and his age was estimated between 26 and 28 years.

On 4/11/68, Mrs. EARL SMITH, Manager, Appliance Department, Western Auto Store, 5001 Charlotte Pike, Nashville, Tennessee residence 919 16th Avenue South, telephonically contacted the Nashville FBI Office and requested to be interviewed by Agents concerning information he possessed relative to the murder of MARTIN LUTHER KING, JR.

Upon interview same date, Mr. SMITH furnished the following information to SAs LEONE J. FLOSI and M. BARRY CARMODY:

SMITH stated that he was formerly an Airman First Class, AF SN [REDACTED] for six years. His duty station was Seymore Johnson SAC Air Force Base and his particular job was Explosives Ordinance Disposal technician (EOD).

During August of 1966, SMITH was employed by Western Auto Store Number 3, located at 1345 Summer Avenue, Memphis, Tennessee. At this time he was residing in a rooming house owned by an older woman named LOUISE BOWEN at 1257 Peabody, Memphis, Tennessee. SMITH frequented a tavern on Bellevue Street. He does not recall the name of this tavern but stated that it is directly across the street from a Huddle Hamburger Restaurant and several doors from another bar called "The Show Bar". The owner of this tavern is a white female, first name ANN. While SMITH was in this tavern he engaged in a conversation with another patron and told this person that he was formerly in the Air Force and was an EOD. During this conversation this individual mentioned the name of a fellow whom he claimed was his nephew that was also in the Air Force as an EOD. SMITH recognized this airman's name and stated that he was

assigned to the Tactical Air Command at Seymore Johnson in May, 1962. He said that this airman was on Temporary Duty Station at Seymore for about one month.

Two days after the initial conversation while at the same tavern SMITH was recontacted by the above individual and called over to a booth. SMITH stated that during this conversation, the above individual told SMITH that he was aware that since SMITH was a former EOD in the Air Force SMITH had contacts and would have access to munitions and explosives. He then requested SMITH to get for him 50 handgrenades and pulled out \$5,000

in cash which he laid on the table and offered to SMITH stating "This is yours if you get me the grenades". He then went on to explain that he and four other men in Memphis had vowed to each other that one of them would kill MARTIN LUTHER KING, JR. in one way or another and that was the reason that he wanted the hand grenades. SMITH inquired of the individual as to whether he was a member of the Ku Klux Klan and he said he was not. SMITH stated that he declined to accept the offer whereupon he was told that "if you can't get them for me you had better forget it. You are the only one who knows about this and if anything happens I will know where it came from". SMITH said that he considered this a threat. This was the last contact SMITH ever had with this individual and he does not remember his name nor the name of his nephew, the airman.

SMITH described the above individual as a white male, 45 years of age, 5'7", grey hair, heavy build, 220 lbs., and well dressed. He drove a new 1966 Corvette.

SMITH stated that from his conversation with this person he received the impression that he had a prison or police record.

Mr. SMITH further advised that one E. C. CHILDS who now operates a barber shop in Memphis and formerly owned a recording studio which recorded the record "NAACP Flight Number 125" was also a customer at the above tavern and perhaps could help in identifying this person. SMITH stated that he also received the impression that the tavern owner ANN was acquainted with the above individual.

SMITH stated that he had no objection to having his identity revealed in connection with this inquiry.

Subsequent to the above interview on the same date Mr. SMITH again telephonically contacted the Nashville Office and stated that he had just been fired from his job but stated that this was not because of the earlier interview with the FBI Agents.

After receiving the above information from SMITH, Mr. C. E. WEAVER, general manager, Western Auto Store, 5571 Charlotte Pike was contacted. WEAVER advised that he had not fired EARL SMITH but that SMITH was told to return home as WEAVER stated SMITH was drinking on the job. WEAVER further stated that SMITH was due to arrive at a meeting of Western Auto employees at 6:30 a.m., 4/11/68. When SMITH failed to attend, WEAVER sent a man to locate SMITH at SMITH's residence. It was reported to WEAVER that SMITH was drunk the previous evening and overslept, missing the meeting. WEAVER advised that he considers SMITH to be deceitful, unreliable and perhaps a heavy drinker and has been seriously considering terminating his employment.

In view of Mr. WEAVER's appraisal of SMITH any action to be taken on the information furnished by SMITH is being left to the discretion of the case agent.

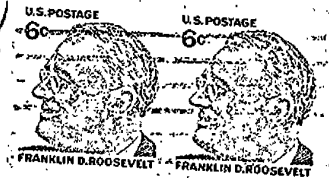
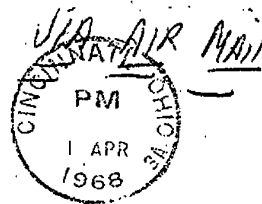

After numerous unsuccessful efforts were made to contact and locate HAROLD F. PALMER, home address 1327 Laidlaw Avenue, Cincinnati, Ohio, Mr. PALMER was located and interviewed at his place of employment, U. S. Department of Public Health, Taft Engineering Center, Cincinnati, Ohio, on 4/24/68. Mr. PALMER advised he is employed by the U. S. Public Health Service as an engineer.

Mr. PALMER readily admitted that he wrote instant letter to the Subscription Department of the New York Times and at the bottom printed "THE KING IS DEAD". He explained the reason for printing this inscription "THE KING IS DEAD" at the bottom of the letter was a result of himself being overjoyed at hearing the news either a day or two before 4/1/68, that President LYNDON JOHNSON was removing himself from seeking re-election for President for the next four years.

Mr. PALMER said that he had written several other letters shortly after President JOHNSON made this announcement and also printed "THE KING IS DEAD" at the bottom of these letters.

At 9:30 AM, 4/11/68, Mr. J. H. COFFEE, owner Coffee Upholstering Shop, 7898 Raleigh-Millington Road, Millington, Tennessee, advised he observed a artist conception drawing of the suspect in the murder of Dr. MARTIN LUTHER KING, JR., in a local Memphis newspaper shortly after the murder. He said he has not called earlier because he felt authorities had a good suspect and he did not desire to cloud the issue.

Mr. COFFEE advised the artist conception drawing looks very much like one (FNU) CRAVENS who is with Cravens Fabrics and Supply Company, Little Rock, Arkansas. He said (FNU) CRAVENS is tall, about 6'0", has a slender build, and has a long thin nose like the drawing. He said CRAVENS has receding hair, and for that reason it is hard to estimate his age, however, he feels CRAVENS is age between 30 and 40 years. He could not recall the color of CRAVENS hair, but he feels it is light colored. He said CRAVENS, as a fabrics salesman, visits him about every three or four months, and CRAVENS drives a light colored automobile, not a Ford Mustang. From CRAVENS conversations he feels he is married and has children.

On 4/16/68 Mr. JIMMY REEDER, 1928 Lamar Ave., Memphis, telephone BR5-2409, who is employed as a used car salesman at Jim McDonald Motors, 2466 Summer Ave., telephone 452-6553, furnished the following information:

He had observed the composite photograph of an individual in one of the Memphis newspapers regarding captioned case. He stated he desired to furnish information regarding MURRELL (ph) HICKS, who now resides at Atwood, Tenn., who resembles the person in the paper.

He stated that HICKS formerly lived in Memphis, and in his opinion, is a "crackpot" who had pulled some various insurance-type frauds in Memphis. He stated HICKS left Memphis about two years ago, at which time he was driving a 1964 Ford Galaxie. HICKS is supposedly living with his father-in-law, name unknown, in Atwood, Tenn., and left Memphis because he began drinking quite heavily.

He furnished the following description of MURRELL HICKS:

Mrs. MARTHA BOSH, Receptionist, the Salvation Army, 47 South Main Street, advised that at approximately 1:00 P.M. on April 8, 1968, a white male came to the entrance of the Salvation Army Headquarters at 47 South Main Street, and lingered at the door for a brief period. She stated that she asked him to come in and then asked what he wanted. He replied by asking, "Could you give me a meal ticket?".

Mrs. BOSH stated that she did not recognize this individual and that when he responded affirmatively to her question as to whether he had ever been there before by giving his name as ALFRED J. KAMINSKI, she checked her registration records and found that he had previously been registered at the Mansfield Salvation Army and that she then furnished him with a Salvation Army meal ticket in the amount of 75 cents, redeemable at Prince's Lunch, located on South Park Street, Mansfield, Ohio.

Mrs. BOSH stated that it is not the practice of the Salvation Army to ask for identification when it has determined that an individual has previously been registered with the local branch of the Salvation Army. In addition, she stated that it was not necessary for an individual who has previously registered to sign any form when requesting a meal ticket.

Mrs. BOSH stated that this individual, who identified himself as ALFRED J. KAMINSKI acted very unusual, as if he may have been sick or possibly an alcoholic. ALFRED JOSEPH KAMINSKI, was observed walking north on North Main Street at Temple Court, by ALBERT D. O'NEIL, Captain, Mansfield Police Department and SA ANDERSON, at which time he was approached; was advised by SA ANDERSON of the identities of the interviewing officers; further advised of his rights and told that he was not under arrest. He admitted his identity as ALFRED JOSEPH KAMINSKI and agreed to voluntarily accompany the interviewing officers to the Mansfield Police Department for questioning in regard to a Federal matter involving a possible Civil Rights violation.

At the police department, he was again warned of his rights by SA ANDERSON and he waived them as shown on an executed Warning and Waiver Form, which waiver also discloses that he accompanied the interviewing officers to the Mansfield, Ohio Police Department on his own choice and that he knew that he was not under arrest and could leave the office if he so desired.

On this occasion, he advised Captain O'NEIL and SA ANDERSON as follows:

He is an itinerant traveler and maintains a residence address as that of his sister, Mrs. RITA FRIEND, 5 Pavonia Court, Bayonne, New Jersey.

The recent winter months have been spent by him in San Marcos, Texas where he worked for Rhea B. Merritt, 4613 Chaipero Trail, Austin, Texas.

He departed San Marcos January 2, 1968 en route to the home of his sister in Bayonne, New Jersey, where he contemplated spending a day or two before renewing his travels.

He had a spiral ring notebook on his person disclosing his daily whereabouts from March 1, 1967 to date, and the following was made known by him as to his specific locations on the indicated dates set out below:

Shortly after his arrival in Marion, Indiana, he claims he was taken to the police department based on a complaint by a citizen that he had been hitchhiking. While at the police department he was interrogated by two detectives as to his whereabouts and location on the day Dr. MARTIN LUTHER KING, JR. was assassinated. Upon these detectives becoming convinced he was not involved in this assassination, he was photographed and released.

KAMINSKI denies he has ever been in Memphis, Tennessee at any time; denies he shot MARTIN LUTHER KING, JR.; claims no knowledge concerning this incident except what he has learned through the news media. He claims to have never used any names except his own.

A search of his person and personal property by SAS LAVERN C. STOVER and A. JAMES ANDERSON, JR., with KAMINSKI's consent, met with negative results. He had no money, claiming he spent his last two dollars when staying at the hotel in Anderson, Indiana.

Six colored polaroid photographs were taken of him by Captain O'Neil in the presence of SA STOVER.

He was photographed and fingerprinted in the presence of SA ANDERSON by Captain RAYMOND KARSMIZKI, Identification Officer, Mansfield Police Department, having been assigned Mansfield Police Department #14372.

Major case fingerprint impressions were also obtained of him by SA ANDERSON.

On termination of the interview, he was transported to the Volunteers of America, where he desired to spend the night.

HENRY ALBERS, owner and manager, Prince's Sandwich and Coffee Shop, 12 South Park Street, advised that at approximately 1:30 P.M. this date a white male, approximately 40 years of age, weighing approximately 145 pounds, and being approximately 5'9" tall, entered his establishment and presented Salvation Army meal ticket #4734, in the amount of 75 cents, dated April 8, 1968, to be remitted at Prince's Lunch by ALFRED KAMINSKI.

ALBERS stated that this individual did very little talking and was furnished a bowl of chili, hamburger, and two cups of coffee as his meal. He recalled that he only answered yes when asked if he had completed his first cup of coffee.

ALBERS stated that the individual had a very dark tan and seemed very nervous. He appeared to be ill but there was no indication that he had been using intoxicating beverages.

ALBERS stated that this individual was wearing a tan topcoat and was carrying a cloth AWOL type duffel bag. He said he was wearing black shoes, grey pants, and that he was not wearing a hat. He said the individual had dark blond hair that was combed straight back and was receding in the front. He does not recall whether this individual was wearing a necktie.

ALBERS advised that after this individual left his lunch room, another customer, whose name he does not recall, mentioned that this man resembled the artist's conception of the suspect in the assassination of Dr. MARTIN LUTHER KING, JR. that had appeared in the Mansfield News Journal. He stated that he himself thought that this man bore a certain resemblance to the artist's drawing of the assassination suspect.

The following investigation was conducted by SA
A. JAMES ANDERSON, JR. on April 8, 1968:

Captain ALBERT D. O'NEIL, Mansfield Police Department, related that THOMAS TUCKER, owner of Tucker Furniture, Park Avenue West, telephonically advised that approximately 1:30 P.M. or shortly thereafter, he observed an individual at Prince's Lunch, who strongly resembled a commercial artist sketch of the suspect in the killing of Dr. MARTIN LUTHER KING, JR., which sketch appeared in the "News Journal", Mansfield local newspaper, April 6, 1968. Lunch was purchased with a salvation army meal ticket.

It was immediately determined the only Salvation Army meal ticket presented at this establishment was Salvation Army ticket #4734, having the name ALFRED KAMINSKI written thereon. It was also verified through the Salvation Army that such a meal ticket had been issued to one ALFRED KAMINSKI.

The Salvation Army, Mission Houses, Volunteers of America, cheap bars and cheap hotels were checked for ALFRED JOSEPH KAMINSKI with the assistance of the Mansfield Police Department. KAMINSKI was found on the streets by Captain O'NEIL and SA ANDERSON after which he was interviewed.

At a later hour, THOMAS TUCKER, identified above, examined Polaroid colored photographs of KAMINSKI as displayed to him by Captain O'NEIL. O'NEIL commented TUCKER immediately identified the photograph of KAMINSKI as being identical to the individual he observed in Prince's Lunch as mentioned above.

On the evening of April 8, 1968, the Springfield and Indianapolis Divisions telephonically advised the Cleveland Division that investigation verified that one ALFRED JOSEPH KAMINSKI had stayed at the Salvation Army, March 29, 1968 in Springfield, Illinois; at the Mission House, Muncie, Indiana, April 4, 1968.

The fingerprint classification of KAMINSKI's fingerprints as taken at the Mansfield Police Department were telephonically made known to the Identification Division of the Bureau. Subsequently, the Identification Division advised the Mansfield Police Department fingerprint classification concerning the fingerprints of KAMINSKI is a classification similar to the classification of the known fingerprints of ALFRED JOSEPH KAMINSKI, as on file Identification Division; that the known fingerprints of KAMINSKI
