PENNY GILLIAM, Apartment 102, 2118 County Road, District Heights, Maryland, telephone 735-1064, telephonically advised WFO instant that she had just seen television broadcast revealing identity of assassin as JAMES EARL RAY. GILLIAM furnishing following information in the event individual she knows as JIM RAY might possibly be identical with JAMES EARL RAY.

GILLIAM related that in 1962 or 1963 she used to swim at a private lake near Kansas City, Mo., at 9900 Raytown Road. She related this lake is secluded from the road and presently deserted with no one living nearby. GILLIAM recalls a JIM RAY, who was quite a bit older than she and who was from a large family, also swam in this lake during this period.

Inasmuch as referenced teletype indicates that JAMES EARL RAY was incarcerated at the Missouri State Penitentiary, Jefferson City, Mo., since March 17, 1960, and allegedly confined to that Institution until time of his escape, 4/23/67, This is being furnished to Memphis and Kansas City for info purposes. Possibility exists that "JIM RAY," individual GILLIAM refers to is a possible relative of subject JAMES EARL RAY.

KANSAS City from file review determine if this is area of RAY's background and determine if this information has significance to captioned case.

No lead is being set forth for the Los Angeles Division at this time because of the limited information available to WFO concerning subject this case.

On 4/18/68 LE (MRS. CHARLES R.) REECHER, aka Mrs. LE MORISSE, her previous married name, currently residing with her daughter BRENDA (MRS. JERRY ALLEN) WEBER, (P.O. Box 85), Mead, Nebraska, advised that both she and her daughter are in process of obtaining divorces from their husbands who travel together and are away from home almost continuously.

Mrs. MORISSE related that although married to him since 6/16/66, she had not ever come to know much about CHARLES R. REECHER and that, except for that having to do with his employments, marriage, and description, he is the only source of the information set out below, the authenticity of which she has no way to verify.

REECHER was paroled early in 1966 from the Illinois State Penitentiary where he had been sentenced for rape. She became acquainted with him when they were both employed at International Harvester, Moline, Illinois, and J.I. Case, Bettendorf, Iowa. Either through direct association or mutual acquaintances at the penitentiary, REECHER became closely associated with Chicago hoodlums "Little Caesar" (an "Italian name" not recalled by Mrs. MORISSE), MIKE (LNU) and PETER VERDINO. REECHER "thinks the world" of "Little Caesar". The "Double R" bar or tavern in Chicago is operated by MIKE (LNU) and VERDINO.

On or about 3/24/68 REECHER and WEBER returned to Mead and during their conversations regarding his trip, REECHER told Mrs. MORISSE they had been in Chicago where PETER VERDINO had "offered him (REECHER) a contract to kill 'KING' for \$20,000" or, as an alternative, to "transport dope out of New York" for \$10,000. REECHER said he had not accepted either offer and sought Mrs. MORISSE's views concerning them which she expressed as "a ridiculous idea" for him even to consider.

REECHER and WEBER again departed Mead on or about Sunday March 31 and returned Sunday 4/7/68, reportedly by bus to Fremont or possibly Omaha, Nebraska, where they were picked up by WEBER's mother. They stayed only about 24 hours when they left again, taking Mrs. MORISSE's car, a black two-door Ford, about 1962 model, license or VIN not immediately available, and their present whereabouts are unknown to her. During that time REECHER mentioned that WEBER had a gun and that he had taken possession of it for safekeeping. She did not see a gun nor was it described to her. No reference was made by REECHER to their previous conversation about his offer of "a contract" nor to the shooting of MARTIN LUTHER KING, JR., which had occurred during the previous week and Mrs. MORISSE was prompted to advise the FBI of these circumstances only after long deliberation and her conclusion that she should not withhold it even though it may be without significance.

Mrs. MORISSE requested that her identity be protected in any investigation which may be undertaken with respect to the information furnished by her.

REECHER was described as white male, born [REDACTED] 6'2½, 230 pounds, light brown curly hair with blond streaks; blue eyes and always wears hornrimmed glasses; native of Coleta, Dixon or Sterling, Illinois; employed, since early 1966 when paroled from Illinois State Penitentiary, as welder and lift truck operator, at International Harvester, Moline, Illinois, J.I. Case, Bettendorf, Iowa, Independent Metals and Omaha Steel, Omaha.

JERRY ALLEN WEBER was described as white male, born [REDACTED] or [REDACTED], 6', slender build. His (adoptive) parents are LAWRENCE and EDNA WEBER who operate the Spart Time Cafe at Mead. An adopted sister is LINDA WEBER, employed as Nurse's Aid at University Hospital, Omaha. WEBER described as lazy and dependent upon his mother for pocket money.

LEONARD SPEARS, FORMER EAST BATON ROUGE PARISH SHERIFF'S DEPUTY, ADVISED THAT AT APPROXIMATELY EIGHT FORTYFIVE PM, FOUR NINETEEN SIXTYEIGHT, HE PULLED UP BESIDE GRAY VOLKESWAGEN BEARING SIXTYEIGHT ALABAMA LICENSE THREE ONE SEVEN TWO THREE NINE HEADING SOUTHERLY DIRECTION AIRLINE HIGHWAY, BATON ROUGE. Mr. DONOVAN explained that the WADE'S are "high type people" and close social friends of the DONOVAN'S. He stated that Mrs. WADE'S maiden name was LOWMYER (phonetic) of Memphis, Tennessee. Mr. DONOVAN stated he did not know Mrs. WADE'S family, but felt that she could be interviewed to determine whether she might be a relative of subject of this case.

Mr. DONOVAN stated that because of the nature of the social relationship between his family and the WADE'S, he desired that his identity be protected in this matter.

DETAILS NOT RECALLED. DRIVER WAS IN CAR ALONE AND CAR WAS HEAVILY LOADED WITH LUGGAGE, POSSIBLY FIVE OR SIX SUITCASES.

DRIVER PRODUCED A VALID FLORIDA DRIVERS LICENSE. DOES NOT RECALL NAME ON LICENSE, BUT SAID IT WAS UNCOMMON NAME IN THIS AREA AND WAS A VERY SHORT NAME WITH ABOUT FOUR LETTERS. LICENSE REVEALED THE DRIVER WAS EMPLOYED AS AN AIRPLANE PILOT, AND HE ASKED DRIVER WHAT AIRLINE HE FLEW FOR AND DRIVER NAMED AN AIRLINE, NOT WELL KNOWN, WHICH WILLIAMS CANNOT RECALL. AIRLINE HAD TWO NAMES.

ON SEAT NEXT TO DRIVER WAS A FOLDED MAP OF SEVERAL SOUTHEASTERN STATES, WHICH WAS NEATLY MARKED SHOWING A ROUTE FROM SOMEWHERE IN DEEP CENTRAL GEORGIA TO WYTHEVILLE, VA., AND WILLIAMS ASKED DRIVER WHERE HE WAS GOING AND DRIVER STATED HE WAS GOING TO WYTHEVILLE TO VISIT FRIENDS AND WAS THEN GOING TO CHARLESTON OR ELIZABETH, W. VA., TO VISIT FRIENDS AND OR RELATIVES. HE DID NOT MENTION ANYONE BY NAME. HE INSTRUCTED DRIVER AS TO HOW TO GET ON HIGHWAY SEVENTEEN, NORTH.

HE IS CERTAIN THAT GALT WAS THE DRIVER OF THIS CAR. HE SAID THERE IS NO DOUBT IN HIS MIND THAT THIS WAS GALT. HE STATED THE DRIVERS CHECKS WERE NOT AS FULL AS IN THE PHOTOGRAPH. HE HAD SHARP FEATURES AND HIS FACE WAS HANDED AND LONGER THAN IN THE PHOTOGRAPH. HE HAD A LONG, NARROW, POINTED NOSE AND LARGE EARS. FACE WAS LESS FLESHY THAN PHOTOGRAPH OF GALT. HE DESCRIBED DRIVER AS AGE ABOUT THIRTY, NOT LARGE FRAME, BROWN HAIR, NOT DARK, WHICH WAS SHORT, RECEDING AND MUCH SHORTER THAN IN PHOTOGRAPH AND BRUSHED STRAIGHT BACK. On 4/10/68, HOWARD McCUSITON, Knoxville Parking Service, 5601 North Boradway, Knoxville, Tennessee, telephonically contacted SA HOWARD A. McKAMEY and indicated he had some information concerning the murder of MARTIN LUTHER KING.

On the same date SA McKAMEY contacted McCUSITON, and he provided the following information indicating that he desired that this information remain confidential.

He stated that approximately three years ago he was a member of the American Nazi Party (ANP) at Washington, D. C., and lived in the ANP barracks in that city. He stated he disassociated himself from the ANP three years ago and returned to Knoxville. While in Washington, D. C., he became acquainted with ALLEN WELCH who at that time was the national secretary or the national treasurer of the ANP in Washington, D. C., and worked full time at the ANP headquarters. He stated that WELCH at one time worked with an insurance company in Texas and that he is from either Houston or Dallas, Texas.

He stated he observed a photograph in the local newspaper indicating this individual was the murderer of KING. When he observed this photograph, ALLEN WELCH immediately came to his mind and at this time he looked through some ANP literature and obtained a photograph of WELCH which appeared in some literature he obtained just prior to his leaving Washington, D. C.

He stated that WELCH is a white male, age 32, weight 160 lbs., and has receding light brown or blonde hair, medium complexion, and 6 ft. to 6 ft. 1 in. in height. He stated that WELCH has sharp features and no visible scars or marks. He further advised that WELCH is of the emotional type and that one time in Washington, D. C., he threatened to kill himself.

This man seems to hide his face when someone comes by. Scoggins added that he thinks this man lives on North Parway near the corner of Waldren in one of the rooming houses located along there.

At 4:45 am above date, Mr. John Glimp called and said he was now staying at a flop house at 299 S. Main, room six. He did not want to be contacted at this address. He added that his real address is 5264 Millington Road where his brother is in a rest home. He also advised that he did not want to be a witness or involved in captioned matter in anyway but wanted to past on the following information. During September of 1967 a Dan Parham told him that Marthin L. King would be slain in Memphis and that there would be \$100,000 on his head. Glimp was not too clear on whose head he meant and admitted he was ~~XXXX~~ half drunk while making this call. He added however, that Parham told him his information came out of ~~XXXXXX~~ Alabama.

He added that the last he saw of Parham was in November, 1967 when Parham got out of the Shelby County Jail, Memphis, Tenn. Parham has also served time in the Arkansas State Pen.

Glimp advised that he knew the FBI would look up his (Glimp's) record and see that he was an alcoholic etc. but he wanted to past on the above information anyway for what it was worth.

Glimp is no doubt ident with the John Glimp mentioned in Memphis closed file 91-3332. serial 47.
