RE CLOVINA OLONZO, TRIPS TO CALIFORNIA.

MRS. OLONZO ADVISED INSTANT DATE SHE RECALLS MAKING THREE TRIPS TO CALIFORNIA, TWO OF WHICH WERE MADE SHORTLY AFTER DEATH OF LINO ROSAS. EXACT DATES OF TRIPS UNRECALLED DUE TO ILLNESS SUFFERED BY MRS. OLONZO. MRS. OLONZO ADVISED LAST TRIP TO CALIFORNIA MADE IN FALL OF SIXTYSEVEN, EXACT DATE UNRECALLED. MRS. OLONZO KNEW OF NO ILLICIT NARCOTICS TRAFFIC AT RESIDENCE OF RITA ROSAS.

MR. OLONZO ADVISED HIS WIFE TRAVELED TO CALIFORNIA AFTER DEATH OF LINO ROSAS AUGUST THIRTY, SIXTYSIX. STAYED A SHORT TIME, THEN RETURNED TO NEW ORLEANS FOR A SHORT TIME, THEN RETURNED TO CALIFORNIA. MRS. OLONZO'S LAST TRIP TO CALIFORNIA MADE IN SEPTEMBER OR OCTOBER, SIXTYSEVEN AND SHE REMAINED IN CALIFORNIA TWO MONTHS DUE TO FACT SHE FELL INTO COMA WHILE IN LOS ANGELES. MRS. OLONZO RETURNED TO NEW ORLEANS IN DECEMBER, SIXTYSEVEN, WITH TWO OF CHILDREN OF RITA ROSAS, NEE STEIN.
