NILES WAS CONFINED SHIELDS NURSING HOME, OBERLIN AVENUE, LORAIN, OHIO, FOR PSYCHIATRIC TREATMENT ENTIRE SUMMER OF SIXTY SEVEN. CHIEF PSYCHIATRIST DURING THIS PERIOD WAS DR. (FNU) FIECKS OF LORAIN, OHIO.

ON RELEASE FROM SHIELDS NURSING HOME, LATE AUGUST, SIXTY SEVEN, NILES VISITED LEWISES IN CHATTANOOGA FOR TWO OR THREE DAY PERIOD. LEWISES DID NOT HEAR FROM NILES FROM AUG. SIXTY SEVEN, UNTIL HE APPEARED UNANNOUNCED CHATTANOOGA ON JAN. TEN LAST. NILES REPORTED HE HAD BEEN LIVING AT ANP HEADQUARTERS, DALLAS, TEXAS. PERIOD, ROCKWELL, NILES AND CURRENT LEADER OF ANP, KAYLE (PHONETIC), WOULD STOP BY LEWIS' RESIDENCE FOR NILE TO HAVE BRIEF VISIT WITH HIS DAUGHTER. LEWIS STATES DOES NOT BELIEVE NILES CAPABLE OF RESORTING TO TO PHYSICAL VIOLENCE BUT HAS INDICATED REPEATEDLY HE WANTS TO BE MARTYR. LEWIS FIRMLY BELIEVES NILES WANTS TO BE KILLED AS MARTYR FOR SOME CAUSE. NILES HAS THREATENED SUICIDE ON NUMEROUS OCCASIONS OVER PAST SEVERAL YEARS.

LEWIS AND WIFE HAVE CONTINUALLY BEEN EMBARRASSED BY NILES FOR NUMBER OF YEARS AND ON LAST VISIT, JAN., SIXTY-EIGHT, WOULD NOT PERMIT HIM IN THEIR RESIDENCE. LEWIS COULD ONLY FURNISH GENERAL INFORMATION RE NILES ACTIVITIES. ALTHOUGH LEWIS MARRIED CECILIA NILES IN NINETEEN FIFTY EIGHT, HE DID NOT MEET NILES UNTIL ABOUT SIXTY-TWO OR SIXTY-THREE. LEWIS STATES ANY DISCUSSION WITH HIS WIFE, NILES' DAUGHTER, PHYSICALLY AND MENTALLY DISTRESSES HER. LEWIS REQUESTED THAT HIS WIFE NOT BE

INTERVIEWED RE NILES. LEWIS VERY COOPERATIVE BUT DOES NOT WANT TO CAUSE HIS WIFE ANY MORE GRIEF OVER ACTIVITIES OF HER FATHER AND DEFINITELY DOES NOT WANT INQUIRY AT CHATTANOOGA THAT WOULD BE HARMFUL TO THEIR GOOD REPUTATION AND HIS EMPLOYMENT.

LEWIS STATED NILES HAD PHOTOGRAPHIC SHOP IN UNKNOWN CITY DURING WORLD WAR 11, THEN SPENT CONSIDERABLE TIME IN ALASKA FOLLOWING WORD WAR 11, ALSO REPORTED TO BE LEADING SALESMAN IN U.S. FOR AMERICAN CORPORATION, SELLING ENCYCLOPEDIAS IN VICINITY OF CLEVELAND AND CINCINNATI, OHIO, NINETEEN SIXTY-ONE OR SIXTY-TWO. HE THEN SUFFERED ONE OF HIS MORE SEVERE MENTAL DISORDERS, FOLLOWING WHICH HE JOINED ANP ABOUT NINETEEN SIXTY-TWO OR SIXTY-THREE.

REGISTRATION CAR, HOTEL PLAZA, CHATTANOOGA, TENN., REFLECTS NILES REGISTERED AS FRANK H. NILES, THREE FIVE ZERO SIX LINDERWOOD AVE., DALLAS, TEXAS, ARRIVING NINE TWENTY-EIGHT P.M. JAN. TEN LAST AND DEPARTING TEN THIRTY TWO P.M. JAN. THIRTEEN LAST.

The following investigation was conducted at Williamsburg, Va., by SA H. CURTISS BURRELL:

On 5/3/68 Mrs. WYOLENE POINTER, Superintendent, Office, Eastern State Hospital, Williamsburg, Va., furnished their file on FRANK HENRY NILES, patient # 43520. A review of this file revealed the following information:

NILES was committed at Eastern State Hospital on 1/17/68 under a regular commitment by Special Justice DANIEL GRINNAN, City of Richmond, Richmond, Va.

He was diagnosed as being a psychoneurotic reactive - depressive reactive.

He was allowed one pass, which was issued for the period of 4/24-26/68, when he listed his destination as being 6150 Wilson Boulevard, Arlington, Va. He has missed no scheduled roll calls at Eastern State Hospital.

Very little background information has been acquired by Eastern State Hospital. On several occasions they have sent personal background questionnaires to Mrs. CECILIA HOPE LEWIS at 5099 Tinelawn Avenue, Chattanooga, Tennessee. They have received no replies from Mrs. LEWIS.

Their files revealed that NILES was confined at the St. Joseph Hospital, 205 West 29th St., Lorain, Ohio, from 8/28/67 to 8/11/67.

NILES is described as a white male, born [redacted], 131 pounds, 5'9" tall, blue eyes, gray hair, with mustache.

The admitting doctor was W. H. BATTE.

His attending physician is Dr. MARTIN PALMAZ.

Interview of Dr. PALMAZ revealed that NILES is an alcoholic currently assigned to the Alcoholic Vocational Rehabilitation Section of the Eastern State Hospital. It is noted that this area is not secured at all times. Dr. PALMAZ advised that NILES is a definite racist but has had no violence exhibited toward any of his fellow Negro inmates. Dr. PALMAZ described his feelings as being merely a general prejudice. He is described as being very polite but in definite need of a great deal of activity to keep his mind occupied. Dr. PALMAZ advised that he has a very deep-seated hostility toward life in general and that things need to go his way at all times. Dr. PALMAZ considers him to have definite suicidal tendencies. Dr. PALMAZ advised he has never heard NILES make any comments regarding any of the racial or Nazi leaders in the United States.

Dr. PALMAZ noted that NILES wrote a letter to the Social Security Administration recently in regard to his Social Security account, number [redacted], which he felt was delinquent.

It was noted that since March 30, 1968, NILES has been allowed to work at the Howard Johnson's Restaurant, off the Eastern State Hospital's grounds, in Williamsburg, Va. Since that time and to date, he has worked five and six days a week, 40 hours per week, and is paid \$58.

On 5/3/68 JAMES HAMILTON, Manager, Howard Johnson's Restaurant, Williamsburg, Va., was interviewed and advised that NILES was employed at his restaurant from 3/30/68 to the present time. He noted that he was at all times on duty during the period 4/3-6/68. His days off during the instant period were April 2 and 9, 1968. HAMILTON advised that NILES is very well liked and gets along well with all the Negro help.

It was noted that NILES returned to the Eastern State Hospital after his work days during the instant period and at all times during his period of employment at the Howard Johnson's Restaurant. He has missed no roll calls at Eastern State Hospital.

No further investigation being conducted concerning NILES at Norfolk.

The following investigation was conducted by SA(A)
DON FRITZ HEIM:

Mrs. VIOLA V. BORYS, 38 Church Street, Waterloo, New York, advised on May 1, 1968, that the individual referred to in her letter to the Bureau on April 22, 1968, is not known to her personally, and she has not seen him since. She stated she had never seen this person before, does not know where he lives, or what his employment might be. She stated she has made inquiries concerning this individual; however, has been unable to determine his identity.

BORYS described this individual as follows:

On May 1, 1968, Mrs. PHILIP STONE, 581 Geneva-Waterloo Road, Waterloo, New York, advised that DARWIN STONE is her son, and that he currently owns a red MGB automobile, New York License OA 5560. She stated her son is only home on weekends, as he currently attends the University of Syracuse, Syracuse, New York.

On May 2, 1968, EUGENE HELPARD, General Investigator, Provost Marshal's Office, Seneca Army Depot, Romulus, New York, advised the only record at SAD concerning STONE is that he worked as a civilian employee from February, 1967 to September,

GLENN ALVIN PLATZ, 722 South Broadway, Room 4, Santa Maria, California, advised on 5/7/68 that he had previously corresponded with the Post Office Department advising he had information which may be of value to the FBI regarding the assassination of MARTIN LUTHER KING.

PLATZ stated he was employed for about two months during 1966 as a maintenance man at the Sovereign Hotel and Apartments, Santa Monica, California. He could not recall the exact dates of his employment. He continued that when he observed the name and photograph of ERIC STARVO GALT in the newspaper shortly after the assassination of Dr. MARTIN LUTHER KING, it "rang a bell" and he felt sure he had seen GALT sometime in the past, most likely at the Sovereign Hotel. He continued that it was possible he may have seen GALT in Hollywood or somewhere else in the Los Angeles area since he remained in Los Angeles until the early part of 1967 when he moved to San Clemente, California.

She was questioned concerning her knowledge of ANNIE COLEMAN and OLLIE OLTELO, how they were associated with the matter, and any details concerning their identities or further location. Mrs. DAWSON replied that she had a direct communication with God and that God had told her who the killers of Dr. MARTIN LUTHER KING, JR. were and also had told her to notify the FBI. She related that God had also given her the names of the two ladies and also their addresses. She stated that she has never heard either of these two names before, knows nothing whatsoever of their background or occupation, and could furnish no other additional information.

No further investigation is being conducted by SL; no leads being set out.

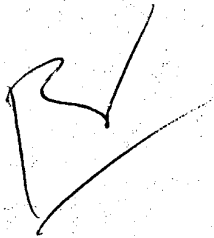
