Files, Passport Office, however, disclose that one JOE BAILEY MUSCROVE was issued Passport [redacted] at New Orleans, Louisiana, on 10/4/67 for proposed travel to Nigeria for one year to work. The name "McKENNITT" appears under purpose of travel. In application 10/3/67 at New Orleans, he stated intended depart NYC via KLM/Pan American Airways/Sevensair about 10/6/67, not by organized tour. According to a notice published in the Federal Register on 3/16/67, this passport was valid for 3 years for all countries except Cuba, Mainland China, North Korea, and North Vietnam.

This individual stated he was born [redacted] at Seminola County, Oklahoma; and file reflects his birth certificate has been seen by passport authorities. He gave his permanent residence as Box 1002, Farmington, N. H., and arranged pick up his passport in New Orleans. Listed father as WILLIAM RAMES MUSCROVE, born Alabama, 1910, and mother as CLAUDE IRENE THOMAS, born Texas, 1910. He stated he was last married 4/16/56 to BETTY LOUISE RANNEY, born New Mexico, [redacted] marriage not terminated. In event of death or accident, he requested that Mrs. BETTY MUSCROVE, his wife, be notified at his permanent residence. He identified himself with N. H. driver's license 410006.

On the basis of photograph comparison, MUSCROVE does not appear to be identical with JAMES EARL RAY.

Mr. ALLEN HARDY, Nigerian Desk, Office of Inter-African Affairs, Department of State, advised on 5/1/68 that the Wilder Oil Company or the McDERMOTT Company in Nigeria are unknown to him. He stated that there are many small American companies with contracts and sub-contracts in Nigeria. He suggested that the Department of Commerce be contacted to identify and locate such companies.

On 5/1/68, Mr. JAMES H. ASHIDA, Foreign Service Office, USDS, attached to the African Division, Bureau of International Commerce, U. S. Department of Commerce, advised SA ROBERT W. BAWSON he could locate no record for a Wilder Oil Company of the U. S. doing business in Nigeria. He stated, however, that the McDERMOTT Overseas, Inc., has address of Nabhib House, 1-9, Berkley Street, P. O. Box 2841, Lagos, Nigeria; further that the J. Ray McDermott and Company, Oil Division, has offices at 14th floor, Houston Club Building, Houston, Texas, and at 200 Loyola Avenue, New Orleans, Louisiana.

HO and NO conduct investigation through J. Ray McDermott Company to determine if MUSGROVE is identical with JOE MUSCAQUE, and if MUSGROVE is residing at Bristol Hotel, Lagos, Nigeria.

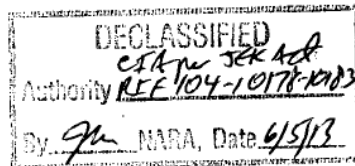
Copies of this communication are being furnished to AQ in the event further information is required in that Division to eliminate MUSGROVE as a suspect in this matter.

SUBJECT: MUSGROVE, Joe Bailey

1. The following paragraphs summarize information relayed telephonically to the Bureau, and are forwarded to you for confirmation and for your files.

2. On 28 April 1968, our representative in Addis Ababa reported that Doctor Klaus Steer, a West German citizen and Director of the African Scientific Department, E. Merck Aktiengesellschaft, Karmstady, Germany, visited the American Embassy, at the request of the local German Ambassador, and reported that he had seen a man in Lagos, Nigeria on 23 April 1968 who strongly resembled newspaper photographs of Eric Stavro Galt, who is currently wanted in connection with the assassination of Dr. Martin Luther King. Dr. Steer said that he saw the Subject at the desk of the Bristol Hotel on the afternoon of 23 April when both were checking out of the hotel. Dr. Steer was accidentally given the hotel accounting receipt for the Subject, on which he noted "Name: Joe Musgaque, Room No: 403, Receipt No: D 52138, Account No: 08325." In a short conversation with Subject, Dr. Steer learned that Subject was employed by the "Wilder Oil Company" and was en-route to Warri, Nigeria on an 18 month contract. Subject told Dr. Steer that he had recently arrived in Lagos from Las Palmas via Accra on Nigerian Airlines.

3. The above information was relayed to the Bureau upon receipt by our duty officer on 29 April 1968. We were advised that the Bureau records did

not contain information on Subject or the Wilder Oil Company. We then requested our representative in Lagos to investigate this matter through unilateral means and through liaison.

4. On 29 April, liaison in Lagos checked the Bristol Hotel and determined that a Joe Musgrove, an American employee of McDermott Overseas Incorporated, arrived in Lagos on 23 April from Las Palmas and stayed in Lagos until 26 April, when he was to leave for the Midwestern State (Warri). Our representative received this information on 30 April 1968, and then visited Mr. Ray Landry, a U. S. citizen, Acting Chief of the McDermott Company, and obtained the following information from a personnel file: Joe Bailey MUSGROVE departed the U. S. on 9 October 1967 for employment with McDermott Nigeria. He has been resident in Nigeria since that date, except for the period 10-23 April, when he went to Las Palmas on leave. Date of Birth: [redacted]. Occupation: Welder. Home Address: P.O. Box 1002, Farmington, New Mexico. Married, wife in U. S. Father: Banks Musgrove, 1017 East Garden (city and state not recorded).

5. Our representative also obtained a passport photograph of the Subject from the McDermott Company and is forwarding the photo to our Headquarters. Later on 30 April, liaison informed our Lagos representative that the Subject holds a U. S. Passport Number [redacted], issued in the U. S. and valid until 4 October 1970.

On Monday past, April 22, I was baby-sitting in the home of my niece Mrs. Alan Terwilliger. At about 10:30 a.m. I went to the living room window facing south and watched a dark (black, I believe) car slowly approaching the fork in the road outside. What attracted me was the apparent nervousness of the driver, young, about 26 or 27, dark straight smooth haired and from the rather crouched driving position of slightly above medium height. He was looking every which way and appeared very nervous. As he pulled past the house to the right I got a $\frac{3}{4}$ face view of his companion, who when ^{the driver} he saw me appear at the window I got the impression he was trying to shield

by leaning forward and the man himself, ^{companion} to draw back against the seat. But I did get a front 3/4 view of that companion's face and it looked like the face of James Earl Ray, as he appears on the Post Office FBI Wanted list. I had the impression ^{the companion} he was wearing a mackinaw in the car, ^{no hat, wearing the companion's} his appearance was casual and rumpled like the Post Office poster.

The direction the car turned would lead either across the mountain into the Mohantongo Valley, or along the base of the mountain to Ashland, and on.

I would have written sooner, but I did not believe my eyes. But on Tuesday I saw the Post Office Bulletin and the resemblance was striking and it set me to thinking maybe I had seen him after all. I remember thinking at the time if only I could have glimpsed that left ear, but that part of his head was hidden by the driver's. The high bank precluded getting a look at the license, afterward. It was drizzling and the macadam road was wet. The atmosphere was quite luminous, however.

On 4/25/68, ROBERT ROJECK, Bartender and Assistant Manager, the Gaslight Bar, 317 Central Street, Kansas City, Kansas, advised SA ROBERT V. HANSEN, JR. that that bar had been operating under that name only since about 1962, and was definitely not operating under that name prior to 1960. He explained that there had been no other Gaslight bar in Kansas City, Kansas.

Since a bar known as the Gaslight was not in operation in Kansas City prior to subject RAY's arrest and continuous incarceration beginning on 10/16/60, no investigation will be conducted at Kansas City, Missouri, to locate any girl friend of subject RAY whom he may have met at such a bar.
