ANITA KATZWINKEL REINTERVIEWED APRIL THIRTEEN LAST. AND ADVISED THAT POSSIBILITY WRITING ON KLEENEX BOX IS HERS. COULD NOT RECALL WRITING SAME BUT SHE HAS NEVER GIVEN HER NAME AND ADDRESS TO "CUSTOMERS" AS HER DATES WERE ALWAYS SENT TO HER BY SUSAN HARRIS. SHE FILLED ONE DATE WHILE AT SERRANO APARTMENTS, BUT EXACT TIME UNRECALLED. DATE'S NAME TOM REGGIE (PH), WHO OPERATED LAUNDRY ON SUNSET BLVD., EXACT LOCATION UNKNOWN AND WHO DID LAUNDRY FOR SUSAN HARRIS ON REGULAR BASIS. HARRIS AND REGGIE HAD ARRANGEMENT WHEREBY HE DID LAUNDRY IN EXCHANGE FOR QUOTE FAVORS ENQUOTE RATHER THAN REGULAR PAYMENT. REGGIE DESCRIBED AS WHITE, MALE, THIRTY FIVE TO FORTY YEARS, BLACK CURLY HAIR, FIVE FEET TEN INCHES, ABOUT TWO HUNDRED FIFTY POUNDS, POSSIBLY HAD HAIRLINE MUSTACHE. REGGIE MET KATZWINKEL AND GINGER NANCE AT APARTMENT OF SUE HARRIS. WENT FROM THERE TO SERRANO APARTMENTS. REGGIE DROVE WHITE PANEL TRUCK.

KATZWINKEL STATED ONLY PERSON WHOM SHE MIGHT HAVE GIVEN HER NAME AND ADDRESS WAS A COLORED MALE, WHOM SHE MET AT BOWLING ALLEY, BY NAME OF TOM WASHINGTON. STATES WASHINGTON ON BOWLING TEAM AND ASKED HER FOR DATE BUT SHE REFUSED. SHE MIGHT HAVE GIVEN HIM HER AND GINGER'S NAME AND ADDRESS. KATZWINKEL NEVER DATED WASHINGTON AND KNOWS NOTHING OTHER THAN HE DROVE A WHITE MUSTANG CONVERTIBLE.

RE REINTERVIEW WITH JAY WALLIS VERNON

VERNON REINTERVIEWED FOUR THIRTEEN LAST AND AMENDED HIS PREVIOUS DESCRIPTION OF GALT AS BEING BETWEEN TWENTY FIVE AND THIRTY YEARS OF AGE, AND APPROXIMATELY ONE HUNDRED SIXTY POUNDS. DID NOT WEAR BERMUDA SHORTS AS PREVIOUSLY STATED. WAS CONFUSED WITH ANOTHER CUSTOMER. STATED GALT'S DRESS WAS UNUSUAL IN THAT IT WAS NOT CALIFORNIA STYLE. COULD NOT PLACE CLOTHING IN ANY PARTICULAR PART OF THE COUNTRY OR FROM ANY FOREIGN COUNTRY, BUT DID THINK MORE ON ENGLISH STYLE. STATES GALT HAD A SLIGHT EDUCATED SOUTHER ACCENT. NEVER SAW GALT IN ANY BARS OR OTHER LOCATION AND COULD NOT ELABORATE ON APPEARANCE OR WEARING APPAREL SUCH AS RINGS, WATCHES, ETC. VERNON TOOK THE TWO COMPOSITES OF SUSPECT AND PLACED THE FOREHEAD AND TOP OF HEAD OF THE BIRMINGHAM PHOTO ON THE ONE FROM MEMPHIS AND INDICATED THAT THIS LOOKED LIKE GALT.

ADVISED FOUR THIRTEEN LAST THAT SHE FREQUENTLY GAVE DANCING LESSONS

TO A MR. ERIC GALT FROM DECEMBER, NINETEEN SIXTY SEVEN TO FEBRUARY,

SIXTY EIGHT. GALT TOLD HER HE WAS A MERCHANT SEAMAN BUT WAS

NOT PRESENTLY WORKING. SAID HE WAS ATTENDING BARTENDING SCHOOL

BUT DID NOT SAY WHERE. SAID HE WAS UNEMPLOYED AT THE TIME.

GALT WAS NOT KNOWN TO BE FRIENDLY WITH ANY OF THE OTHER STUDENTS

OR INSTRUCTORS. HE WAS NEVER OBSERVED IN AN AUTOMOBILE. ON

ONE OCCASION GALT ATTENDED A PARTY AT THE RESIDENCE OF MR. AND

MRS. PAUL CARLSON, TWO SIX ZERO ST. JOSEPH AVE., LONG BEACH,

CALIF., TELEPHONE NUMBER GE NINE EIGHT TWO EIGHT NINE, DURING

LATTER PART OF DECEMBER, SIXTY SEVEN. NORTON ALSO ATTENDED

PARTY BUT DID NOT ACCOMPANY GALT. PARTY ARRANGED THROUGH DANCE

STUDIO AND GALT NOT A FRIEND OR CLOSE ASSOCIATE OF

CARLSON'S. ABOUT TWENTY OTHER PEOPLE ATTENDED THE PARTY.

GALT ARRIVED AND LEFT ALONE. STAYED TO HIMSELF DURING PARTY

AND GENERALLY UNCOMMUNICATIVE. WHILE AT PARTY DRANK PUNCH

CONTAINING ALCOHOL. NORTON SAID HER CONVERSATIONS WITH GALT

WERE LIMITED TO DANCING. GALT WAS RATHER WITHDRAWN AND GAVE

VERY LITTLE BACKGROUND DETAIL CONCERNING HIMSELF AND WAS OFTEN

EVASIVE. STATED HE LIKED TO TRAVEL. WAS A GOOD DANCER.

NORTON NEVER SAW GALT WITH AUTOMOBILE. SHE DESCRIBED GALT AS CAUCASIAN, MALE, AGE ABOUT TWENTY SEVEN, BROWN CREW CUT HAIR, EARS PROTRUDED SLIGHTLY, NOSE NARROW WITH STRAIGHT BRIDGE LINE, EYES, BLUE, HAD SLIGHT SOUTHERN ACCENT, RURAL CHARACTERISTICS TO LANGUAGE AND DICTION, LANGUAGE DID NOT SUGGEST HIGH DEGREE OF EDUCATION, NORMAL PITCH AND NOT LOUD VOLUME, EYEBROWS NORMAL, MEDIUM SLIGHT TAN COMPLEXION, FIVE FEET ELEVEN INCHES, ONE HUNDRED SIXTY FIVE TO ONE HUNDRED SEVENTY POUNDS, TEETH WERE STRAIGHT AND CLEAN, INDICATED HE WAS SINGLE, FINGERNAILS CLEAN AND NEATLY TRIMMED, WORE GOLD RING WITH DARK COLORED STONE, NEATLY DRESSED ALWAYS WORE SUIT COAT, SHIRT AND TIE, SHINY BLACK ALLIGATOR SHOES WITH THIN SOLES AND SLIP ON TYPE, BLACK HOSE, AND TIE TACK AND CUFF LINKS.

NORTON ADVISED SHE NEVER DETECTED THE ODOR OF ALCOHOL ON GALT'S BREATH. HE SMOKED FILTER CIGARETTES, BRAND UNKNOWN. HAD A NERVOUS HABIT AND OCCASIONALLY PULLED ONE OF HIS EAR LOBES. NORTON DID NOT KNOW IF GALT RIGHT OR LEFT HANDED. NORTON HAD NO SOCIAL CONTACT WITH GALT OUTSIDE DANCE STUDIO.

ANDREAS JORGENSEN, INSTRUCTOR, NATIONAL DANCE STUDIO INTERVIEWED AND COULD FURNISH NO ADDITIONAL PERTINENT INFORMATION.

RODNEY ARVIDSON, OWNER, NATIONAL DANCE STUDIO, ADVISED THAT ERIC GALT, ONE FIVE THREE FIVE NORTH SERRANO TOOK A FOUR

HUNDRED NINETY NINE DOLLAR DANCE COURSE FROM DECEMBER, SIXTY SEVEN TO FEBRUARY, SIXTY EIGHT, WHEN HE QUIT ABRUPTLY TO GO TO BAR TENDING SCHOOL. BELIEVED GALT WAS IN MEXICO, POSSIBLY MEXICO CITY EARLY PART OF SIXTY SEVEN. THINKS GALT A SOUTHERNER AS HE SPOKE OF ALABAMA. WAS A MERCHANT SEAMAN AND SHIPPED TO SEA LOCALLY IN THE PAST POSSIBLY FROM LONG BEACH.

ARVIDSON, WHO SPEAKS SPANISH, SAID GALT DID NOT SPEAK SPANISH AND SPOKE ENGLISH BADLY, INDICATING TO HIM THAT HE HAD NO MORE THAN HIGH SCHOOL EDUCATION. WAS SOCIALLY INEPT, AN INTROVERT AND POOR DANCER BECAUSE HE WOULD NOT QUOTE LOSSEN UP UNQUOTE. DROVE WHITE CAR MAKE AND MODEL UNKNOWN. SMILED RARELY AND WHE DID IT WAS A QUOTE NERVOUS CROOKED SMILE UNQUOTE. GALT WAS A LONER, WAS NOT EMPLOYED AND PAID CASH FOR LESSONS TAKING A WAD OF BILLS FROM POCKET. ARVIDSON ADVISED THAT SHARON RHODES, A PART TIME DANCE INSTRUCTOR, EMPLOYED BY CHARTER TITLE COMPANY, BEVERLY HILLS, CALIF. WAS GALT'S REGULAR DANCE INSTRUCTOR.

RHODES PRESENTLY IN STATE OF WASHINGTON ON VACATION, TO RETURN LOS ANGELES APRIL FIFTEEN NEXT. WILL BE INTERVIEWED UPON RETURN.

STEIN ADVISED THAT THE FOLLOWING MORNING DECEMBER FIFTEEN, SIXTY SEVEN, GALT PICKED UP STEIN, RITA, AND MARIE AT THE FRANKLIN HOTEL AND TRANSPORTED THEM IN THE WHITE MUSTANG TO A VOTER'S REGISTRATION PLACE ON LANKERSHIM BLVD., LA. GALT LET THE THREE OF THEM OUT OF CAR IN FRONT OF REGISTRATION PLACE AND THEY WENT INSIDE TO REGISTER. THEY WERE IN PROCESS OF REGISTERING FOR WALLACE'S AMERICAN INDEPENDENT PARTY WHEN GALT ENTERED. STEIN GOT IMPRESSION GALT WAS KNOWN TO PEOPLE IN REGISTRATION OFFICE. GALT SAT BEHIND THEM AND OBSERVED THEIR REGISTRATION. UPON COMPLETION OF REGISTRATION THEY ALL RETURNED TO FIVE SIX SIX SIX FRANKLIN AVE., WHERE RITA AND MARIE DEPARTED. STEIN OBTAINED CLOTHING AT HIS RESIDENCE AND WENT TO GALT'S RESIDENCE ON NORTH SERRANO AND THEN LEFT FOR NEW ORLEANS VIA YUMA, ARIZ, TUSCON, ARIZ, AND EL PASO, TEXAS.

WHILE ENROUTE NEW ORLEANS AND MOSTLY IN TEXAS GALT MADE SEVERAL PHONE CALLS FROM PAY PHONES TO PARTIES UNKNOWN TO STEIN. GALT DURING TRIP INDICATED THAT HE WAS FROM ALABAMA AND PLANNED TO RETURN.

GALT TOLD STEIN THAT HE RECENTLY RETURNED FROM MEXICO WHERE HE FORMERLY HAD A PART OWNERSHIP OF A BAR WITH A MEXICAN. BAR LOCATED NEAR OCEAN AND HE RECENTLY SOLD OUT TO MEXICAN PARTNER.

IN CONVERSATION WITH GALT, STEIN GOT IMPRESSION THAT GALT WAS INVOLVED IN CAMPAIGN TO NOMINATE GEORGE WALLACE IN CALIFORNIA. GALT INDICATED THAT HE HAD TO CONTACT SOME PEOPLE IN NEW ORLEANS, EITHER AN ENGINEERING FIRM OR CONTRACTING FIRM, STEIN WAS NOT CERTAIN. DURING TRIP STEIN TOOK PHOTOGRAPHS OF COUNTRYSIDE AND POSSIBLY OF GALT, HOWEVER NOT CERTAIN. STEIN FURNISHED THIS UNDEVELOPED FILM TO FBI TO BE DEVELOPED. FILM FORWARDED TO BUREAU ON TWA FLIGHT SIX TWO ARRIVING FRIENDSHIP AIRPORT APRIL FOURTEEN SIX ZERO SEVEN AM.

IN NEW ORLEANS GALT EXPRESSED DESIRE TO STAY AT A MOTEL RATHER THAN AT STEIN'S MOTHER'S RESIDENCE. On 4/11/68, SA KENNETH J. HASER was advised that no record of ERIC STARVO GALT or ERNEST GALT could be located in the files of the Office of Security, the general correspondence files or the Visa Office, Department of State. A check was also made on 4/11/68, of the files of the Passport Office, Department of State concerning KARL GALT with negative results.

It is noted that the Visa Office, Department of State maintains records on fewer than 1% of all U.S. visas issued throughout the world. Visa records are maintained in the issuing Embassies or Consulates abroad, nonimmigrant files being retained for 4 years after issue and immigrant files, 16 months, and then destroyed.

From a review of passport files in the surname of GALT, it was noted that several such individuals were born in England or Scotland; it is also felt that there are several GALT families in Pennsylvania of German descent. It is, therefore, suggested that the Bureau consider having Legats London and Bonn check with the Embassies there in an effort to locate a visa file on suspect GALT.


