He described RAY as one of the "nuts" or "cowboys" who according to RICHARDSON were small time hoodlums who would be involved in most any type or petty thievery or gangsterism going on inside the institution.

RICHARDSON stated he knew subject RAY only casually since he worked more than 20 years in the hospital in the institution under Doctor HUGH W. MANLEY. RICHARDSON stated he read some publicity concerning RAY escaping shortly after it occurred but had heard nothing indicating that subject RAY had been in St. Louis or made any contacts in the St. Louis area since that time.

He described RAY as one of the inmates who used narcotics or medicine of any king whenever obtainable. He stated that his most frequent encounter with RAY was upon the occasions of RAY's reporting to the hospital for sick call.

AT MOBERLY, MISSOURI

The following investigation was conducted by SA WILLIAM R. DUNCAN on April 26, 1968.

Inmate DONALD DEAN RIGGER, Number 03959, Missouri Training School for Men, Moberly, Missouri, advised that he had been convicted in December of 1951, and had been an inmate at the Missouri State Penitentiary, Jefferson City, Missouri, from December, 1951, through August of 1967. While there, he worked in the kitchen at the Penitentiary with RAY. RIGGER stated that no one was really friendly with RAY.

RIGGER stated that prior to his apprehension he had jumped bond and had been in Salpillo Coahuila, Mexico. Following his apprehension, he received mail from Mexico. RAY was aware of this and asked questions of him concerning the economy in Mexico. He indicated particular interest in the Mexican Army structure. RIGGER explained it was generally understood by inmates that if they could get into the Mexican Army they could effectively lose their identities.

RIGGER stated that in his estimation the person who was most closely associated with RAY was inmate DONALD JOHNSON, who, to the best of his knowledge, is currently employed in the bread room at the Missouri State Prison in Jefferson City, Missouri.

RIGGER was unable to offer any suggestions as to the present whereabouts of subject.

FELLOW PRISONERS

AT MOBERLY, MISSOURI

The following investigation was conducted by SA WILLIAM R. DUNCAN on April 25, 1968.

JAMES R. RUSSELL, inmate, Missouri Training School for Men, Moberly, Missouri, advised he had been committed to the Missouri State Penitentiary, Jefferson City, Missouri, in November of 1965, and had remained confined there until January, 1966, when he was transferred to Moberly, Missouri. He was released in February, 1967, but went back to Jefferson City as a parole violator in June of that year. He was in the same cell with ROBERT POWELL, also known as BOB POWELL, from August, 1967, to January, 1968.

RUSSELL stated he knew JAMES EARL RAY by reputation only, but did not know him personally. RUSSELL was in the prison kitchen at Jefferson City and also worked with POWELL. He said POWELL mentioned that RAY, because of his escape, was the cause of prison officials cutting down the size of the boxes used to hold bread from the main kitchen. It was his belief that POWELL was released in February, 1968, and was thereafter employed by the American Car Company in St. Louis. To his understanding, POWELL is now in the Los Angeles area. He was of the opinion that POWELL's sister, FRANKIE, who is a student at Farmington, Missouri, High School, might be aware of POWELL's current residence.

RUSSELL stated he recalled a Negro penitentiary guard named BILLY BOB TURNER, but stated he had never heard anyone say that TURNER should be dead.

The following investigation was conducted at St. Louis, Missouri, by SAs CLETIS B. BIDEWELL and WILLIAM H. WARFIELD on May 3, 1968:

OPAL HIGHLEY, owner of the property 1630 through 1636 South 18th Street, advised that one JOHNNY VELANTI resides in an upstairs apartment at 1630 South 18th. He has resided there for approximately eight or nine months and is employed as a radio broadcaster at the Lady of the Snows FM Radio Station, WMRY, Belleville, Illinois. She advised that VELANTI worked from about 11:00 a.m. until sometime around 8:00 p.m. but frequently did not return home until around midnight.

Efforts to interview VELANTI on that date were negative. Appointment was made with VELANTI for an interview on the morning of May 4, 1968, at the St. Louis FBI Office.

JOHN PAUL VELANTI, 1632 South 18th Street, St. Louis, Missouri, was interviewed at the St. Louis Office of the FBI and furnished the following information:

He viewed photographs of JAMES EARL RAY as depicted on Wanted Flyer #442-A dated April 19, 1968. He advised that none of these photographs resembled RAY as he recalls him. He advised that the picture of RAY in the bow tie particularly does not resemble him. He viewed a photograph of RAY taken by the St. Louis Police Department October 10, 1959, and stated this is a very good likeness of RAY as he recalls him.

He advised that as a result of his employment as a radio announcer he has frequently broadcast news releases regarding RAY but failed to recognize RAY as a fellow inmate at the Missouri State Penitentiary until viewing his photograph in a newspaper.

He described RAY as a quiet type who was seldom noticed. RAY did not gamble, play sports, or do anything to attract attention to himself while at the Missouri State Penitentiary. He does not recall having ever spoken with RAY or having been in the same dormitory as RAY. However, he does recall RAY's face from having seen him at the penitentiary. He advised that RAY's escape attempts attracted no attention to RAY inasmuch as there were frequent such attempts by numerous inmates.

VELANTI advised that he was in the Missouri State Penitentiary at Jefferson City, Missouri, from February 13, 1960, to December 19, 1964, at which time he was transferred to the Moberly Minimum Security Prison at Moberly, Missouri. In December, 1966, he was transferred to the honor camp at Fordland, Missouri. He was released on parole March 21, 1967. He was sentenced to the Missouri State Penitentiary February 11, 1959, to serve a 20-year sentence for armed robbery.

While in the Missouri State Penitentiary VELANTI advised that at one time or another he lived in all of the halls. However, he does not believe he was ever housed in the same hall as RAY.

While at the Missouri State Penitentiary he never heard of money being offered for the death of Dr. MARTIN LUTHER KING or anyone else. He advised that it was common knowledge that anyone could "pick up a few bucks by killing guys like He suggested that organizations such as the Ku Klux Klan or other southern organizations commonly referred to as the Klan resisting the present integration movement might pay for the death of KING or other Negro leaders.

VELANTI recalls that ORVILLE GANN, also known as PAPPY, who presently resides at the Dismas House, St. Louis, Missouri, lived in F&G Hall at the Missouri State Penitentiary with RAY. VELANTI believes that he has seen GANN speaking with RAY at the penitentiary. VELANTI has not seen GANN since he was released but has heard that GANN was released from the penitentiary approximately one month ago. He recalls JOHNNY JOHNSON, FRANK MAYBERRY, KENNY HURT, and NONEY EDEN as fellow inmates at the Missouri State Penitentiary. believes the true name of NONEY EDEN to be JAMES EDEN. He explained that EDEN is tongue-tied and was nicknamed NONEY for his inability to pronounce bologna. He is unaware of EDEN's present whereabouts.

VELANTI advised that the name COOLEY (phonetic) and Cooley's Organization have no meaning to him. He advised that COOLEY may apply to a Negro inmate at the Missouri State Penitentiary whose true identity is unknown to him.

On April 19, 1968, Officer RONALD BOCKENKAMP, Intelligence Unit, St. Louis Police Department, advised SA ROBERT L. BENDER that he had been acquainted with JAMES EARL RAY when RAY had been in St. Louis prior to his conviction for the armed robbery of a Kroger store in 1959. He stated further that one J. D. DAILEY, St. Louis Police Department number 68254, was also acquainted with RAY and in his estimation was the type of person who would offer RAY a place to stay, money, or whatever he might need to avoid apprehension. He described DAILEY as a gambler who formerly operated the Halfway Cafe on Jefferson Avenue in St. Louis, Missouri, and who during the middle of March 1968 moved to Portageville, Missouri, where he currently operates a bus stop restaurant under the name of LAFONTE. This restaurant is located on Highway 61 just outside of Portageville.

On April 20, 1968, Sergeant EDWARD SCHAFF, Intelligence Unit, St. Louis, Missouri, Police Department, advised SA EDMUND C. WELTON that at approximately 1 AM on that date he had received a telephone call at his residence from an attorney friend in St. Louis, whose name he would not disclose under any circumstances and who had told him that, in his opinion, JAMES EARL RAY might be hid out by an ex-convict named J. D. DAILEY on a farm owned by DAILEY near either Portageville or Wardell, Missouri.

SCHAFF stated the attorney indicated that JAMES EARL RAY in September, 1967, had been hid out by J. D. DAILEY at the Hathaway House, 1549 South Jefferson, St. Louis, which was formerly owned by DAILEY. The attorney had indicated he had been contacted in September, 1967, by DAILEY, and offered \$1,500 if he could square the escape of RAY from the Missouri State Penitentiary. He had declined to do so, and had indicated he wanted nothing to do with the matter. The attorney had emphasized that his identity should not be brought into this case in any manner. Sergeant SCHAFF stated the attorney felt if DAILEY had anything to do with the subject he might hide him on his farm near Portageville or Wardell, Missouri.

Sergeant EDWARD SCHAFF, Intelligence Unit, St. Louis, Missouri, Police Department, was telephonically contacted by SA ROBERT L. BENDER, on April 20, 1968.

Sergeant SCHAFF advised he had been in contact with an informant, identified only as an elderly attorney acquaintance known to Sergeant SCHAFF for over twenty-two years. He stated this attorney had indicated that JAMES EARL RAY was well acquainted with J. D. DAILEY, who is now residing in the area of Portageville, Missouri. Sergeant SCHAFF stated that he could not, and would not, under any circumstances reveal the identity of the attorney with whom he was in contact.

He stated that attorney indicated there was a good possibility that if RAY were in the State of Missouri, he could be hiding out on DAILEY's farm, which he felt was located in the vicinity of New Madrid or Kennett, Missouri.

Sergeant SCHAFF stated the attorney had called him at approximately 11 PM on the night of April 19, 1968, and had indicated that, although he did not know positively, he thought RAY could be hiding out on DAILEY's farm. SCHAFF emphasized that this was only a "connection" between RAY and DAILEY, and that his source, the attorney, did not know positively that RAY was on the DAILEY farm. He stated the attorney is well acquainted with DAILEY but has not talked to him in over a year and does not know RAY very well. The attorney is definitely not in touch with subject RAY.

Sergeant SCHAFF stated he had given the FBI every bit of information he has learned from his lawyer source, and that he would exclusively provide this office with any additional information coming to his attention which might possibly be developed pertaining to this case. He stated he had provided the Chief of the St. Louis Police Department with the same information but no other individual. He has not told anyone the identity of his attorney informant and would decline to divulge such identity to the Chief of the Department.

On April 23, 1968, Detective Sergeant EDWARD SCHAAF, Intelligence Unit, St. Louis Police Department, was interviewed by SA SPURGEON J. PETERSON and SA ROBERT L. BENDER.

Detective SCHAAF advised that he could provide no additional information which would place JAMES EARL RAY and JAMES DAILEY together. He said he had no other information which might be more specific with regard to any farm property that DAILEY might have in the Portageville area. He said that his source of information had indicated to him that there were two persons who might have additional information regarding DAILEY and any farm property that DAILEY owned, and these people were the man who runs the shoe repair shop located nextdoor to the Halfway Cafe on Jefferson and also VIRGIL DENTON who operates Denton's Bar, which is also in that block. Detective SCHAAF said that any type of information which came to his attention would be immediately provided to the St. Louis FBI Office. Every effort will be made to help in the investigation of RAY.

Re: ALLEGED ASSOCIATION OF JAMES D. DAILEY AND JAMES EARL RAY

Police Officer RON BOCKENKAMP, Intelligence Unit, St. Louis Police Department, advised SA ROBERT L. BENDER and SA SPURGEON J. PETERSON on April 23, 1968, that at the time of JAMES EARL RAY's escape from the State Penitentiary at Jefferson City, Missouri, he was assigned to the Third District, St. Louis Police Department (SLPD). This district covered the area surrounding Jefferson and Park Streets in St. Louis, the area which RAY was known to frequent.

On learning of RAY's escape, BOCKENKAMP stated he contacted a source of information that he thought might have some information about RAY. This source told him that "RAY had been in town for approximately a week" and JAMES DAVID DAILEY had been putting him up and had hid him out in the basement of the Halfway Cafe located on Jefferson.

As a result of this information, he (BOCKENKAMP) went to the Halfway Cafe, where he made a search for RAY but did not locate him. Detective BOCKENKAMP feels that unquestionably the information from his confidential source was accurate. Detective BOCKENKAMP further stated that his source of informatio. knew both JAMES DAILEY and RAY and told him that he (the source) knew from personal knowledge that RAY had been put up by DAILEY.

BOCKENKAMP stated that this source of information was the same person who provided him with the information which led to the apprehension of THOMAS BEECHUM CREWS, who had also been harbored by DAILEY at the Hallway Cale. CREWS is a very close personal friend of DAILEY and had made his escape from the penitientiary at Jefferson City after RAY had made his escape. DAILEY subsequently admitted to him (BOCKENKAMP) that he had hid CREWS out, had given him money, fed him and denied CREWS' request that he obtain him a gun. BOCKENKAMP said that his confidential source, whose identity he declined to make known, was a completely irresponsible local citizen who just happened to know some of the persons in the area of Jefferson, Park and Lafayette Streets. BOCKENKAMP said that he would be willing to confront DAILEY with the above information if it would be of assistance to the FBI in their investigation in instant

matter. He also advised that he would be glad to recontact this source in an effort to determine the identity of any persons who might have personal knowledge of any association between JAMES EARL RAY and JAMES DAVID DAILEY. BOCKENKAMP said that both CREWS and DAILEY were boyhood friends, both coming from the Wardell, Missouri area, and it was very probable that THOMAS BEECHUM CREWS and JAMES EARL RAY served time together at the Missouri State Penitentiary, and RAY may have learned of DAILEY in St. Louis through CREWS, and in this way came to DAILEY for assistance after his escape.

BOCKENKAMP also stated that perhaps some investigation at the penitentiary at Jefferson City could throw some light on who may have assisted RAY in his escape and also determine the driver of the truck that RAY hid in when he made his escape. He stated that he thought possibly a St. Louis Police character, RICH RENO, was the driver of that truck and RENO is probably out of the penitentiary and back in St. Louis at this time.

BOCKENKAMP said that DAILEY had openly admitted to him and to Detective JOHN SIEBANMAN of the Intelligence Unit that he had on various occasions taken whisky, cigarettes and money to the area of the honor farm at the Missouri State Penitentiary and would throw these off on the side of the road so that the convicts could pick them up and take them back into the penitentiary. DAILEY corresponds with CREWS in the penitentiary and visisted him on numerous occasions.

Officer BOCKENKAMP emphasized that he has not and does not say from any knowledge that he has that JAMES EARL RAY and JAMES DAVID DAILEY were friends or even close or that they knew each other prior to RAY's escape, but he does say that some information received by him, which he feels is reliable, indicates DAILEY did put RAY up when he escaped, and when he (DAILEY) denies that he knows RAY he is a "liar".

JAMES D. DAILEY, residing at 402 West 9th Street, Portageville, Missouri, was interviewed at his place of business, LaFonts Cafe, Portageville, Missouri.

He was advised of the identities of SAs DOUGLAS ROSENBERGER and WILLIAM R. BURTON and the purpose of the interview.

DAILEY stated that up until about three to four weeks ago he had owned and operated a restaurant-cafe known as the Half Way House at 1549 South Jefferson Street, St. Louis, Missouri, and was residing at 2708 St. Vincent, also St. Louis, Missouri.

DAILEY stated that he cannot recall the name JAMES EARL RAY or ERIC STARVO GALT or any of the other names as furnished to him by the interviewing agents.

DAILEY stated that within the past several days he has looked at a picture of GALT which was in the Memphis, Tennessee, newspapers and he did not recognize it as anyone he has ever known or ever seen.

DAILEY was advised by the interviewing agents of the fugitive status of JAMES EARL RAY and at this time was also advised of the provisions of the Federal harboring statute.

DAILEY at this time reiterated that he does not know JAMES EARL RAY or anyone of a similar name or description.

JAMES D. DAILEY, 402 W. Ninth Street, Portageville, Missouri, was interviewed at his place of business, La Font Cafe, Portageville. He was advised of the identities of Special Agents CLETIS B. BIDEWELL and EDWARD M. MORELAND, and the purpose of the interview.

DAILEY stated he was unable to identify a photograph of JAMES EARL RAY, St. Louis Police Department number 81071, as any person he has ever known or has ever seen. He displayed a cooperative attitude and related that the only escapee from the Missouri State Penitentiary, Jefferson City, Missouri, with whom he has ever come into contact is one THOMAS B. CREWS, white male, age 39, who escaped in September, 1967. CREWS and DAILEY were childhood friends from southeast Missouri, and after his escape, CREWS came to DAILEY for assistance. At this time, September, 1967, DAILEY was operating the Half Way House Cafe on South Jefferson in St. Louis, Missouri.

DAILEY, who knew CREWS to be an escapee, gave him \$100 knowing he would probably use it to try to go to Chicago, Illinois, but he, DAILEY, advised against it. In conversation with CREWS he tried to convince him to turn himself in to the authorities. CREWS eventually went to a brother's house in St. Louis and was later apprehended by the St. Louis Police Department.

DAILEY related that HOMER TOWNSLEY, a St. Louis bondsman and former tavern operator was aware of his helping CREWS and he, DAILEY, strongly suspects that TOWNSLEY, who is also an informant of the St. Louis Police Department, particularly the Intelligence Unit, probably told them that he, DAILEY, had harbored an escapee from the Missouri Penitentiary and that this escapee was RAY. DAILEY also stated TOWNSLEY would probably try to get him in trouble because in the past he and TOWNSLEY had a violent disagreement over a "joint fleecing" they had been conducting on a victim, a retired U. S. Army Major, PAUL (last name unknown), Alton, Illinois, which amounted to thousands of dollars.

This disagreement resulted in TOWNSLEY hiring a small time hoodlum, JUNIOR CONWAY of Salem, Missouri, to smash windows

DAILEY in February, 1966, retaliated by shooting CONWAY a number of times which shooting permanently paralyzed CONWAY in his lower limbs.

DAILEY emphasized he has never owned, leased, or operated any farm in southeast Missouri, or any other place, and further has never or at the present time have access to a farm through any other source.

DAILEY stated his wife and two children are currently engaged in operating his cafe at Portageville.

DAILEY stated he cannot imagine any situation in which RAY would contact him, but in the event any such contact is made or he develops any information concerning him he would immediately contact the Federal Bureau of Investigation.

The current St. Louis telephone directory listed the address for J. D. DAILEY as 2708 St. Vincent, St. Louis, and telephone number as TO 5-0449.

An effort was made to call the above number and it was determined the number had been disconnected.

Mr. and Mrs. JOSEPH B. HERRELL, 2708 St. Vincent, St. Louis, Missouri, on April 20, 1968, advised Special Agents JACK A. FRENCH and ROBERT J. WILKISON as follows:

They moved to 2708 St. Vincent on Marcy 23, 1968, and the house was vacant at that time. Mr. HERRELL is employed at Concord Homes, Bridgeton, Missouri (suburb of St. Louis).

They stated the former tenant was a man named DAILEY, who operated the Halfway House Cafe on Jefferson Street. When DAILEY moved, he left a black-colored German Shepherd dog at 2708 St. Vincent. The HERRELLs took care of the dog for two or three weeks, at which time DAILEY's sister, Mrs. (first name unknown) JACKSON, picked up the dog and apparently took it to DAILEY, who reportedly lives somewhere in southern Missouri.

They stated that mail addressed to DAILEY, sent to the Halfway House Cafe, was brought to their residence by an unknown youngster in the neighborhood a couple of weeks ago and they returned this mail to the Post Office about a week ago to be returned to sender.

They stated they rented this building from a real estate agent and never knew DAILEY. They said no one came

to 2708 St. Vincent looking for DAILEY during the time they have resided at that address.

Visual observation of the Halfway House Cafe, 1549 South Jefferson, St. Louis, Missouri, determined the store room at that location is now vacant.

Mrs. HAZEL TERRELL, Wardell, Missouri, advised that she is the sister of J. D. DAILY who currently owns and operates a restaurant that he recently purchased in Portageville, Missouri.

Mrs. TERRELL pointed out that in addition to J. D. DAILY being her brother she has two other sisters; namely, ADA GILES who formerly resided at 1812 North Washington Street, Chicago, Illinois, but who recently moved and can be contacted through her daughter, VITA NEWTON, telephone number 421-2853 in Chicago, Illinois. Another sister LILLIAN JOHNSON resides at 2012 Sidney Street, St. Louis, Missouri. She pointed out that both parents are deceased.

She stated that their father, BARNEY DAILY was a ginner for a Mr. ACON's cotton gin, Wardell, Missouri, and they never resides on or owned a farm. She stated that she has never known her brother, J. D. DAILY, to own, operate or lease a farm noting that most of his life has been spent in a tavern business in St. Louis. Missouri.

Mrs. TERRELL pointed out that she has never heard her brother speak of JAMES EARL RAY and she has never heard him mention any persons acquainted with anyone allegedly connected with the Doctor KING assassination.

Mrs. TERRELL pointed out that in event she should learn that J. D. DAILY has any personal knowledge of JAMES EARL RAY she would immediately contact the FBI.

She also noted that she knew of no close friends or associates of J. D. DAILY's who lived on a farm or owned a farm in this area.

SHELBY TERRELL, Wardell, Missouri, advised that he is the brother-in-law of J. D. DAILY being married to J. D.'s sister HAZEL.

He stated that he has known J. D. DAILY since 1946, although he has not closely associated with him because until about a month ago J. D. DAILY operated a tavern in the St. Louis area and only infrequently visited in Wardell, Missouri.

Mr. TERRELL stated that J. D. DAILY now operates a restaurant in Portageville, Missouri, and lives in that town having recently purchased this restaurant.

He stated that he has never known J. D. DAILY to own, operate, lease, rent or visit for any length of time on a farm nor does he know of any of J. D.'s close friends who own farms.

Mr. TERRELL stated that he has never heard DAILY mention JAMES EARL RAY nor has he talked about the assassination of Doctor KING. Mr. TERRELL noted that he has seen J. D. DAILY more frequently in the past month since DAILY owns a restaurant in Portageville than he has in the past fifteen years.

Mr. TERRELL noted that J. D. DAILY had three sisters; namely, HAZEL (SHELBY TERRELL's wife), ADA GILES of Chicago, Illinois, and LILLIAN JOHNSON of St. Louis, Missouri.

Mr. TERRELL noted that in the event he hears any information at all that would indicate that J. D. DAILY had any contact with or any personal knowledge of JAMES EARL RAY he would immediately notify the FBI.

Father - BARNEY DAILEY; Died around 1959, age about sixty-six. At the time of death he lived in house (not farm) about one-fourth mile north of city limits of Wardell, Missouri. Can be reached by turning right at a stoplight on Route 61, and then right again beyond Donohoe's Store. This house was owned by BARNEY, and is now LILLIAN's. It is rented to a family named STILL. STILL's wife is believed to be a Federal employee.

Mother - EVA (nee EDMUNSON) DAILEY; Died about 1938, age about forty-three. At time of death lived in town of Wardell, Missouri, two houses south of house now occupied by LILLY GASKIN (J. D.'s mother-in-law).

DAILEY and recalled J.D. and other members of the family working intermittently on farm land operated by his father from the time they were small children until they became grown. He also worked for several years for the Acom Cotton Gin at Wardell, Missouri, where J.D. DAILEY's father, BARNEY DAILEY, worked for a number of years until he passed away a few years ago.

JAMES stated that J.D. DAILEY married one of the GASKIN girls of WARDELL and that her brother, HARLEY B. GASKIN still resides in the Wardell area. Another brother, CLEO GASKIN reportedly resides somewhere in St. Louis. A brother-in-law of J.D. DAILEY, one EWELL DE PRIEST, presently resides north of Wardell on Highway B. A sister-in-law, Mrs. STANLEY (ELIZABETH) BLURTON, is also believed to still be residing in the Wardell, Missouri, area.

According to BOBBY JAMES he has never heard of any members of the DAILEY family, the GASKIN family, the DE PRIEST or the BLURTON family being land owners in the Wardell, Missouri, area.

WO. JAMES, residing approximately two miles south of Wardell, Missouri, on County Highway B, advised upon interview that he has known the family of J.D. DAILEY since the time J.D. DAILEY was approximately five years of age. At about this time DAILEY's father, BARNEY DAILEY and the other members of his family began working as cotton choppers and cotton pickers on land farmed by Mr. JAMES in the vicinity of Wardell, Missouri. This type of irregular employment by the members of the BARNEY DAILEY family continued intermittently until the time J.D. DAILEY quit high school and drifted out of the Wardell area. On various other occasions subsequent to this time, J.D. DAILEY would return to the Wardell area and work for a short period of time on land operated by JAMES.

According to JAMES neither BARNEY DAILEY who is deceased or any of his children have ever owned or even share-cropped any land in the Wardell area to his knowledge. During the last several years of his life, BARNEY DAILEY operated a gin at Wardell, Missouri. He recalled that J.D. DAILEY was always considered a trouble maker and was always in some difficulty with the law in the local area and he heard that he was in similar trouble in the St. Louis area after he left Wardell.

Mr. JAMES furnished the name of other members of the DAILEY family as being HAZEL RANDELL TERRELL, presently residing a couple of miles north of Wardell; ADA JILES and LILLIAN DAILEY present addresses unknown.

He advised that BARNEY DAILEY was an individual who drank to excess when he was not working and the three daughters named above were generally considered in the community as being women of loose morals.

JAMES stated he was positive that J.D.DAILEY never owned, operated or sharecropped a farm in the area of Wardell and he knew of no individuals residing on farms in the general area who were close friends of DAILEY.

SELLERS, who resides on County Highway B, one mile north of State Route 84 in Pemiscot County, Missouri, advised he is chairman of the Pascola Township Agriculture Stabilization Committee of Pemiscot County, Missouri. In this capacity he had in his possession a Pemiscot County map reflecting the various townships of Pemiscot County with the names of the land owners written in on the land plots of the various farms within the townships of that county.

The maps of Pascola Township covering the area surrounding Pascola, Missouri; the Little River Township covering the Wardell, Missouri, area; and the Peach Orchard Township covering the Bragg City area were examined.

There were no farm owners by the name of DAILEY listed in any of the three above-named townships.

Mr. SELLERS advised he is 95 percent familiar with all of the land owners in the Pemiscot County area west of U.S. Highway 61 and north of State Highway 84 and there is no land owner by the name of DAILEY operating in that area.

He went on to state that in his capacity of town-ship committee chairman, he is also familiar with tenants and sharecroppers in this area and he has never heard the name DAILEY mentioned in this capacity.

HOMER TOWNSLEY was contacted at his residence, 2705 Missouri, St. Louis, Missouri, on April 22, 1968, by Special Agents ROBERT L. BENDER and EARL E. BROWN. He said he is now employed as a bail bondsman out of his house and has unlisted phone number PR 6-1879. He is usually at that address from 11:00 a.m. until 1:00 p.m. He has given up his bar, The Neighborhood Bar, 1929 Hickory, and also his confectionary store, 3434 Caroline Street.

When contacted at his house by Special Agents BENDER and BROWN on April 22, 1968, he appeared to be completely cooperative throughout the interview, and voluntarily accompanied the agents to the St. Louis Office where he was interviewed.

He furnished the following information:

He knows the subject. Subject frequented his tavern at 1929 Hickory around 1958 - 1959. At that time, subject's mother resided on Hickory Street between 18th and Mississippi and subject resided in the vicinity on LaSalle or Park.

He said JACK ALLISON, who has been arrested for counterfeiting and served time in Leavenworth, knows the subject. ALLISON now is going straight and lives with a brother. ALLISON and this brother now have a television shop on Park Avenue west of Compton on the north side of the street, the third or fourth building west of Compton. JACK ALLISON probably will tell what he knows about RAY.

A man named SMITH operates a confectionary on Hickory about four houses west of 18th Street, north side of the street. The confectionary is in a basement. This is at about the address of RAY's mother. SMITH should know the mother, whether or not she is dead, and possibly know the subject.

TOWNSLEY said he does not know WALTER TERRY RIFE. (RIFE was arrested with RAY, March 7, 1955, for the burglary of the Post Office at Kellerville, Illinois, and served time with the subject at Leavenworth.)

He said he believes a man named JACK or JOHN, who operates the Grapevine Tavern at Illinois and Arsenal, came into his tavern at least once with RAY.

TOWNSLEY said he gave up the Neighborhood Bar in May, 1967. He did not see RAY after RAY's escape from the Missouri State Penitentiary in April, 1967. He heard from some source that RAY came back to St. Louis to kill a man. It was TOWNSLEY's recollection that the man RAY wanted to kill was responsible for RAY's arrest for the holdup resulting in RAY's sentence to the Missouri State Penitentiary in the spring of 1960.

TOWNSLEY said he has heard that RAY's family had property and relatives in southeast Missouri and the Poplar Bluff area sticks in his mind.

He said he cannot recall of hearing of RAY's father, any brothers or sisters. He has heard of no attorney used by RAY, nor any bailbondsman.

TOWNSLEY was then questioned as to whether he knew if RAY ever contacted J. D. DAILEY and stated he thinks J. D. told him RAY had contacted DAILEY after RAY escaped from the Missouri State Penitentiary. DAILEY said that he had known RAY for a long time. He did not know that DAILEY had ever helped RAY.

TOWNSLEY said RAY could be with DAILEY in Wardell, Missouri. He said he could not figure out why DAILEY suddenly gave up his tavern and moved to Wardell. He said DAILEY had fitted it up with new, expensive equipment and when DAILEY said he was moving and selling the house he had bought, TOWNSLEY was

very surprised and asked why. DAILEY told TOWNSLEY that the tavern had been inspected by a St. Louis building inspector who had found the wiring to be defective. DAILEY said it would cost over \$500 to have the place rewired, that the landlord had refused to undertake the necessary repairs, and because of that DAILEY had decided to get out and take over a tavern in Wardell, Missouri. TOWNSLEY said this did not make sense to him and commented, "J. D. hates niggers with a passion."

On being specifically questioned, TOWNSLEY admitted that he had had a falling out with DAILEY. His version is as follows:

TOWNSLEY had been gambling with a man and had taken a couple of checks for the losses. This man then went next door to DAILEY's restaurant, started talking about it and was advised by DAILEY that TOWNSLEY could not collect on the checks if TOWNSLEY pressed him because they were gambling losses. TOWNSLEY learned of DAILEY's advice to this man, got mad, and told DAILEY he would knock his brains out. Later, J. D. apologized to TOWNSLEY, the matter was forgotten, and they again became friends.

When pressed upon this further, he said that the check writer in question was an Army officer from Illinois, that the reason DAILEY had given him such advice was because DAILEY was jealous TOWNSLEY had found a soft touch, and that now there were no hard fedings whatever between him and DAILEY.

When pressed further about this matter, he said that a man named CONWAY frequented his, TOWNSLEY's, tavern. CONWAY learned of the officer's welching on the bet and said he would take care of him. TOWNSLEY told CONWAY he did not need any help, pointing out that he had been a former amateur and professional boxer, and that he could whip DAILEY with one hand tied behind him.

He said that nevertheless, CONWAY took it upon himself to further the argument when he was drinking and hit DAILEY, fracturing DAILEY's jaw. Thereafter, DAILEY shot CONWAY in cold blood, permanently paralyzing him. TOWNSLEY said he was in no way responsible for CONWAY's action, and later told DAILEY so. DAILEY agreed to TOWNSLEY that TOWNSLEY could take care of DAILEY and need not have gotten help, and they became friends again.

To point out that their differences had been patched up, TOWNSLEY pointed out that DAILEY had called him when DAILEY was leaving St. Louis for Wardell, and promised to give him his (DAILEY's) address and phone number so they could keep in touch.

TOWNSLEY said that upon further recollection, he remembers LUCILLE RYAN and remembered RAY's stating that RYAN was his mother, that RAY had visited her in RAY's visit to TOWNSLEY's tavern in the 1958 - 1959 era. He said that LUCILLE RYAN is now dead because of her drinking and that when she lived on Hickory Street, she was living with an uncle of JOHN, who runs the Grapevine Tavern at Illinois and Arsenal. He said this uncle is an old-time thief and is still living, and frequents the Grapevine.

This uncle is 5'9", 165 pounds, 55 to 60, unemployed, and has a criminal record. He talks very fast and around the Grapevine keeps talking of old jobs he has pulled so that a listener gets the impression the old man is crazy.

JOHN, manager of the Grapevine, has a speech impediment and will be uncooperative. He drives a white Thunderbird, 1964, or later, model.

TOWNSLEY said DAILEY definitely helped an escapee from Missouri State Penitentiary named CREWS.

He denied that he has discussed this with anybody. He said he considers the lead at the Grapevine much better than a follow-up on DAILEY. He said that while RAY contacted DAILEY after RAY's escape from the Missouri State Penitentiary, he does not know whether DAILEY actually helped RAY.

He said a former barmaid, GRACIE WISE, 1920a Hickory, should remember RAY's mother, LUCILLE RYAN, should known who was living with LUCILLE and whether LUCILLE is dead.

Re: Alleged Association of JAMES EARL RAY and J. D. DAILEY

On April 21, 1968, HOMER TOWNSLEY advised SAs ROBERT L. BENDER and EARL E. BROWN that RAY visited TOWNSLEY's tavern, "The Neighborhood Bar", 1929 Hickory, St. Louis, in the 1958-1959 period. TOWNSLEY said his barmaid then was GRACIE WISE who now lives at 1920a Hickory and she should remember RAY's mother, LUCILLE FYAN, now who was living with LUCILLE, and whether LUCILLE is deceased.

On April 22, 1968, SA BROWN attempted to contact GRACE WISE at 1920a Hickory but no response could be obtained. A note on the door for the gas man instructed him to obtain payment from the tenant at 1920 Hickory by going to the rear door. Inquiry there revealed that GRACE WISE has no telephone and is now visiting a daughter somewhere in Indiana. The address of this daughter, her name, and the length of the visit was unknown. She stated she would give GRACE WISE a note to contact SA BROWN at the St. Louis Office upon her return.

Re: Alleged Association of J. D. Dailey and Subject

HOMER TOWNSLEY has advised that he heard, possibly from J. D. DAILEY himself, that subject contacted DAILEY when DAILEY operated the Half-Way Restaurant on Jefferson Avenue, and that such contact was made shortly after subject escaped from the Missouri State Penitentiary in April, 1967. At that time TOWNSLEY operated the Neighborhood Bar, located on the corner of Hickory and Mississippi, a few doors from the house occupied by subject's mother, known to TOWNSLEY as LUCILLE. A barmaid at the Neighborhood Tavern was GRACIE WISE, now residing at 1920 Hickory.

On April 29, 1968, GRACE WISE, 1920 Hickory, in response to a note left with a neighbor by SA EARL E. BROWN, telephonically contacted the St. Louis Office and advised she had returned to St. Louis from Indiana.

On April 29, 1968, she was contacted at that address by SA ALBERT J. RUSHING and SA EARL E. BROWN. She was unable to remember the subject. She remembered LUCILLE RYAN, and stated LUCILLE lived in a rooming house operated by a woman said to be LUCILLE's mother, and who was known as "Old Mary". A number of men lived there at various times, including one of LUCILLE's sons. From data obtained, it appears that this son was subject's brother JOHN RAY. LUCILLE also lived in a rooming house on Mississippi operated by a woman now about 96 years of age. WISE believes this woman, known as "Granma" is now somewhere in a nursing home. LUCILLE moved there after leaving the house on Hickory Street. This house is on the west side of Mississippi Street, in the block south of Hickory, and is the first house north of the alley. vation was later made of this house, and it appears to be vacant and probably condemned.)

WISE had no information regarding an "Uncle John" who may have lived with LUCILLE on Hickory. She knows J. D. DAILEY, but has no information connecting him with this matter.

On April 21, 1968, HOMER TOWNSLEY advised SAs ROBERT L. BENDER and EARL E. BROWN that JACK ALLISON, who has been arrested for counterfeiting and served time in Leavenworth, knows RAY. He said ALLISON is now going straight and lives with a brother who has a TV shop on Park Avenue west of Compton on the north side of the street, the third or fourth building west of Compton. TOWNSLEY felt ALLISON would tell what he knows about RAY.

On April 22, 1968, SA BROWN contacted JACK ALLISON at his place of employment, the Union Electric Service Company, 3211 Park Avenue, telephone MO 4-8888. ALLISON owns this business and has never been arrested. He employs his brother, CHARLES EDWARD ALLISON, who has been in Leavenworth and who occasionally refers to himself as JACK ALLISON. ALLISON said his brother, CHARLES, started on a drunk on Sunday, April 21, 1968, and his whereabouts are not known. When he goes on a drunk it usually lasts a week. He is somewhere in the vicinity but even if located would be completely incoherent until he sobers up. He will drift back to the shop in the next several days after he starts sobering up and ALLISON promised he would then notify SA BROWN in order that he might be interviewed.

JACK ALLISON said he never forgets a face and he feels he has somewhere, sometime, seen JAMES EARL RAY. He cannot fix the time or place but feels it was probably several years ago in the St. Louis area.

VIRGIL DENTON, Operator of Denton's Bar, 1553
Jefferson, residing at 1551a Jefferson, was interviewed April
23, 1968, by Special Agents SPURGEON J. PETERSON and ROBERT L.
BENDER. Photographs of JAMES EARL RAY and JAMES DAVID DAILEY
were displayed to DENTON who stated that he is well acquainted
with DAILEY and he recognizes RAY as having been a customer
in his tavern. He said that he has operated a tavern at this
location and next door for the past 17 years, that he cannot
recall specifically when JAMES RAY was in his tavern but
presumed that it was prior to RAY's being in the penitentiary
in 1960. DAILEY operated the Half-Way Cafe located a couple of
doors from his tavern and as a matter of fact DAILEY purchased
this cafe from him.

Prior to DAILEY taking over the Half-Way Cafe approximately three years ago DAILEY had a place of business, a tavern and restaurant, located near Caseyville or Collinsville, Illinois. DENTON knew of this due to the fact that on one occasion approximately two years ago DAILEY took him in his, DAILEY's, automobile over to this place and pointed it out to him and they actually went in and had some drinks. It is noted that DENTON explained that at this time DAILEY no longer owned this establishment but merely wanted to show it to him. DAILEY told him that he had had "hustling girls" at this place in Illinois, and had run into trouble with the law and apparently that was why he had moved to St. Louis. DAILEY has a very close friend who he visits at least once a month in Jefferson City Penitentiary whose name is CREWS and DAILEY has actually been to Jefferson City and made an effort to get CREWS out.

DENTON further advised that when CREWS escaped from the penitentiary in Jefferson City he was arrested in St. Louis, he thought, in either CREWS' brother's or sister's house. He said the police would have a full report on that. He further advised that CREWS has a no-good brother who is a wino and alcoholic who is still around town and wanders up and down Jefferson Avenue periodically. (It is noted that this brother of CREWS, the alcoholic, may be identical with the informant of

Detective RON BOCKENKAMP who indicated previously that although the police records would not reflect it he had arrested CREWS as an escapee from the penitentiary in the same house in which his informant who provided him with the information lived.)

DENTON said that he could not associate RAY with DAILEY and could not put them together. DENTON said that he recalls when JUNIOR CONAWAY was shot by DAILEY in front of Dailey's Cafe. He said that if anyone had ever had "it coming to him" it was CONAWAY, that CONAWAY was nothing but a mean person who had broken his, DAILEY's, jaw and stomped on other persons, hurting them seriously and actually maiming them for life. CONAWAY presently lives in the country and DENTON states he has heard he is still as mean as ever and actually carries a gun and a club in the wheel chair that he is confined to.

CONAWAY's girlfriend, not his wife, OPEL, was working for him, DENTON, as a bartender at the time of this shooting. She is now married to a man named SHERRILS whose brother is J. D. SHERRILS and lives somewhere in the country. Her mother lives on Missouri Avenue, place unknown to DENTON.

DENTON further stated that he recalls that DAILEY had a friend who he thought his first name was KEN. KEN apparently was a gambler who played in the card games with DAILEY and they would get some guy in the middle. This individual at one time drove a Chrysler automobile, was a very dapper dresser, but DENTON did not know his name. DENTON was recontacted and stated that CONAWAY is currently residing in Salem, Missouri, exact address unknown, and OPEL SHERRILS' (phonetic) mother is VIRGINIA HILL and resides on Mississippi Avenue, the second house off of Park, and she could probably provide her daughter's current address.

Re: ALLEGED ASSOCIATION OF JAMES D. DAILEY AND JAMES EARL RAY

On April 23, 1968, Mr. LEO J. SPINO, owner and operator of the shoe repair store located at 1547 Jefferson was interviewed by SA SPURGEON J. PETERSON and SA ROBERT L. BENDER. Mr. SPINO identified JAMES DAVID DAILEY as a person with whom he is acquainted through his (SPINO's) knowledge that DAILEY ran the Halfway Cafe, located nextdoor to his shoe store. Ince wanted flier of JAMES EARL RAY was displayed to Mr. SPINO, at which time he stated that to his knowledge RAY was unknown to him. SPINO said he has never heard that DAILEY owned or had a farm. DAILEY did tell him, prior to his moving from the Kalfway Cafe, that he (DAILEY) thought he had a good deal running a restaurant down in the country near Portageville, that he had a friend who owned a tavern and a restaurant there and this friend had offered him the opportunity to run the restaurant if he cared to move to that area.

SPINO advised that DAILEY had told him that the reason he had decided to move from Jefferson Avenue was because of the fact that the City of St. Louis would not approve of the wiring in the restaurant and it would have cost him (DAILEY) approximately \$600 to make the necessary repairs to the wiring. SPINO said that to the best of his recollection DAILEY had moved to the country approximately five or six weeks ago. has not heard from him since. The only friend he knew about of DAILEY was a man who came to the Halfway Cafe two or three times and sometimes more a week and participated in cardgames with DAILEY. SPINO explained that DAILEY apparently had a little gambling going on at the restaurant, and this friend of DAILEY would participate in the game and work with DAILEY. Actually the friend would be playing for the house. said he did not know this person's name, but the man was a white, male American, 45 to 50 years of age, 5 feet 10 inches, 165 to 170 pounds, medium build, grey hair - thinning on top, very well dressed with fine clothes, married - had a wife and tsenage daughter. SPINO said that this individual when he first came to the restaurant drove a Chrysler automobile which had Illinois license plates on it, thought to be about a 1964 model. This car was apparently sold and the man appeared in a new 1967 Buick automobile, a "real dark brown bottom and black vinyl top". This Buick had Missouri license plates on it.
