WAYNE M. ROTHBERG, MANAGER, ROCO AUTO SUPPLY COMPANY, TWENTY SEVEN THIRTY NINE IRVING BLVD., DALLAS, INTERVIEWED AT EMPLOYMENT JUNE FOUR AND FURNISHED THE FOLLOWING: HE HAS KNOWN PAUL BRIDGEMAN FOR MANY YEARS AND BRIDGEMAN'S SON PRESENTLY RESIDING WITH HIM IN DALLAS. ROTHBERG VISITED BRIDGEMAN MANY TIMES WHILE BRIDGEMAN WAS IN MISSOURI STATE PENITENTIARY. BRIDGEMAN RELEASED IN JAN. SIXTYEIGHT, AT WHICH TIME ROTHBERG ACCOMPANIED HIM TO HOME OF BRIDGEMAN'S SISTER, JANET LOU CAWVEY, IN A SMALL UNKNOWN TOWN IN MISSOURI. BRIDGEMAN'S SISTER REFUSED TO ADMIT THEM TO HER HOME, STATING SHE WANTED TO HAVE NOTHING TO DO WITH HIM. IN JAN., BRIDGEMAN RECEIVED ABOUT THREE THOUSAND DOLLARS INHERITANCE FROM ESTATE OF DECEASED PARENTS. PARENT'S DEATH WAS RESULT OF MURDER AND SUICIDE.

BRIDGEMAN CAME TO DALLAS FROM KANSAS CITY THE DAY OF MARTIN LUTHER KING'S FUNERAL AND THEY WATCHED IT ON TELEVISION. BRIDGEMAN LEFT DALLAS SOON THEREAFTER AND HIS WHEREABOUTS UNKNOWN TO ROTHBERG UNTIL MAY SEVEN LAST WHEN BRIDGEMAN RETURNED TO DALLAS AND STAYED OVERNIGHT AT THE HOLIDAY INN, CENTRAL EXPRESSWAY, DALLAS. THE FOLLOWING MORNING BRIDGEMAN FLEW TO MINNEAPOLIS WITH ONE-WAY PLANE TICKET PURCHASED FOR HIM BY ROTHBERG.

ROTHBERG HAS BEEN PAYING BILLS FOR BRIDGEMAN AND WIRING HIM MONEY SINCE HIS RELEASE FROM PRISON IN JAN. HIS LAST CONTACT WITH BRIDGEMAN WAS MAY TWENTYNINE LAST WHEN HE WIRED THIRTY DOLLARS TO HIM VIA WESTERN UNION TO PAY HIS RENT AT THE HOTEL HARMON (PHONETIC), MINNEAPOLIS. ROTHBERG ATTEMPTED TO CALL BRIDGEMAN THE EVENING OF JUNE THREE LAST, AT THE HOTEL HARMON, BUT WAS TOLD BRIDGEMAN WAS OUT. WAS TOLD BY HOTEL CLERK BRIDGEMAN WAS STILL REGISTERED THAT HOTEL AND MESSAGE WAS LEFT FOR HIM TO CALL ROTHBERG.

ROTHBERT AND BRIDGEMAN DISCUSSED JAMES EARL RAY AFTER HIS NAME CAME OUT IN NEWSPAPER IN CONNECTION WITH KING MURDER. BRIDGEMAN SAID HE KNEW RAY IN MISSOURI STATE PEN BUT DID NOT KNOW HIM ANY BETTER THAN ANY OF THE OTHER INMATES. ROTHBERT STATED
