ADDRESS OF TWO ONE ZERO SIX NORTH FIRST STREET , DALLAS, GIVEN BY BRIDGEMAN AT NETHERLAND HOTEL IS NON EXISTANT. THERE IS NO FIRST STREET IN DALLAS AND FIRST AVENUE DOES NOT HAVE THIS NUMBER ON IT.

EXTENSIVE INTERVIEW OF WAYNE ROTHBERG CONDUCTED NIGHT OF JUNE FIVE LAST AND HE FURNISHED THE FOLLOWING: HE MET BRIDGEMAN IN KANSAS CITY APRIL NINETEEN SIXTYFOUR WHEN BRIDGEMAN WAS EMPLOYED AT THE PRINCTION HOTEL IN KANSAS CITY. THEY BEGAN SEEING EACH OTHER REGULARLY AND IN JULY SIXTY FOUR BEGAN LIVING TOGETHER AT THREE THREE ZERO FIVE PASEO, KANSAS CITY. BRIDGEMAN HAD INFANT SON, MICKERY JOE, WITH HIM. BRIDGMAN'S DAUGHTER WAS IN CUSTODY OF ESTRANGED WIFE, CAROL. AT THIS TIME BRIDGEMAN WAS ALSO LIVING PART TIME WITH SHARON ANDERSON IN THE FORTY THREE OR FORTY FOUR HUNDRED BLOCK OF WORNALL, KANSAS CITY. BRIDGEMAN AND ROTHBERG CONTINUED LIVING TOGETHER UNTIL BRIDGEMAN WENT TO PRISON IN APRIL SIXTYFIVE. MICKY JOE WAS LEFT WITH ROTHBERG AND HAS BEEN LIVING WITH HIM SINCE.

ROTHBERG ADMITTED HE IS IN LOVE WITH BRIDGEMAN AND THEY HAVE HAD A HOMOSEXUAL RELATIONSHIP. HE STATES BRIDGEMAN IS PROBABLY MORE HETEROSEXUAL THAN HOMOSEXUAL BUT HUSTLES HIM AND OTHER HOMOSEXUALS FOR ALL HE CAN GET OUT OF THEM. HE ADMITTED THAT HE HAS GIVEN BRIDGEMAN MONEY WHENEVER HE HAS REQUESTED IT AND HAS WIRED HIM MONEY ON AN ALMOST WEEKLY BASIS SINCE BRIDGEMAN'S RELEASE FROM PRISON. WHEN HE WIRED MONEY TO BRIDGEMAN ON MAY TWENTY NINE LAST HE TOLD HIM HE WAS NOT GOING TO SEND HIM ANY MORE. HE HAS NOT HEARD FROM BRIDGEMAN SINCE THAT TIME, WHICH HE CONSIDERS UNUSUAL. ON A FEW OF OCCASIONS WHEN HE HAS REFUSED TO GIVE MONEY TO BRIDGEMAN, BRIDGEMAN HAS THREATENED TO TAKE HIS SON AWAY FROM ROTHBERG. ROTHBERT STATED HE WANTS TO RETAIN CUSTODY OF MICKEY JOE UNDER ANY CONDITIONS BECAUSE HE FEELS HE HAS PROVIDED A BETTER HOME FOR HIM THAT HIS FATHER COULD.

ROTHBERG HAS BEEN WITH BRIDGEMAN ON THE FOLLOWING OCCASIONS SINCE HIS RELEASE FROM PRISON: JAN. NINETEEN TO TWENTYFIRST AT THE HOLIDAY INN IN KANSAS CITY. BRIDGEMAN WAS STAYING AT THE KACEE HOTEL AT THE TIME; FEB. TWENTYTHIRD TO TWENTYFIFTY AT THE DOWNTOWNER MOTOR HOTEL, OKLAHOMA CITY. ROTHBERG PAID BRIDGEMAN'S PLANE FARE TO AND FROM KANSAS CITY; MARCH THIRTY TO APRIL ONE AT THE HOLIDAY INN ON FIFTY NINTH STREET, NEW YORK CITY. BRIDGEMAN FLEW TO AND FROM KANSAS CITY ON TICKET PURCHASED BY ROTHBERG. BRIDGEMAN WAS PROBABLY LIVING AT NETHERLANDS HOTEL, KANSAS CITY AT THE TIME; APRIL FIVE AND SIX HE TALKED TO BRIDGEMAN BY PHONE AT THE FOUR ACRES MOTEL, SOUTH HIGHWAY SEVENTYONE, KANSAS CITY, AND ON APRIL SEVEN BRIDGEMAN FLEW TO DALLAS FROM KANSAS CITY. HE STAYED AT THE LEMONWOOD

NOTOR HOTEL, THREE FIVE TWO FOUR INWOOD ROAD, DALLAS. HE RETURNED TO KANSAS CITY BY BUS ON APRIL TEN. DURING EACH OF THESE TRIPS TO MEET BRIDGEMAN, ROTHBERG WAS ACCOMPAINED BY MICKEY JOE WITH THE EXCEPTION OF THE TRIP TO NEW YORK CITY. ON MAY SEVEN BRIDGEMAN RETURNED TO DALLAS BY TRAIN, UNFINANCED BY ROTHBERG. HE TOLD ROTHBERG HE HAD BORROWED MONEY FROM JIN DOUGHERTY, OWNER OF THE OLD FORTRESS BAR, KANSAS CITY, TO BUY HIS TRAIN TICKET. HE STAYED AT THE HOLIDAY INN, FORTY SEVENTY NORTH CENTRAL EXPRESSWAY, DALLAS. HE LEFT DALLAS ENROUTE TO MINNEAPOLIS ON BRANIFF AIRLINES MAY NINE ON TICKET PURCHASED BY ROTHBERG.

SINCE MAY NINE LAST HE HAS RECEIVED SEVERAL POSTCARDS AND COLLECT TELEPHONE CALLS FROM BRIDGEMAN IN MINNEAPOLIS.

SOMETIME BETWEEN APRIL TEN AND MAY THIRD BRIDGEMAN MADE A TRIP TO TULSA, OKLAHOMA. THE TRAIN FARE TO TULSA WAS PAID BY ROTHBERG AND BRIDGEMAN SAID HE HITCHHIKE BACK TO KANSAS CITY. HE STAYED IN TULSA LESS THAN A WEEK, SUPPOSEDLY LOOKING FOR A JOB, WHICH HE DID NOT FIND.

BRIDGEMAN HAS APPEARED TO BE WITHOUT FUNDS SINCE HIS RELEASE FROM PRISON AND AT NO TIME INDICATED TO ROTHBERG THAT HE HAD MORE THAN A FEW DOLLARS. HE HAS DISCUSSED NEGROES WITH ROTHBERG AND

INDICATED HE DID NOT PARTICULARLY LIKE THEM BUT GAVE NO INDICATION OF ANY HATRED FOR THE RACE. AT THE TIME OF THE MURDER OF KING HE GAVE NO INDICATION OF OTHER THAN SYMPATHY FOR KING AND LATER WHEN RAY WAS IDENTIFIED AS THE POSSIBLE KILLER, BRIDGEMAN ONLY COMMENTED THAT HE HAD SEEN RAY IN PRISON BUT INDICATED HE DID NOT KNOW HIM WELL. ROTHBERG FEELS THAT IF BRIDGEMAN HAD KNOWN RAY WELL AT ALL HE WOULD HAVE DISCUSSED IT AND WOULD HAVE BRAGGED ABOUT IT TO ROTHBERG. ROTHBERG EXAMINED PHOTOGRAPHS OF RAY CAREFULLY AND STATED HE HAS NEVER SEEN THIS MAN AND KNOWS OF NO ASSOCIATE OF BRIDGEMAN WHO FITS THIS DESCRIPTION.

ROTHBERG STATED HE BELIEVES JIM DAUGHERTY WOULD BE ONE PERSON IN KANSAS CITY WHO WOULD MOST LIKELY KNOW THE WHEREABOUTS OF BRIDGEMAN. JACKIE KLEIN HAS BEEN A GIRL FRIEND OF BRIDGEMAN AND HAS GIVEN HIM MONEY TO LIVE ON SINCE HIS RELEASE FROM PRISON. SHE WOULD LIKE TO MARRY BRIDGEMAN AND WOULD PROBABLY GO ANYWHERE TO BE WITH HIM AND WOULD DO ANYTHING FOR HIM. SANDRA LAUGEN HAS LIVED WITH WITH KLEIN FOR SEVERAL YEARS AND SHOULD KNOW HER WHEREABOUTS.

BRIDGEMAN HAS MENTIONED A GIRL FRIEND NAMED DEBBIE NEEDLIES WHO HE HAS SAID LIVES IN ROE VILLAGE APARTMENTS, PRAIRIE VILLAGE, KANSAS. BRIDGEMAN SAID HE MET NEEDLES THROUGH JIM DOUGHERTY.

HE HAS PROMISED HIS FULL COOPERATION IN LOCATING BRIDGEMAN AND HAS STATED IF HE GETS A CALL FROM BRIDGEMAN HE WILL GET HIS LOCATION AND IMMEDIATELY NOTIFY THIS OFFICE. IN VIEW OF HIS APPARENT COMPLETE COOPERATION, BUREAU PERMISSION IS NOT BEING REQUESTED AT THIS TIME TO OBTAIN ROTHBERG'S PAST TOLL CALLS AND TO MONITOR HIS FUTURE CALLS.

ROTHBERG RECONTACTED TODAY AND HE ADVISED HE HAS NOT HEARD FROM BRIDGEMAN. DAILY CONTACT WITH ROTHBERG WILL BE MAINTAINED.
