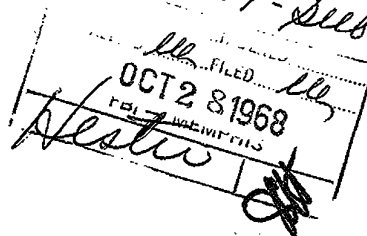

This source advised that efforts have been unsuccessful to obtain an informal waiver for Shelby County officials or to arrange for some type of special travel documentation permitting them to enter Mexico in furtherance of the prosecution of this case.

Mr. Phil M. Canale, State Attorney General, Shelby County, Tennessee, has stated that he still desires to interview persons in Mexico who may be able to furnish information concerning James Earl Ray, and that he has directed a letter to the United States Department of State requesting that they obtain for him special permission from the Mexican Government for representatives of his office to conduct interviews in Mexico.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

SHANAHAN and was advised that the Attorney General's Office of the State of Tennessee was anxious to obtain his cooperation in presenting testimony in the forthcoming trial of JAMES EARL RAY in Memphis, Tenn. It was explained to Mr. SPAIN that the trial is scheduled to start on 11/11/68, but his testimony would not be required until a later date, possibly two weeks or more from the beginning of this trial. It was further explained to Mr. SPAIN that the State of Tennessee is authorized only to pay \$6.00 a day expenses and 10¢ a mile to cover the cost of transportation to and from Memphis. The trial of the State of Tennessee vs. James Earl Ray, who is accused of slaying Dr. Martin Luther King, Jr., is set for November 12, 1968. One of the material witnesses for the State of Tennessee in this trial will be Mrs. Manuela Teixeira Lopes, c/o Canadian Embassy in Lisbon, Portugal.

It is respectfully requested that your office request that an invitation be extended to Mrs. Lopes through the United States Department of State to the Canadian Foreign Office, to attend as a witness for the State of Tennessee, the trial of the State vs. James Earl Ray.

If permission is granted to allow Mrs. Lopes to visit the United States, the State of Tennessee will pay her expenses as follows:

Payment for transportation from Lisbon, Portugal to the Point of Entry into the United States; then ten cents (10¢) a mile from the Point of Entry into the United States to Memphis, Tennessee; plus five dollars (\$5.00) a day every day she is in attendance as a witness; the State of Tennessee will pay the witness ten cents (10¢) a mile from Memphis to the Point of Exit from the United States and then her transportation from the Point of Exit of the United States to Lisbon, Portugal.

I wish further to inform you that the said witness' lodging and meals during her stay here in Memphis, Tennessee will be paid for by the State of Tennessee.

When this office is notified to the effect that permission is granted and the witness is available to come to Memphis, Tennessee, I will arrange to have the funds forwarded to her to purchase a round trip ticket, tourist class, plus an incidental expense fund, in order to enable the witness to make said airline trip. This amount advanced will then be deducted from the total amount due the witness upon her being paid her additional witness' fees here in Memphis.

In view of our trial date being November 12, 1968, it is important for us to be notified as soon as possible whether the permission for this witness to enter the United States will be granted.

Although the trial date is set for November 12th, it is not expected that Mrs. Lopes will be needed on that date, as it will probably take us some time to select a jury, and we will have other witnesses to offer in evidence prior to the need for the presence of Mrs. Lopes. I estimate that it will be the early part of December before the presence of Mrs. Lopes is needed, and when you notify us that permission has been granted for her attendance, we will give her one week's advance notice in order that she might complete arrangements for her trip. It is anticipated that the presence of the above witness will not be needed in Memphis more than the necessary time for testimony at the trial, and in no event will she be required for more than three or four days.

It is further respectfully requested that Senor Jose Manuel Da Cunha Passo and Antonio Rocha Fama, Passport Inspector with the National Police of Portugal, be permitted to visit the United States of America so that they may testify as witnesses for the State of Tennessee in the trial of the State of Tennessee vs. James Earl Ray. It is also respectfully requested that Senor Passo bring with him the records pertaining to Ramon George Sneyd.

If permission is granted to allow the above-named persons to visit the United States, the State of Tennessee will pay their expenses as follows:

Payment for transportation from Lisbon, Portugal to the Point of Entry into the United States; then ten cents (10¢) a mile from the Point of Entry into the United States to Memphis, Tennessee; plus five dollars (\$5.00) a day every day they are in attendance as witnesses; the State of Tennessee will pay the witnesses ten cents (10¢) a mile from Memphis to the Point of Exit from the United States and then their transportation from the Point of Exit of the United States to Lisbon, Portugal.

I wish further to inform you that the said witnesses' lodging and meals during their stay here in Memphis, Tennessee will be paid for by the State of Tennessee.

When this office is notified to the effect that permission is granted and the witnesses are available to come to Memphis, Tennessee, I will arrange to have the funds forwarded to each witness to purchase a round trip airline ticket, tourist class, plus an incidental expense fund, in order to enable the witnesses to make said trip. This amount advanced will then be deducted from the total amount due the witnesses upon their being paid their additional witnesses' fees here in Memphis.

In view of our trial date being November 12, 1968, it is important for us to be notified as soon as possible whether the permission for these witnesses to enter the United States will be granted.

Although the trial date is set for November 12th, it is not expected that the persons named above will be needed on that date as it will probably take us some time to select a jury, and we will have other witnesses to offer in evidence prior to the need for the presence of the above-named persons. I estimate that it will be the early part of December before the presence of the above-named persons is needed, and when you notify us that permission has been granted for their attendance, we will give you and them approximately one week's advance notice in order that they might complete arrangements for their trip. It is anticipated that the presence of the above witnesses will not be needed in Memphis more than the time necessary for them to testify at the trial, and in no event will they be required for more than three or four days.

As you know, three of the men from this office recently visited Lisbon regarding pre-trial work in the instant case. Each of these three men was extremely complimentary and grateful for the treatment they received while in Lisbon, and I wish to express my personal and sincere appreciation to you, Mr. Harvey R. Wellman, and to Mr. Doyce Ray McNaughton for the assistance you have rendered this office.

In accordance with your request, this is to advise you as to the exact procedure which would be necessary to obtain proper permission for Sr. Jose Manuel Da Cunha Passo, Inspector of the Policia Internacional e de Defesa do Estado, Lisbon, Portugal, and Mrs. Manuela Teixeira Lopes, a Portuguese employee of the Consulate of the Canadian Embassy, Lisbon, to appear as witnesses during the trial to take place in Memphis, Tennessee.

Insofar as Inspector Passo is concerned, it would be necessary for you to address a communication to The Honorable W. Tapley Bennett, Ambassador of the United States, Embassy of the United States, Lisbon, Portugal, requesting that the Embassy direct a request to the Portuguese Foreign Office that Passo be permitted to visit the United States to testify in the trial of James Earl Ray, who is accused of the assassination of Martin Luther King. It would be advisable for you to stipulate the financial arrangements in the communication. At the same time, it is suggested that you advise our Memphis Office so that I can be advised expeditiously through Bureau channels in order that I can inform Passo personally at the same time that you are advising the Embassy in Lisbon.

Insofar as Mrs. Lopes is concerned, it would be necessary, according to the Canadian Embassy in Lisbon, for you to direct a communication to the U. S. Department of Justice requesting that an invitation be issued to Mrs. Lopes through the U. S. Department of State to the Canadian Foreign Office.

I met them at the airport and extended courtesies during their short visit in Paris. I departed with them on the morning of 10/23/68 for Lisbon, Portugal, and assisted them in every possible way there in connection with their inquiries.

With the assistance of Inspector JOSE MANUEL DA CUNHA PASSO of the Policia Internacional e da Defesa do Estado (Portuguese International and State Security Police - PIDE), Lisbon, Portugal, each of the potential witnesses previously mentioned in connection with the investigation in Portugal was contacted by DWYER and his associates.
