It is noted that HENDERSON states JIMMY (LNU) does not resemble photos of subject RAY, however, he alleges that this individual along with SYLVIA SNOWDEN and her sister GLENDA WILKINSON stayed at his residence in Jackson, Miss., either the day of or immediately after the slaying of KING and that they had just arrived in Jackson from Memphis, Tennessee. He described JIMMY (LNU) as a white male, 5'9" to 5'10", 160 to 170 pounds, approximately 24 years of age, brown hair, medium build, with eyes close together - oddness about the eyes, and a very neat dresser.

This investigation was conducted on May 24, 1968, by SAs MICHAEL F. HUTTER and DAVID J. LANG.

At Oklahoma City, Oklahoma

Miss JAN AUBERT, 8716 N.E. 52nd Street, advised that she and her mother, Mrs. IRMA AUBERT, are the only occupants of this address and that Mrs. AUBERT is the subscriber to telephone number 405-771-3268, and was the subscriber to this telephone number in December, 1967. Miss AUBERT advised the telephone call received at this time on December 17, 1967, from San Antonio, Texas, was made to her by her boy friend, BUTCH LOVE. She stated LOVE is in the Air Force and on the date of this call he was stationed at Lackland Air Force Base, San Antonio, Texas. LOVE has since been transferred to duty with the Air Force in Viet Nam, having been so transferred on December 27, 1967.

Miss AUBERT furnished the above information in the presence of her mother, Mrs. AUBERT. Mrs. AUBERT was unable to furnish any additional information.

Both Miss AUBERT and Mrs. AUBERT were exhibited photographs of JAMES EARL RAY and were unable to effect an identification. Both also advised that the name JAMES EARL RAY was entirely unfamiliar to them with the exception of news items they had seen and heard concerning RAY.

The following investigation was conducted at Waterbury, Connecticut, by SA WILLIAM V. GRICKIS in connection with phone call from listing 223-7689, San Antonio, on December 17, 1967, to listing 203-754-6121 to a Miss JAMES, Room 319, Palace Hotel, Waterbury, Connecticut.

Mr. HENRY DESSUREAULT, Manager, Palace Hotel, 94 East Main Street, Waterbury, on May 27, 1968, advised a Mr. and Mrs. JAMES, first name unknown, registered at this hotel sometime in December, 1967, and remained until the middle of February, 1968. DESSUREAULT did not have the exact dates available at this time. It is to be noted that instant hotel does a considerable "vagrant" business and is a low-rated hotel.

DESSUREAULT advised that the couple had room 319. They were both Negroes and DESSUREAULT expressed the opinion that the woman was not JAMES' wife because while here JAMES received several long distance telephone calls from Texas from a woman who stated she was JAMES' wife. DESSUREAULT knew of no questionable activities on the part of JAMES but stated he left owing two days rent. He appeared to be an intelligent individual and worked locally, exact place unknown. He on occasion frequented Mel's Bar, East Main Street.

Mr. JOHN MELCHIONNE, Proprietor, Mel's Bar, 165 East Main Street, Waterbury, on May 27, 1968, advised he knows no one by the name of JAMES but that a Negro by the name of BLACKBURN on occasion frequents this bar. He is employed at Patwin, Inc., Waterbury, and on occasion he has cashed his checks.

Mr. ORTON CAMP, Vice President, Patwin, Inc., 41 Brown Street, Waterbury, on May 27, 1968, advised records reflect LANDSON ROBERT BLACKBURN, Jr., date of birth [redacted] San Antonio, Texas, residence 24 Linden Street, Waterbury, Social Security # [redacted] entered on duty September 6, 1967, and is employed here as a production checker or timekeeper. On an application filed September 5, 1967, he indicated he served in the United States Air Force, had no police record, no physical defects, father-LANDSON BLACKBURN, no address; mother-EDITH SIMPSON, 1607 Harrison Avenue, Winston Salem, North Carolina. He attended Atkins High School, Winston Salem, and thereafter "Automotive Institute". He listed his wife as HELEN J. SHAW, 1731 Commerce Street, San Antonio, and that she was moving to Waterbury.

Mr. CAMP stated that BLACKBURN has been a satisfactory employee but apparently has been having domestic troubles with his wife because she has on occasions in the past made phone calls here to BLACKBURN from San Antonio, Texas, and reversed the charges. BLACKBURN told him that he has two children who are living with his wife in San Antonio, one of which is in need of heart surgery, and that the calls from his wife pertained to the health of the children. She has not called in six weeks. He further advised that BLACKBURN indicated that he did not plan to bring his wife to Waterbury until he found a suitable apartment as he did not plan to live in "a ghetto area". CAMP related that from their conversations he gathered that BLACKBURN "was much in sympathy with the aims of Dr. MARTIN LUTHER KING, Jr."

LANDSON ROBERT BLACKBURN, Jr., checker, Patwin Inc., 41 Brown Street, Waterbury, residence 24 Linden Street, Waterbury, was interviewed on May 28, 1968, by SA WILLIAM V. GRICKS and SA WILLIAM B. ZIMMERMAN at which time he furnished the following information:

BLACKBURN stated that he has no knowledge whatsoever of JAMES EARL RAY and has never been in contact with him. He advised that he first came to Waterbury, in August of 1967, to visit friends from Winston Salem, North Carolina. He decided to accept employment here. He registered under the name JAMES at the Palace Hotel because he was living with a woman other than his wife. While at the Palace Hotel, and specifically on December 17, 1967, he received phone calls from his wife HELEN BLACKBURN, residence 1731 East Commerce Street, San Antonio, Texas, telling him about his two daughters, one of which is 2 years old and under a doctor's care because of a heart condition. This call was made from the Suzanne Hotel, corner of New Brunfels and East Commerce Streets, San Antonio. She made several other calls from a phone booth at Ellison's Liquor Store, same location, and a Gulf Service Station at the corner of East Commerce and Gevers Streets, San Antonio. This was during December, 1967 and January and February of 1968. The above booths are located about one and one half miles from Highway 90 and Interstate 10. BLACKBURN concluded by stating that he had no knowledge whatsoever regarding the assassination of Dr. MARTIN LUTHER KING, Jr. other than what he read in the papers.

Mrs. CHARLES F. DENT, 835 South 58th Street, Pullman, Michigan, advised she has had Pullman, Michigan, telephone number 616-236-5598 since prior to December, 1967. She said the party named WATKINS who reportedly received a call at that telephone on December 17, 1967, was undoubtedly SONETTA WATKINS who lives across the street; has no telephone, but frequently receives telephone calls at the DENT residence.

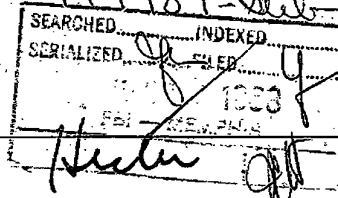

Subject allegedly made eight long distance telephone calls while in Texas.

Numerous efforts have been made to contact PRINCE DIXON at 4303 Morgan Avenue, Los Angeles, California, with negative results. Contact with neighbors of DIXON revealed he continues to reside at the above address but none of the neighbors know his place of employment. DIXON, according to neighbors, is a Negro male.

On 6/12/68, Mrs. EDWARD DWYER, 221 Fanwood, Long Beach, California, advised that the former resident MURRAY J. CLATER, 3332 Roxanne Avenue, Long Beach, California, moved and presently resides at 448 Via Herbosa, Novato, California, telephone number 883-4192.

According to Mrs. DWYER, the CLATERs left the Roxanne residence during December, 1967.

Previous communication has been submitted to San Francisco asking that CLATER be interviewed concerning any information he might have regarding JAMES EARL RAY.

On 6/12/68, FELIX ROBINSON, 651 North Commonwealth Avenue, Los Angeles, California, was interviewed, at which time he advised that he could not recall having received any telephone calls from anyone within the San Antonio area but possibly the individual who resides with him at the above address, GUS MC KEAN, received the telephone call as he is originally from the San Antonio area.

On 6/12/68, GUS MC KEAN was interviewed at his place of employment, Five Torches Restaurant, 11344 Crenshaw Boulevard, Inglewood, California. MC KEAN advised he could not specifically recall a telephone call to his telephone number 663-3675 on 12/17/68, but it was very probable the call was from his sister, MARY WILLIAMS, or his brother, JOHN MC KEAN, who both reside in San Antonio. He related his brother and sister call him at least two or three times a month. He was shown photographs of JAMES EARL RAY and advised he could not recall having ever seen the individual depicted in the photographs nor did the name JAMES EARL RAY or ERIC STARVO GALT mean anything to him, except from reading about him in the newspaper and hearing the name on television.

Mrs. CLORELENE M. CARPENTER, 1221 South Main Street, Santa Ana, California, advised on 6/12/68 that in December, 1967, she and her family resided at 518 West Edinger Street, Santa Ana, California, and had telephone number 714-540-7240. She stated that they moved to this address about March, 1968, and have telephone number 835-5127.

Mrs. CARPENTER recalled about in December, 1967, her close friend, Mrs. KATIE DANIELS, went to Texas to visit her parents for Christmas. She stated the only call she received from Texas in December, 1967 was a call from Mrs. DANIELS.

Referenced San Antonio airtel advised that on 12/15/67, a telephone call was placed from telephone number 223-8266 in the San Antonio Division to telephone number 213-231-5482 in the Los Angeles Division. Telephone Company records at Los Angeles revealed that the Los Angeles telephone number is listed to PRINCE DIXON, 4303 Morgan Avenue, Los Angeles.

On 6/28/68, PRINCE DIXON at the above address, advised that this telephone call from the San Antonio area to his home in Los Angeles was placed by his brother, LEO DIXON, who lives at 215 South Olive, San Antonio. DIXON, a Negro, advised that his brother called him on that date to advise him that he, LEO DIXON, was forwarding some money to his brother in Los Angeles.

In view of the above, it does not appear that further investigation is warranted in connection with this particular telephone call.

One copy of this report is being provided to the Houston and San Antonio Offices for information purposes in anticipation of assisting in any subsequent investigation.

The purpose in submitting this report even though it contains the results of negative investigation is because information had been previously reported that allegedly the subject was observed on the evening of 12/16/67, making a telephone call from a coin box while being accompanied on a trip from Los Angeles, California, to New Orleans, Louisiana, by CHARLES STEIN, during the period December 15 - 17, 1967. This call was allegedly placed from a pay telephone in the area near Houston, Texas.

It has also been alleged that the subject may have made several telephone calls while traveling through Texas.

It has been further alleged that the subject had indicated that his purpose in traveling to New Orleans was on business and the subject had mentioned an Italian sounding name as the person he was to contact.

Referenced Houston airtel, dated 5/2/68, contained a list of 281 calls made 12/15 - 17/67, from within the Houston Division to Louisiana.

Referenced Houston airtel, dated 5/6/68, contained an additional 75 phone calls made 12/15 - 17/67, from within the Houston Division to Louisiana.

Referenced San Antonio teletype contained a list of nine calls made from within the San Antonio Division to Louisiana.

In view of the allegations previously set forth, New Orleans is reporting only the results of interviews of persons residing in the New Orleans area.

The subscribers of the rest of the calls to other parts of Louisiana furnished by the Houston and San Antonio Divisions have also been determined. These persons who still reside in Louisiana have been located and interviewed, and no pertinent information relative to this investigation was developed. The results of these
