



- Further to F.B.I. request made on the above noted date, please be advised of the following.
- 2. Checks were made at the address where GALT reportedly had resided, 2589 Notre-Dame East, Montreal, P.Q. This address is for the "HARKAY" Apartments. The janitor at Harkay Apts, one Roland RACICOT, was interviewed. With his permission, a perusal of the room ledger was made. Although GALT's name did not appear on any room sheet, on the reverse side of page number 3 (which stands for room #3) was found the following: "Eric S. GALT, 507 Chestnut Street, Kansas City, Mo.". On the front appeared the names Mr. MECKLIN, SEPT 4 to OCT 4 - moved, also MANIA FEB 3 to MAR 3 - changed to Apt #4. The dates for MECKLIN are for 1967 and the dates for MANIA are for 1968. When further questioned with regards to the Register, leases and any other information, Mr. RACICOT informed me that he had taken over the job only at March 1st 1968. He informed me that the former janitor, Morris QUINTAL, was no longer in the area, but that his present whereabouts could be obtained from the Manager, one Harry ROTHMAN.
- 3. Mr. H. ROTHMAN, 11 Halthom Road, Hampstead, Quebec, phone 488-8525, was telephonically contacted at his office in Pont Viau, P.Q., at 669-1721. When questioned further, Mr. ROTHMAN sounded hesitant and unsure. He claimed he had no knowledge of any lease signed by GALT or any further information.
- As a result of our conversation with ROTHMAN, Sgt. CARREAU of our "O" Division, Windsor Detachment, was contacted by phone. It was requested that QUINTAL be interviewed and any possible information concerning GALT be obtained.

16 APR 68

On the above date, newspaper clippings from "The Gazette" and "La Presse" along with a composite picture of GALT and the ledger sheet with GALT's name and a US address were forwarded by Air Canada to Windsor.

17 APR 68

On the above date, the results of the interview with QUINTAL were received from Cst. HARTLAND of Windsor Detachment. Same are as follows: the interview was held with QUINTAL at his residence at approximately Midnight of the 16-4-68. QUINTAL advises that GALT rented apartment 18 for approximately one to one and a half month from August to September 1967. QUINTAL believes a lease was signed and same should be

in the possession of ROTHMAN.

- CALT's physical description as given by QUINTAL is as follows: 5'6", 160 lbs, black hair combed backwards on an angle and not receding. He has a light complexion, shallow face and gave the appearance of being thin. He appeared to be 32 to 35 years of age. QUINTAL advised he would recognize GALT if he ever saw him again.
- During his stay at the Harkay Apts, GALT was a quiet man who kept to himself. He only had two visitors that were noted by QUINTAL. Both were female and were together. The only description of these subjects that could be obtained is that they were elderly women between 40 and 42 years of age and one had black hair and the other had reddish brown.
- With respect to mail, only two letters were received during his stay. One was from a US address but no information was available regarding this letter. The other was from Tip Top Tailors here in Montreal. From the information obtained from QUINTAL, CALT had ordered a suit there and this was a notice to pick it up. This information is presently in the process of being verified.
- 10. GALT claimed to have been working at Expo 167. possibility was checked with negative results. Mr. R. MADORE, Personnel Manager for the C.C.W.E., was interviewed; a check of his records was made for the name of GALT and also John WILLARD, Harvey LAWMEYER and Eric STERVO which are known aliases. As previously mentioned, these were non-resultant. Mr. J. TRAYNOR of Expo Security was also interviewed and the aforementioned names were again verified with the passes issued to Expo employees both full and part-time. Checked were the press passes (both permanent and temporary), the permanent work passes and the temporary work passes. Again, this met with negative results. This does not exclude the possibility that CALT was employed by a private concessionaire; however, these types used a blanket pass for their employees and without the name of the concession or concessionaire, it is impossible to trace.
- The possibility that GALT was driving a car in this area was also covered. QUINTAL claimed GALT asked if there were any parking spaces at the apartment. When QUINTAL told him there were, however, that they were \$20.00 a month, he declined. GALT asked if there were any other places for rent and he was referred to a local Shell and/or Esso Service Station. QUINTAL never saw the vehicle if there was one, therefore could add nothing further in this respect. Checks were made at Charlebois Shell, 2515 Notre-Dame East and at Michel Catala Texaco at 2508 Notre-Dame East with negative results. In either place, no receipts were given and due to the huge number of cars that were handled during this period, no one could recall either the subject or any particular auto with US plates. Enquiries along this line are being continued.
- With respect to GALT's name and a US address appearing on the reverse side of Ledger sheet #3, QUINTAL could add nothing further. He did not know why they appeared there but is reasonably sure that this CALTIS handwriting.

- When GALT left Harkay Apts, he said he had to return to the US to look after some sick relative. He left around the 2 SEPT 67 and in so doing, forfeited the deposit he had placed on the apartment. This amounted to approximately \$90.00.
- There is a possibility that the two women mentioned in paragraph 7 of this report would be Mrs. Rita STEEN, 5666 Franklin, Los Angeles, California and Mary DENINNO, 5533 Hollywood, Los Angeles, California. According to QUINTAL, these women and GALT had a party in his room. The next morning, one left and the other stayed on with GALT for a few days.
- Record checks were made with both the Q.P.P. and M.C.P.; however, same met with negative results. A check of the surrounding area was made on the 13 APR 67 however with no results.
- A photo of GALT is being forwarded by the F.B.I. to our Windsor Detachment for QUINTAL's identification. Also, it is requested that QUINTAL supply us with the names of any persons who resided in apartments #17 and #19 while GALT resided at the Harkay Apt.
- 17. Investigations in this matter are still being conducted at Tip Top Tailors, with the Manager of Harkay Apts and with QUINTAL. Various parking facilities in the area of the apartment are also being checked.
- 18. All leads will therefore be looked into as soon as possible with a further report to be submitted. A copy of this report is sent to Windsor Det.

- On the above date, Miss Marjorie BIRCH called to report that when she saw the picture of GALT, alledged assassin of Dr. Martin Luther KING when shown on the 11:00 p.m. TV news this evening, she noticed a striking resemblance to a person she had seen at 6:00 p.m. today in the waiting room of the Cartierville Airport. The man, in his early thirties, 5'10" or 5'11", had facial features practically similar to the one shown on TV. For more details, Miss Birch advised she could be contacted at 288-8322 the next day in the a.m.
- Miss Marjorie BIRCH was interviewed at which time she was shown a glossy photograph of Eric Starvo GALT. She identified him as being the man she saw the Laurentide Aviation, Cartierville Airport. BIRCH's roommate agreed with the above. They both saw the suspect enter by the door that leads to the runway. He was dressed in a camel hair sweater. The physical description is identical to the one held by this office. A check at the Laurentide Aviation waiting room proved that the suspect was not seen by the employees.
- Mr. LAMBERT, despatcher of the said airport, was asked if any aircrafts came in around 6:00 p.m. of the 17-4-68. He stated that the only one that came in at that time was registered to Ted WALKER from Aylmer Ontario, registration number CF-UGO. He also mentioned that he was accompanied by some passengers. A telex was forwarded to London Detachment requesting checks on the owner, date and time of departure from Aylmer, identification of passengers and destination. A reply was received stating that CF-UGO flew to Montreal on business on the 2-4-68. Log book and independent sources verified that the said plane was on the ground at Aylmer, Ontario, for the duration of the 17-4-68.
- having made an error and that he now remembers WALKER's flight on the 2-4-68. At this point, the Daily Air Traffic Records of Cartierville Airport, were obtained from the Control Tower giving all the details of flights made on the 17-4-68. From these records, the registration number of aircrafts, owners, arrivals and departures between the hours of 4:00 pm and 8:00 pm were taken off the said records. The flights made between the said hours were aircrafts mostly all registered to Laurentide Aviation, won Del Aviation and The Montreal Flying Club which makes up the Cartierville Airport. After checking these flying clubs, the writer was advised that these are mostly all routine training flights; however, the log books were checked and the pilots, students or passengers are registered and all known by the said clubs. Other aircrafts not attached to Cartierville Airport were identified as being regular customers and are also known at this point.

The writer was also made aware that no pilot can depart the airport for a flight without checking with the front office. He also has to identify his student or passengers. A violation of this sort would cause a pilot to loose his licence. Therefore, there does not appear to be any possibility whatsoever that GALT could have arrived or departed without being registered or noticed. It should be noted that the staffs of these flying clubs were shown a photograph of GALT at which time the writer was advised that he was not seen in these vicinities; however, if he is seen, our office will be advised.

6. Due to the above facts, this file is considered closed unless otherwise instructed.

- Miss Shirley GREENFORD contacted the Duty N.C.O. and stated that she had information concerning Eric Starvo GALT. This information was referred to Cat. Donelle for immediate attention. She was interviewed at her place of employment, "SEE EUROPE TOURIST", 375 Victoria Ave., room 204, Westmount, telephone no. 489-5359, and she stated that a former employee, named Collin J. BLACKMAN, 7845 Mountain Sights, apt. 73. Montreal, telephone no. 733-4224, has a strong resemblance of suspect. He was employed from 25 MAR 68 to 29 MAR 68 and on that date he told her that he was flying to New York and she said that SAUNDERS, another employee, told her that BLACKMAN said that he was flying to Philadelphia. SAUNDERS was subsequently interviewed on the 29th. He was asked to describe BLACKMAN and the description given was the exact description held by this Office on GALT. He was then shown the photograph of GALT and he identified BLACKMAN as being GALT. It was also learned at the Agency that he quit his job without notifying his employer and for no apparent reasons; he was again seen on the 8th or the 9th of April by SAUNDERS whilst driving in a 1968 white convertible. Ontario plates, make and licence number unknown. He told SAUNDERS that he had been in the hospital and that he would contact him in the afternoon but has never been seen or heard from afterwards.
- The record of Collin J. BLACKMAN, F.P.S. no. 742327, was requested on the 30th of April and his photograph as well as GALT's and several others, were again examined by Miss GREENFORD, Mr. SAUNDERS and Mr. CLEMENS, manager of the said agency, who had returned from a trip. They all picked out BLACKMAN's photograph as being the one employed previously at the Agency. Mr. CLEMENS was shown GALT's photograph which he identified as also being BLACKMAN. Other photographs of GALT taken from the "Newsweek Magazine" which were taken in 1952, 59, 60 and 66 were also shown to the staff. Miss GREENFORD said that the photo of GALT taken in 1960 had a strong resemblance of BLACKMAN and Mr. SAUNDERS said that the photograph taken in 1966 resembled BLACKMAN.
- BLACKMAN was located and interviewed at this office; I immediately recognized BLACKMAN whom I met some five (5) years ago whilst he was working for Murray Hill Limousine Service at the Monteeal International Airport, Dorval. He worked for Murray Hill Limousine for approximately three (3) years and has held various jobs since that time including SEE EUROPE TOURIST, TRAILWAYS OF CANADA, Richmond Hill, Ont, CHARLTON TRANSPORT and is now driving a taxi for Emil ISPAS, 8040 Wiseman Montreal. He is divorced from his second life Anita DUBE who resides at 7845 Mountain Sights, Montreal and visits his children regularly. He is presently residing at 2582 Sheppard St., Montreal, telephone no. 526-0717, living in common law with Miss Rachel TAYLOR, who I also knew when she was working for Bry's Pharmacy at the Airport. She is now employed 4....

.NOW EMPLOYED at the Bell Telephone. His social insurance no. but on his is 216-632-042. His date of birth is driving permit his date of birth is shown as 9th of March 1933. He changed his birth date in order to obtain a driver's permit when he was under age and has not been able to change it. BLACKMAN was shown various photographs of GALT and admits that he somewhat resembles GALT but said that his brother strongly resembles GALT and would not be surprised if this office would receive similar information. It is intended to interview BLACKMAN's brother in order to climinate useless and extensive enquiries.

It should be added that many verifications were made before contacting BLACKMAN but are not elaborated upon in this report. It has been established without any doubt that BLACKMAN is not identical to GALT.

- Further to sub-paragraphs 2, 4 and 5 of the memorandum from the A/Officer i/c C.I.B. dated in Ottawa 1 MAY 68, please find enumerated hereunder, an approximate amount of businesses mentioned which are situated in the Greater Montreal area.
  - (2) Dance studios 27
  - (4) CAR SALES - New - some with separate used cars -115lots
    - Used Independent from used cars lots operated by authorized automobile dealers - 40
    - 88 Car Rental Agencies
  - (5) Banks - 413 Caisses Populaires -123Post Offices 33 839 TOTAL
- It is to be noted that the better part of the above business concerns would be large in size and have many employees. A direct approach of personnel of these concerns is not concerned feasible at this point and our investigators would have to visit the same business on more than one occasion as all employees would not be readily on hand for interview, i.e., salesmen or employees out on the road, absent on holidays or for various other reasons. As an example: new cars sales garages in Montreal are in an approximate amount of 115. In placing an average of three (3) salesmen per garage, our investigators would have to contact three hundred and forty-five (345) persons on a direct basis.
- 3• In view of the above, it is suggested that a form of bilingual "Wanted" notice be prepared by our Crime Index Section for mail circulation to the above mentioned businesses. This matter was discussed with the N.C.O. i/c "C" Division C.I.S. who concurred with the fact that notices could readily be prepared and that this manner of procedure would expedite the investigation. The mailing list would be prepared at G.I.S. level.

Further to paragraph 2 of memorandum from the A/Officer 1/c C.I.B. dated in Ottawa 1 MAY 68, and from perusal of our file at this point, it is felt that only two (2) persons would in a position to definitely identify the photograph of the man purported to be RAY. These persons would be Mr. and Mrs. Morris QUINTAL, former janitor of RAY's Montreal address, who are presently residing in Windsor, Ontario (reference: Windsor Detachment report dated 18 APR 68).

## 6 MAY 68

- Further to telex CIEILI6/2 dated 1 MAY 68, Cst. MCUSSEAU interviewed Mr. Lou EISENBERGER of 2285 Charles Gil Street, Montreal, telephone number 334-8469. Photographs of RAY were exhibited and he was asked if any were familiar to him. He replied in the negative and the same results were obtained from his wife. He could add nothing further in respect to the theft of the car itself and neither him nor his wife were familiar with the name Mitchell or Michel ST-PIERRE. EISENBERGER also stated that he would be out of town for the remainder of the week and would not return until the 13 MAY 68.
- Captain ST-PIRRRE, Montreal City Police, was interviewed and through him, a search of records was made with the Auto Theft Squad. A complete ledger which lists all auto thefts from the City of Montreal and surrounding communities was checked for the months of August and September 1967. Out of approximately 1,400 cars reported stolen, the only theft which could be remotely related to this file was one recovered in Glens Falls, New York, U.S.A. The car was rented from Avis Rent-A-Car, 1225 Metcalfe Street, Montreal, P.C., telephone 861-6761. It was described as a Dodge coach, year 1967, green in colour and bearing 1967 Quebec registration #87-127. This vehicle was reported stolen on the 13 SEPT 67 and located on the same date. No further information could be obtained from the Montreal City Police. With respect to canvassing all homes on Charles Gill Street, it should be noted that there are approximately 300 residences on this street alone. Homes surrounding EISENBERGER's were canvassed and the investigation revealed that they had already been canvassed by police at the time of the car theft. At both times, negative results were obtained. It is felt that further canvassing would not reveal anything of use in this investigation.
- Further to telex CIB 1128/2 dated 2 MAY 68, this matter was discussed with the N.C.O. i/c "C" Division C.I.S. who will attend to the distribution of RAY's fingerprints to police agencies who maintain latent fingerprints files. This matter will be further discussed with C.I.S when they have received sufficient copies of F.B.I. Identification Orders 4182 for distribution with their request to police forces concerned. The matter of obtaining sufficient copies of the Identification Order has already been attended to by Division C.I.S.
