A review of Atlanta files concerning MURKIN and of case captioned "RAYMOND LEWIS CURTIS, aka - FUGITIVE. UFAC - MURDER, ESCAPE", reflects that CURTIS was interviewed by Bureau Agents on 4/21/68, and 4/22/68, concerning his acquaintance with JAMES EARL RAY and alleged information he obtained from RAY concerning a plot to kill KING. This information is contained in the three enclosed Atlanta teletypes.

In connection with the pending fugitive investigation regarding CURTIS, Mr. FREEMAN C. HILL, Unit Coordinator, Community Base Services, Rome, Georgia, CURTIS' former parole officer made available on 11/28/72, a copy of an autobiography written by CURTIS at HILL's request in about 1970. This autobiography traces CURTIS' criminal life from early childhood to the time he wrote the autobiography.

Investigation conducted regarding CURTIS reflects that psychiatric tests conducted by the State Department of Corrections at the Jackson Diagnostic Center incidental to the murder sentence being served by CURTIS at the time of his escape reflects CURTIS has a mental age of 10 years and 6 months and has a psychopathic personality.

A review of CURTIS' criminal history reflects he is basically an armed robber, unintelligent, and there is no indication he has ever been involved in any confidence schemes.

CURTIS is currently a fugitive, having escaped a work detail of the Ware Correctional Institution on 7/18/72, while serving a life sentence for murder, imposed on 7/26/67, at Whitfield County, Georgia. On 7/20/72, a warrant was issued by the Georgia State Board of Offender Rehabilitation, Atlanta, Georgia, for escape. On 9/5/72, an authorized complaint was filed before the U.S. Magistrate, Savannah, Georgia, charging CURTIS with violation of Title 18, Section 1073, U.S. Code. A warrant was issued and \$100,000 bond recommended. CURTIS has not been apprehended to date and continues as a fugitive.

A review of the Atlanta 88 file reflects CURTIS is a former cellmate of JAMES EARL RAY at the Missouri State Penitentiary and received nationwide publicity on

television and in newspapers and magazines after making statements about RAY.

GEORGE McMILLAN was listed as a correspondent with CURTIS while CURTIS was at the Ware Correctional Institute (WCI). WCI files reflect McMILLAN made numerous requests to see and interview CURTIS while CURTIS was at WCI, but these requests were denied. Prison files reflect GEORGE McMILLAN, Coffin Point, Frogmore, South Carolina, as a correspondent with CURTIS.

In connection with the current fugitive investigation regarding CURTIS, Mr. GEORGE McMILLAN, 12 Hilliard Street, Cambridge, Massachusetts, advised on 1/22/73, that he is an author working on a book about the life of JAMES EARL RAY. He learned that CURTIS had been a cellmate of RAY's and had also been jailed with him at the same institutions on two other occasions. McMILLAN said he interviewed CURTIS regarding RAY on several occasions and thereafter received leather goods from CURTIS, which CURTIS manufactured. McMILLAN furnished CURTIS cigarette money for these leather goods. McMILLAN stated he has not been contacted by CURTIS since CURTIS' escape.

It is noted in the referenced Memphis airtel to the Bureau that ROBERT LIVINGSTON, attorney, allegedly met with his source, identified as CLIFF ANDREWS, in Detroit, on 4/20/74. A review of CURTIS' fugitive file does not contain any information indicating CURTIS has been in the Detroit area.

ROBERT THOMAS WEHUNT, JR., 3109 Hartnett Avenue, Tampa, Florida, personally appeared at the Tampa, Florida, Office of the Federal Bureau of Investigation. He was advised of the official identity of the interviewing Agent, the nature of the inquiry and that any information he furnished could be used in a court of law. He did not desire to furnish a signed statement but orally furnished the following information:

WEHUNT has been in the U. S. Air Force for the past six years, and he is presently a Staff Sergeant in the First Munition Maintenance Squadron at MacDill Air Force Base (AFB), Tampa, Florida. He recently read in the newspaper that JAMES EARL RAY, who was convicted of killing Dr. MARTIN LUTHER KING, JR. in 1968, is attempting to get a new trial and is stating that he wants to tell who was involved with him in this killing. This article reminded WEHUNT of information that he had received from his father, ROBERT THOMAS WEHUNT, SR., in 1968. WEHUNT furnished this information to his Commanding Officer, Major OZOL. Major OZOL referred WEHUNT to Colonel HOLMES of the Legal Office of MacDill AFB, who in turn referred WEHUNT to the Federal Bureau of Investigation Office in Tampa.

WEHUNT's father was a criminal investigator in the U. S. Army for 20 years. After his father retired from the Army, he worked as an investigator for Fidelofax, later for a bonding company and then for eight years as a guard at the Fulton County Jail, Atlanta, Georgia, up until his death in August, 1973.

Approximately two months after KING's death in 1968, WEHUNT's father showed WEHUNT, WEHUNT's mother, ALMA LOUISE WEHUNT, maiden name RALSTON, and WEHUNT's sister, JANET UPSHAW, maiden name WEHUNT, at least three signed statements that WEHUNT's father stated he had obtained from "hard-core" convicts in the Fulton County Jail. Each statement stated that these convicts had been approached by "very influential businessmen" to kill Dr. MARTIN LUTHER KING, JR. for \$100,000.

At this time WEHUNT's father was a jailor and he told WEHUNT that these criminals furnished him this information and he took it from them in the form of signed statements. The father told WEHUNT that on one occasion he attempted to turn these statements over to proper authorities for investigation but that the father's life and that of his family were threatened, and the father told WEHUNT that he had decided to keep his mouth shut. The father did not tell WEHUNT to whom he had offered the statements or who had threatened the father.

The father formerly had these statements and other related papers at his house in Atlanta, Georgia, but after the father died in August, 1973, WEHUNT and his mother attempted to locate these papers but to date they have not located them. WEHUNT assumes that it is possible his father had a safe deposit box that no one has yet discovered and that possibly the statements and papers are contained in the safe deposit box.

WEHUNT cannot recall names of the individuals who furnished the statements or names of the "very influential businessmen", but these names were all contained in the statements.

WEHUNT doubts that his mother or sister would recall any additional information about the statements or that contained in the statements, and WEHUNT does not know of anyone else who has any information concerning these statements.

WEHUNT noted that shortly before the death of his father his father was an alcoholic and he had many girl friends and more money than he could have possibly been earning as a jail guard. WEHUNT, therefore, at that time surmised that it was possible that his father had been paid off by unknown individuals to remain quiet about the statements.

WEHUNT mentioned this story to his commanding officer about two months ago but the commanding officer did not give WEHUNT any response to it and WEHUNT dropped the matter at that time. WEHUNT brought this matter up at this time after reading the newspaper article about RAY and after thinking that if RAY talks possibly WEHUNT and his father's name might be brought up and there might be some danger to WEHUNT and

his family. WEHUNT noted that another reason that he never mentioned this story to anyone before is because he did not feel that anyone would believe him. WEHUNT advised that if he recalled any additional information or was able to develop any additional information he would immediately recontact the Federal Bureau of Investigation.

SUBJECT JAMES EARL RAY REPRESENTED BY MEMPHIS ATTORNEY ROBERT LIVINGSTON AND WDC ATTORNEY BERNARD FENSTERWALD. LIVINGSTON HAS RECENTLY MADE STATEMENTS TO THE PRESS THAT HE HAS BEEN CONTACTED BY AN INDIVIDUAL CLAIMING THAT HE AND TWO OTHERS ARE THE ACTUAL MURDERERS OF KING. LIVINGSTON CLAIMS TO HAVE MET WITH THIS INDIVIDUAL ON MORE THAN ONE OCCASION. LIVINGSTON HAS IDENTIFIED HIM AS CLIFF ANDREWS BUT IT IS NOT KNOWN WHETHER OR NOT THIS IS TRUE NAME.

MEMPHIS ATTORNEY, RUSSELL X. THOMPSON, CONTACTED MEMPHIS OFFICE THIS DATE AND STATED THAT DURING THE PAST WEEK LIVINGSTON HAS ASKED HIM TO REPRESENT CLIFF IN CLIFF'S ATTEMPT TO OBTAIN IMMUNITY FROM THE SHELBY COUNTY DISTRICT ATTORNEY. CLIFF'S LAST NAME NOT FURNISHED TO THOMPSON. THOMPSON RECEIVED TELEPHONE CALL AT ABOUT TEN PM, JULY 15, 1974, FROM CLIFF WHO REQUESTED THAT THOMPSON COME TO DETROIT TO MEET HIM. THOMPSON IS SUPPOSED TO CALL CLIFF THIS DATE, JULY 16, 1974, AT FIVE PM, AT 519-852-2021.

THOMPSON HAS STATED HE DOES NOT INTEND TO GO ANYWHERE TO MEET CLIFF AND WILL ADVISE HIM TONIGHT THAT CLIFF MUST COME TO MEMPHIS IF HE DESIRES TO HAVE THOMPSON REPRESENT HIM. THOMPSON BELIEVES CLIFF IS PERPETRATING SOME TYPE HOAX BUT HAS NOT YET BEEN REQUESTED TO FURNISH CLIFF ANYTHING OF VALUE. THOMPSON HAS SUGGESTED THE FBI MIGHT WANT TO ATTEMPT TO IDENTIFY CLIFF. THE ABOVE TELEPHONE NUMBER IS A MOTEL, CITY UNKNOWN, AND CLIFF IS ALLEGEDLY RESIDING IN ROOM ELEVEN. THOMPSON STATES CLIFF SOUNDS LIKE A MATURE, INTELLIGENT, WHITE MALE WITH WHAT THOMPSON DESCRIBES AS A CANADIAN ACCENT BUT NOT A FRENCH ACCENT.

DISTRICT ATTORNEY HUGH STANTON, MEMPHIS, HAS PREVIOUSLY REQUESTED THAT THE FBI NOT TAKE ANY ACTION WHICH WOULD FRIGHTEN CLIFF AWAY AND END HIS CONTACT WITH LIVINGSTON. STANTON HOPES TO INTERVIEW CLIFF FOR WHATEVER VALUE IT MIGHT HAVE. FOR THIS REASON, MEMPHIS DOES NOT RECOMMEND THAT DETROIT OFFICE CONDUCT ANY OVERT INVESTIGATION LOOKING TOWARD AN INTERVIEW OF CLIFF; HOWEVER, IF IT COULD BE DONE THROUGH AN ESTABLISHED SOURCE IT MIGHT BE WORTHWHILE TO ATTEMPT TO IDENTIFY CLIFF. AREA CODE 519 IS IN ONTARIO, CANADA, IN THE DETROIT VICINITY.

THE TELEPHONE NUMBER SET OUT IN REFERENCED TELETYPE WAS INCORRECTLY FURNISHED TO THIS OFFICE BY MR. THOMPSON. THOMPSON CONTACTED CLIFF ANDREWS AT THIS NUMBER AT ABOUT FIVE PM, JULY 16, 1974. THE PERSON ANSWERING THE TELEPHONE IDENTIFIED THIS NUMBER AS BEING AT THE COLONIAL MOTEL, CITY UNKNOWN. CLIFF ASKED THOMPSON TO SEND HIM \$700 BY NOON, JULY 17, 1974. HE REQUESTED THE MONEY BE SENT TO CLIFF ANDREWS, CANADIAN NATIONAL TELEGRAPH OFFICE, OWEN SOUND, ONTARIO. CLIFF STATED HE WOULD GO TO OWEN SOUND AND WOULD ARRIVE THERE BY NOON, JULY 17, 1974. CLIFF STATED IT WOULD EVENTUALLY TAKE \$2,500 TO \$3,000 TO ENABLE HIM TO ROUND UP ALL THE PEOPLE INVOLVED AND TO GET THEM TO MEMPHIS.

CLIFF TOLD THOMPSON THAT HE WAS "BURIED IN A VERY BACKWOODSIE PART OF THE COUNTRY" AND THAT DETROIT WAS ABOUT HALF THE DISTANCE FROM HIS HOME TO MEMPHIS.

THOMPSON CALLED CLIFF AGAIN ON THE MORNING OF JULY 17, 1974, AND ADVISED HIM HE WOULD NOT BE ABLE TO ADVANCE HIM THE \$700. CLIFF REQUESTED THAT THOMPSON CONTACT BOB LIVINGSTON, THE ATTORNEY AT MEMPHIS WHO IS REPRESENTING JAMES EARL RAY. Dear Warden Rose:

Our office at St. Louis, Missouri, received a telephone call from a young female who advised that on the afternoon of July 29, 1974, she was approached on the street in downtown St. Louis by a dark skinned individual who told her that he was from Jamaica. He never disclosed his name, but he told this young woman that he was en route from Chicago, Illinois, to Tennessee. He displayed to her what she considered to be a large amount of money. He told her he had \$5,000 which had been furnished him to purchase dynamite, and he said he was en route to Tennessee to free James Earl Ray. He further told her he was leaving St. Louis on the evening of July 29, 1974, and she believes he indicated he was traveling by bus.

She described this man as being about 25 to 30 years old, about 5 feet 6 inches tall, as having a medium build, and a pronounced accent. She said he was dark skinned, had dark hair, and was wearing blue slacks and a shirt. She said that he appeared ignorant of American customs but otherwise seemed stable.

This is being furnished for your information and for whatever action you might deem advisable.

On 7-31-74, Miss SHIRLEY JEAN WHEELER, Negro female, born [redacted] St. Louis, Mo., was personally interviewed for the purpose of enlarging upon the information she telephonically furnished the St. Louis Office on 7-29-74. WHEELER furnished the following information:

She was walking and enroute to a bus stop in downtown St. Louis at 3:30 P.M. on 7-29-74 when she was approached by a male individual with dark complexion whose complete description was previously obtained and furnished in retel. Individual stated he was from Jamaica (hereafter referred to in this communication as the Jamaican). The Jamaican asked her for directions to the Reece Boarding House for Colored People. WHEELER denied any knowledge of such a place. Individual then told her that he had paid \$75 to a colored girl for the purpose of a sexual date and he was to meet her at the Reece Boarding House for the date. For no apparent reason, the Jamaican then exhibited a large amount of money to WHEELER, claiming it was \$5000 in cash. He asked her if she knew of any house of prostitution in the area and she denied any knowledge of such a house. At this time a second individual whom WHEELER described as a Negro male, 35-40 years, 5'9", medium build, who walked with a limp, came

up to her and the Jamaican and entered in a casual conversation stating that he was from St. Louis and asked if he could be of assistance. Jamaican told the Negro male he would give him \$100 if he would find him a girl. Jamaican then proceeded to show the Negro male his money. Jamaican walked several feet away and the Negro male told WHEELER that he had been following the Jamaican and knew that he had a large quantity of money and was a stranger in this country. Jamaican returned to WHEELER and asked her if she knew JAMES RAY. She replied in the negative, whereupon he reminded her that JAMES RAY was the white male who killed Dr. MARTIN LUTHER KING, JR. and RAY was then in a Tennessee penitentiary. Jamaican told WHEELER that RAY's brother owned a big farm in Jamaica and he was the houseboy at the farm. He further stated that RAY's brother, name not mentioned, had given him \$5000 in cash to go to St. Louis to buy dynamite and then go to Tennessee to blow up the prison to effect JAMES RAY's escape. Jamaican then told WHEELER and the Negro male it would be a while before he could buy the dynamite and did not know what to do with the money in his possession in the meantime. Jamaican asked WHEELER's opinion where she would keep the money. WHEELER told him that the safest place would be to deposit it in a bank. Jamaican told her that he heard that Negroes in the U. S. could not deposit money in a bank. She told him that he was wrong. Jamaican asked her if she had a bank account and she replied that she did. Jamaican refused to believe her and told her that if she could show him that she could withdraw her money from the bank, he would give her \$100 just to prove it to him. WHEELER advised that the Negro male was present during this conversation and told her it would be an easy way for her to make \$100.

WHEELER advised the three of them went to the Mercantile Trust Company where WHEELER has a savings account. Upon arrival at the bank, the Jamaican asked to see her bank deposit book which she had in her possession and she showed it to him. At the time WHEELER had a \$24 balance. She withdrew \$20 as proof to the Jamaican that Negroes can withdraw money from a bank. He did not give her the \$100 and immediately the Negro male told the Jamaican that he knew where he could get him a girl and both hurriedly departed from the scene. WHEELER still retains possession of her \$20 bill.

In view of the fact that the above incident was probably a flim-flam scheme with WHEELER as the intended victim, St. Louis is conducting no further investigation. St. Louis Police Department advised of scheme.

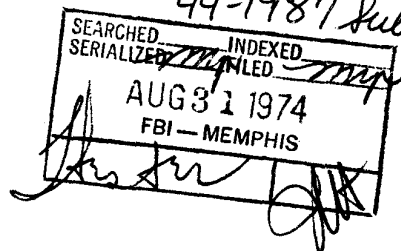

THURSTON all motel registration records for the Hawaiian Motel for the years 1972 and 1973 and a review of these records failed to reveal any registration record pertaining to BILL HARRIS and also failed to reveal any registration record pertaining to DAVID J. GAINES, or SHIRLEY GAINES. Mrs. BITTNER did advise that sometime during 1972, the motel changed hands and felt that because of this,

On 8/19/74, Mr. DONALD DARR, Town Clerk, Brunswick, Maryland, advised that he recalls that a Chesapeake and Ohio Canal Citizen Advisory Commission hearing was held at Brunswick during either June or July, 1972, but stated he could provide no information as to whether a SHIRLEY GAINES was employed as a private court and conference reporter at the Brunswick hearing.

No matter how much men may try to cover up and "plaster over" the serious divisions that lie deep within human society as it is now structured, they cannot prevent the consequences pointed to in Jesus' words: "A house divided against itself falls."—Luke 11:17.

But the finest, most convincing evidence that a new order is near comes from the promises and prophecies of God's Word, the Bible. Its prophecies not only foretold the present decay of morality and the turning away from truth and righteousness that have brought the present order to its state of global crisis, but they also tell us God's declared purpose to sweep away all these present systems in an unequalled "great tribulation" within "this generation" and to establish his own order with new systems founded on righteousness, on love of God and love of neighbor.—Matt. 24:21, 33, 34; Rev. 7:14-17.

Mrs. DORIS HOOVER, Hoover Reporting Company, 320 Massachusetts Avenue, Northeast, on 9/9/74, acknowledged the reporting of the hearing of the Chesapeake and Ohio Canal Advisory Commission held 6/7/72, was performed by DAVID GAINES, an employee of her company. She stated SHIRLEY GAINES, wife to DAVID GAINES, is not an employee of the company and, to her knowledge, does not perform court reporting work for any other company.

# TREASON

## Record Supreme Court Law NINE OLD MEN BETRAYED NIXON

THE PRESIDENT OF THE UNITED STATES IS EXEMPT FROM THE JURISDICTION OF ANY COURT AND FROM RESPONSIBILITY TO ANY AUTHORITY EXCEPT THE SENATE ORGANIZED AS A COURT OF IMPEACHMENT, AND THEN ONLY FOR CRIMINAL ACTS AS OPPOSED TO POLITICAL ACTS. THE REASON FOR THIS EXEMPTION OF THE PRESIDENT FROM THE JURISDICTION OF THE COURTS DOES NOT REST ON THE PRINCIPLE THAT THE PRESIDENT CAN DO NO WRONG, BUT UPON REASONS OF PUBLIC POLICY AND EXPEDIENT. IF HE WERE SUBJECT TO THE PROCESSES OF THE COURTS HIS POWER AND DUTY TO EXECUTE THE LAWS MIGHT BE SERIOUSLY INTERFERED WITH. FURTHERMORE, IT WOULD RESULT IN BRINGING THE EXECUTIVE AND JUDICIARY INTO CONFLICT, FOR IT WOULD BE IMPOSSIBLE TO EXECUTE A PROCESS AGAINST THE PRESIDENT SHOULD HE RESIST, SINCE THE WHOLE MACHINERY OF EXECUTION IS BY THE CONSTITUTION PLACED IN HIS HANDS. HE MIGHT ALSO PARDON HIMSELF AND THUS RENDER NULL AND VOID ANY ATTEMPT TO MAKE HIM AMENABLE TO THE COURTS. 99 COMPARE BURGESS, POLITICAL SCIENCE AND CONSTITUTIONAL LAW, VOL. II, P. 246.

CHIEF JUSTICE MARSHALL, IN THE CASE OF MARBURY V. MADISON, SPEAKING OF THE POWER OF THE COURTS TO CONTROL HIS POLITICAL OR DISCRETIONARY ACTS, SAID: "IT IS SCARCELY NECESSARY FOR THE COURT TO DISCLAIM ALL PRETENSIONS TO SUCH A JURISDICTION. AN EXTRAVAGANCE SO ABSURD AND SO EXCESSIVE COULD NOT HAVE BEEN ENTERTAINED FOR A MOMENT. THE PROVINCE OF THE COURT IS SOLELY TO DECIDE ON THE RIGHTS OF INDIVIDUALS, NOT TO INQUIRE HOW THE EXECUTIVE OR EXECUTIVE OFFICERS PERFORM DUTIES IN WHICH THEY HAVE A DISCRETION. QUESTIONS IN THEIR NATURE POLITICAL, OR WHICH ARE BY THE CONSTITUTION AND LAWS SUBMITTED TO THE EXECUTIVE, CAN NEVER BE MADE IN THIS COURT."

"BY THE CONSTITUTION OF THE UNITED STATES THE PRESIDENT IS INVESTED WITH CERTAIN IMPORTANT POLITICAL POWERS, IN THE EXERCISE OF WHICH HE IS TO USE HIS OWN DISCRETION AND IS ANSWERABLE ONLY TO HIS COUNTRY IN HIS POLITICAL CHARACTER AND TO HIS CONSCIENCE. TO AID HIM IN THE PERFORMANCE OF THESE DUTIES, HE IS AUTHORIZED TO APPOINT CERTAIN OFFICERS WHO ACT BY HIS AUTHORITY AND IN CONFORMANCE WITH HIS ORDERS.

IN SUCH CASES THEIR ACTS ARE HIS ACTS, AND WHATEVER OPINION MAY BE ENTERTAINED OF THE MANNER IN WHICH THE EXECUTIVE DISCRETION MAY BE USED, THERE STILL EXISTS AND CAN EXIST NO POWER TO CONTROL THAT DISCRETION." AGAIN THE COURT SAID IN A NOTABLE CASE:

"THE EXECUTIVE POWER IS VESTED IN A PRESIDENT AND AS FAR AS HIS POWERS ARE DERIVED FROM THE CONSTITUTION, HE IS BEYOND THE REACH OF ANY OTHER DEPARTMENT, EXCEPT IN THE MERE PRESCRIPTION BY THE CONSTITUTION THROUGH THE IMPROVING POWER."

DURING THE TRIAL OF AARON BURR FOR TREASON, CHIEF JUSTICE MARSHALL, WHO PRESIDED OVER THE TRIAL, ISSUED A SUBPOENA DIRECTED TO PRESIDENT JEFFERSON, REQUIRING HIM TO PRODUCE A CERTAIN PAPER RELATING TO BURR'S ACTS, BUT THE PRESIDENT DECLINED TO OBEY THE WRIT, AND THE CHIEF JUSTICE DID NOT REGARD IT WORTH WHILE TO ISSUE AN ATTACHMENT OR PROCEED FURTHER AGAINST THE PRESIDENT.

THE SUPREME COURT IN A WELL KNOWN CASE DECLINED TO CONSIDER AN APPLICATION FOR AN INJUNCTION AGAINST THE PRESIDENT TO RESTRAIN HIM FROM ENFORCING AN ACT OF CONGRESS ALLI- EGED TO BE UNCONSTITUTIONAL, AND WHEN THE PRESIDENT DISREGARDED A WRIT OF HABEAS CORPUS ISSUED BY THE CHIEF JUSTICE, THE COURT DECLINED TO TAKE FURTHER ACTION TO COMPEL THE OBSERVANCE OF ITS PROCESS. NEVERTHELESS THE SUPREME COURT WILL EXERCISE CONTROL OVER THE SUBORDINATES OF THE PRESIDENT, AND SINCE HE ACTS IN MOST CASES THROUGH AGENTS, THE ADMINISTRATION IS AS A RESULT BROUGHT UNDER A CERTAIN JUDICIAL CONTROL. THUS THE COURTS WILL REFUSE TO ENFORCE UNCONSTITUTIONAL ORDERS AND AN ILLEGAL ORDER OF THE PRESIDENT WILL AFFORD NO PROTECTION TO A SUBORDINATE WHO ACTS IN PURSUANCE OF SUCH AN ORDER.

THE ABOVE LAW IS WRITTEN IN THE MODERN AMERICAN LAW BOOK, CONSTITUTIONAL LAW VOLUME II. BLACKSTONE INSTITUTE CHICAGO. PAGE 735. SECTION 27. REMEDIES AGAINST THE ACTION OF THE PRESIDENT.

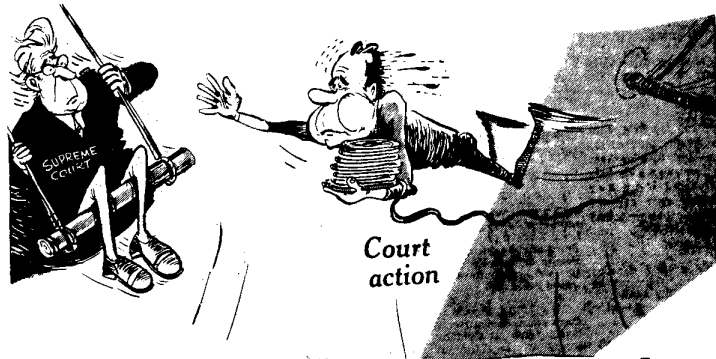

McRAE, JR., USDC, WDT, MEMPHIS, OCTOBER 22, 1974. EXPECTED TO TESTIFY FOR RAY ARE HERBERT I. McDONALD, A BALLISTICS EXPERT FROM ITHACA, N. Y., AND HAROLD WEISBERG, AN AUTHOR WHO HAILE STATES HAS PREVIOUSLY FILED SUIT AGAINST FBI REGARDING ASSASSINATION OF PRESIDENT JFK.

MR. HAILE HAS REQUESTED THE BUREAU GIVE HIM ANY INFORMATION AVAILABLE WHICH WOULD ASSIST HIM IN CROSS EXAMINATION OF McDONALD AND WEISBERG. HE WILL KEEP SOURCE OF SUCH INFORMATION STRICTLY CONFIDENTIAL BUT NEEDS ANY INFORMATION WHICH MIGHT HAVE A BEARING ON THEIR VERACITY, COMPETENCY, AND BIAS.
