# Memorandum

On 12/1/75 Mr. DENNIS BATES, U. S. Parole Officer, Nashville, contacted the writer and advised as follows:

ROY RICHARDSON, Belfast, Tennessee, is currently on Federal parole for bank robbery and is under his, BATES', supervision. At approximately 3:15 a.m., 11/28/75 RICHARDSON called Mr. BATES at home stating he needed to talk to him. BATES made arrangements to meet RICHARDSON at the Sheraton Inn South motel, I-65, Nashville, Room 119.

RICHARDSON advised BATES he had information he desired to trade for consideration in being removed from parole status. BATES advised RICHARDSON this was not possible and RICHARDSON then stated he would give the information anyway.

RICHARDSON is described by BATES as a white male approximately 50 years of age and who formerly operated Richardson's Body Shop, Lewisburg, Tennessee, until his health forced him to retire. According to BATES, RICHARDSON has lupus, a terminal blood disease, and is a patient of the Veterans Administration Hospital.

RICHARDSON advised Mr. BATES that several months prior to the murder of Dr. MARTIN LUTHER KING in Memphis he flew to Memphis in an airplane he had rented. He checked into a motel, name unrecalled but probably could recall additional details at a later date. RICHARDSON stated the motel was either the Downtowner or a motel across the street from the Downtowner. He had made arrangements to be visited by a prostitute and while waiting on

the prostitute he heard voices from an adjoining room. One male voice was heard by RICHARDSON to state something to the effect there was plenty of money and that money was no problem. This same male voice was also heard to say something about a female named JANICE, stating that "JANICE" would get her money in the same manner as RAY would. This same voice was also heard to mention \$50,000 or \$60,000 and also mention the name of KING. The same voice was also heard to state something about there was about one chance in six that someone would be caught.

RICHARDSON stated he then left his motel room, and as he left he observed a white male leaving the adjoining room. RICHARDSON went to the motel bar, as did the man from the adjoining room, and he noticed this man kept looking at him. He recognized this man as being JOHN J. HOOKER.

RICHARDSON later went to prison on bank robbery conviction and while in prison two attempts were made on his life. One of the convicts that had tried to kill him stated he had been paid to kill him.

RICHARDSON stated he was released from prison later and after his release he received a telephone call from a male, who told him to forget about Memphis and the assassination. He recognized this voice as being that of JOHN J. HOOKER.

Since his release from prison he has had numerous problems, one of which included the shooting of the plate glass window from his body shop in Lewisburg, which indicates to RICHARDSON that someone is trying to keep him from talking.

Mr. BATES advised that RICHARDSON indicated that he possibly could furnish additional details at a later time, after he had an opportunity to think about the occurrences that happened in Memphis. Mr. BATES advised that RICHARDSON did not appear to have been drinking or to have been using narcotics at the time of his contact with him.

Re Buffalo nitel dated 11/28/75 relating to newspaper publicity, etc., at Toronto, Ontario, Canada concerning efforts to reopen investigation of Dr. KING's death in the United States. Re nitel reflected that one HAROLD KIRK of Toronto was to be interviewed by the Metropolitan Toronto Police Department (MTPD), Toronto since he reportedly had information relating to a former cellmate at Mimico Correctional Institute, identified as CLIFFORD H. ANDREWS, aka R. L. WARREN. As noted in referenced nitel ANDREWS, according to Toronto newspaper publicity reportedly could testify as to his participation in the plot to assassinate Dr. KING.

On 12/3/75, Staff Sgt. GERALD A. STEVENSON, Homicide Squad, MTPD, advised he had been responsible for an investigation in Toronto which led to HAROLD KIRK's subsequent incarceration at Mimico and that KIRK, probably because he remembered STEVENSON's name called the Homicide Squad at approximately 3:15 p.m. on 11/28/75 at which time he made reference to the KING newspaper publicity and asked to be interviewed.

Sgt. STEVENSON advised that he interviewed KIRK later on that afternoon at Mimico and that he apparently intended to impress STEVENSON with his importance due to his former association with CLIFFORD H. ANDREWS.

STEVENSON characterized KIRK as a prolific check passer in the past and a "con man". KIRK claimed that he first met ANDREWS while in the hospital ward at Mimico in July, 1975 at which time he made various statements, exact details unrecalled, relating to the KING assassination. It was not until KIRK read the newspaper publicity re ANDREWS on 11/28/75 that he felt that there might be some substance to ANDREWS claim to have some knowledge of the alleged plot to assassinate Dr. KING.

KIRK recalled that ANDREWS had told him he was in need of money to return to the United States and that he had also asked KIRK regarding the location of an individual in Toronto from whom he might obtain money. KIRK had no knowledge if ANDREWS had been successful in contacting this person in Toronto following ANDREWS release from Mimico.

Summing up the contact with KIRK, Staff Sgt. STEVENSON was of the opinion that he, KIRK, had nothing positive to furnish relating to an alleged assassination plot based on conversations he had with ANDREWS previously.

As previously reported in referenced nitel, ANDREWS reportedly was released from Mimico on 9/30/75. In this regard, Inspector GEORGE SELLAR (NA), Homicide Squad, MTPD, Toronto, advised 12/9/75 as follows:

The 12/5/75 edition of the "Toronto Star," a Toronto daily newspaper, contained an article captioned, "Cited in King Case, Jailed Canadian Says He Knows Nothing," and was datelined Calgary, Alberta. This article made reference to ANDREWS, identifying him as CLIFFORD HOLMES ANDREWS, formerly of the Southamptton-Port Elgin area of Ontario, as presently being incarcerated for a three month period at the Calgary Correctional Institute, after being convicted of car theft. Reportedly, the institute's warden, identified as TERENCE DOWNIE, was quoted in the article as saying ANDREWS told him that he did not know anything about the assassination of Dr. KING and further that he did not wish to be interviewed by anyone concerning it.

An additional article regarding this matter appeared in the 12/6/75 edition of the "Toronto Star," wherein the warden of Calgary said that ANDREWS actually was serving only one month in prison there and that it was expected he would be released around 12/10/75. This article, along with other things, pointed out that prison records, not further identified, revealed that ANDREWS was in jail in Sudbury, Ontario, on the day that Dr. MARTIN LUTHER KING was assassinated in April, 1968.

No further action being taken.

Re Birmingham airtel to the Bureau, 12/12/75.

For information of Memphis, referenced airtel and LHM furnished information from a Birmingham source, with whom insufficient information has been received to establish reliability, that indicated that MARTIN LUTHER KING's assassination was "lined up" by FRANK LABERTO (phonetic), an underworld figure in New Orleans.

FRANK LABERTO's connection in this matter was previously explored. Memphis airtel to New Orleans, 4/20/68, enclosed information received on 4/8/68, from JOHN MC FERREN, a Negro male, residing at Route 4, Box 133A, Somerville, Tennessee. On 4/4/68, MC FERREN picked up supplies for his grocery store at LL&L Produce Company, 814 Scott St., Memphis, Tennessee. While there, MC FERREN overheard a white male on the telephone say, "Kill the SOB on the balcony and get the job done. You will get your \$5,000." That person later said on the phone, "Don't come here. Go to New Orleans and get your money. You know my brother."

LL&L Produce Company was found to be operated by JAMES WILLIAM LATCH and FRANK CAMILLA LIBERTO. FRANK LIBERTO had a brother, TONY, in New Orleans.

Both LATCH and FRANK LIBERTO were interviewed by Memphis on 4/19/68, wherein both emphatically denied any knowledge of the identify of the individual responsible for KING's death. They both failed to identify photograph of JAMES EARL RAY. Both denied receiving any telephone call on 4/4/68.

There is no Pontchartrain Restaurant in New Orleans. New Orleans telephone and city directories, New Orleans PD arrest records, and computerized drivers' licenses for the State of Louisiana operated by the Louisiana State Police, all failed to reflect the name FRANK LIBERTO.

New Orleans is not undertaking any further investigation in this matter, UACB.

# Court Eyes TV Bid For King Evidence

JACKSON, Tenn. — A request from CBS, Inc. (Columbia Broadcasting System), for permission to test ballistics evidence in the James Earl Ray case was taken under advisement Monday by the Tennessee Court of Criminal Appeals.

However, some of the appeals court judges expressed reservations over their authority to decide the issue and asked attorneys to submit briefs on whether the CBS request was filed in the proper court in the first place, and, whether the issue is properly under consideration by the court of criminal appeals.

CBS wants to examine and photograph the evidence for a television special on the assassination of Dr. Martin Luther King Jr., which the network hopes to televise Jan. 6.

Ray pleaded guilty to murder charges stemming from King's death and is serving a 99-year sentence in the state penitentiary. However, he has since repudiated his confession of guilt. He said he is innocent but that he pleaded guilty under pressure from his lawyers.

Ray's appeal for a new trial is pending before the Sixth U.S. Circuit Court of Appeals in Cincinnati.

His attorneys did not attend Monday's hearing in the state's criminal appeals court, but submitted briefs opposing any scientific examination of the evidence by CBS.

CBS attorney Newton P. Allen of Memphis argued Monday that the network should be able to test the evidence — a window sill, a rifle, a bullet taken from King's body and unspent cartridges and bullets — because the items are public records.

He also said that a scientific analysis is the only "meaningful" examination that could be conducted of such evidence.

Allen also argued that the First Amendment right to freedom of the press extends to news-gathering functions as well as actual publication of information.

The appeals court judges — Presiding Judge Mark A. Walker, Joe Duncan and John A. Mitchell — expressed concern that if the evidence is opened to examination by CBS, there will be a stampede of other persons interested in doing the same thing.

"Every nut in the world would be here with his expert," Judge Duncan said.

William Haynes, an assistant attorney general, said in opposition to CBS' request that the state has a duty to protect the evidence from destruction or harm, especially in a case such as this where the material may be needed for a new trial.

"State courts have a real duty to protect evidence from a zealous press," Haynes said.

He said the network already has been allowed to view all the records in the case, including the ballistics evidence, and that its constitutional right to freedom of the press does not grant the right to scientifically examined evidence in a criminal trial.

Allen said the examination would be conducted by the same expert who tested evidence in the Robert Kennedy assassination case for CBS. He said the examination would involve no chemicals, but would consist of a microscopic examination and photographing.

Interest in the case has been intensified in recent weeks after disclosures that the Federal Bureau of Investigation sent fake letters to King urging that he commit suicide. King's widow, Mrs. Coretta King, has called for a new investigation of her husband's death because of the recent disclosures.

# Mr. Church's Cover-Up

WASHINGTON, Nov. 19.—On Oct. 10, 1963, the then-Attorney General of the United States put his personal signature on a document that launched and legitimized one of the most horrendous abuses of Federal police power in this century.

In Senator Frank Church's subcommittee hearing room this week, the authorized wiretapping and subsequent unauthorized bugging and attempted blackmailing of Martin Luther King Jr. is being gingerly examined, with the "investigation" conducted in such a way as not to unduly embarrass officials of the Kennedy or Johnson Administrations.

With great care, the committee has focused on the F.B.I. Yesterday, when the committee counsel first set forth the result of shuffling through press clips, it seemed as if no Justice Department had existed in 1962; today, an F.B.I. witness pointed out that it was Robert Kennedy who authorized the wiretap of Dr. King, and that "the President of the United States and the Attorney General specifically discussed their concern of Communist influence with Dr. King."

But the Church committee showed no zest for getting further to the Kennedy root of this precedent to Watergate eavesdropping. If Senator Church were willing to let the chips fall where they may, he would call some knowledgeable witnesses into the glare of the camera lights and ask them some questions that have gone unasked for thirteen years.

For example, he could call Nicholas Katzenbach, Attorney General Kennedy's deputy and successor, and ask what he knows of the Kennedy decision to wiretap Dr. King. Who at Justice concurred in the recommendation? How does the F.B.I. know the President was consulted or informed?

After Mr. Katzenbach assumed office, and the wiretapping continued, he was told by angry newsmen that the F.B.I. was leaking scurrilous information about Dr. King. Why did he wait for four months, and for a thousand telephonic interceptions, to discontinue the officially approved tap?

Of course, this sort of testimony would erode Senator Church's political base. That is why we do not see former Assistant F.B.I. director Cartha (Deke) Deloach, Lyndon Johnson's personal contact with the F.B.I. in the witness chair. What did President Johnson know about the character-assassination plot and when did he know it? What conversations took place between Mr. Deloach and President Johnson on the tapping of Dr. King, or about the use of the F.B.I. in any other intrusions into the lives of political figures?

The committee is not asking embarrassing questions even when answers are readily available. A couple of weeks ago, at an open hearing, an F.B.I. man inadvertently started to blurt out an episode about newsmen who were wiretapping in 1962 with the apparent knowledge of Attorney General Kennedy. The too-willing witness was promptly shooshed into silence, and told that such information would be developed only in executive session. Nobody raised an eyebrow.

That pattern of containment by the Church committee is vividly shown by the handling of the buggings at the 1964 Republican and Democratic con-

ventions which were ordered by Lyndon Johnson. Such invasions of political headquarters were worse than the crime committed at Watergate, since they involved the use of the F.B.I., but the Church investigators seem to be determined not to probe too deeply.

If F.B.I. documents say that reports were made to specific Johnson aides, why are those men not given the same opportunity to publicly tell their story so avidly given the next President's men? If Lyndon Johnson committed this impeachable high crime of using the F.B.I. to spy on political opponents, who can be brought forward to tell us all about it?

But that would cause embarrassment to Democrats, and Senator Church wants to embarrass professional employees of investigatory agencies only. A new sense of Congressional decorum exists, far from the sense of outrage expressed in the Senate Watergate committee's hearing room. When it is revealed that the management of NBC News gave press credentials to L.B.J.'s spies at the 1964 convention, everybody blushes demurely—and nobody demands to know which network executive made what decision under what pressure.

I have been haranguing patient readers for years about the double standard applied to Democratic and Republican political crimes, and had hoped the day would come when the hardball precedents set by the Kennedy and Johnson men would be laid before the public in damning detail.

Obviously, Democrat Frank Church is not the man to do it. His jowl-shaking indignation is all too selective; the trail of high-level responsibility for the crimes committed against Dr. King and others is evidently going to be allowed to cool.

Pity. You'd think that after all the nation has been through in the past few years, our political leaders would have learned that the one thing that brings you down is the act of covering up.
