NOTE STATED THAT "THE BLACK SON OF A BITCH WON'T BE F----- ANY MORE WHITE BROADS." NOTE WAS SHORT AND CONSISTED OF ONE HANDWRITTEN PAGE. ?

HART SAID THAT HE HAS MORE INFORMATION BUT WILL NOT DISCLOSE THAT INFORMATION UNTIL HE HAS BEEN GIVEN ASSURANCE OF NO PROSECUTION BY MISSOURI STATE AUTHORITIES. HE EXPLAINED THAT AT THE TIME RAY CAME TO HIS RESIDENCE, HE (HART) KNEW THAT RAY WAS AN ESCAPEE FROM THE MISSOURI STATE PENITENTIARY, AND THAT IF HE ADMITTED THAT RAY VISITED HIS RESIDENCE THE NIGHT OF THE KING ASSASSINATION, THAT HE FELT HE COULD BE PROSECUTED FOR HARBORING A STATE FUGITIVE.

HART SAID DAVID SELLERS WAS THE MANAGER OF THE APARTMENT IN WHICH HE RESIDED ON RUTGER STREET IN ST. LOUIS, MISSOURI. HART SAID THAT AT THE TIME OF RAY'S VISIT, HE DID NOT KNOW THAT RAY ASSASSINATED KING AND THAT HE LATER REALIZED WHAT HAPPENED WHEN RAY WAS ARRESTED IN ENGLAND.

On October 12, 1978, Edwin B. Coleman, Sheriff, Alcorn County, Corinth, Mississippi, telephonically contacted the Federal Bureau of Investigation advising that on that date, he received a letter from James Earl Ray, postmarked Petros, Tennessee, Zip Code 37845, requesting that the Alcorn County Sheriff's Department furnish any records they may have to indicate that a 1966 Mustang displaying Alabama License B8993, was observed in Alcorn County, Corinth, Mississippi, April 1, 1968. In his letter, Ray claims to have been registered at a Corinth motel on April 1, 1968.

As reflected in the files of the Federal Bureau of Investigation, extensive investigation concerning Eric S. Galt and a 1966 Mustang registered in the Galt name, was conducted subsequent to the killing of Dr. Martin Luther King in Memphis, Tennessee.



This letter pertains to the Dr. Martin Luther King jr homicide and related matter as follows:


On April 1, 1968, I checked into a Motel in Corinth, Mississippi, and departed the following morning. Until just recently I assumed the authorities knew this consequently I never asked anyone to check into the matter. Now I learn the authorities believe I was else where April 1st.

My reason(s) for this letter is to enquire if your office has a record, through perhaps a routine check of cars registered in Motels on the aforementioned date, of the automobile I was driving. It was a 1966 Mustang registered under the name of Eric S. Galt; Alabama tag no. B 8993.

Also, assuming Motels have to be licensed by the city or county in Mississippi, would either of those Governments require Motels to retain, or furnish them to retain, a list of the Motel Guests ? possibly for tax purposes.

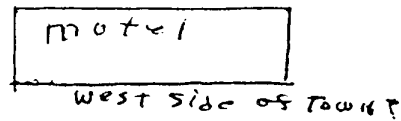
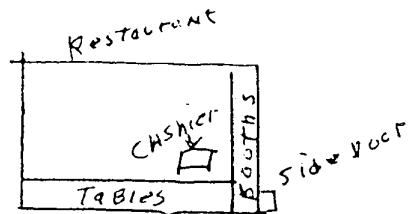

Inmate ROBERT E. HART, inmate number 23747, date of birth [redacted] was interviewed at his request at the Bureau of Prisons Facility, the Federal Correctional Institution, El Reno, where he is confined. HART advised he is currently serving a two year sentence from St. Louis on a possession of firearms charge with anticipated release June, 1979. He stated he has information with reference to JAMES EARL RAY and that he has previously been approached by congressional committees and the Secret Service and that to date, he has refused to co-operate. He stated that he is soon due for release and it is his desire to now co-operate so that he will not be bothered following release from prison.

HART stated that JAMES EARL RAY, a former neighbor in a neighborhood in vicinity of Mississippi and Park Streets, St. Louis, Missouri, came to his, HART's, residence at 1921 Rutger (phonetic), shortly after midnight the day KING was assassinated, and that RAY remained at the residence until daybreak. HART stated that RAY asked that a note be delivered to his brother, JERRY RAY, who owned a bar on Broadway in St. Louis, and attempt was made to deliver that note, HART stated, but the bar was closed. The note stated that, "The black son-of-a-bitch won't be f----- any more white broads". Note was short and consisted of one handwritten page.

HART said that he has more information, but will not disclose that information until he has been given assurance of no prosecution by Missouri State authorities. He explained that at the time RAY came to his residence, he (HART) knew that RAY was an escapee from the Missouri State Penitentiary and that if he admitted that RAY visited his residence the night of the KING assassination, that he felt he could be prosecuted for harboring a state fugitive.

HART said DAVID SELLERS was the manager of the apartment in which he resided on Rutger Street in St. Louis, Missouri. HART said that at the time of RAY's visit, he did not know that RAY assassinated KING and that he later realized what happened when RAY was arrested in England.

On 12/1/78, DANIEL MC MAHON, 84 Sanford Avenue, Belleville, N. J., home telephone number 759-0244, occupation unemployed-disabled, furnished the following information to the Newark Division:

During the Winter of 1964-1965, MC MAHON was employed as a room clerk at the Sheraton-Mc Alpin Hotel, 34th Street and Broadway, Manhattan, New York. During that period, the following individuals registered at the hotel:

RALPH ABERNETHY, SR.
RALPH ABERNETHY, JR. (his son)
MARTIN LUTHER KING, SR.

These individuals were frequently guests at the hotel and when in New York, were usually involved in Southern Christian Leadership Conferences (SCLC) activities. On this occasion, during their visit to New York, MC MAHON took care of the SCLC group personally by registering them in suitable rooms and handling all of their needs.

A day or two after the SCLC party registered, a JOHN RAY registered at the front desk and a review of the reservation list reflected that he had made a reservation at the hotel before arriving. RAY, at that time, told MC MAHON that he was connected somehow with the ABERNETHY party. MC MAHON described RAY as a white male American, around 30-40 years of age, large frame, round features, who conveyed the impression to MC MAHON that he was a Southerner. MC MAHON remembers that

RAY had a "deep penetrating personality."

ROBERT J. POLICASTRO (PH), Room Clerk, who was also on duty the night RAY registered, can substantiate the fact that JOHN RAY registered at the hotel and indicated that he was connected somehow with the ABERNETHY party. MC MAHON is not aware of POLICASTRO's present whereabouts but speculates that he could be contacted through the New York City Hotel-Motel Association. On that evening, POLICASTRO made a remark to MC MAHON that he felt as if there was something strange regarding JOHN RAY.

Later that winter, MC MAHON took a leave of absence from the hotel and returned around the Summer of 1965, at which time, he discovered POLICASTRO had been drafted in the U. S. Army. MC MAHON advised that based on his brief encounter with JOHN RAY, coupled with the remark of POLICASTRO that there was something strange about RAY, MC MAHON became fearful for his life and around the Autumn of 1965, in Milwaukee, MC MAHON contacted SA JOHN MORAN of the Milwaukee Division, and told MORAN that he was disturbed because he "thought something might happen to him." MC MAHON acknowledged that he had no concrete basis for his apprehension, and during his contact with the Newark Division, was unable to be more specific on the basis for his apparent fear. MC MAHON, at that time, was undergoing some type of emotional turmoil and the only disturbing incident that he could recall was this brief encounter with JOHN RAY.

After reviewing the current publicity surrounding the House Assassination Committee Hearings in Washington, D. C., and the contemplated appearances before the Committee of JAMES EARL RAY's brothers, JERRY RAY and JOHN RAY, MC MAHON telephonically contacted the West Hunter Street Baptist Church, 1040 Gordon Street N.W., Atlanta, Georgia, number 404-758-5563, where RALPH ABERNETHY, SR., is Pastor. Rev. ABERNETHY was not available but MC MAHON furnished the above information to one of ABERNETHY's associates. In addition, MC MAHON followed up the telephone call which was made a few days ago with a letter.

In addition, today, MC MAHON was in telephonic contact with Ms. EMANUEL, Secretary to G. ROBERT BLAKEY, Chief Committee Counsel, House Assassination Committee, Washington, D. C.

MC MAHON added that he has no definite information that the JOHN RAY who registered at the Sheratin-Mc Alpin is in any way related to JAMES EARL RAY but added that he might have xeroxed or made notes of RAY's registration card and buried

this document in a container on his uncle's property, ALFRED HYDE, Spencertown, New York, who reportedly is a Municipal Judge in the area.

Records of the Belleville, NJPD, revealed no pertinent information re MC MAHON. Newark indices negative regarding MC MAHON.

Newark contemplates no action in this matter, but in view of the House Assassination Committee Hearings, above is being furnished for information of Bureau.

After observing a picture of JOHN RAY on television, he concluded that the individual registered at the Sheraton-McAlpin Hotel, 34th Street and Broadway, Manhattan, New York, was not JOHN RAY, but may have been his brother, JERRY RAY. He further stated that RAY may have been in the company of one GENE HARRISON, address unknown, whom MC MAHON subsequently worked with at the Cozy Corner Restaurant, 76 West Third St., NY, NY.

The above is being submitted for information. Newark Division contemplates no further action.

He advised that someone in his family had contacted him and said that WDIA was carrying a news story from MARK LANE, JAMES EARL RAY's attorney, that JONES was going to testify and free JAMES EARL RAY.

JONES said LANE is not representing him and he has not been contacted by anyone recently in regard to his testimony and he would like to talk to an FBI Agent as soon as possible.

On January 30, 1979, an anonymous woman caller telephonically furnished the following information to Special Agent Udo H. Specht, FBI, Dallas, Texas:

She stated that an individual by the name of C. H. Wilson, residing at Boyd, Texas, in a brick house on the road between Boyd and Azle, Texas, might have been responsible or somehow involved in the assassination of Martin Luther King, Jr. She described Wilson as a white male, 6', 180 pounds, 51 years of age, and a pipe welder by trade. Wilson was involved in Ku Klux Klan activities and lived in Greenville, Mississippi in 1968 and prior to that. Prior to the assassination of King, Wilson allegedly stated that he would kill or was going to kill Martin Luther King. Wilson and another man, whom she would not identify, were in Memphis the day King was assassinated. At that time, Wilson owned a relatively new white Ford Mustang bearing Mississippi license plates. After Wilson returned to Greenville, Mississippi, from Memphis, Tennessee, he hid the white Mustang for approximately one month.

The caller stated that Wilson is an alcoholic and was during that time. He was drinking two and three quarts a day. The caller stated that Wilson is mean and capable of murder, especially if he has been drinking.

The caller would not identify the other man who was in Memphis with Wilson until she found out somehow that someone is investigating what she is saying.

On January 30, 1979, a telephone company information operator advised that a C. H. Wilson is listed as residing in Boyd, Texas, telephone number (817)433-5105.

The Dallas, Texas FBI indices to investigatory records did not reflect any information identifiable with C. H. Wilson.

Stokes Says FBI Actions Fueled King Conspiracy

By LEROY WILLIAMS JR.

The FBI's harassment and surveillance of Dr. Martin Luther King Jr. created a climate which led conspirators to believe they could kill Zoro (code name for King) and get away with it, Rep. Louis Stokes (D-Ohio) said yesterday.

Stokes, who was chairman of the House Assassinations Committee, also said a conspiracy hatched in St. Louis could lead to charges against some unnamed individuals if the Justice Department thinks the committee's evidence supports prosecution.

Stokes, who spoke at a breakfast sponsored by Rep. Harold Ford (D-Memphis) at Number One Beale Street Restaurant, said the FBI's actions in connection with King would be detailed in the committee's final report scheduled for release March 31.

"There were 5,000 recordings made of conversations with his wife, the SCLC (the Southern Christian Leadership Conference which King headed), friends and associates he talked with all over the country. This much electronic involvement was never used on anybody else.

"They got so arrogant . . . they discussed that the Negro people would be lost (without King) and decided to push a New York lawyer to lead the lost people after King was discredited . . . They picked out key people in Congress (to hear the tapes) and went to Cardinal Spellman in New York and tried to get him to

get the Pope to cancel an audience King had with the Pope."

The Central Intelligence Agency and other law enforcement agencies also failed to perform their duties properly, he said.

"We found here in Memphis, Tennessee, that your police department had destroyed the surveillance they conducted on them." But he said there was no evidence the police department was involved in King's death.

In a preliminary report last year the committee concluded convicted assassin James Earl Ray did kill King, but said an alleged \$50,000 offer made by two St. Louis businessmen could have provided the motive. Both of the St. Louis men are dead, but Stokes said there were others involved.

"We are not a prosecutorial body. We are not a grand jury. But we are asking the Justice Department to go over all the evidence and decide whether further measures are warranted."

Stokes said he was satisfied with the committee's work, but could not say if it was worth the \$5.3 million effort.

"I don't know. I don't know what the value is on human life. I don't know what the value is on a Nobel Peace Prize winner, a man that is probably the greatest black man to walk on this earth. This nation owes these men (Kennedy and King) the same kind of dignity in death they gave to this nation."

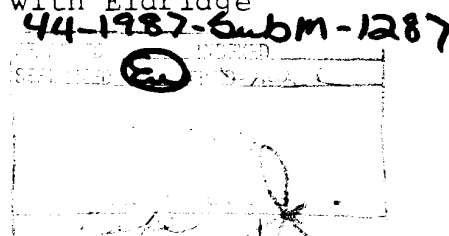

On May 2, 1979, a confidential source, whose reliability has not been verified, furnished the following information:

He is presently serving a life sentence for murder in the California Prison System, and is currently incarcerated at the California Mens Colony (CMC), East Facility, San Luis Obispo, California.

During the past year he developed a friendship with another inmate known to him as Gary Lee Kraut, who also uses the last name of Wilkenson. Kraut is a federal prisoner serving a 50 year term for kidnaping. Kraut was transferred to CMC from the Federal Prison in Marion, Illinois. The source developed a friendship with Kraut because they were both serving extremely long sentences for very serious crimes.

During Christmas, 1978, Kraut stated to the source that he was the individual who was actually guilty for shooting Dr. Martin Luther King in Memphis, Tennessee. Kraut advised that he was married to James Earl Ray's first wife Betty, who currently resides somewhere in Quincy, Illinois. The source does not know Betty's last name, but she is described as a white female, 45 years of age, with reddish hair. Kraut has a son as a result of his marriage to Betty. Kraut advised the source that there was a black male with him, known only as Bobby, who was later killed in a shootout with police in an unknown area. Bobby had some connection with Eldridge Cleaver.

Kraut further advised the source that while he was in Marion Federal Prison, Marion, Illinois, he had made a jewelry box with a false bottom. This jewelry box had been sent to Betty. In the false bottom of the box were the names of a group of individuals who would carry on the work of Kraut since he was in prison. Kraut advised the source that Dr. Martin Luther King's father was next on the list to be assassinated and that it was just a matter of time. Kraut advised the source that Betty (last name unknown) used to own a bar, whereabouts unknown, and a white male that she knew obtained the rifle with which King was shot. Kraut further advised the source that he shot Dr. Martin Luther King with a rifle, but he did not state what caliber the rifle was. Kraut stayed awake for two days in order to have the chance to shoot King.

Kraut advised the source that he had been offered a chance to testify before the House Assassinations Committee on the death of Martin Luther King, but did not concede to testify. Kraut allegedly knows James Earl Ray and James Earl Ray's brother.

The source advised that in the past four or five months he has had no further friendship with Kraut because they had had a disagreement. The source does not believe that he could re-establish a friendship with Kraut.

On May 4, 1979, a review of the California prison record pertaining to Gary Lee Kraut, also known as Wilkenson, Federal Prison Number 31702-138(H), revealed the following information:

Kraut is serving a 50 year sentence after being convicted of the Federal Kidnaping Statute in the District of New Mexico. He pled guilty on April 22, 1975, and was committed to the U. S. Federal Penitentiary at Marion, Illinois, on June 12, 1975. Kraut will be eligible for parole on December 29, 1984, and for mandatory release from his sentence on July 26, 2008.

On April 10, 1978, the State of California in an agreement with the U. S. Bureau of Prisons, Washington, D. C., accepted Kraut as a boarder in the California Prison System where he was delivered to the California State Prison located at Chino, California.

The record indicates that Kraut was transferred to the California Prison System as he had testified in a murder trial at Marion Federal Penitentiary in the case of Bobby Gene Garcia, Federal Prison Number 02002-135. Kraut lied on the witness stand, but still helped federal prosecution in the matter, and Garcia was found guilty on December 24, 1976, of killing victim inmate Ralph Cunningham. Garcia was sentenced in U. S. District Court, Benton, Illinois, on March 23, 1978.

The file contained a Federal Bureau of Investigation identification record pertaining to Kraut, a United States Probation Department Presentence Report dated April 30, 1975, and a California Department of Corrections Cumulative Case Summary Legal Status Report dated May 13, 1978, which are attached to this memorandum, and which give background information pertaining to Kraut.

OFFENSE:

Official Version: Prior to the offense, on June 11, 1974, this defendant, using the name of Kenneth Ray Wilkonson, was arrested in Jacksonville, Florida and subsequently sentenced to 90 days in jail for attempted auto theft. Authorities there allege that the defendant broke into a home after his escape on July 29, 1974, and stole the occupant's automobile. Warrants have been issued by the local sheriff's office.

On November 18, 1974, under the name of Gary Lee Kraut, this defendant was arrested for residential burglary in Edwardsville, Illinois. He posted a cash bond and was released. District Attorney Van Dyke is in possession of a letter from Gary Kraut indicating that he had received 55 years in federal prison in Albuquerque, New Mexico. He requested that charges there be dropped and that his bond be returned.

On December 14, 1974, Macoupin County records reveal that this defendant was identified as committing an armed robbery in Shipaan, Illinois. \$200, two shotguns, a .22 rifle, credit cards identification, a deputy sheriff's commission and badge belonging to Albert Burnett were taken. An unlawful flight to avoid prosecution was issued by the FBI and a detainer has been lodged with the U. S. Marshal's Office.

Using Burnett's identification, an unknown male then rented a 1975 Ford Mustang at Lambert Field near St. Louis, Missouri in the early morning hours on December 15, 1974.

On this same date at 10:30, an individual posing as a deputy sheriff and driving the same 1975 Ford, took 2 rifles and a pistol from a man whose van had become stuck in the mud. This defendant's picture was identified by all three occupants of the truck as the perpetrator.

On December 17, 1974, 55 year old George Salome was working on his ranch, which was 22 miles south and east of Socorro, New Mexico, when he encountered this defendant and a male traveling companion.

OFFENSE: (CONT'D)

As they were having car trouble, Mr. Salome volunteered to take them to the nearest phone. Shortly after that, this defendant pulled a gun on Mr. Salome and forced him to drive south.

During the trip, according to the victim, this defendant fired three shots out of the car window. They made a stop in Carrizozo, New Mexico, where the Salome truck was filled with gas. The trio continued to Alamogordo, New Mexico, where they stopped at another service station for gas.

Mr. Salome indicated that he had to use the rest-room and was followed by the defendant. Kraut stated as he closed the rest-room door, "Don't come out as I will kill you". Five minutes later, Salome found the service station dark, the attendant and his kidnapers gone.

According to the Socorro County District Attorney's Office, they have been unable to get Mr. Salome into their office to sign a complaint. They do not feel that there will be a prosecution.

An examination by the New Mexico State Police of the 1975 Ford rented in Illinois and abandoned in New Mexico revealed numerous fingerprints belonging to Gary Lee Kraut.

On December 17, 1975, 62 year old Archie L. Cape was preparing to close his service station when he noticed a pickup as it pulled into the side of the station. Assuming that the occupants were going to use the rest-room, he continued with his duties just prior to closing.

He was suddenly confronted by a white male who was armed. His wallet was taken, as well as 12 to 15 dollar bills in his shirt pocket. As his assailant held the pistol to his left ear, they moved to the office, where the day receipts were taken.

OFFENSE: (CONT'D)

Using Mr. Cape's 1965 Cadillac, the trio then drove to El Paso, Texas, without incident. Upon their arrival, the third individual rented a room in a local motel, and Mr. Cape was bound and gagged. They removed his watch and left him after turning on the television set so he would have something to look at. When he was able to free himself, he called the local police.

On January 29, 1975, the Cape Cadillac was recovered in El Paso, Texas. Mr. Cape was unable to identify from photographs this defendant as his kidnapper.

Subsequent Activities: Officials believe that subject and a companion purchased a 1963 Corvair in El Paso, Texas, as sales representatives identified a photograph of Kraut, who was using the name of Kenneth Ray Wilkenson.

On December 19, 1974, the red Corvair was located in Gulf Port, Mississippi, where it had been traded for a 1961 GMC Pickup. The pickup was later traded for a 1966 maroon Oldsmobile 98, all under the name of Kenneth Ray Wilkenson.

On December 27, 1974, police allege that this defendant and one other attempted an armed robbery in Fort Lauderdale, Florida. The robbery was unsuccessful and one subject was killed. A maroon Oldsmobile 98 was used by the second armed robber to make good his escape.

On December 29, 1974, sheriff's officers were involved in a shoot out with a wanted individual who was killed. Investigation revealed that the dead man had been accompanied by Kenneth Ray Wilkenson, who was driving a maroon Oldsmobile. The maroon Oldsmobile described in an earlier Fort Lauderdale armed robbery was located by Pasco County Sheriff's Deputies, and ~~this defendant was arrested on December 30, 1974. He admitted to the arresting officer that he had kidnaped both Salome and Cape in New Mexico.~~

Subsequent Activities: (Cont'd)

On January 24, 1975, Gary Lee Kraut was indicted and charged with kidnaping. Mr. Kraut attempted to plea under Rule 20 in Florida. Marshal Sharp of the Tampa office advised that the Judge refused to accept the plea because Kraut attempted to bargain with him concerning his place of confinement and his desire to waive the presentence report. Mr. Kraut then had to be forcibly removed from the court room.

On April 14, 1975, after his return to the District of New Mexico, Mr. Kraut, who now used the name of Kenneth Ray Wilkenson, entered a plea of guilty to the grand jury indictment in the presence of public defender. Prior to this, a psychiatric examination had found him competent. Sentencing was set before the Honorable Howard Bratton for May 2, 1975.

DEFENDANT'S VERSION OF OFFENSE:

Mr. Kraut-Wilkenson reports that after his release from prison on April 23, 1974, he tried very hard to settle down. Work was a problem, but he was finally able to find a job in November of 1974. Because he lost his job two days later, he became embittered and went on a crime spree, which began with several burglaries in Illinois. He indicated that once this got started, he couldn't stop.

In general, he confirms the official version of the two kidnappings, indicating he was on the Salome ranch in an attempt to avoid a road block near Socorro, New Mexico. He states he did not want to harm Mr. Salome, but found it necessary to use his gun after Mr. Salome insisted on taking him to Socorro to use a phone.

He advises that during the trip, he bought gas for the Salome truck and really didn't want to harm him. He reports that he didn't want to hurt Mr. Cape and even turned on the television set so he could watch it after he left him in the motel room.

He makes no statement concerning the balance of his escapade, except to confirm that he traveled in various cars from Texas to Florida.
