FBI Seizes Car Linked To Slaying

Atlanta, Ga. —UPI— The federal bureau of investigation Thursday impounded a 1966 white Mustang for which it had issued a nationwide alert following the assassination of the Rev. Martin Luther King, jr., in Memphis last Thursday.

The car, which had been parked for several days in an Atlanta subdivision, was towed to FBI headquarters here and reporters were barred from the FBI building.

The FBI refused comment on the development except to say that no warrants had been issued in the slaying of Mr. King.

The sniper who killed Mr. King with a single rifle bullet was reported to have escaped in a white Mustang.

Alabama License

The car impounded by the FBI bore Jefferson county (Ala.) license tags. It was reported that the gunman apparently purchased a .30-06 Remington rifle in Birmingham several days before the slaying. Birmingham is in Jefferson county.

The 1968 license tags were issued to a man who lived in a rooming house about four blocks from Birmingham's downtown business section.

Residents of the housing project in Atlanta who had previously joked about the car's similarity with the wanted vehicle were questioned closely by agents from the federal bureau of investigation, the Atlanta Constitution reported.

The Constitution, in a story

by Duane Riner, said two residents of the housing project were known to have seen a young man who they said looked like the description of the sniper.

The news story said the FBI agents swarmed around the car most of Thursday afternoon snapping pictures and taking fingerprints.

Arrived Friday

Quoting Mrs. Ernest Payne, the newspaper said the car was seen arriving in the parking lot between 8:30 and 9 a.m. last Friday, the day after Mr. King was shot down in Memphis, Tenn.

The newspaper said she described the man who stepped out of the car as between 25 and 30 years, 5 feet 9 or 10, and weighing 165 to 170 pounds.

She told the newspaper she had not heard that the suspected killer was described as 26 to 32 years of age, 6 feet tall, weighing 165 to 175 pounds.

Driver Described

She was quoted as saying the man had sandy colored hair. The newspaper said another witness described it as dark and curly.

A youth was quoted as saying there were cigaret ashes all over the car floor and red mud on the interior at the driver's side. The paper said the boy, Johnny Niesen, 13, said there were two 1967 Mexican visa stickers on the window.

It was the stickers that prompted Johnny's mother, Mrs. John H. Riley, to call the

FBI Wednesday night, the news story said.

Mexican Stickers

"The stickers had preyed on her mind since she'd heard on television a couple of nights earlier that a man fitting the description of the suspected assassin had visited the Mexican consulate in Memphis prior to the murder and obtained a visitor's pass," the paper said.

The paper said Mrs. Riley's estimate of the time the car arrived differed from Mrs. Payne's. Mrs. Riley was quoted as first seeing the car at 7 a.m. Friday.

"We discussed it and watched it because we hadn't seen it before," she told the paper. "Most of the cars parked here are people who live here."

Order in Florida

In Miami, Fla., the FBI circulated a pick up order on Florida police teletypes Thursday night for a man driving a white Mustang and who matched the description of the killer, then withdrew the message.

The message was issued at 5:22 p.m. by teletype to the Dade public safety department, Miami communications and all stations statewide.

It instructed officers to locate a white man, born [redacted]

The man was described as being 5 ft. 11 in., 175 pounds, blue eyes and brown hair.

At about 9:35 p.m. the message was withdrawn in a bulletin signed by Special Agent John Hanlon.

When questioned Hanlon said, "I cannot comment."

The teletype message said the man was last seen driving a 1966 white Mustang hardtop with an Alabama license.

Car Like One Sought in King Death Found

From Press Dispatches

Atlanta, Ga. - A white Mustang resembling one reported near the scene of the sniper slaying of Dr. Martin Luther King, jr., was impounded in Atlanta Thursday. The FBI also issued, then withdrew, a "locate and notify the FBI" alert for a Birmingham (Ala.) man who the bulletin said was driving a white Mustang.

Residents of a Birmingham rooming house, to which the white man had been traced, said they had not seen him in three months.

The FBI's message, distributed on, the statewide police

teletype network in Florida at the request of the FBI, was withdrawn five hours after it was issued Thursday afternoon. It was withdrawn with the explanation that it was released by mistake.

The alert was for the purpose of spotting the man rather than for a pickup order.

The bulletin described the man as a white male, 36 years old, about 5 feet 11, and 175 pounds with blue eyes and brown hair. This roughly matched the description circulated by federal authorities on the night of King's slaying.

State records in Montgomery, capital of Alabama, show the man's occupation as "merchant seaman, unemployed." But checks with maritime sources in New Orleans, Mobile, Ala., New York and Washington failed to turn up any seaman papers issued to him.

The alert was issued about the time the 1966 Mustang was being towed into the FBI's Atlanta headquarters.

The car had been parked since last Friday, the day after King's slaying, in the parking lot of a public housing project near the Georgia state capitol. Police were called five days later after "Turista" stickers were noticed on the car's windows.

Mrs. John H. Riley said she saw the car as early as 7 a.m. last Friday, about 12 hours after King was shot 382 miles away.

"We (her family) watched it and discussed it because we

hadn't seen it before," said Mrs. Riley. "Most of the cars parked here are owned by people who live here."

Later that morning, a neighbor dropped in for coffee and the talk turned to the King assassination. Mrs. Riley's visitor said a white Mustang was believed to be the killer's getaway car.

"Why, it's sitting out there in the parking lot," Mrs. Riley said jokingly.

Another resident of the project, Mrs. Ernest Payne, said she saw the 1966 Mustang arrive. But she estimated the time at 90 minutes to two hours later than Mrs. Riley's guess of 7 a.m.

She said "a nice looking man" got out of the car, locked it and walked away, carrying a small black book in his hand. She described him as about 25 or 30 years old, 165 to 170 pounds and around 5 feet 10 with sandy hair. She said the car bore an Alabama license plate.

Other residents also saw the car or the man. Joe Manus said he had noticed the car since last Friday, the day after King was shot. Mrs. Mary Bridges said she saw a well dressed, dark haired man near the vehicle recently.

But no one reported the car to police until Mrs. Riley's son, Johnny, 13, told her he had seen two Mexican "turista" stickers on the windows of the Mustang. Mrs. Riley said she had heard news stories that the suspected assassin had visited Mexico before the killing. Johnny also said the floor of the car was covered with cigaret ashes and red mud.

Mrs. Riley called the FBI and Atlanta police Wednesday night, she said. Police made a brief inspection immediately, and then FBI agents followed Thursday morning, she said.

FBI Trailing Man In Slaying of King

Atlanta, Ga. —UPI— Federal bureau of investigation agents investigating the sniper slaying of the Rev. Martin Luther King, jr., have been on the trail of an unemployed seaman for nearly a week, United Press International learned Friday.

The suspect first surged into the headlines Thursday night when a white Mustang auto, registered to him and resembling one that reportedly sped from the King assassination scene, was found parked in an Atlanta apartment complex.

No warrant has been issued.

The Mustang registered to the man carried Alabama license number 1-38993. A check with Alabama authorities established the man's address as a rooming house at 2608 Highland av. in Birmingham, but residents, while recalling the man, said they had not seen him since November.

In obtaining his driver's license in 1967, the man listed his occupation as an unemployed merchant seaman.

The FBI replied with a blanket "no comment" to all questions concerning the King investigation, but persons at the Birmingham rooming house said agents were asking "plenty" of questions about the man last week.

This was four or five full days before the Mustang was located in Atlanta.

The only official announcements in the King case have come from Atty. Gen. Ramsey Clark, who was sent to Memphis by President Johnson to help with the investigation after Mr. King was killed by a sniper while standing on a hotel balcony last Thursday.

Clark said authorities had a suspect and his name but would not disclose the name. He also said that officials had a man on the run and were confident the case would be solved.

Reporters checking with maritime officials in Mobile learned Friday that agents, in addition to questioning persons at the Birmingham boarding house, had also made a check of the docks long before the Mustang was found.

This raised speculation, which again officials refused to confirm or deny, whether someone, as early as last September, set about to establish credentials under a fictitious name.

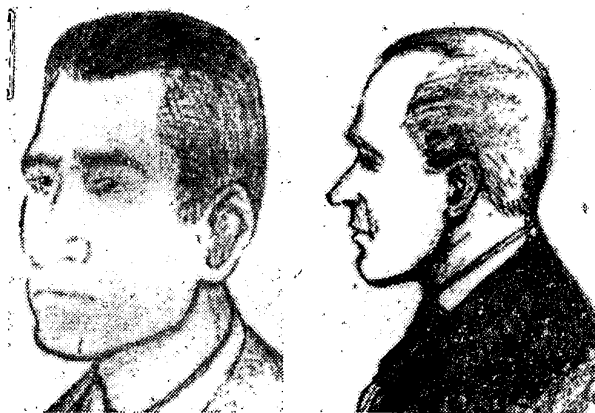

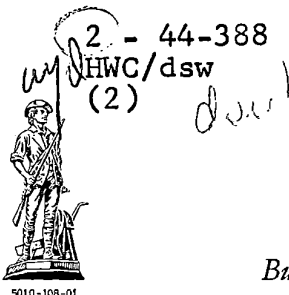

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT ERIC STARVO GALT IS BEING SOUGHT BY THE FBI AS A FUGITIVE ON A FEDERAL CHARGE ARISING FROM THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR., IN MEMPHIS, TENNESSEE, ON APRIL 4, 1968.

DIRECTOR J. EDGAR HOOVER STATED THAT A FEDERAL COMPLAINT WAS FILED BY THE FBI IN BIRMINGHAM, ALABAMA, TODAY CHARGING GALT WITH CONSPIRING TO VIOLATE THE CIVIL RIGHTS OF DR. KING IN VIOLATION OF TITLE 18, SECTION 241, OF THE UNITED STATES CODE.

THE FBI COMPLAINT CHARGES THAT "ON OR ABOUT MARCH 29, 1968, AT BIRMINGHAM, ALABAMA, ...ERIC STARVO GALT AND AN INDIVIDUAL WHOM HE ALLEGED TO BE HIS BROTHER, ENTERED INTO A CONSPIRACY WHICH CONTINUED UNTIL ON OR ABOUT APRIL 5, 1968, TO INJURE, OPPRESS, THREATEN, OR INTIMIDATE MARTIN LUTHER KING, JR.,... IN THE FREE EXERCISE OR ENJOYMENT OF A RIGHT SECURED TO HIM BY THE CONSTITUTION OR LAWS OF THE UNITED STATES; NAMELY, THE RIGHT TO FREELY TRAVEL FROM STATE TO STATE. IN FURTHERANCE OF THIS CONSPIRACY, ERIC STARVO GALT DID, ON OR ABOUT MARCH 30, 1968, PURCHASE A RIFLE AT BIRMINGHAM, ALABAMA..."

ACCORDING TO MR. HOOVER, A 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL AND MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH 30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

PAGE THREE

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAMA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND 4, 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

INTENSIVE INVESTIGATION BY THE FBI HAS DISCLOSED THAT GALT HAS CLAIMED TO HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH CALIFORNIA, FROM DECEMBER, 1967 TO FEBRUARY, 1968.

GALT LEFT LOS ANGELES ON DECEMBER 15, 1967, AND DROVE HIS WHITE MUSTANG TO NEW ORLEANS, WHERE HE CLAIMED HE CONTACTED EITHER AN ENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON DECEMBER 19TH AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2, 1968.

THE FUGITIVE IS DESCRIBED AS WHITE MALE. HE IS APPROXIMATELY 5 FEET 8 INCHES TO 5 FEET 11 INCHES TALL AND WEIGHS BETWEEN 160 AND 175 POUNDS. HE IS SAID TO BE A NEAT DRESSER AND HAS A MEDIUM BUILD.

GALT HAS BROWN HAIR, WHICH HE WEARS IN A "BRUSH" CUT. HE REPORTEDLY HAS BLUE EYES; HIS NOSE IS STRAIGHT AND NARROW; HIS TEETH ARE STRAIGHT AND CLEAN; AND HE HAS GIVEN HIS DATE OF BIRTH AS

THE FUGITIVE IS SAID TO HAVE A NERVOUS HABIT OF OCCASIONALLY PULLING AT AN EAR LOBE WITH HIS HAND. HIS LEFT EAR PROTRUDES FARTHER FROM HIS HEAD THAN HIS RIGHT EAR.

ACCORDING TO MR. HOOVER, PERSONS WHO HAVE MET GALT DESCRIBE HIM AS A "LONER" AND STATE HIS LANGUAGE AND DICTION HAVE A "RURAL" QUALITY AND SUGGEST THAT HE PROBABLY DOES NOT HAVE A HIGH DEGREE OF EDUCATION. HE IS SAID TO DRINK ALCOHOLIC BEVERAGES AND HAS A PREFERENCE FOR VODKA AND BEER. HE IS A FAN OF WESTERN AND COUNTRY MUSIC.

GALT SHOULD BE CONSIDERED ARMED AND DANGEROUS. ANY INFORMATION CONCERNING HIM SHOULD BE FURNISHED IMMEDIATELY TO THE NEAREST FBI OFFICE.

Mrs. DAVID CALVERT, Rural Route # 3, County truck V, Sheboygan, Wisconsin, phone number 452-1612, called the office and reported that two days ago she had been driving through Sheboygan, Wis., on Memorial drive (highway 141), and observed a new model car, possibly 1968 or 1967 Chevrolet, Light gray over dark Gray, with Tennessee license, DR-0824 Montgomery county, following her.

She further advised that the individual who was driving the car, appeared to be in his late 30's, was not clean shaven and was wearing a dark shirt or sweater. There was a sport coat hanging on the clothes hook in the back of the car. CALVERT advised that she had heard the news broadcasts concerning the captioned matter and reported the above incident to the local police. She advised that the police appeared not to be interested in the matter.

CALVERT advised that this morning she saw the photograph of the subject GALT in the morning paper, and believed that the man she mentioned above bears a strong resemblance to the subject.

Fake Calls Alleged After King Slaying

Memphis, Tenn. —UPI— The Memphis Commercial Appeal said in a copyrighted story Wednesday that conspirators may have faked a series of police radio calls to throw authorities off the trail after the assassination of the Rev. Martin Luther King, jr.

The story said that police radio reports of a car chase involving a white Mustang apparently were faked.

"Could someone have used a transmitter tuned to the police frequency to put out misleading information — information which would take the focus of the search north from the city and open up escape routes . . . into Arkansas or south into Mississippi?" said a page one story by George Bryan.

Fire and Police Director Frank C. Holloman confirmed that such a possibility is under investigation, the story said.

The newspaper said seven transmissions crackled over police radios about the chase between 6:30 p.m. and 6:47 p.m. last Thursday, about half an hour after the slaying. The messages told of a speeding Mustang and a blue Pontiac that was chasing it.

Two white Mustang automobiles, one with Arkansas license plates, were parked near the hotel where Mr. King was slain, the Commercial Appeal reported Wednesday night.

The assassin is believed to

have fled in a white Mustang, but only one such automobile was known to have been seen near the hotel.

Charles Hurley, an advertising executive, was quoted as saying he saw a young white man who "roughly" matched the description of the suspect sitting in the car at 5:20 p.m., about 40 minutes before Mr. King was shot by a sniper as he stood on the balcony of his hotel room.

Clifton Canipe, owner of Canipe Amusement Co., said he saw a man drive away in a white automobile which had been parked about 20 feet south of his store at 425 S. Main st.

Questioned Man Gets Joplin Term

Joplin, Mo. —AP— A man who identified himself as an itinerant preacher entered a plea of guilty to a vagrancy charge in magistrate court Wednesday and received a three day jail sentence with the further stipulation that he would be released to his father for return to Texas.

The man had been questioned briefly Tuesday night as to his whereabouts on the day the Rev. Martin Luther King, jr., was assassinated.

The man identified himself as Lynn R. Cleveland, 33. He was picked up at the edge of Joplin and said he was hitchhiking a ride from Springfield, Mo., to Tulsa, Okla.

Sole Killer

Theory Re-examined in King Death

Memphis, Tenn. —AP— Investigators appeared Saturday to be re-examining the possibility that more than one person was involved in the assassination of the Rev. Martin Luther King, jr.

They seemed puzzled about conflicting reports on the number of getaway cars involved and about police radio transmissions detailing a high speed chase — which apparently never took place — through northeast Memphis 30 minutes after a sniper killed King with a single rifle shot.

The FBI, conducting the most massive manhunt in its history, maintained silence on all aspects of the investigation. But Atty. Gen. Ramsey Clark issued a new statement that dropped his earlier reference to "one man on the run."

Sixteen hours after King was slain Apr. 4, Clark said evidence "indicates a single individual" was involved. "There is no evidence of a widespread plot," he said.

Prediction Avoided

In a seven line statement issued in Washington Friday night, Clark said the FBI was devoting all its resources to the investigation, "working around the clock pursuing every lead."

He said it was impossible to predict when an arrest would be made.

Another justice department spokesman noted that it took 12 days to make arrests in the May, 1963, slaying of civil rights leader Medger Evers, and more than five months in the 1964 slayings of three civil rights workers in Mississippi.

In the 10 days since King's slaying, the lights have burned all night in the corner suite on the eighth floor of Memphis' new federal building.

There, in offices overlooking the Mississippi river, dozens of FBI agents have methodically sifted through what

is described as "very substantial" physical evidence.

Exactly what constitutes this evidence is officially unknown, but sources report some of the major items are palm and fingerprints, an overnight bag believed to contain clothing and a high powered rifle with a telescopic sight.

FBI There First

FBI agents have interviewed hundreds of persons in Memphis, Birmingham, Atlanta and elsewhere. They have taken over the records of two rooming houses and at least one gun shop. They have pored through documents in state and local government offices throughout the south.

It seems that everywhere reporters go, the FBI already has been there. In many cases, witnesses report the FBI has instructed them to say nothing.

Across the street from the FBI office, spokesmen for the Memphis police insist that the department still is working closely with federal agents. But from all indication, the FBI has taken over the investigation completely.

At police headquarters, Fire and Police Director Frank C. Holloman, for 25 years an FBI agent, hands inquiring reporters a mimeographed statement.

"The successful investigation of this case is the overriding consideration and for that reason I have no comment to make concerning the case at this time," it says.

Both Cars Vanished

Holloman held five news conferences within 24 hours

after King was shot, and freely answered most inquiries from reporters. Since then, he

has joined the FBI's stony silence.

This is an account of the events that took place after King was shot at 6:01 p.m. Apr. 4 as he stood on a balcony of the Lorraine motel.

The killer hurried from the flophouse 205 feet away. Within 100 feet from the rooming house entrance at 6:01 were two 1966 white Mustangs.

Fifteen minutes later, both were gone.

Some witnesses said the killer walked calmly down the steps to the street, turned left

and dropped a rifle in the next doorway, and continued several feet to the Mustang bearing a red and white license plate. Red and white plates are used in both Arkansas and Alabama.

At 6:25 p.m., a police dispatcher began relaying calls about a chase in northeast Memphis, eight miles away, which involved a white Mustang and a blue Pontiac.

A white male driving the Mustang, the police radio crackled, was "responsible for this shooting."

Eight Calls Relayed

Eight calls, supposedly from a police lieutenant, were relayed by the dispatcher during the next 22 minutes. At one point, the dispatcher reported, the driver of the Mustang was firing on the pursuing Pontiac.

"I was not involved in any chase," the lieutenant said afterward.

A college student with a citizens band radio in his car later said he was relaying details of the chase to the lieutenant. He said the voice he was monitoring identified himself as the occupant of the blue car chasing the Mustang.

The student said the trans-

missions he received never faded, indicating the calls came from a stationary transmitter. By week's end, police appeared to have concluded that the chase, for whatever reason it was reported, was a hoax.

Twelve hours after the shooting, an Atlanta housewife looked out the window of her apartment in the Capitol Homes project — 383 miles to the southeast — and saw a "nice looking man" step out of a 1966 white Mustang.

Six days later, federal agents examined the abandoned Mustang.

Alabama License

The car bore a license tag from Jefferson county (Birmingham), Ala. Two Mexican inspection stickers were pasted to the front windshield. The floor was littered with cigaret butts and covered with mud.

Between 5:15 and 5:30 p.m., the car was towed to the federal building.

At 5:22 p.m., the Florida police teletypewriter ticked out a "locate and notify" message — an FBI alert for a 36 year old suspect.

The bulletin said he was

driving a 1966 white Mustang with an Alabama license plate bearing the same numbers as the car found in Atlanta.

Four hours later, the message was withdrawn with the explanation that it was "erroneous."

Records in Alabama show that the suspect applied for a driver's license last Sept. 5. The application describes him as 5 foot 11 inches, 175 pounds, with blue eyes and brown hair — roughly the same description given by witnesses for the man seen fleeing the Memphis rooming house.

Applied for License

The document says he is an unemployed merchant seaman. The maritime union has no record of him.

His address was listed as a two story stucco house in Birmingham with a neon light that flashes "rooms."

Other residents of the house say they have not seen him in three months, although a duplicate drivers' license was mailed to him at that address Mar. 1.

The FBI refuses to say why it is seeking him.

FBI Won't Release Sketch of Assassin

Memphis, Tenn. —AP— The federal bureau of investigation is withholding nationwide distribution of a composite drawing of the Rev. Martin Luther King's assassin, police sources said Sunday.

"They haven't given us anything but a physical description," said one police official. "They aren't handing out pictures of the man. They either don't have a good one, or they're going it alone."

The official asked that his name not be used, citing the FBI's ban on comment about the investigation.

When Jacksonville (Fla.) police questioned a Louisville, (Ky.) man Saturday night about the King slaying — the man since has been cleared of any connection — Police Lt. M. P. Richardson said, "It's a long shot, but he looks too much like the sketch of the man who is wanted in the King slaying."

Jacksonville police said Sunday the man who was arrested after a resident noted a likeness to a composite picture which appeared in Florida newspapers. This sketch was prepared by a newspaper artist from the description given of the slaying. It was not released — nor endorsed — by the FBI.

Residents of the Memphis rooming house from which King was shot Apr. 4 reported last week that investigators had shown them composite drawings. But they said the

sketches were the same — or at least very similar — as those prepared by newspaper artists.

FBI officials rejected reporters' requests for a composite drawing of the man they are seeking in what perhaps is the most massive manhunt of modern times. They refuse to say whether they have prepared such a sketch.

Agents have a good physical description of the King assassin: 30 to 32 years old, 5 feet, 10 inches tall, weighing 165 pounds, with a receding hairline and a long, thin nose.

They also have a good description of the white 1966 Mustang which witnesses said sped away from the Memphis rooming house minutes after King was shot as he stood on a motel balcony 205 feet from the rear of the rooming house.

A white Mustang was impounded Thursday night from an Atlanta parking lot where it had been parked since the morning after King's slaying.

The impounded car bore license tags issued in Birmingham, Ala.

At almost the same moment last week that they were impounding the car in Atlanta, the FBI sent over the Florida Teletypewriter circuit a request to locate the listed owner. The message was withdrawn four hours later with the explanation it was erroneous.

Suspect In Killing Of Dr. King Got Chicago Mail

BIRMINGHAM, Ala. (UPI)—Eric Starvo Galt, object of the FBI's most intensive man-hunt, received a letter from Chicago a few weeks before the slaying of Dr. Martin Luther King Jr., his landlord said Monday.

In a copyrighted interview in the Birmingham News, rooming house manager Peter Nicholas Cherpes, said the sketch of the man wanted in Dr. King's slaying "looked exactly like" Galt.

He said Galt stayed at his rooming house from Aug. 26 to Oct. 7 last year.

He said that during September, Galt received a prepaid package in the mail from Chicago. He said it weighed 20 to 25 pounds, was about two feet long and one foot wide. The next day, Cherpes said, Galt told him it was the wrong merchandise and he planned to send it back.

"About half an hour later I saw him carrying the box to his car," Cherpes said.

In October, Cherpes said, Galt told him he was leaving for Mobile, Ala., to seek a job. Galt said he expected a letter from Chicago and asked Cherpes to hold it for him.

In February or March, Cherpes said, the letter came. He said the envelope was tan and green, with a Chicago post mark.

"I was puzzled for a while where to mail it," Cherpes

said. "I didn't have an address (for Galt). So I held the letter for a week, and returned it."

Cherpes said it appeared to him the letter contained a check.

When he received the letter, Cherpes said, he went to his file to look for Galt's registration card and found it. But when FBI agents came to him last week, Cherpes said, it was missing.

Cherpes earlier denied knowing Galt. He said this was because the FBI has asked him not to say anything about the man. But he said the FBI had no authority to stop him. His rooming house was bolted and he refused to admit anyone Monday afternoon.

Paid On Time

He said Galt was a natty dresser who always paid his \$27 a week room and board in cash, on time.

"When he was here, on the third or fourth day, he asked me if I would drive his car downtown for him to take a driver's test," Cherpes said.

"He was a new man to Alabama and to Birmingham and also a customer," Cherpes continued, "and I wanted to help him on that basis. If he had asked for my recommendation, I would have investigated more closely."

Cherpes said that when Galt

arrived at the rooming house, he told him his last job was in the shipyards at Pascagoula, Miss. However, Ingalls Shipbuilding Co. at Pascagoula said it had never hired a man by that name.

Talks of Vacation

Galt told Cherpes he was taking a "long vacation" and expected to stay at the rooming house three or four months. But he only stayed six weeks, Cherpes said.

The interview with Cherpes came amid growing reports that Galt—as such—may never have existed. Authorities were looking into the possibility that someone may have carefully constructed the identity of Galt for a brief period in Birmingham.

He gave his occupation, when applying for the driver's license in September, as merchant seaman. But none of the merchant seamen's unions have even heard of him.

Authorities apparently have been unable to trace him earlier than his appearance at Cherpes' rooming house, and

his trail grows cold in Atlanta where his car was abandoned April 5, the day after Dr. King was slain in Memphis.

There is no warrant for him.

It had been speculated that his middle name, as given in an FBI "locate and notify bulletin," was misspelled. It was given there as Starvo, but Stavro is a common European name.

The FBI refuses to comment on the investigation—even to confirm that it is searching the nation for Galt.

Dead Ends Snag Search for King's Killer

Birmingham, Ala. —AP— The FBI Tuesday apparently was confronted with nothing but dead end clues in its investigation of the slaying of the Rev. Martin Luther King, jr.

False leads multiplied in the hunt for a mysterious man whose last known address was a Birmingham rooming house. His former landlord said Monday he had identified drawings shown by FBI agents as resembling his former roomer.

"It's him," said Peter Cherpes, 72, who runs the Birmingham boarding house where the man lived for six weeks last fall.

An abandoned white Mustang owned by the roomer

was impounded last Thursday by the FBI in Atlanta. It fit the description of a car seen leaving the scene after King was killed Apr. 4 by a sniper firing from a rooming house in Memphis.

Memphis witnesses described the suspected assassin, who registered as John Willard at a rooming house opposite King's motel, as about 6 feet, sandy haired and "a clean, neat man."

Talked of Ship Work

Apparently, no trace of the man has been found.

The man had told Cherpes that he was employed at a Mississippi shipyard, but there was no record of him. He claimed he held a Louisiana

driver's license six years ago, but no record was found in the files.

The man had a room at the boarding house from Aug. 26 to Oct. 7, 1967, Cherpes said. The rent was \$22.50 a week. He registered as coming from Pascagoula, Miss.

"He was here on vacation and he said he was going to stay here about four months," the landlord said. The new boarder usually slept until about 11 a.m., had most of his meals at the rooming house and stayed to himself most of the time.

The second week after he arrived, he bought a car, the 1966 white Mustang, paying cash. He needed a driver's license.

"He asked me if I could drive him down to take the test," Cherpes said. "I did."

On the license application, he listed his occupation as "merchant seaman, unemployed." Maritime unions have no record of his name, nor was he drawing unemployment pay from the state.

Box From Chicago

About a week later, the landlord recalled, he got a package in the mail from Chicago: A box about two feet long, a foot wide and weighing 20 to 25 pounds. But he complained that it was the "wrong merchandise" and he was going to return it.

He left saying he had found ship work in Mobile, Ala., but left no forwarding address.

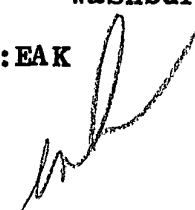
