No. DI 2-6032, no extensions, and the phone is located to the left of the main door of the apartment which is at the rear of the building. There are two does to the apartment, one which enters into the kitchen. living room is a bedroom and entrance to the bedroom is off a halway near the bath which can be entered via the dining room, The dining room is located immediately behind the kitchen and the bathroom and entrance to the hall leading to the bathroom immediately behind the dining room. There are two windows in the dining room, one in the bath, two in bedroom and three in the living room. A court surrounds the apartment and the windows are only approximately  $2\frac{1}{2}$  feet from the ground.

CALT was arrested 8/3/66 as a Selective Service violator. His father is RALPH MARTIN GALT and his mother is LOUISA MAY GALT. He attended high school at Stillwater, Minn. and Williston, N. D. He was at the Univ. of Minn. 1963-66. Newspaper clippings giving further background information on GALT are attached to copy of instant memo filed in 25-0.
