Ban on Comment

Assassin's Sketch Withheld by FBI

MEMPHIS, Tenn. — (AP)

— The FBI is withholding nationwide distribution of a composite drawing of Dr. Martin Luther King Jr.'s assassin, police sources said

"They haven't given us anything but a physical description," said one police official. "They aren't handing out pictures of the man. They either don't have a good one, or they're going it alone."

The official asked that his name not be used, citing the FBI's ban on comment about the investigation.


When Jacksonville, Fla., police questioned a Louisville, Kr., man Saturday night about the King slaying — the man since has been cleared of any connection — Police Lt. M. P. Richardson said, "It's a long shot, but he looks too much like the sketch of the man who is wanted in the King slaying."

Jacksonville police said
Sunday the man was arrested
after a resident noted a likeness to a composite picture
which appeared in Florida
newspapers. This sketch was
prepared by a newspaper
artist from the description
given of the slayer. It was
not released — nor endorsed
— by the FBI.

FBI officials rejected reporters' requests for a composite drawing of the man they are seeking. They refuse to say whether they have prepared such a sketch.

NEW EVIDENCE

FBI Finds Clues In King Murder

MEMPHIS, Tenn. — (AP) — FBI agents have uncovered "very substantial" physical evidence as they work "around the clock pursuing every lead" in the search for Dr. Martin Luther King Jr.'s assassin, says Attorney General Ramsey Clark.

"The FBI is devoting every possible resource to this investigation," Clark said. "... While it remains impossible to predict when the killer will be arrested, I remain hopeful that it will be soon."

A Justice Department spokesman said the statement issued in Washington last night, Clark's first public pronouncement on the case in five days, was in response to newsmen's queries.

But Clark, like FBI officials, refused to answer newsmen's questions. "All I can say is no comment," said Robert Jensen, special agent in charge of the Memphis FBI office.

In New York, the Daily News reported today it had learned that the FBI had definitely established that the white Mustang sports car abandoned in Atlanta was the same car seen driving away from the murder scene after the assassination.

The Daily News said witnesses in Memphis gave investigators the license humber of the car. It quoted unnamed sources as saying the plate numbers matched those of the car found in Atlanta. The FBI in Memphis said it had no comment on the News report.

The search for the assassin has spread hundreds of miles from Memphis, sources report, and involves thousands of investigators.

The scope of the investigation was evident yesterday in both Memphis and Birmingham. Newsmen seeking to question persons who might have information about the case were told repeatedly: "The FBI has already been here."

At the Memphis rooming house from which the fatal shot was fired, Charles Q. Stevens said FBI agents had shown him two composite drawings of the suspected slayer — one a partial profile and the other a full-face view.

Stevens said he could identify the partial view, but not the full-face view. He said he saw the guman flee atter hearing a shot fired from a


communal bathroom next door to his room. The bathroom window affords a clear view of the motel balcony where King was standing when shot.

And at a rooming house in Birmingham, residents said FBF agents had questioned then about Eric Starvo Galt, a white man named in an FBI bulletin issued, then withdrawn, in Florida, Thursday night.

The message sent over the state police telestypewriter network in Florida asked help in locating Galt. It said Galt was driving a white Mustang.

Federal authorities in Atlanta impounded Thursday night a white Mustang which had been abandoned in a parking lot near the Georgia State Capitol. Residents of the neighborhood said the car had been there since the day after King was shot.

THE STRANGER AT KING'S FUNERAL

ATLANTA, Ga. — (AP) — A white man who was an usher at the funeral of Dr. Martin Luther King Jr. was not authorized by the arrangements committee despite security precautions for Vice President Hubert H. Humphrey.

It was learned yesterday that the usher was an encyclopedia salesman named Floyd "Buddy" Ayers of Stone Mountain, Ga.

The King family thought he was with the Secret Service, the minister in charge of arangements thought he was a governor's aide and the Secret Service apparently thought he had clearance.

Ayers, who had seated former Vice Prsident Richard M. Nixon, also led Sen. Robert F. Kennedy (D-N.Y.), to a pew.

An Associated Press newsman overheard him say to the senator, "come right this way, Robert. We have security here."

The reporter first met Ayers when the salesman attended a murder trial with the defense counsel, James Venable, who heads the National Knights of the Ku Klux Klan Inc.

Ayers, who sat down after busily seating many dignitaries, gave up his seat to basketball player Wilt Chamberlain later and stood near the casket of King.

Federal sources confirmed the reporter's identification of Ayers. It was learned that the FBI had studied Ayers and concluded he was seeking the limelight. The FBI declined comment, but a spokesman said the bureau had nothing to do with security arrangements at the funeral.

A. B. Wentz, Secret Service chief in Atlanta, declined comment.

"on the run." He indicated that the name the man had used to register at a hophouse from which King was shot, John Willard, was not believed to be his right name.

Atlanta residents who spotted the Mustang before the FBI hauled it in noticed a Mexican "Turista" sticker on the windshield. It had been reported in Memphis that a man answering the description of the King suspect had sought a tourist card at the Mexican Consulate there.

More and more, the hunt appeared to concentrate on the Birmingham man, although the FBI notice pointed out no warrant had been issued for Galt.

Little was known about Galt. Several persons in the Highland Avenue neighborhood said they were acquainted with him, but had

not seen him for about three months.

The manager of a sporting goods firm near the Birmingham airport said the FBI had seized his sales records after questioning him about purchasers of Remington rifles.

The apparent murder weapon which killed King with a single shot, was a .30-06 caliber Remington pump

rifle abandoned near the slaying scene.

Other Birmingham arms dealers said Federal agents wanted to know if a man had

quest oned them recently about various types of rifles, and their capabilities.

First reports said the slayer of King aced away in a

White Mustang with Arkansas plates. Arkansas, just across the Mississippi River from Memphis, has red and white tags — like Alabama.

As the investigation of King's marder entered its second week, the mystery seemed to deepen. Federal agents were known to be checking sales records of gunshops in Birmingham, and several dealers told reporters that investigators had ordered them not to talk to the press.

There was one news report that agents had taken the records of Aero Marine, a boat and sporting goods dealer near the terminal of Birmingham Municipal Airport.

Don Wood, who said he is the store owner's son, said agents had been at the store to go through its records, but he refused to elaborate.

"Thousands of rumors are going around town," he said.

One of the few details of the investigation that has leaked out is that investigators suspect that the .30-06 caliber rifle abandoned near the Memphis murder scene was bought in Birmingham.

King was fatally wounded

April 4 as he stood on the balcony outside his Memphis motel. The shot that killed him came from a rooming house bathroom across the street.

* * *

THE MURDERER is believed to have checked into the house and rented an \$8.50-per-week room using the name John Willard. Persons at the murder scene reported that soon after the fatal shot was fired a man sped off in a white Mustang.

A few minutes later, there were reports on the Memphis police radio frequency of a high-speed chase involving a white Mustang. Later, it was learned that a motorist with a citizen's band radio overheard the reports. He said he knew they were false reports because the signals of the transmitting car never wavered, indicating it was not moving.

Investigators were asked if this meant someone was setting up a decoy, but they replied, "No comment."

U.S. Attorney General Ramsey Clark said in New York Thursday night that he remains optimistic that King's murderer will be found.

"We will report on some developments that should be made public soon," he said. "When there are facts, a report will be made."

KING SLAYING CLUES?

Assassin Hunt On, Off Here

The FBI issued a pickup order in Florida for a man wanted for questioning in the Martin Luther King murder at about the same time the man's car was located in Atlanta, it developed today.

The pickup order was on the Florida police network for four hours last night before it was withdrawn by the FBI with the explanation that it had been issued "by mistake."

The Miami FBI, which issued the order, refused any further comment as did Attorney General Ramsey Clark's office in Washington.

The pickup notice added further mystery to the FBI's intensive but secrecywrapped hunt for the assassin who shot the civil rights

leader to death in Memphis a week ago.

But the public now has a name linked with King's

assassination and the FBI has an automobile with which to broaden its investigation.

The name is Eric Starvo Galt, a white man born July 20, 1931, described as 5-feet-11, 175 pounds, blue eyes and brown hair. His last known address was 2608 Highland Ave., Birmingham, Ala., once a fashionable address in that city. But a Birmingham newspaper reporter who went there found a decaying rooming house and got no answer to his knock on the door.

Galt, it was learned, is a merchant seaman by profession. He has no police record in Birmingham and apparently is little known there.

The FBI notice said that Galt was driving a 1966 white Mustang hardtop, license tag 1-38993, Alabama 1968, The "1" in the number

denotes Jefferson County, or Birminghim.


With the FBI notice freshly in circulation, word came from Atlanta that a Mustang with the Alabama tag described had been impounded there by the FBI.

The car had been parked since last Friday, the day after the assassination, at Capitol Homes, a housing project near the Georgia capitol in Atlanta. Atlanta is about 400 miles driving distance from Memphis.

The FBI announced shortly after the slaying that the hunt for King's assassin lad stretched "several hundred miles" from Memphis.

Assassin_ Hunt Adds A Mystery

Eric Starvo Galt? There may be no such person. It may be only the fake name of a fugitive.

Friday, while the Federal Bureau of Investigation in half a dozen cities was saying "no comment," reporters were scurrying about the South, doing their own detective work.

They were trying to find out what connection, if any, a man using that name may have had with the murder of Dr. Martin Luther King — and whether there is such a man. The name caused a flurry of excitement Thurday when the FBI asked Florida police to look for Galt and his white Mustang — a car similar to one used by a man who is a suspect in the murder of King.

The police bulletin said no arrest warrent had been issued.

The lookout alarm was withdrawn after a white Mustang was found parked in Atlanta. It bore the Alabama license plante number 1-38993, the same license number mentioned in the Florida police message.

As facts gradually fell into place, it became increasingly likely that there is no Eric Starvo Galt; that the name is an alias.

The car registration, issued Oct. 2, 1967, carried an ad-Galt, and carried an address: dress: 2608 Highland Ave., a Birmingham, Ala., rooming house. Residents there said the BBI had been questioning them about Galt for four or five days, and one of them said he last saw Galt here about three months agd. He could not say how long Galt had lived there.

Peter Cherpes, owner of the Economy Grill and

Rooms, refused to talk about Galt. He said he had turned his records over to the FBS

In Montgomery, Ala., state records show that a man named Galt applied in September 1967 for a driver's license. The applicant listed his occupation as "merchant seaman, unemployed."

Maritime sources were checked in Louisiana, Alabama, New York and Washington but reported there are no records of seaman's papers being issued to an Eric Starvo Galt. Federal agents also made these checks.

Whether or not the name is fake, it was used more than once. Other Alabama records show that a man named Galt bought a 1966 Mustang last August from William D. Paisley of Birmingham. Paisley would not talk about it.


ALABAMA records also show that Galt requested a duplicate driver's license which was mailed to him last month at the Highland Ave. rooming house It was not learned whether he ever got it.

FBI men were asked why the lookout alarm for Galt himself was not continued after the car was found in Atlanta. To this, as to all other questions, they answered, "No comment."

Sources in Tennessee, Alabama and Georgia said they had seen no further word on the man on police communication wires.

In Birmingham, reporters began the tedious job of checking birth records, in hopes of finding the name of Eric Starvo Galt. The Florida police bulletin Thursday gave Galt's date of birth as July 20, 1931. The source of the birth date was not given, but it could have come from the Alabama driver's license application.

Willie said he saw the man hurrying down the hall, a long, paper-wrapped object and a blue bag in his hand, and one arm thrown up by his face.

"That sounded like a shot," Willie observed.

"Yes, it was," confirmed the killer, without looking around or stopping.

He next appeared in front of Guy Canipe's amusement company — "Records 25 Cents."

He ducked into the recessed doorway of Canipe's place and what Canipe did thereafter depended upon when you talked to him. The day after the killing, Canipe said he saw the man drop a rifle and a blue bag — "like a typewriter case" — in the doorway.

"I didn't go out. If you had seen a man drop a rifle in your doorway, what would you have done?" Canipe asked — then he got busy in the back of his store.

But a week after the shooting, Canipe sat with his brown hat on behind a desk and, carefully spitting into a wastebasket, told how he had gone to the front of the store to see the man race off in a white Mustang. Canipe said he was reluctant to say so much because he was afraid he might get shot himself.

THERE WERE two white Mustangs parked on the 400 block of South Main on the evening of April 4. One roared away seconds after King died and the other, said the boys in Jim's Grill, got away 14 minutes later.

Police Director Holloman had about 40 policemen in the area around the Lorraine because he was worried about King staying in a rough neighborhood. Last time King was in Memphis he hag stayed at the fashionable Holiday Inn Rivermont.

Police flooded the area in seconds, and within minutes all Memphis was in confusion.

Half an hour after the shooting, from a point 10 miles across the city, a police car began relaying reports of a hot pursuit. Actually, the police car was parked next to the car of a college student, who had a citizens band radio in his car. Over this radio, he was picking up reports from what identified itself as a blue Pontiac, also with CB equipment. The broadcaster in the blue Pontiac said he was chasing a white Mustang. He kept pouring on the details, and the police car radioed them to headquarters. Speeds were rising, 75 miles an hour, now 100 miles an hour.

Three police cars were dispatched to take up the chase, running north of Memphis. The blue Pontiac reported the white Mustarg,

with three white men in it, had opened fire.

Rådio Signal Wasn't Fading

BUT THEN the youth receiving the calls noticed that the signal strength meter on his receiver was not fading: it was not even fluctuating. The blue Pontiac was not going 100 miles an hour; it wasn't even moving.

Was this, perhaps, an effort to draw police off to the north, opening escape routes to the south?

It is a leisurely eight-to-10-hour drive from Memphis to Atlanta.

Sometime between 7 and 9 a.m. the next day a man roughly fitting the description of Galt was seen parking a white Mustang in Atlanta. When residents finally got concerned about the abandoned car on Thursday, six lays later, and reported the incident, the car turned out to be Galt's.

The Mexican consul got worned about a man to whom he had provided a tourist visa. The investigation roared into Mexico. But it turned out the man with the visa was merely a Memphis State University student, innocent.


A hitchhiker got nervous watching television accounts of King's death in Joplin, Mo. He was hauled in and questioned, but he cleared himself.

Reports flow in to Memphis and Washington from every FBI bureau in the nation. The search for Galt has gone from Mississippi to Alabama to Georgia to Florida.

The bullet was recovered from King's body, but the indications are that it was too severely broken up for ballistics tests. A fingerprint, or a paln brint, or both were found — either in the bathroom or on the rifle, But indications are that authorities don't expect much from

THE 400 block of South Main St. in Mempins is not an appealing avenue. On the east side there is a big cafe; fixtures store with coffee machines and hot dog cookers in its windows; Jim's Grill, a rundown but clean cafe with a jukebox belting out blues, and white and Negro help and white and Negro patrons. Next to this are two flights of stairs leading up to Mrs. Brewer's flophouse. One is an entrance and the other is an exit.

Behind the two buildings that comprise the flophouse — a guest goes from one to the other through a battered passageway — there is a vacant lot. It is overgrown with vines and mimosa trees and a high fence separates it from the machinery sales parking lot.

It is a drop of about nine feet from the back lot to the sidewalk of Mulberry St., and the dirt embankment is held up by a cement wall. Across the street there is the Lorraine Hotel — an old hotel with a modern wing on the rear.

AT 3:15 p.m. on April 4, a dark-haired man with a sharp nose and a neat, dark suit walked up the yellow-walled entrance stairs to Bessie Brewer's place. He asked for a room. Bessie showed him No. 8, on her side of the building, which had a kitchenette. It cost \$10 a week. But he said:

"I only want a skeeping room."

So she took him through

the broken mortar into the other building, where Rooms 4, 5 and 6 are located. She showed him Room 5 and he said "this will be fixe."

He paid his \$8.50 rent with a \$20 bill and two quarters and signed "John Willard" on the register. Mrs. Brewer remembered his smile.

"He had a silly smile," she said.

She didn't remark upon his dress — the sort of elegance not usually found in her establishment — nor upon the fact that he carried nothing with him.

He Went Out For Binoculars

SOMETIME during the next couple of hours he went out again. He went about six blocks away, to York's Arms, and bought a pair of binoculars.

The rest of his gear consisted of a Remington .30-06 pump action rifle with a telescopic sight, wrapped in brown paper. A hunter's gun, not an assassin's.

There were reports that he had a pite to eat in Jim's Grill.

He sat in his room for a while. He left a depression on the mattress. Then he went into the bathroom and locked it. He was in there for half an hour. Willie Anchutz, who lived in No. 6, wanted in. He knocked on the door. He got no answer.

The window is jammed open. It hasn't been closed all winter, another hardship on Mrs. Brewer's guests. In order to get the rifle trained on Room 306, the assassin probably stood in the bathtub, or on it, while Willie was hammering impatiently on the door.

After Willie went away, King emerged on the balcony across the street. He came in and out of his room three times. The third time he fied.

The shot shook Mrs. B ewer's boarding house like a clap of thunder. Willie Anchutz ran to his door.

King's Death: A Hodgepodge of Mysteries

On April 4, Dr. Martin Luther King Jr. was slain by a sniper, throwing the nation into mourning and violence. The mourning and the violence are subsiding, but the massive manhunt for the killer continues, from a Memphis flophouse to a Birmingham boarding house, from Mexico to Atlanta, in an air of unprecedented secrecy. Here's an in-depth report on the search.

MEITPHIS, Tenn. — UPI) — In the dingy flophouse the bathroom window is still jammed open, and across the street the wreaths are wilting on the balcony of the Lorraine Hotel.

In the gutter, spoiled Polaroid pictures flutter and tourists trample over a placard which says "I Am a Man." They can see it all, the place where Dr. Martin Luther King Jr. died.

The tears have dried and

the eulogies echoed away, the violence is subsiding and the flowers are dying, but the man who killed King still is free.

Within hours after King fell dying, the FBI launched a massive manhunt for a shadowy sailor named Eric Starvo Galt. It searched for Galt in utter secrecy, and those few police departments asked to look out for him were asked only, to locate him — not to arrest him. No

warrant was issued for him.

Officially the FBI will not even concede that it wants a man named Eric Starvo Galt. The name became known only after the FBI issued — an later hastily withdrew — a "locate and notify" order for him.

No such bulletin was issued in Memphis, where King died. No such bulletin was issued in Birmingham, Galt's last known residence.

ERIC GALT is an erigma.

In fact there is some official suspicion that Eric Gait may not exist, for it is very hard

for a man to leave so few traces of himself. As far as can be determined, his trail grows cold in Atlanta, where agents found his white Mustang Thursday. It had been abandoned there the morning of April 5, one day after the killing.

He was traced to a rooming house in Birmingham where no one has seen him since November — although a duplicate driver's license was mailed to him there last month.

Where he came from, where he has gone — they


are mysteries. The death of Martin Luther King Jr. is a hodge-podge of mysteries — of mysterious men in white hoods, of mysterious radio messages, of mysterious cars and total secrecy.

On Friday, the day after the killing, and on Sunday and Monday on television programs, Attorney General Ramsey Cark talked freely and optimistically.

The attorney general now avoids reporters. Sources which normally provided guidance in criminal investigations say they have never seen such secrecy. Normally in a search for a suspect, the FBI freely publicizes descriptions and likenesses. But this secrecy, sources indicate, comes from beyond the FBI, beyond the Justice Department — from the White House.

The day after the slaying,

Clark said "we are very hopeful that we can have an early and successful conclusion" and later he said "our evidence points very strongly" toward only one manbeing involved in the assassination.

But the FBI did not want Eric Galt touched, bothered or chased. Even though it had not found him, it apparently did not want him to know he was hot. Did it, perhaps, hope that Galt might lead agents to someone else?

* * *

IN THE office of R. S. Lewis and Sons Funeral Home in Memphis, Solomon Jones paused in his narrative occasionally to smile at mourners entering the front door. There was a body on view in the chapel.

Jones told in a soft, funereal voice the story of King's last day. He was driving for King on Thursday, April 4.

He said he was standing on the payement beside King's car, the engine running, and King was turning to leave the balcony and come down to be driven to a friend's house for dinner.

"I heard the shot, and I felt it go past me. Believe me, gentlemen, if it had been a little lower it would have killed me and not Dr. King. I ran to the street and I looked across, and I saw a man jump up from behind the bushes and run back toward Main Street. He had something white on his head, like a hood."

How the Police Say It Happened

ACCORDING to Memphis Police Director Frank Holloman, the assassin stood in the bathroom of a nameless flophouse to make his shot.

He rented a room, locked himself in the bathsoom and fired out the window, at the back of the building. Then he fled down the stairs and out onto Main Street, one block over from the botel, which is on Mulberry Street.

He dodged into the doorway of Canipe Amusements Co., one door up the street, and dumped his rifle and a small case containing binoculars in the doorway. Then he leaped into a white Ford Mustang and roared away.

THAT IS how police say it happened, and it is constructed from testimony of witnesses and, presumably, from evidence.

*

But Sidney Walker also claims to have seen something strange. Walker, a tall, wizened Negro, said he was in Jim's Grill, below the flophouse, having coffee when he heard the shot. Walker said he sprinted out the door, around the corner, down Huling Street and into Mulberry Street by the hotel. He saw King's aides gathering atound him on the balcony,

and, he said, he saw a man running down the street, away from him, with a white hood on his head. The police had not yet arrived, he said.

But, according to Holloman, 150 officers converged on the scene in a matter of seconds.

Chauncey Eskridge, King's lawyer, was standing in the parking lot with Jones when the shot rang out. He, too, ran to the street. He said he saw no one with a hood, but claimed that a group of policemen leaped out of the bushes — the same bushes from which Jones said he saw a hooded man run.

THE WHITE stuce house with a red tile roof at 2608 Highland Ave. in Birmingham has a red and white neon sign insistently announcing:

ECONOMY SLEEPING ROOMS BY THE DAY OR WEEK Air Conditioned Dining Room

Room and board at 2608 Highland costs \$27 a week, and most of its guests stay only two or three weeks before they move on. Eric Starvo Galt used to live there.

Peter Cherpes runs the place and he says he talked to the FBI and won't talk to anyone else. Only one of the roomers has been there long enough to remember Galt and that roomer, Percy Strickland, doesn't recall much.

"He was just one of the boys," Strickland said. He said he figured Galt had lived there no more than six months — a long time at 2608 Highland — and doesn't recall seeing him since November.

"The FBI has been asking about him plenty the last week," said Strickland.

Mustang Bought In Birmingham

GALT BOUGHT the white Mustang which was so passionately sought for a week

from William D. Paisley, of Birmingham on Aug. 30, 1967. Paisley said the FBI told him not to talk to reporters.

The Alabama State Employment Office never heard of Eric Galt. The Birmingham police never heard of him, and the Birmingham Credit Bureau has no file on him. No one knows, now, where Eric Galt has been since November.

but it was in Birmingham, four days before King died, that a sporting goods store sold the gun that killed him.

On Saturday, April 6, 1968, reportedly a closed meeting of the NOI was held at 670 N.W. 22nd Road. Approximately 12 or 13 cars were seen in the area of the meeting place; however, it was not known if the occupants of the cars attended the alleged meeting.

On Sunday, April 7, 1968, the Muslim newspaper was being sold in the durgstore located at N.W. 9th Avenue and N.W. 6th Street.

- On Sunday, April 7, 1968, reportedly another closed meeting of the MOI was held; however, youngsters ages about 12-13, dressed in blue, were also in the area and proceeded to participate in the memorial services for Dr. MARTIN LUTHER KING, JR. at Pumland Park, Fort Lauderdale, Florida.

Was King's Killer a Hired Pro?

MEMPHIS, Tenn. — There is growing speculation among Memphis police detectives that the Rev. Martin Luther King's assassin was a disinterested professional killer — not a racist ideologue — who left an elaborate trail of phony clues to confuse his pursuers.

They won't say who they think hired the killer or why, but the evidence, they say, points to a wellpaid professional job.

Frank C. Holloman, director of fire and police, has maintained a stony silence on progress of the

April murder investigation, as has his chief of detectives, William Huston. But sources in the department indicate that the "hired-killer" theory is gaining momentum

One notion is that the killer began his preparations six or eight months ago by dissolving his real identity and manufacturing a new personality known as "Eric Starvo Galt, 36, unemployed merchant seamen"

Surrounding himself with phony credentials, he waited patiently in various cities for the right opportunity to fulfill his assignment.

In Birmingham, where Galt once lived, Jefferson

County Sheriff Mel Bailey said he believes the assassin originally may have planned to kill King in the Alabama city.

Bailey, who threw a protective net around King when he was in Birmingham last October to serve five days in jail, said he thinks a conspiracy existed to murder the civil rights leader. The sheriff said his theory is only conjecture, but, "It is based on the evidence uncovered so far in the case."

Galt, who has been identified by fellow hoarders in a rooming house in Birmingham as being the same man shown in FBI sketches of the suspected assassin,

lived in the city when King was serving his jail term, Bailey said.

The opportunity came April 4 in Memphis. Dr. King had arrived the day before, and both television and local newspapers had announced the motel and room number where Dr. King was staying.

The assassin rented a room in an adjacent building under the name "John Willard," fired the fatal shot and fled, leaving an enormous trail of fingerprints, clothing, binoculars, a rifle and an expended shell in his wake.

Federal authorities said here Tuesday they are satisfied John Willard and Eric Starvo Galt are the same person.

Memphis detectives say evidence that the killer was hired at a substantial price is reflected by his ability to purchase a "white Mustang" automobile and follow Dr. King around the country for several months without apparently holding a job.

The detectives are deery of the physical evidence left behind by the killer.

"He was supposed to have shot King with a pump rifle," Miami, Florida

one said. "Well, there was a spent shell found on the bathroom floor of the rooming house, and a pump rifle won't eject a shell automatically. It won't come out unless you pull back on the pump mechanism."

He noted that the discarded Remington .30-06 pump rifle found on the street near the rooming house was inside a Browning Automatic Rifle packing box. He suggested that the assassin actually had two rifles, using the Browning automatic to kill Dr. King and planting the Remington as a red herring. Even if the expended shell found in the bathroom matches the Remington, he said, the killer could have fired it at an earlier date and planted the shell to match the Reming-

The FBI has the Remington and other physical evidence at its laboratories in Washington and has not revealed its findings.

Memphis detectives look at the assassin as an incredibly "cool" character who didn't seem to mind being obvious. Dressed neatly in a business suit and necktie, he rented an \$8.50-a-week room in a flop house, paying in advance with a clean, new \$20 bill. He then proceeded to leave finger and hand prints

around the bathroom and dump a bag full of clothing, a rifle with telescopic signt and a pair of binoculars on the street as he fled.

"It was better than a television show, the way he did it," one officer said.

Most of the items dumped in the street, they speculate, will lead up blind alleys. The killer was casual about his finger and hand prints either because he is an alien or because he thinks he is one of the few American adults who has not been finger-printed at one time or another, they say.

In Atlanta, meanwhile, two cab drivers said they gave rides to the man identified as Galt immediately after the assassination. They made the claims after identifying Galt from sketches circulated by the FBI.

Both drivers said the trips were in Atlanta's "hippie" neighborhood around Peachtree Street and 14th Street. The area is about seven miles from the public housing project where a white Ford Mustang, registered to Galt, was located by FBI agents last Thursday.

Both taxi drivers work for the Atlanta Million Gooperative Cab. Co. Their names were withheld at the request of the firm. A IRTEL




