All potential bombing suspects in the Miami Division were eliminated as being identical with subject through physical observation and the fact their whereabouts were known at the time of the commission of the crime.

In accordance with the instructions set out in Bureau teletype to all SACs dated 4/22/68 and Memphis airtel to Knoxville dated 4/7/68, all criminal informants and appropriate racial and security informants were contacted relative to any information concerning this matter.

With regard to BOB MC GOWAN, an individual who was previously used by the Miami Office concerning Klan activities and racial matters, it is being left to the

discretion of Memphis as to the manner in which this background information on MC GOWAN is to be reported. In this regard Miami notes Memphis teletype to Bureau and Miami dated 4/8/68, and Miami teletype to Bureau, Memphis and Jackson dated 4/9/68.

With regards to IRA DAVID HAWTHORNE (former MM 1081-R) and WILLIAM SUMMERSETT (former MM 607-R), who furnished information regarding EARL LINDER and one GILBERT which was set forth in a Miami teletype to the Bureau dated 4/29/68, an airmail copy of which was furnished to Memphis, it is being left to the discretion of Memphis as to the manner in which the information contained therein is to be reported.

Reference is made to previous memo to all Agents relative to this matter, setting forth all background information.

The Bureau has advised that it has been developed subject spent a considerable sum of money from 4/23/67 to 4/4/68, and that the source of this money has not been determined. Consequently the Bureau has instructed that subject's photograph be displayed to all appropriate witnesses in unsolved bank robberies and bank burglaries, in those instances where witnesses are available. Additionally, requests should be made of police departments to display subject's photograph to witnesses in their unsolved robberies.

The Bureau has also pointed out the possibility that the subject may have died since the commission of this crime. In this connection, the Bureau has instructed that all law enforcement agencies be alerted to the fact that subject's fingerprints should be compared with all unidentified dead persons located from the period beginning 4/5/68 to date.

All Agents having unsolved bank robberies and/or other cases in which it would be appropriate, are requested to display subject's photograph to witnesses. In addition, Agents having liaison with local law enforcement agencies should assure that they are requested to display subject's photograph in connection with their unsolved robberies and additionally, that all fingerprints of unknown dead are compared with fingerprints of subject RAY.

The Bureau further pointed out that in connection with covering leads in this matter, it should be borne in mind that prior to departing Los Angeles in March, 1968, the subject made several telephone calls to country clubs in an effort to obtain employment as a bartender.

Referenced Milwaukee airtel to Miami, 4/20/68, set forth information from a citizen in Milwaukee, Wis., who had visited the Sun Castle Motel, Pompano Beach, Fla. While at the motel he dealt with a bell boy who he later learned traveled to the State of Tenn. and after viewing photographs of subject RAY decided that this bell boy resembled the photos of RAY.

Based upon the above info, investigation was conducted at the Sun Castle Motel to identify the bell boy in question. It developed that this individual's name was EARL B. SHIELDS, who is originally from Randolph, Mass.

Referenced Miami airtel to Memphis, 4/29/68, informed Memphis of the results of preliminary inquiries re SHIELDS and set forth a lead for Boston at Randolph, Mass., to further identify this individual and eliminate him as a suspect in captioned matter.

Referenced Miami airtel to Bureau, set forth results of additional inquiries regarding SHIELDS further identifying information concerning him and leads for Boston to continue their inquiries to eliminate SHIELDS as a suspect in captioned matter.

Boston was requested to advise Miami the results of their investigation so that further inquiries regarding SHIELDS could be conducted if necessary.

Inasmuch as SHIELDS has been identified and leads set forth to locate him through contacts in Randolph, Mass., no further inquiries are being conducted at this time.

Not Interested, James Earl Ray Family Asserts

Miami Herald-Los Angeles Times Wire

ST. LOUIS — "I'm not interested in my brother at all. Not at all. I never want to see him again."

The words are harsh, bitter, disappointed, and spoken by John Larry Ray, 37-year-old brother of James Earl Ray, the man accused of killing Dr. Martin Luther King.

Sipping an orange juice and vodka drink at a south-side St. Louis bar, John Larry refused to discuss in detail his brother or anything touching on the April 4 assassination of Dr. King in Memphis.

Moody, and somewhat of a loner, according to his friends, John Larry Ray is the next eldest after James Earl of nine Ray children.

He and his sister, Mrs. Carol Ann Pepper, 27, live quietly in St. Louis seeking anonymity from the publicity which has surrounded the family since their lives came under public scrutiny.

As the member of the family closest to James Earl, John Larry has been the only one not publicly accounted for since the assassination. Like all other members of the family, however, he has been questioned at length by the FBI.

He has been described as everything from a migrant worker to a New York City bartender. Actually, John Larry owns a one-truck delivery service here and helps run a south side neighborhood tavern, the Grape Vine, which is leased by his sister, Mrs. Pepper, for \$960 a year.



James Earl Ray
... still at large

Asked how well he remembered James Earl, or what he knew about his brother, he replied: "Who knows him? Probably his cellmate knew him better than anybody."

James Earl's cellmate at the prison has described him as a loner, an avid reader of espionage and detective stories, and a man "who served his time in his own way."

A state psychiatric examination of James Earl made in October 1966 after an escape attempt failed, diagnosed him as a "sociopathic personality, antisocial type with anxiety and depressive features." It said he had an I.Q. of 105, somewhat above the average prisoner.

Byron L. Kinder, the Cole County prosecuting attorney who tried James Earl in 1966, says the suspect is an improbable assassin.

"He was a loser in everything he did," Kinder said. "Nothing in his background indicates he had any practice with a telescopic rifle or had ever handled weapons to any extent.

Nothing indicates he hated Negroes, and he could never even pull off a smart-time robbery, so how could he plan and execute the assassination of Dr. King? I think Ray is an improbable assassin," Kinder said.

A friend of John Larry Ray said he sometimes used an alias of "Jerry Ryan." Both John Larry and Mrs. Pepper's husband have had minor scrapes with the police over the years. Mrs. Pepper's husband is a mechanic at a downtown St. Louis hardware store and has been a friend of John Larry's for years.

"Few of his friends here even know John is the brother of James Earl," said a close acquaintance. "He doesn't talk about what happened, but he said after the assassination that he hated his brother for what he had done."

The acquaintance also said John Larry Ray was shocked by the identification of James Earl as the suspected assassin. "He has tried to make something of himself despite his poor family background and maybe he knows how James Earl ended up a convict. Larry's a nice guy."

John Larry lives on the city's south side where the Grape Vine is located, not far from the streets and sidewalks where some of the Ray children matured. It is an old German neighborhood, says a city official, rapidly being filled with people from rural areas.

The FBI obviously has gone into the Ray family background extensively.

Contrary to published reports, the father, George Ray is still alive and there are some indications he may be living in or near St. Louis.

John Larry was the last member of the family to see his brother, during a visit the day before James Earl escaped from the Missouri penitentiary at Jefferson City on April 28, 1967. He visited his brother at the prison eight times, more than any other member of the family

while James Earl served almost six years of a 20-year sentence for armed robbery in St. Louis.

Ray talked briefly about his brother but refused to go into any detail. He particularly declined to discuss the possibility of a conspiracy. Friends say he keeps to himself, occasionally plays a game of pool, doesn't talk very much and sometimes uses the alias "Jerry Ryan."

"I don't have any comment. I'm not implicated in this in any way. The FBI has been here to talk to me. They've talked to my sister. She's sick and tired of it all and so am I," he said.

"I could sell my story for \$15,000 or \$20,000 to magazines or television if I wanted to, but I don't want to do that and I don't have any intention of doing it. I don't want to talk about it. That's all there is to it," he added.

Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.

Re telephone call from Supervisor HUNTER HELGESON, SOG, 5/16/68 concerning lead to contact Dr. RUTH TURRELL, North Palm Beach, Fla., re possible suspect this matter known to her. Dr. TURRELL had mentioned in a letter ~~XXXX~~ to her nephew, FBI Lab. Asst. JAMES M. WOLF, a patient of her who resembled RAY.

On 10/17/68 Dr. RUTH TURRELL, 928 Shore Drive, North Palm Beach, Florida, advised SA RICHARD B. KELLOGG that in her letter to her nephew, JAMES WOLF, she did not mean to indicate the patient she had in mind resembles RAY physically, as he does not, but only that the patient is psychologically capable of anything, and could have killed Dr. KING. Dr. TURRELL said when that person first contacted her, in her capacity as a marriage counselor, he gave the name FRANK MARCUS but later told her his name is really FRANK BENSCOTER. His wife's name was ALETA. She described BENSCOTER as about six feet tall, heavy or medium heavy build, who claims to be 31 but looks more like 41. She said he had dark hair and his right eye seemed to stray off or always point in the same direction. She said he does not resemble any of the photographs of RAY, and from information furnished her by BENSCOTER and his wife, they were either just arriving in West Palm Beach, Florida, or enroute from St. Louis, Mo., to West Palm Beach on 4/4/68.

HAZEL V. PEACOCK, 608 Hancock, Okeechobee, Florida, appeared at the office of the Fort Pierce Resident Agency of the Federal Bureau of Investigation (FBI), and furnished the following information:

She is employed as a secretary at the Guidance Center of the Okeechobee School for Boys, Okeechobee, Florida.

At midnight, April 4, 1968, she received a collect telephone call from her ex-fiancee, DONALD JACKSON CARPENTER, from Birmingham, Alabama, advising that he and TERRANCE ALVIN SMITH were on the run and involved in the death of MARTIN LUTHER KING. Because of the nature of the call she made notes shortly thereafter of the conversation which are as follows:

She explained that the initials "D. C." stood for DONALD CARPENTER, "T.A.S." stood for TERRANCE ALVIN SMITH, and "M. L. K" stood for MARTIN LUTHER KING. She also explained that the statements in quotes were made by CARPENTER.

"Phone call at 12 midnight 4 April from Birmingham (collect) from D. C. (T. A. S. w/him, could hear him in background. I think one other man).

"Stated, 'We're on the run'. Why? - 'Haven't you been watching TV?' No- 'You mean you haven't heard the news?' No - 'Well - M.L.K. is dead'. Oh, No! What do you mean? --

"We did it. They're hot on our ass. You don't mean this. Don't kid me about this!

"Can you hide us out for a couple of weeks?

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

"I don't know - No - Oh, I guess so.

"Do you know what you'd be charged with if we were found there? Yes, nothing. I don't believe you. Where are you?

"Birmingham - the cops went off to the north, but we're here, okay.

"When are you coming? Tomorrow night late. We get our money in Dothan, no, outside of Dothan (He was corrected as to location by TAS) tomorrow (5 April) and then we'll come to Okeechobee.

"You are serious, aren't you? How much is a job like this worth on the market today? \$100,000, split two ways.

"How could you do this?

"We need the money.

"It isn't worth it. How will you, an old Ga. boy, explain all that sudden wealth? You're crazy.

"Don't worry about it. Why is your voice shaking? I'm scared for you - I'm shaking all over.

"Us too. TERRY thought he missed. He (MLK) leaned over just as he fired, but he got him. He's dead.

"I still can't believe all this.

"Well, go to sleep. I'll be there tomorrow night. Let us do the worrying. I can't believe we could be so slick."

She stated that they did not come to see her nor have they contacted her since this telephone call.

She said she first met CARPENTER on January 23, 1968, through a mutual friend, SUSAN MORELAND, who works for the United Telephone Company in Okeechobee, Florida. At the time he was working for the Power Engineering Company in Okeechobee. He was closely associated with JIM O'NEAL who also worked for Power Engineering. CARPENTER suddenly left town on February 25, 1968, with a Mr. BARNES. They were allegedly going to Tampa, Florida, to see the head man of Union IBEW 102. CARPENTER never returned to Okeechobee although she subsequently talked to him several times by telephone. On or about February 11, 1968, she called him at the home of his ex-wife, Mrs. VIRGIL SALTER, in Americus, Georgia, telephone number 924-5133, and he advised that he was working for the Continental Telephone Company, Gray, Georgia. In the latter part of February he called from Terre Haute, Indiana, around two or three A.M., and advised that he had flown there with a friend and was snowed in. On either March 8 or 11, 1968, he called and advised that a friend of his by the name of TERRY SMITH was coming to Okeechobee, Florida, and would look her up. SMITH was also supposed to be working for Continental Telephone in Gray, Georgia. That was the first she had ever heard of TERRY SMITH.

TERRANCE ALVIN SMITH arrived at her apartment on March 20, 1968, accompanied by a hippie he had picked up in Tallahassee, Florida, by the name of BOB THIBODEAU, a French - Canadian. THIBODEAU left Okeechobee the following day. SMITH stayed in her three bedroom apartment until mid-afternoon March 25, 1968. He rarely left the apartment and was only gone for short periods. On Saturday night, March 23, 1968, he left the apartment carrying a black Samsonite attache case. He left at about 8 PM and did not return until almost 1:00 AM. She stated that he was almost hysterical and he mentioned something about almost being caught or that a witness had almost seen him. He had been drinking; however, he was ~~not drunk~~. She said she recalled the initial "R" being on each side of the

handle of the briefcase. SMITH left Okeechobee sometime between 2 PM and 5 PM while she was at work. She said when she returned home shortly after 5 PM she found a note he had left her which is as follows:

"HAZEL,

"I had to split the scene. I knew I would as soon as my assignment was finished, but once you're in you're in and no way out until they are finished with you. I never know how long I'll be in one place but I knew this would be a short trip but I couldn't say anything. I wish I could be here to see your face when (don juan) DON arrives but it was impossible. I'm sure you will be very happy (but for how long). Never base your happiness on the future, only excitement comes from thinking of the future; happiness is the present, but ----- who knows the future? A person can talk himself into believing anything or thinking it possible unless he asks why? or how? I have my own thoughts about you and DON, there are many things I could say and tell you because I've seen it happen time and time again but maybe it will be different this time, only time will tell as always. I'm not trying to discourage you but stop wishing and start doing, keep your self-confidence it will always pull you through.

"I'll contact you within a week to see what happen. Well, good-bye, wish I could take you with me to see the many wonders of the world, in actions, -----people.

She received a call from CARPENTER on March 29th and he described how he was going to help SMITH do a little job outside of Atlanta. Apparently they were going to kill a former member of their group whom they thought might talk. CARPENTER described how he could be electrocuted without causing any suspicions. It was at this time CARPENTER mentioned that he had a briefcase like SMITH's with the initial "R" on each side of the handle. She said she believed he was calling from Gray, Georgia.

All potential bombing suspects in the Miami Division were eliminated as being identical with subject, through physical observation and the fact their whereabouts were known at the time of the commission of the crime.

- INFORMANTS -

In accordance with the instructions set out in Bureau teletype to all SACs, dated April 22, 1968, and Memphis airtel to Knoxville, dated April 7, 1968, all criminal informants and appropriate racial and security informants were contacted relative to any information concerning this matter.

By teletype dated April 26, 1968, the Bureau advised that on February 26, 1965, the Los Angeles "Herald Examiner" stated in effect that KEITH D. GILBERT, a Minuteman, had dynamite, was a racist, and was a threat to the life of MARTIN LUTHER KING.

The same communication stated that on March 5, 1965, MM 607-R advised that EARL LINDER, 2521 N. W. 23rd Street, Miami, told him that they would not make the same mistake again and next time a high powered rifle would be used on KING.

By teletype dated April 29, 1968, the Miami Office advised the Bureau and Memphis as follows:

IRA DAVID HAWTHORNE, JR. (former MM 1081-R), who resides directly behind EARL LINDER in Miami, was contacted April 26, 1968, and April 29, 1968. He advised he has almost daily contact with LINDER, who has not expressed any unusual interest in or knowledge of KING's death. He said LINDER has not taken any recent extended trips from the Miami area and there has been no unusual activity around LINDER's home. He said LINDER's main interest presently seems to center around a "conservative church group" from South Carolina. He said LINDER is getting old, not in good health, and appears to have some financial problems and therefore his activities have been limited.
