U.S. District Judge John Lewis Smith gave the FBI 90 days to assemble all known copies of the tapes and transcripts of its surveillance of King and offices of his Southern Christian Leadership Conference between 1963 and

But Smith refused to award damages to the SCLC or Bernard 'Lee, former assistant to the slain civil rights leader, who had filed suit on grounds the surveillance was a civil rights violation.

Smith ruled a damage award was barred by a three-year statute of limitations, which he said began to run at the time Lee and the SCLC "actually discovered or ... should have discovered" facts about the surveillance.

WASHINGTON — A congressional investigation into the assassinations of President John Kennedy and Martin Luther King Jr. came dlose to collapsing Friday as a result of a dispute within the committee.

Four investigators from the House Select Committee on Assassinations staff were refused access to FBI files on orders from committee chairman Rep. Henry Gonzalez (D., Tex.), who announced Thursday that he was firing Richard Sprague, the committee's chief counsel and staff director.

However, Sprague refused to be fired. He showed up at his office Friday, worked a while, then left to keep an appointment in Philadel-

The 11 other members of Gonzaez's committee backed Sprague claiming that Gonzalez lacked authority to fire him.

King Assassination Probe Clears FBI

WASHINGTON — A Justice Department task force says that the "sum of all the evenence" points to James Earl Ray as the sole killer of civil rights leader Dr. Martin Luther King Jr., but concedes that it was unable to find out where Ray got the money to escape abroad after the April 4, 1968, slaying.

The task force report also concludes that the FBI was not implicated in the King slaying and that its investigation of the assassination was thorough and honest.

The report, made public Friday, immediately came under fire from King's widow, Mrs. Coretta King, and the civil rights leader's associates.

"WE DON'T have any faith in that report because it seems the FBI and the Justice Department, to a degree, were involved in the assassination or the events surrounding it," said Tyr-

one Brooks, spokesman for the Southern Christian Leadership Conference.

Mrs. King told reporters in Atlanta that she would "like for some agency to disclose ... whether the Justice Department made a sufficient inquiry and could find their conclusions convincing."

The task force was set up by former Attorney General Edward H. Levi to clear up questions about the FBI harassment of King and the investigation of his death.

"The sum of all the evidence of Ray's guilt points to him so exclusively that it most effectively makes the point that no one else was involved," the report said, commenting on the task force review of more than 200,000 FBI documents and its interview of some 40 witnesses.

"Of course," the report added, "someone could conceivably have provided him (Ray) with logistics or even paid him to commit the

AS FOR THE FBI investigation, the task force said the bureau failed to check some leads that might have erased some lingering mysteries about the case. Among these was the possibility that one or both of Ray's brothers might have helped him escape from the Missouri State Prison in 1967.

Later Friday, FBI Director Clarence Kelley issued a statement expressing "great satisfaction" that the task force had found the FBI investigation thorough and concluded the bureau was not involved in King's death.

He noted that task force criticized the harassment of King and said, "guidelines, procedures and our determination to be completely observant of civil rights and the dignity of man will prevent a recurrence of these activities."

Inquiry concludes Ray acted alone

WASHINGTON — A major Justice Department inquiry has concluded that the Federal Bureau of Investigation probe of the murder of the Rev. Martin Luther King was "thoroughly, honestly, and successfully" conducted, and that the best available evidence suggests that the convicted murderer, James Earl Ray, acted alone.

The Justice Department investigators, who made an eight-month review of the FBI's andling of the case, also confluded that the bureau may have had grounds for starting a security investigation of King, but that its six-year surveillance was clearly unwarranted.

The report released yesterday said that the FBI never developed evidence that King had any affiliation with the Communist Party, and that it was the personal feuding between him and the late FBI director, J. Edgar Hoover — not legitimate rational security cocerns — that resulted in the bureau's "determination to discredit Di. Ring."

Ray, Brother May Testify About King Assassination

WASHINGTON — (AP) — The embattled House Assassinations Committee has a letter, purportedly from James Earl Ray, indicating that he is willing to discuss testifying about the murder of Dr. Martin Luther King Jr.

Walter Fauntroy, chairman of the subcommittee investigating the King assassination, confirmed that Ray and his brother are among witnesses he wants to call.

But Fauntroy, Washington, D.C. delegate, indicated that the brothers are not the source of new information that he said the committee has on King's assassination. He refuses to say what that information is.

THE CHAIRMAN said he would like to hold public hearings this month, but is not sure the subcommittee can move that fast.

The committee has a letter carrying Ray's name and signature rejecting the insistence of his lawyer, James H. Lesar, that he not testify before the committee.

"This is not necessarily my position," the letter says. "Therefore, if the committee has any queries I would appreciate it if they would in the future direct them to Attorney Jack Kershaw."

Kershaw, a Nashville, Tenn., lawyer, could not immediately be reached.

A committee spokesman comfirmed that "we are in receipt of such a letter and from what we know of his (Ray's) signature that is a legitimate letter."

Ray's brother, Jerry, said he told a committee investigator that both he and Ray are willing to testify on Ray's contention that he did not kill King.

"I'M ANXIOUS to corroborate or repudiate the information we have through his (Ray's) testimony," Fauntroy said. "Having him before us under oath would be quite valuable."

Asked if the hope of calling Ray means the investigation will deal with his contention that he was railroaded into falsely pleading guilty, Fauntroy said, "Obviously that is the purpose of Mr. Ray.

"He indicated at his hearing in pleading guilty that there was a conspiracy and that is the basis of this appeal, Fauntroy said.

House Speaker Thomas O'Neill said after a meeting with committee Democrats Thursday that they have new information on the King assassination that they hope will persuade the House to keep the investigation alive.

THE COMMITTEE dies at the end of this month unless the House extends it and Fauntroy wants early public hearings largely for that reason.



WASHINGTON — The House Select Committee on Assassinations got a new chairman Tuesday after the resignation of Rep. Henry Gonzalez (D., Tex.) was finally accepted on the House floor by a vote of

296-100.

Speaker Thomas O'Neill named Rep. Louis Stokes (D., Ohio) to preside over the uncertain inquiry, which will go out of business March 31 unless the House votes to continue it.

Stokes' appointment was seen as a sign of hope only for the investigation of the murder of Martin Luther King Jr. The Cleveland

Democrat is one of the four STOKES members of the Congressional Black Caucus who were appointed to the 12-member committee last September as a result of caucus' special interest in the King assassination.

Gonzalez lasted as chairman little more than a month. Appointed Feb. 2 with what he regarded as a mandate to take firm command and deal with the committee's overextended finances, he ran into resistance from chief counsel Richard Sprague but was overruled by all 1 other members of the committee when he tried to fire Sprague.

Assassination panel to hear James Earl Ray

NASHVILLE, Tenn. — James Earl Ray, convicted of murdering Dr. Martin Luther King, will give preliminary depositions to the House Assassinations Consmittee next week, his attorney said today.

Jack Kershaw, retained three weeks ago as Ray's lawyer, said the session will be conducted by the committee's deputy chief counsel and two court reporters at the Brushy Mountain State Prison in Petros, Tenn. Ray is serving a 99-year sentence there.

The attorney said he has new evidence that will aid the assassinations probe, but he declined to reveal

Kershaw said, however, that Ray will not testify before the special committee merely to support his

original guilty plea.

"Like Mr. Ray just said, he wouldn't go before them just to prove he was guilty," Kershaw said, reterring to a statement his client made in an interview with CBS television.

Ray originally pleaded guilty to killing Martin Lutter King in Memphis, Tenn., in 1968, but he later asked to retract his plea. His request was refused.

Kershaw said Ray "hasn't had a forum before" to tell his story.

"At that time (of the conviction), the establishment was looking for a victim. Right then, Ray was victimized," Kershaw said. "It will be my contention that he never plotted together, never breathed together, to murder King. He was a victim of a conspiracy, just like King was."

Ray contended in an interview on the CBS program "Who's Who" last night that he had been sent to have a tire fixed when King was assassinated and that

he was set up to take the blame.

Ray said "investigations by people representing me" are producing evidence he thinks will clear him in a new court proceeding.

But Ray shed no new light on who killed King it he did not, or why. He said, as he has before, that his only contact with the murder was through a Latin named Raoul. He said he thought Raoul was conducting a gun-running operation.

Giving new details about his story about Raoul and a conspiracy, Ray said he delivered a rifle to Raoul shortly before the assassination in what he thought was part of the gun-running operation. He said Raoul

then sent him to have a tire fixed.

He said the attendants at a service station told him they were too busy to fix the tire because of the hour. King was assassinated shortly before 6 p.m., the traffic rush-hour period.

Ray said in the interview he was certain he was not in the rooming house from which the rifle was fired at King after 5:30 p.m.

Ray said Raoul had been directing him in gun-running activities for a year. He said there was nothing to distinguish Raoul except that he had auburn hair, not

black hair like most Latin people he knew.

But Ray said he and Raoul had never discussed killing King and so he did not know why King was

He said he believes the most plausible theory is the one that King was killed to halt his civil rights activi-

Ray pleaded guilty to killing King but tried to recant that plea three days later and his efforts since then to get a new trial have been turned down all the

way to the Supreme Court.

He said in the interview he pleaded guilty because "I determined there was no way I could force Percy Foreman (his lawyer) to go to trial with any prospect

ASKED WHY the man contacted him and let him listen to a copy of the tape recording, Snyder said, "He may have just been looking for someone with nerve, a fighter.

Snyder read part of the letter and used the word "blank" where the man had used names.

"I retired from (blank) police department in (blank) after serving (blank) years," Snyder quoted the letter as saying. "While I was in the police department I was innocently involved in a conspiracy to assassinate Dr. Martin Luther King.



Cop Was Offered \$500,000 To Kill King, Wife Confirms

The wife of a retired Louisville, Ky., police officer confirmed Welnesday that her husband told Reb. Gene Snyder that he was offered \$500,000 on two occasions to kill Dr. Martin Luther King Jr.

Mary Baird, 44, said her husband Clifton who was not in Louisville and was not available for comment, told Snyder of an offer he said was made by members of the Louisville Police Department and several FBI agents.

She said her husband, 50, retired from the Louisville police department several years ago after 27 years' service.

"HE TOLD ME about this when I first married him, seven years ago," Mrs. Baird said. "I think he thought he wasn't going to be believed."

She said she believes one reason he came forward a second time with the allegation was because "he wants to know why someone asked him" to kill the civil rights leader, who was assassinated in Memphis, Tenn., in 1968.

She said her husband, before contacting Snyder, told one of James Earl Ray's attorneys of the alleged plot. She said her husband was "discouraged" after he told the attorney.

Ray is serving 99 years in prison for the slaying of King.

Snyder, who disclosed last week that he had heard from a man who claimed knowledge of a plot to kill King, had refused to divulge the man's name,

Mrs. Baird said her husband told her "he was offered \$500,000 to kill" King and that "he didn't appreciate it,"

"I CAN'T SAY any more, but he's just not that type of person," she said. Asked why her husband thought he was asked, Mrs. Baird respondent: "That's the \$64 question. He wants to know why someone asked him."

Snyder said earlier this week that he had met the man "face to face" and was convinced he was a "rational" man. In fact, Snyder said he changed his mind about voting to extend financing for the House Select Committee on Assassinations solely because of his conversation with the man.

In Washington, the House Assassinations Committee approved a \$28-million budget request a d then went into closed session to look at evidence on the murders of King and President John Kennedy.

The biggest cut from the committee's earlier, controversial \$6.5-million proposal was a \$2.3-million slice to cut the staff from 170 persons to 115. The budget figures are for this year.

Chief counsel Richard Sprague told the committee that means the two investigations will take longer and "we'll have to wait and see" whether they can be completed during the two-year life of the current Congress.

Miami Office files contain no reference reflecting receipt of the information allegedly furnished by WILLIAM SOMERSETT relative to his claim that he overheard a death threat at a union affair in Washington as set forth in said article.

In connection with the statement in the article by CHARLES SAPP, formerly of the Miami Police Department, a review of Miami files does not show the receipt of any information from CHARLES SAPP furnished to him by WILLIAM SOMERSETT.

On March 23, 1977, Supervisor LEONARD C. PETERSON of the Miami Office of the FBI, who was in periodic contact with personnel of the Miami Police Department, Intelligence Division, during 1968, advised that he did not receive and knows of no other FBI employee who received any information concerning a death threat against Reverend MARTIN LUTHER KING, JR., during that period.

King Panel Might Call Miami Man

House Panel Contacts Ex-Police Lieutenant

By JIM BUCHANAN

A former Miami police lieutenant said Sunday that he may be called to testify before a congressional committee about receiving a pre-assassination tip in 1968 that Martin Luther King might be killed.

Charles Sapp, the former policeman, said the information came in April 1968 from a Miami Police Department paid informant, Willie Somerset, who five years earlier had claimed advance notice of President John Kennedy's assassination.

"I've been contacted by a spokesman for the House Assassi, nations Committee," Sapp said Sunday, "and I've told them I'd be happy to testify as to what I know."

SAPP SAID he "can't recall the exact time element, but it was shortly before King was killed." King was killed on April 4, 1968.

Other sources told The Herald that the telephoned tip was received by the lieutenant April 3. Sapp, who retired in 1971, headed the department's intelligence-gathering unit.

Somerset, an admitted racist who then was trying to organize his own National Foundation of Labor, "claimed to have overheard the death threat at a union affair in Washington," according to Sapp.

Washington," according to Sapp,
"He said he overheard two men
condemning King for meddling in
union affairs. If you remember,
King was helping the Memphis
sanitation workers, who were out
on strike," Sapp said.

"Somerset told me the men said they'd have to 'take care of King," or words to that effect." "SOMERSET called me because he wanted me to know he was an Miami and shouldn't be suspected if something happened."

Somerset was once a member of the National States Rights Party and claimed to have heard, during a conversation 13 days before the Kennedy slaying, of plans to shoot him.

Sapp said Sunday, "I can't remember the exact day he called me, but I'm certain the FBI got an immediate report on the tip, because the agents were in our office every day, and they got the same information I sent on to the chief."

Sapp's distant connection with the King case came to light last September as part of a Miami magazine article dealing with the assassinations of King and Kennedy.

Two weeks ago, Sapp said, he was contacted by an investigator for the House committee.

"WE TALKED for a while, and he said they'd be in touch with me. But I haven't heard anything from them yet," Sapp said.

Miami files do contain information that WILLIAM SOMERSETT telephonically contacted Miami Division on 11/10/63, and advised that a conversation between JOSEPH A. MILTEER and himself had been tape recorded by the Miami Police Department.

This information was furnished to the Bureau by Miami teletype dated 11/10/63, under the caption, "THREAT TO KILL PRESIDENT KENNEDY BY J. A. MILTEER", at Miami, Florida, on 11/9/63.

Miami records reflect that on November 11, 1963, Sergeant CHARLES SAPP, Miami Police Department, advised the Miami Division of the FBI that a conversation between WILLIAM SOMERSETT and JOSEPH A. MILTEER, had been tape recorded by his department.

Miami records show that on November 12, 1963, the Miami Police Department furnished a transcribed copy of the taped conversation between SOMERSETT and MILTEER to SA LEONARD C. PETERSON of the Miami Division.

Copy of this transcript was furnished to the Bureau by an airtel dated 11/13/63, under the "J. A. MILTEER, RACIAL MATTERS, 00: ATLANTA" caption.

Miami records show that WILLIAM SOMERSETT was a discontined informant who had been turned over to the Miami Police Department and was not being contacted by the Miami Division of the FBI per Bureau instructions dated 11/13/61.

However, any information SOMERSETT volunteered to the Miami FBI was accepted and appropriately disseminated.

WASHINGTON — The House late Wednesday gave new life to its embattled Select Committee of Assassinations to follow its "new leads" in the investigations of the murders of President John F. Kennedy and Dr. Martin Luther King Jr.

The 230-181 vote came after the sudden resignation of the committee's controversial chief counsel, Richard Sprague, the suicide near Palm Beach of a "key witness" in the Kennedy inquiry and four hours of stormy debate on the House floor.

The seven-month-old committee, which had been mired for most of its existence in a bitter feud between Sprague and former committee Chairman Henry B. Gonza-lez (D., Tex.), would have gone out of business if the House had failed to issue a new authorization.

THE COMMITTEE, which is asking for a slashed budget of \$2.7 million for 1977, now may continue its investigations through 1978.

In Florida's House delegation, those voting to extend the committee's life were Democrats Gibbons, Lehman, Pepper and Rogers. Voting against the extension were Democrats Bennett, Chappell, Fascell, Ireland and Sikes, and Republicans Bafalis, Burke, Frey, Kelly and Young. Democrat Fuqua did not vote.

The witness who shot himself was George de Mohrenschildt, who was identified by the Warren Commission as a confidant of Kennedy assassin Lee Harvey Oswald and who had indicated in a published interview that he felt responsible

for the assassination.

De Mohrenschildt shot himself, Palm Beach sheriff's deputies said, ore hour after an assassinations committee investigator, former Philadelphia reporter Gaeton Fonzi, telephoned him to ask him to testify.

THE CRUCIAL factor in the rescue of the committee was Sprague's resignation shortly before midnight Tuesday.

PALM BEACH — A friend of Lee Harvey Oswald who recently was quoted as saying he had prior knowledge of the 1963 assassination of President John F. Kennedy, apparently shot himself to death here yesterday shortly after he was contacted by a congressional investigator.

The body of George de Mohrenschildt, 65, was found by his daughter Alexandra, 33, in the guest room of the palatial oceanside home of Mrs. Charles Tilton III in Palm Beach. He and his daughter had arrived there from Brussels for a visit with relatives.

Lt. Richard Sheets of the Palm Beach County sheriff's office said there was "no reason to suspect anything other than suicide, but the investigation is continuing."

According to Palm Beach County Sheriff Richard Wille, de Mohrenschildt returned to the Tilton home at about 2:45 p.m. yesterday and learned that a staff investigator for the Assassinations Committee had been trying to reach him in regard to his testifying before the committee in Washington.

Wille said it appeared that de Mohrenschildt became extremely upset when he learned of the investigator's efforts to reach him.

De Mohrenschildt, a professor at Bishop College in Dallas, disappeared from the college about three weeks ago. He was quoted by Dutch journalist William Oltmans as having made a "shocking confession" that de Mohrenschildt knew in advance what Oswald was going to do.

Oltmans said de Mohrenschildt nade the revelation during an inerview in February. Oltmans said the gave that information to the Assassinations Committee and following that, he and de Mohrenschildt then went to Europe where, according to Oltmans, de Mohrenschildt "disappeared."

Witness in JFK probe possible suicide victim

MANALAPAN, Fla. -- The Rus sian-born confidant of Lee Harvey Oswald who killed himself an hour after he talked to an investigator looking into the assassination of President John F. Kennedy was despondent, wracked by marital problems and felt threatened by congressional interest in his knowledge of Oswald.

George de Mohrenschildt, 65, who shot himself with a 20-gauge shotgun Tuesday, had been questioned repeatedly by the Warren Commission in its probe of the

Kennedy assassination.

The Russian-born geologist and professor of French had been a close associate of Oswald and his wife Marina when the two lived in Dallas.

INTEREST IN him heightened when the House Select Committee on Assassinations vowed to retrace the steps of the Warren Commis-sion and a Dutch journalist reported that de Mohrenschildt somehow felt responsible for the assassination.

The journalist, Willem Oltmans, said, "He asked me, 'How do you think the media would react if I came out and said I feel responsible for Oswald's behavior?'."

Shortly after the quote was reported, committee staff members intensified their search for the

much traveled professor.

Tuesday, staff investigator Gaeton J. Fonzi contacted De Mohrenschildt where he was staying at the home of friends in Manalapan. He left a message asking the professor to testify before the committee and an hour later De Mohrenschildt. placed a 20-gauge shotgue in his mouth and pulled the trgger.

DE MOHRENSCHILDT'S value as a witness is the subject of debate in the committee itself.

Committee member Robert W Idgar (D., Pa.) believes he would have been an "extremely signifi-cant" witness and quotes a Warren Commission witness as saying, "If there were any plotters in the assassination, it was this guy." Rep. Richard Preyer (D., N.C.), another member of the committee, agreed that De Mohrenschildt would have been a key witness in the reopened assassination probe.

But one staff investigator doubts that the Russian emigré had any-

thing of value to report.

"I find it highly suspicious that De Mohrenschildt didn't say any-thing for 12 years and then we see motion from him just as the committee was formed," the staff member said. "We have no reason to believe his death was anything but suicide," he said.

TWO OTHER committee witnesses died shortly before and after they testified. Mobster John Roselli was killed after he testified and Chicago gang boss Sam Giancana was killed shortly before he was scheduled to testify. Some say the murders were somehow connected to the assassination; others maintain that they were not.

If De Mohrenschildt's suicide can be related to the testimony he was about to give to the committee, it will bolster claims that the panel was turning up new evidence in

the assassination probe.

The committee's life would have expired at midnight Wednesday, but the House voted Wednesday afternoon to extend its activities for two years.

De Mohrenschildt was described by an associate at Bishop College, where he taught, as a friendly, outgoing man always willing to champion the cause of the down trodo den. But in the last year he began to show signs of having deep emotional problems:

FOR ABOUT six weeks last year De Mohrenschildt was treated for depression at Dallas' Parkland Hos-

pital psychiatric division.

According to John Dvorak, a public information officer at Bishop College, De Mohrenschildt suffered deeply when his wife left him and in early March he asked for an indefinite leave of absence because his daughter was ill.

"He was definitely a disturbed man. Seemingly he'd aged. He was much more nervous. His convertation was more sketchy and it was like he couldn't stay still in one

spot," Dvorak said.

That jibed with testimony on the House floor Wednesday by congressmen trying to end the life of the select committee. Several House members described De Mohrenschildt as a deeply trouble man with severe mental problems. They called committee pursuit of him "irresponsible."

DE MOHRENSCHILDT was a house guest at the oceanside home of Nancy Tilton, his sister-in-law, when he killed himself at about 2:30 p.m. Tuesday, Palm Beach County sheriff's deputies said.

The body was discovered by De Mohrenschildt's daughter, Alexaldra, 33, at about 3:45 p.m. Neither De Mohrenschildt's daughter nor the Tiltons were at home when the shooting took place. But two maids in the house at the time of the shooting were apparently tape recording a television show. And although they didn't themselves hear the shotgun blast, deputies said it was audible on the tape.

Lt. Richard Sheets, chief of detectives for the Palm Beach County sheriff's office, said that the "police were in possession of certain personal papers" of De Mohrenschildt, but he declined to comment on what those papers were, or whether they linked De Mohrenschildt further to Oswald.

SHEETS SAID he passed those personal papers on to the FBI and committee member Edgar said the committee would take immediate steps to gather those and other papers belonging to De Mohrenschildt.

De Mohrenschildt went to Brussels, Belgium, after he was granted his leave at Bishop and didn't appear for classes that began March 21. College officials thought he would be gone only a few days.

An autopsy performed Wednesday confirmed suicide as the cause

of death.

De Mohrenschildt's body wis found in a drawing room adjace to a second-floor bedroom in the filton home, located at 1780 5. Ocean Blvd. No suicide note was left. And the shotgun, found near the body, belonged to the Tiltons and was believed taken from a closet.

THE TILTON home, an old, wood-frame structure painted brown and green, was under tight sheriff's guard Wednesday. "They don't want to speak with anyone. They just want to lead their own lives," sheriff's Sgt. Al Vidal told reporters seeking interviews will the Tiltons. De Mohrenschildt and lis daughter had been at the Tilton residence since March 17.







King Killer Cites Pressure by FBI

Ray told House investigators. Thursday that the FBI tried to pressure him into naming alleged conspirators in the assassination of civil rights leader Dr. Martin Luther King Jr., Ray's attorney said.

Attorney Jack Kershaw met with reporters after Robert Lehner, who is heading the King portion of the House Assassination Committee's investigation, spent more than six hours with Ray behind the walls of Brushy Mountain State Prison. Ray Told Probers That He Had HelpBefore, After

Slaying, Sprague Says

WASHINGTON — James Earl Ray, convicted assassin of Dr. Martin Luther King, has told House investigators that he got help before

and after the slaying, the former chief counsel of the House Select Committee on Assassinations said Monday.

Richard Sprague, who interviewed Ray at the Brushy Mountain State Prison in Tennessee

last month, said Ray talked about several accomplices but did not identify them.

"All of this suggests that this (Ray) was a person who did not act alone," Sprague said.

SPRAGUE CALLED a press conference to give his version of the events that led to his departure as the assassination committee's chief of staff March 30.

Sprague conceded that he doesn't have information that might either prove or disprove Ray's claims. But he said Ray, who pleaded guilty to the 1968 slaying and is serving a 99-year prison sentence, gave him leads that should be explored.

Ray has been trying for years to withdraw his guilty plea and win a full trial. In recent statements, he has maintained that the civil rights leader was killed by a Latin whom Ray knew only as "Raoul." Ray said he bought the rifle that apparently was the murder weapon, but gave it to Raoul for what he thought was a gun-running opera-

Ray claimed that he was helped by individuals other than his two brothers or Raoul. Sprague said Fay told him the aid came at least three times: when Ray escaped from the Missouri State Prison about a year before the King murder, when he left the United States briefly before the assassination, and immediately after King was slain.

THE ACCOMPLICES gave Ray a gun to help him escape in Missouri and money several times in the year before the King killing, Sprague said he had been told. He said the gun was not the one used to shoot King.

A Justice Department task force recently found no evidence that Fay was part of a conspiracy, although the report said the source of Ray's funds "remains a mystery." Ray spent more than \$10,000 during the year while his earnings were just a little more than \$600.

Ray has said in public that he property from Raoul. But Sprague and he concluded, after talking with Ray, that the Raoul story was a fabrication.

THE JUSTICE Department task force determined that Ray got assistance from members of his family, particularly his brothers Jerry and John, after his escape from prison. The report chided the FBI for not investigating Jerry and John Pay more thoroughly. But the

King's Protector Ordered Off Job In a Conspiracy?

WASHINGTON — Investigators for the House Committee on Assassinations are exploring allegations that a black Memphis police detective was relieved from his assignment to guard Martin Luther King Jr. as part of a conspiracy involving top federal officials.

The policeman, Ed Redditt, was

assigned to protect King during his 1968 trip to Memphis, but was pulled off the assignment two hours before the slaying by local officials acting on advice from Washington.

Sources familiar with the current congressional investigation disclosed that House investigators have developed new and conflicting information about Reddittstransfer, even though the Justice Department had looked into the matter earlier.

REDDITT'S ACCOUNT has been cited by supporters of the conspiracy theory of King's death as major evidence of government participation at some level. Two of the supporters, Mark Lane and comedian Dick Gregory, will publish a book Tuesday based on Redditt's case.

A witness familiar with Redditt's transfer told The Tribune that an unidentified "federal law enforcement official" flew to Memphis the day of King's assassination to warn about a threat on Redditt's life.

It was learned from this source that congressional investigators have been given information different from that supplied to the Justice Department earlier this year. The department concluded at that time that there was no evidence that the FBI had participated in a plot to assassinate the civil rights

The new information involves the source of the threat on Redditt's life that prompted his superior, Frank Holloman, then Memphis police director, to remove him from a stakeout on King shortly before the assassination.

The Justice Department had concluded that the threat against Redditt involved the Mssissippi Freedom Democratic Party, but congressional investigators have now been told that the threat came from a New Jersey group.

ACTING ON this threat, the source said, Holloman summoned Redditt, leaving only one patrolman to protect King's entourage at the Lorraine Motel.

Redditt was the Memphis police department's expert on King, and his familiarity with members of King's party as well as local and federal officers on the scene would have enabled him to recognize any stranger when the shot was fired.

Based on the Mississippi report, the Justice Department found a Senate investigator named Phillip Manuel who was visiting police in Memphis the day King was killed. Although Manuel now says be coesn't remember warning about a

threat against Redditt, the Justice Department concluded that he was the mysterious Washington official.

Holloman has told numerous investigators that because of the extreme excitement caused by King's death and subsequent riots, he can remember only that the warning came from a Washington law enforcement official.

The Justice Department, however, maintains that since Manuel was not a law enforcement official, Redditt's transfer does not connect the FBI to a conspiracy.

WHILE THE House investigation examines inconsistencies in the source of the threat, Redditt — now retired — plans to go public this week to promote Lane and Gregory's book.

Gregory's book.

Their book, a sensational account implicating FBI officials in a conspiracy, has prompted House investigators to examine several aspects of Redditt's account and other points the authors raised. Lane and Gregory did not know about the New Jersey angle when they wrote their book.

Their publisher, Prentice Hall, has scheduled a press conference in Washington Tuesday, Lane has been criticized for omitting key details from his conspiracy theories about the assassination of King and President Kennedy, but has gained widespread publicity for his views.

QUESTIONS RAISED by Lane and other conspiracy advocates are credited by both Republican and Democratic congressmen with the decision to spend \$2.5 million investigating the death of King and Kennedy.

Much of the committee's early work has involved the compilation of massive files tracing the chain of events, which Lane and others charge were orchestrated by the late FBI director, J. Edgar Hoover.

A committee spokesman said that a research team has begun a computerized filing system to cross-index and compile hundreds of thousands of secret and public documents dealing with the assassinations of King and Kennedy.
