Good Friday 12-th o April, 1968

"TO WHOM IT MAY CONCERN:

"Please pass on to all the authorities wherever possible - to discontinue the search of a white man, as the killer of Martin Lucifer King, because the smart killer is right now in his own family. He is one of his own Civil Rights Urinators and a negro, not a white. I was among them myself in 1965, there were many young nuts, such as was I, and also many whites. However, God opened my eyes in Alabama, when I witnessed the behavior of our marchers under King's leadership. He was a devil's minister, taking all the money he could from the jews, and was doing his work under their leadership and demand. Those were communist jews.

"Wile marching in Alabama in 1965-it was in spring-we were instructed by King's advisers-red-rat-jews to do the following:

"A group of our negroes forced their way into a nice restaurant; on a given signal, all the negroes grabbed the sugar bawls off the tables, stood up and urinated into them, amid laughter, replaced the bals on the tables-MLK laughed approvingly.

"This is the reason why I, and many others, turned against him, and it was God's will that he was shot by one of his own disciples, a negro, not a white. Please stop all your sham broadcastings and grateful homage for that killed Martin Lucifer King - he was against our best President LBJ - for the nut hippie Bobby Kennedy, who hates the President because he was not appointed as Vice Pres. when his brother JFK was murdered the same way as was MLK. Senate should prohibit all marches at least for the duration of this war, and specially in our Capital. Now the white people are to be more against us for the crazy revolts, murders and damages.

"I am mailing the Police drawing of suspected killer of Dr.K. which appeared on page 2 in yesterday's Daily News, as a white man, who actually is a negro, but a brown one, made white with cream etc. - however, I made it with a crayon darker so they may find him in Atlanta in the King's family.

"You must understand that I cannot reveal my real name and address, although I actually do live in Harlen. Please do not hesitate to use my information, because it is God's truth.

"I am mailing 7 Of these letters to various places - why 7? Because yesterday was Good Thursday, the last supper of Jesus Christ, as a reminder of HIS seven words on the Cross:

'Into Your Hands I command my soul!'
'May your Easter be blessed!

"Sincerely,

"Coon Amen, 23 years old"





IN FURTHERANCE OF THIS CONSPIRACY, ERIC STARVO GALT DID, ON OR ABOUT MARCH 30. 1968, PURCHASE A RIFLE AT BIRMINGHAM. ALABAMA...."

ACCORDING TO MR. HOOVER, A 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL AND MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH 30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL. 1968.

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAMA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND 4, 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

INTENSIVE INVESTIGATION BY THE FBI HAS DISCLOSED THAT GALT HAS CLAIMED TO HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH, CALIFORNIA, FROM DECEMBER, 1967. TO FEBRUARY, 1968.

GALT LEFT LOS ANGELES ON DECEMBER 15, 1967, AND DROVE
HIS WHITE MUSTANG TO NEW ORELANS, WHERE HE CLAIMED HE CONTACTED
EITHER AN ENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON
DECEMBER 19TH AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT
TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2,
1968.

THE FUGITIVE IS DESCRIBED AS A WHITE MALE. HE IS APPROXIMATELY 5 FEET 8 INCHES TO 5 FEET 11 INCHES TALL AND WEIGHS BETWEEN 160
AND 175 POUNDS. HE IS SAID TO BE A NEAT DRESSER AND HAS A MEDIUM BUILD.

GALT HAS BROWN HAIR, WHICH HE WEARS IN A "BRUSH" CUT.

HE REPORTEDLY HAS BLUE EYES; HIS NOSE IS STRAIGHT AND NARROW; HIS

TEETH ARE STRAIGHT AND CLEAN; AND HE HAS GIVEN HIS DATE OF BIRTH AS

JULY 20. 1931.

THE FUGITIVE IS SAID TO HAVE A NERVOUS HABIT OF OCCASIONALLY PULLING AT AN EAR LOBE WITH HIS HAND. HIS LEFT EAR PROTRUDES FARTHER FROM HIS HEAD THAN HIS RIGHT EAR.

ACCORDING TO MR. HOOVER, PERSONS WHO HAVE MET GALT
DESCRIBE HIM AS A "LONER" AND STATE HIS LANGUAGE AND DIGTATION HAVE A
"RURAL" QUALITY AND SUGGEST THAT HE PROBABLY DOES NOT HAVE A HIGH DEGREE
OF EDUCATION. HE IS SAID TO DRINK ALCOHOLIC BEVERAGES AND HAS A
PREFERENCE FOR VODKA AND BEER. HE IS A FAN OF WESTERN AND COUNTRY

THE FEDERAL STATUTE UNDER WHICH GALT HAS BEEN CHARGED

PROVIDES A MAXIMUM PENALTY OF TEN YEARS' IMPRISONMENT AND/OR \$5,000

FINE. BOND OF \$50,000 HAS BEEN RECOMMENDED.

GALT SHOULD BE CONSIDERED ARMED AND DANGEROUS. ANY INFORMATION CONCERNING HIM SHOULD BE FURNISHED IMMEDIATELY TO THE NEAREST FBI OFFICE.



KING CASE AGINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FOR WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967.
